My Dear Friend:-

Your good report of Nashville and Memphis is before me. You -- yes, we, -have great reason to rejoice over the good work you inaugurated at Nashville.

I wish there were some women living in Nashville, who would, without money and without price, give their time to the maintenance of suffrage headquarters in the Woman's Building for the whole six months. It does seem as if there must be such women there. To pay a woman board and salary to go there from outside is, of course, beyond the possibilities of our lean treasury.

I was delighted to see that Mrs. Virginia Clay Clopton made such a good impression. I was deeply impressed with her maiden speech on introducing me to our Huntsville audience in 1895, and told her then she had the power, and should make it her duty, to become one of the best speakers of the country. Of course, I knew that if she went to the Exposition, she would make exactly the good impression that she did.

My big layout of an appeal for money results in but little more than yours. So far, only about \$80 have come in response.

I wish it were possible for you yourself to live in Nashville the next six months. In your quiet, convincing way you would do more than all of us old stagers put together.

I am very glad that the Tennessee women, both of Memphis and the Exposition, have decided to make arrangements for no speaker, unless recommended by you. It would be most disastrous, in all probability, if they should accept offers from women who were not thus endorsed. I hope you will learn of a number of our good speakers, who can be prevailed upon to speak at Nashville. I have the fullest faith that you and Mrs. Meriweather will do everything that can be done for the best interests of our movement. I will keep my eye and ear out too, and let you

-2-Miss L. C. Clay. know if I hear of anybody going near you. If you really think it best for the National Assocition to try and hold meetings the 30th and 31st of October, please correspond with Miss Shaw, who will be at her home, Wianno, Mass., and with Mrs. Foster Avery, and see if they can muster speakers to remain over from the Council for that purpose. It seems to me that there must be several of the women who will attend the Federation of Cluns, the National Council, and the Jewish Council, so as to be there the 30th and 31st, which will be Friday and Saturday, and I believe that you could manage to fill in those two days with suffrage to good advantage. But if you think it wise to have meetings in the city of Nashville on the Saturday and Sunday between the Federation of Clubs and the Council, and can secure speakers, that is a good thing to do in my opinion; and then it would be nice, while all hands are in Tennessee, to have a really good convention in Memphis. You and Mrs. Meriweather, there on the spot, it seems to me, should be the ones to decide on all those matters, and to keeme all arrangements. I am simply overwhelmed with this hunting through the records of the past, and feel no power to be and to do in the present. So you see, whether the meetings are on the grounds or outside, in the city of Mashville, it must be for you and Mrs. Meriweather to decide and to manage. Any of us, who know nothing of the conditions there, could not possibly make wise decisions. I forward your letter to Mrs. Foster Avery, and shall rely on her to make all necessary arrangements with you, since both she and you are members of the National Executive Board, and I know will do everything for the best and as I would like to have it done if I were on the spot. So, with many thanks for all you have done and all you will do, and with love to your sisters, Mary and Sarah, I am, as ever, Devotedly yours, Jusan D. anthony (Dictated.)

Dear Member of the Business Committee: --

I have just read and re-read the concensus of opinion of the different members of the committee sent me by the Corresponding Secretary, to which I will say: .

FIRST. That for the same reason we threw up the New England conferences -the war -- we cannot see into next year and decide wisely when and where to hold our convention outside of Washington. What looks best now may be the very worst thing when the war is over, so I say let the decision wait, at least until after the November elections. This is for a double reason: Michigan and California are to vote on the question of holding constitutional conventions. If both States should vote yes, then we would want to carry our propaganda conventions

into both; if only California, then I should vote to carry our annual meeting there in February, 1899, or just as soon as the Legislature had enacted the law regulating the election of the delegates and fixing the date of the constitutional convention. If only Michigan should carry the proposition, then I should vote to hold our convention in that State, not in Grand Rapids, but in the metropolis, Detroit. Neither of these horns of the dilemma can be chosen until after the elections are over in November next. Putting the constitutional conventions out of the question, I should vote against Minneapolis and Grand Rapids because of our having so recently held great National conferences in both, and I should vote against Cincinnati because of our recent very small National conference there.

I do not at all believe in the policy of taking our National annual meeting into the city which offers the best financial conditions, without consideration of the need of our help to some practical end.

I believe that either New Orleans or Memphis would invite us and offer hospitality too if the friends knew we would like to carry the convention there. So i beg that a decision may not be hurried, but that it shall at least be postponed until we get the election reports from both Michigan and California.

SECOND. I object totally to moving our officer-electing, delegate convention forward to spring, or back into autumn. What I hope to see the friends in all the States settle upon is that our regular annual meeting shall be held in Washington each year, the last of January or the first of February, for national work with Congress; that is, that instead of throwing up our efforts to secure a Federal Constitutional Amendment we shall double them, if possible. In the past four years, by taking our convention away from the capital, we surely have lost very much of the prestige and power we formerly had with Congress. And ##/
I fear very many of the delegates have either lost sight or were never possessed of the primal end and aim of our National organization, viz., that of securing

from Congress the passage of a resolution submitting to the Legislatures of the several States a proposition to so amend the Federal Constitution as to prohibit the States from disfranchising United States citizens on account of sex. To do this we must get a two-thirds vote of both Houses of Congress; and our only hope of getting this vote is to keep "pegging away on that line" if it takes another half century, not once in two years, but every year, and that with renewed earnestness of purpose and increased numbers of delegates from all the States to importune their representatives in person.

Then for State propaganda we should hold several National conferences each spring and autumn in such States as have suffrage amendments or constitutional conventions pending, thus throwing the weight of our national body's influence where it will be of most immediate practical benefit. To illustrate: This year I would have given National conferences to the largest cities of South Dakota and

Washington, instead of to Minnesota, Illinois, Michigan, Ohio (twice over), Pennsylvania, West Virginia, Maryland, Delaware, New Jersey, New York, and each of the New England States had the proposed sweep been carried out; and next year I would hold National conferences in the State or States which should then have precipitated the question before the people for immediate action, as Michigan and California, should they vote for constitutional conventions.

After we have done all we can to influence Congress and the States in which practical action is pending, then let us carry our propaganda to the other States where we feel we can do most toward preparing the way for a hopeful precipitation of amendments. This policy, it seems to me, will most surely and speedily bring to the women of the nation their citizen's right to have their opinions counted at the hakka ballot-box.

I do not want the States to do less in and for themselves, but I do want all of them to combine their powers and concentrate them upon Congress. There can

be efficient State societies without a national association, but there can be no efficient national organization except through and by the combination of those societies in the several States.

My Dear Friend: --

When in Washington I don't know whether you took in my pet scheme of raising a large Standing Fund for the Enfranchisement of Women, only the interest of which should be used from year to year. Enclosed is an appeal I have written concerning I would like to know whether it is such as would set you, your sisters and your mother, to thinking it your duty when you distribute your property to give or bequeath something to this fund.

I know the first thought that comes to you must be, "Who are to be the trustees?" I have thought that perhaps the eight women who now constitute our Business Committee would be good ones, and then twelve more must be found, with perhaps five or six men among them, so as to make the board of trustees number twenty. I have written asking for the constitution and by-laws of the Peabody Fund, but have not yet succeeded in getting them.

I am sure that the time has fully come when the demands for money to carry on our work cannot be met by annual beggings, and I do not see any prospect of the State societies increasing their number of members to such an extent as to bring in any appreciable amount of money. The little they pay in, as things are now, is nothing compared to the amount we have to beg. While I am perfectly willing to bequeath to all of the young women who may come after me, the hard work involved in carrying on our movement I feel bound to relieve them of something harder still -that is, the worry and anxiety of never knowing where to turn for the money to

(Miss Clay) foot the bills. I want you to look over this appeal and try to make it stronger, wherever possible, so that it shall reach the head and the heart and the conscience of everyone who receives it. My other and smaller scheme, the Press Bureau, has already received sufficient money to make sure of its establishment in the autumn, or as soon as the war spirit has settled down enough to make it seem possible for the world to look at and listen to anything upon the suffrage question. My Dear Friend: --

This is to place before you a proposition for insuring a certain income to carry on the work of suffrage from year to year, so as to relieve the young women who will have the responsibility of managing our national association in the very near future of at least part of their financial burden and thus leave them more time and strength for pushing forward the cause.

As you doubtless know, those who have stood at the head of this movement for the last half century have had no possible way of getting money to use for it except that of asking contributions from friends who were interested, and as nearly all this time I have been one of those at the front I have necessarily taken a large part in planning and executing the work, as well as in begging the money to pay for it. I can testify that fully for one half the anxiety, the worry and the toil of my part has consisted in not knowing where to turn for money to foot the bills.

In what necessarily must be the last years of my public service, I want to be instrumental in raising a permanent fund for the cause and placing it in the hands of a committee of fifteen or twenty good business women to invest to the best of their judgment, disbursing only the interest each year to carry forward the work.

My aim is 1,000,000 and as much more as may be. Of course, with such a modest fund the interest each year would be but a very small part of the sum needed, but it would be a certainty.

The contributions to the national association amounted last year in round numbers to \$14,000, and the year preceding to nearly \$12,000. A large proportion of these were from workingwomen and did not exceed one dollar each, and hundreds of them were only twenty-five cents. If the friends possessed of wealth gave annually according to their means we should be certain each year of rasing an amount of money equal to the demands of the work.

What I now ask, my dear friend, is that you will contribute to the Standing Fund for the Enfranchisement of Women as much as your good will to our caus dictates and your circumstances may permit. If your estate will not allow of your giving any considerable sum in your lifetime, then will you send me a writing, duly signed, stating that in your will you have bequeathed a certain number of thousands of dollars to this fund?

I have hed this in mind two years or more, but have been unable to find time to write to the friends who I felt would be glad thus to help our good causeafter they could no longer portion out their own contributions year by year. I hope you read the account in the Atlantic for February, 1897, of the George Peabody Fund and the great work it had done during its first thirty years. That fund was \$1,000,000 and was placed in the hands of a committee of sixteen, with power to fill vacancies, only one of whose original members is now living. The interest paid from it to help schools throughout the South amounted to \$1,200,000, so that in thirty years the trustees had been able to expend a sum larger than the principal itself, and yet had that still left to give them an equal sum to expend during the next thirty.

Year by year the needs of our suffrage work become greater, and I beg of you to aid in this effort to secure a certain mam income with which to start into each New Year. Thus the young women who may be elected to stand at the head of our movement will not be subjected to the necessity of begging every dollar to pay for postage, printing, lectures and expenses of all sorts for the several States struggling to carry on the educational work necessary to place the ballot in the hands of women.

You all of you know that the last has been an exceptional year of the fifty with me, and that had I been in my usual state of freedom I should have taken the bits in my teeth, gone to Washington and at least tried not only to raise the money but to work up the convention myself, for the Washington convention requires very different manipulation from one held in a rural city. So there is no one to blame but just you president, and she is not one particle sorry that she insisted on going with the meeting into a first-class opera house.

THE BULLETIN. I don't recommend giving it up, but I would like it to be made a great deal more practical, and in its next number I hope there will be something to stir up the local and State clubs throughout the country to feel that instead of stopping their home work they should redouble their energies and get up celebrations, bazars, etc. I don't agree with Mrs. Catt about trying to avoid letting the anti-suffrage folks know what we are doing. It is quite enough if the money has been paid out and the committee approved of it, without saying which individual transacted the business.
