Minutes of the Meeting of the Executive Committee of the Board of Trustees, August 2, at 12:00 Noon.

The Executive Committee of the Board of Trustees of the University of Kentucky met in the President's Office at 12:00 noon, Tuesday, August 2, 1955, with the following members present: R. P. Hobson, Harper Gatton, Dr. Ralph J. Angelucci and Smith D. Broadbent. Vice President Leo M. Chamber-lain and Secretary Frank D. Peterson met with the Committee.

A. Luncheon.

The meeting was called for 12:00 of clock and luncheon was served in the office of the President. The members of the Committee took up the business on the agenda at 12:30 p.m.

B. Robert P. Hobson Made Temporary Chairman.

Vice President Chamberlain expressed the deep regret of the members of the Committee and of the University at the death of Mr. Guy A. Huguelet, Vice Chairman of the Board of Trustees and Chairman of the Executive Committee. He suggested that some member of the Committee be named to serve as chairman of the meeting.

Upon the suggestion of Mr. Harper Gatton and the unanimous consent of all other members of the Committee, Mr. Robert P. Hobson was appointed to serve as temporary chairman.

C. Approval of Minutes.

On motion duly made, seconded and carried, the minutes of the meeting of the Executive Committee of February 8, 1955, were approved as published.

D. Financial Report.

The Vice President, Business Administration, made a financial report for the fiscal year ended June 30, 1955. It was suggested that, since the report was for the fiscal year, it be put into the minutes. The report follows:

The realized income from general sources amounted to \$8,570,725.60. The University did realize its estimate of \$8,496,052.95.

Departmental appropriations approved for general fund purposes total \$8,715,804.20. Expenditures and encumbrances amount to \$8,620,675.22 of the approved appropriations, which is 98.91% of the budget estimate, leaving an unexpended balance of \$95,128.68.

F. Easement to City of Scott Street Right-of-Way.

Vice President Chamberlain read the following communication:

July 14, 1955

Dr. L. M. Chamberlain Vice President University of Kentucky

Dear Dr. Chamberlain:

This will confirm my conference with you concerning changes in Scott Street.

The City apparently has a forty-foot right-of-way on Scott Street. Ten feet of this right-of-way is usually taken up with sidewalks. There is currently an existing sidewalk on the north side of Scott Street but none on the south side. The City proposes to put in a forty-foot street, coming to their curb line on the south side. This has the effect of using up all property now owned by the City on the south side of Scott Street which at some future time might provide space for a sidewalk. I have agreed that if and when a sidewalk is constructed, it will be done so by the University of Kentucky on University property, along the line owned by the University.

At the northeast corner of the intersection of Scott Street and South Upper Street, there is a bulge in the corner to the extent of 8.85 feet. The City proposes to extend the sidewalk now existing on the north side of Scott Street straight to the intersection of Scott and South Upper Streets. They propose to put in a new curb and pay all costs incident to this change. I think it will improve the appearance of the intersection and improve safety conditions there.

I have discussed this matter with Dean Dickey of the College of Education, Mr. N. R. Elliott, landscape architect and Mr. E.B. Farris, Chief Engineer. With your approval, I have notified the City to proceed. A sketch is attached hereto evidencing these proposed alterations.

Peterson, Vice President Business Administration Mr. Peterson, Vice President, Business Administration, discussed the proposed rebuilding of Scott Street and the granting of land on the north-west corner of the intersection of South Upper and Scott Streets. It was further explained that a part of the sidewalk on the north side of Scott Street would be rebuilt and the curbing adjacent to the road would be replaced by the City.

Members of the Committee being advised that it was to the best interest of the University and of the public, upon motion duly made, seconded and carried, a strip of land 8.85 feet wide, tapering to 0 width on Scott Street and on South Upper, was ordered given to the City of Lexington for the purpose of improving the width of existing Scott Street from 31.15 feet to a maximum of 40 feet and for the further purpose of straightening the sidewalk along the south side of the area known as the site of the College of Education. The plat and profile scale was ordered made a part of the agreement. The Chairman of this meeting was authorized to execute the deed easement for the University of Kenzucky.

G. Federal Employees Group Insurance Coverage for Cooperative Extension Personnel.

Vice President Chamberlain presented to the members of the Committee Agreement between the United States Department of Agriculture, Federal Extension Service, and the University of Kentucky Agricultural Extension Division. He explained that the Agreement provides that extension employees having Civil Service status may contract for life insurance in the amount of their annual salaries. The University, from Federal Extension Funds, agrees to contribute one half the premium paid by the employees. He read other previsions of the Agreement and upon the concurrence of Frank D. Peterson, Vice President, Business Administration, and Frank J. Welch, Dean and Director, Extension Service, recommended that the Agreement be executed on behalf of the University of Kentucky Agricultural Extension Service of the University of Kentucky.

Upon motion duly made, seconded and carried, the Agreement was approved and authorized executed on behalf of the University of Kentucky.

H. Caty of Erlanger Assessment for Sewer Approved.

Vice President Chamberlain explained that the University of Kentucky (History Department), by will of Mrs. Alice S. Hallam under date of August 10, 1948, received a number of lots in and near the City of Erlanger. The Executive Committee of the Board of Trustees at its meeting July 16, 1954, accepted the provisions of the will and did in due time take possession of lots 32 to 36, 43 to 46, and 61 to 73 inclusive, second addition to Hallam Heights, Erlanger, Ky.

The City of Erlanger has decided to build a sewer servicing the abovenamed lots and has made an assessment against the abutting property owners. The University of Kentucky land having a front footage of 1437.08 feet at \$5.1255 per foot is assessed a total of \$7,365.75. The question has been submitted to the Attorney General, J. B. Buckman, Jr., and he has advised that the City of Erlanger has a right to authorize a sewer in the City of Erlanger and to assess abutting property owners. He advises that the University is not exempt from this assessment and believes it would be liable for the sewer assessment against the lots owned by it in the City of Erlanger.

Members of the Committee being advised, upon motion duly made, seconded and carried, the Comptroller was authorized to pay the assessment in the amount of \$7,365.75 and charge same against physical plant, to be reimbursed from the proceeds of the sale of these lots when and if sold.

I. Transfer of Funds for Eden Shale Farm.

Vice President Chamberlain submitted a request from Frank J. Welch, Dean and Director, College of Agriculture, and Agricultural Experiment Station, that \$50,000.00 of funds provided in Farm Maintenance budget for the Mercer County Farm be transferred to Farm Maintenance budget designated Eden Shale Farm.

Vice President Chamberlain recommended that the request be granted, and upon motion duly made, seconded and carried, the sum of \$50,000.00 was authorized transferred from the Mercer County Farm budget to the Eden Shale Farm budget.

J. Withdrawal of Library Books Approved.

Vice President Chamberlain submitted a list of library books which have been superseded by other editions. He recommended that the Director of Libraries be authorized to withdraw and dispose of the following list of books either by giving them to other libraries or by selling the volumes:

K. Arnold Hanger Funds Transferred to Kentucky Medical Foundation.

Vice President Chamberlain stated that Mr. Arnold Hanger had made a gift of \$25,000.00 to the University of Kentucky with the proviso that he be permitted to designate at a later date the purpose for which the funds might be Doctor Chamberlain reported that he was in receipt of a letter from Mr. Hanger authorizing \$5,000.00 of the fund donated by him to be transferred to the Kentucky Medical Foundation for promotional and running expenses. Doctor Chamberlain recommended that the request be approved.

Upon motion duly made, seconded and carried, the Comptroller was authorized to transfer \$5,000.00 to the Kentucky Medical Foundation.

L. Contract with U. S. Department of the Interior, Geological Survey.

Vice President Chamberlain submitted Agreement between the Geological Survey, U. S. Department of the Interior, and the University of Kentucky for study of water resources of the Commonwealth of Kentucky. Doctor Chamberlain stated that this is a renewal of an existing contract and the costs would be paid for by a grant to the University of Kentucky. He recommended that the Agreement be authorized executed on behalf of the University.

Upon motion duly made, seconded and carried, the Agreement was approved and authorized executed.

M. Release and Waiver, Logan County Land, Approved.

Doctor Chamberlain read the following letter explaining the necessity of having a release and waiver of a tract of land in Logan County.

June 16, 1955

Dr. Leo M. Chamberlain Acting President University of Kentucky

Dear Dr. Chamberlain:

I attach hereto a release and waiver for a tract of land in Logan County, which was leased to the University in 1913 for a period of 99 years. The lease contained a provision that if the University did not operate and maintain on said land an agricultural experiment project under the supervision of the Kentucky Agricultural Experiment Station that the lease would be null and void. Dean Thomas Cooper on October 1, 1924, wrote the fiscal court of Logan County, with copies of leases going to the original grantors, that the Agricultural Experiment Station desired to discontinue use of the land.

Dean Cooper did not report his action to the Board of Trustees; therefore, no official release has ever been made of this land. There is no record that the fiscal court of Logan County ever took note of the University's abandoning the use of the land and such letter as was written by Dean Cooper was never recorded. The land is now owned by the Russell-ville-Logan County Civic Development Corporation. The Louisville Title Insurance Company requests that the records be cleared to show the Russellville-Logan County Civic Development Corporation the current owner of the land. This release and waiver has been prepared and approved by the office of the Attorney General and they recommend that it be authorized and executed. I concur in this recommendation.

N. City of Erlanger Request for Northern Extension Center.

The Secretary brought to the attention of the Executive Committee a letter from the City of Erlanger expressing its desire that the University of Kentucky utilize Hallam Estate property as a site for a Northern Kentucky Extension Center. The letter was read to the Committee, and upon motion duly made, seconded and carried, was authorized received and filed.

O. Adjustment in Agreement with Kentucky Seed Improvement Association.

Vice President Chamberlain reported that some two years ago, an agreement was made between the Kentucky Seed Improvement Association and the Director of the Experiment Station whereby the services of B. W. Fortenbery were utilized by both agencies. He stated that it seemed desirable to make an adjustment in the original arrangement. He read the following letter:

March 31, 1955

President H. L. Donovan University of Kentucky

Dear President Donovan:

Some two years ago we worked out a cooperative arrangement with the Kentucky Seed Improvement Association whereby Mr. B. W. Fortenbery would serve as Executive Secretary of that organization on a part-time basis and serve as Extension Agronomist for us.

The Seed Improvement Association agreed to make available to us sufficient funds to take care of Mr. Fortenbery's salary on an agreed upon percentage of time devoted to the Seed Association and to take care of travel in connection with the business operation of the Association.

We further agreed that the division of Mr. Fortenbery's time would be re-examined annually and changed in accordance with the demands of the Kentucky Seed Improvement Association on his time. We, of course, could use him full-time in Extension if his services were available.

Recently Mr. Smith Broadbent, President of the Kentucky Seed Improvement Association, and I reviewed with Mr. Fortenbery the requirements of his dual position and agreed that for the ensuing year, April 1, 1955 through March 31, 1956, approximately two-thirds (66%) of his time would be devoted to the Seed Improvement Association and hence the Association would deposit \$4500 with us for the payment for his time thus devoted to Seed Improvement Association work.

The percentage division of his time is to be reviewed annually and a decision made on how his salary will be divided as between the Seed Improvement Association and the Extension Division.

I hope this agreement is satisfactory with you.

Fortenbery and the contribution made by the Seed Improvement Association towards his salary was authorized approved and it was further agreed that the two agencies annually work out a satisfactory agreement designating the division of time devoted to each agency.

P. Professor Nollau's Salary Appropriated for Applied Mechanics.

Vice President Chamberlain stated that the College of Engineering was facing an increased enrollment and requested permission to use the funds set up for Professor Nollau to apply on employment of a full-time man in Applied Mechanics. He recommended that the request be granted.

Upon motion duly made, seconded and carried, the sum of \$3,312.00 was authorized appropriated towards the employment of a full-time man in Applied Mechanics, College of Engineering.

Q. Payment to Oak Ridge Institute of Nuclear Studies for 1955-56.

Vice President Chamberlain stated that the University, a few years ago, entered into an agreement with the Oak Ridge Institute of Nuclear Studies to pay \$750.00 annually towards expenses of the Institute. He submitted the invoice for the fiscal year 1955-56 and recommended that same be approved.

Upon motion duly made, seconded and carried, the sum of \$750.00 was appropriated from the Haggin Fund to pay the contribution to the Oak Ridge Institute of Nuclear Studies for the fiscal year 1955-56.

R. H. D. Palmore Thanks the University.

Vice President Chamberlain read to members of the Executive Committee the following letter received from Mr. H. D. Palmore:

Dear President Donovan and Members of the Board:

S. Kellogg Foundation Grant Accepted.

Vice President Chamberlain reported that the W. K. Kellogg Foundation of Battle Creek, Michigan, had notified Dr. Frank Dickey, Dean of the College of Education, that the Foundation had approved a proposal entitled "Institutional Program Experimentation in Preparing Educational Administrators." The proposal of the Kellogg Foundation will carry a grant of \$29,800.00 as a four-year commitment for the conduct of the proposed program. The Foundation's check in the amount of \$7,450.00 for the first fiscal year of the program (September 1, 1955 to August 31, 1956) will be made available in September, 1955.

Vice President Chamberlain recommended acceptance of the grant and approval of the conditions as outlined by the Foundation.

Upon motion duly made, seconded and carried, the recommendation of the Vice President was concurred in and acceptance of the grant was approved.

T. Budget for Department of Agricultural Engineering Approved.

Vice President Chamberlain reported that Frank J. Welch, Dean and Director of the College of Agriculture and the Agricultural Experiment Station had recommended a budget of \$14,700.00 for a department of Agricultural Engineering. Dean Welch requested that \$12,500.00 be taken from unappropriated surplus of the Experiment Station funds and that \$2,200.00 be taken from unappropriated Agricultural Extension Division funds. He said that the proposed budget would be supplemented to some extent from the Agronomy budget. However, any transfer from the Agronomy budget would be recommended later.

Upon motion duly made, seconded and carried, the proposed budget for Agricultural Engineering was approved and the Comptroller was authorized to make the necessary appropriations as above suggested.

U. Injuries to Lewis Walker, Jr., and Clyde Price.

The Vice President, Business Administration, reported an injury to Lewis Walker, Jr., an employee of the Division of Maintenance and Operations. He said that Mr. Walker was struck in the eye by a small piece of metal. He was directed to see Dr. Claude Trapp for treatment. Dr. Trapp submitted an invoice of \$6,00 for services rendered in removing a foreign body from the eye.

Mr. Peterson also reported injury to Clyde Price, janitor in the Division of Maintenance and Operations. Mr. Price was moving a piano on the stage of the theatre in the Fine Arts Building. One of the legs and rubber rollers of the piano came off. Mr. Price lifted the piano to replace the leg and roller. He strained his back and was referred to Dr. Farris of the Infirmary on May 25. Dr. Farris referred Mr. Price to Dr. Robert Kinnaird for treatment and x-rays. Dr. Kinnaird submitted invoice for x-rays, \$25.00; and office call, \$3.00; total, \$28.00.

The Vice President, Business Administration, recommended that the invoice of Dr. Trapp for \$6.00, and the invoice of Dr. Kinnaird for \$28.00 be authorized paid, with the understanding that the University does not admit liability and that the paying of these claims does not set a precedent.

Upon motion duly made, seconded and carried, the recommendation of the Vice President, Business Administration, was concurred in, with the understanding that the University does not admit liability and that the paying of these claims does not set a precedent.

V. Purchase of Kepple Roland and Gustav A. Wendt Farms.

Vice President Chamberlain reported a request from Frank J. Welch, Dean and Director of the College of Agriculture and Agricultural Experiment Station recommending the purchase of two parcels of land in Owen County. He explained that these farms would be used in connection with the Agricultural Experiment Station program. He stated that the Citizens Committee, working in cooperation with representatives of the Agricultural Experiment Station, had agreed upon two farms in Owen County as follows:

Kepple Roland and Beulah Roland, his wife, 660 acres, price \$45,000.00.

Gustav A. Wendt, 234,22 acres, price \$14,500.

He said that the County Attorney and the Attorney General have approved the deeds and abstracts for these properties. The State Property and Building Commission has approved the purchase of the farms. He recommended that the Executive Committee of the Board of Trustees authorize the purchase of a total of 894, 22 acres of land for a combined total of \$59,500,00, to be paid for by funds received by a Citizens Committee and a grant of \$23,500.00 from the Governor's Emergency Fund.

Upon motion duly made, seconded and carried, the farms owned by Kepple Roland and Beulah Roland, his wife, 660 acres, and Gustav A. Wendt, 234, 22 acres, were authorized purchased for \$45,000,00 and \$14,500,00 respectively.

W. Experiment Station Budget Increased, 1954-55.

Vice President Chamberlain reported that requisitions and encumbrances submitted by the Agricultural Experiment Station during the year 1954-55 had exceeded the approved budget. He reported request of Frank J. Welch, Dean and Director, for an increase in the appropriation of \$63,606.13, same to be taken from the unappropriated surplus of the Revolving Fund.

The Vice President recommended that the request be granted, and upon motion duly made, seconded and carried, the Agricultural Experiment Station budget was authorized increased for the fiscal year 1954-55 in the amount of \$63,606.13 from the unappropriated surplus of the Revolving Fund.

X. Correction in Deed Given by Alice S. Hallam to Land in Kenton County.

Vice President Chamberlain explained that the University, by will of Alice S. Hallam under date of August 10, 1948, became the owner of a certain tract of land and other lots in Kenton County in northern Kentucky. He stated that, during the lifetime of Alice S. Hallam, she sold a lot and the deed stipulated that the lot was in Plat No. 515A, whereas it was actually in Plat No. 515. The present owner of the lot requests correction of the original deed.

Upon advice of the Attorney General, the following document was recommended approved and executed:

KNOW ALL MEN BY THESE PRESENTS:

That the Grantor, Commonwealth of Kentucky for the use and benefit of the University of Kentucky, residuary devisee of Alice S. Hallam, deceased,

for and in consideration of One (\$1.00) Dollar and other good and valuable considerations

to it paid by the Grantees herein, the receipt whereof is hereby acknowledged, does hereby remise, release and forever quitclaim to Stanley Vickers and Opal Vickers, Grantees, any and all right, title, claim or interest which it may have in and to the following described real estate, to-wit:

Situated in the City of Erlanger, County of Kenton, and State of Kentucky, and being all of Lots Numbered Sixteen (16) and Seventeen (17), Greenwood Heights Subdivision, as shown on plat of said Subdivision being Original Plat No. 515 in the records of the Kenton County Clerk at Covington, Kentucky.

Being a part of the same property intended to be conveyed by Alice S. Hallam to Earl L. Clutterbuck and Mary Louise Clutterbuck by deed dated October 18, 1947, and recorded in Deed Book 358, Page 54, of the Kenton County Records at Covington, Kentucky. In said deed, however, said lots were described as being shown on Plat No. 515A. Said lots did not appear on such plat and this deed is given to correct such error in description, the said Alice S. Hallam having died testate and by her will probated July 13, 1954, and recorded in Order Book 97, Page 481, of the Kenton County Records at Covington, Kentucky having devised the residue of her estate to the University of Kentucky.

The contract being read by a member of the Committee, upon motion duly made, seconded and carried, the Agreement was approved and ordered executed on behalf of the University.

B-1. Resolution on Death of Guy A. Huguelet.

Doctor Chamberlain stated that he regretted to recall the recent death of the Chairman of the Executive Committee, Guy A. Huguelet. He stated that each member of the Board of Trustees was notified of Mr. Huguelet's death and an appropriate floral design was sent in the name of the University and Board of Trustees. Each member of the Committee entered into the discussion, and upon motion duly made, seconded and carried, the following Resolution was passed:

WHEREAS, on Saturday, July 23, 1955, death came to Guy Alexander Huguelet, alumnus of the University of Kentucky, member of the University's Board of Trustees, chairman of the Board's Executive Committee, a director of the University's Athletic Association, and a member of the Executive Committee of the Alumni Association, and

WHEREAS, Guy A. Huguelet's services to his alma mater were of greatest significance and magnitude,

BE IT THEREFORE RESOLVED that the Board of Trustees of the University of Kentucky adopt resolutions recounting his many public services, taking full cognizance of his many noble attributes, and expressing gratitude for his work and his worth to the University, community, state and nation.

Guy A. Huguelet was born January 1, 1891, in Charleston, South Carolina, the son of George Arthur and Mamie Melchers Huguelet, members of an old Huguenot family. He entered the University of Kentucky as a law student on September 12, 1912, and graduated with an LL. B. degree in the class of 1914, that of his good friend, Herman L. Donovan. Mr. Huguelet practiced law in Lexington from 1915 to 1930, serving as assistant city attorney from 1924 to 1930. In 1926 he helped to organize the Consolidated Coach Lines, acting as secretary and counsel for the This venture under his organizing genius, vision and business acumen developed into the present-day great Southeastern Greyhound Lines. Through this, the greatest of all inter-city bus lines, Mr. Huguelet made Lexington the bus crossroads of the southeastern United States. During the fall of 1954, the Southeastern Lines merged with the Dixie and Teche Greyhound Lines, retaining the original name, with Mr. Huguelet as chairman of the Board.

Ever civic-minded and active, Guy A. Huguelet was one of Lexington's and Central Kentucky's foremost citizens. He was director and president of the Keeneland Association and chairman of many fund-raising campaigns and director of several enterprises in which he had a business interest.

Guy A. Huguelet was a man of action. He was ever a fighter, "a happy warrior." What he believed in, he strove to advance with all the force of his being. Whether it was betterment of his beloved Bluegrass country and Lexington, the upbuilding

of his business, or the advancement of his alma mater, he poured into the enterprise all of his splendid energy and enthusiasm. He built wisely and well.

In 1948, Guy Huguelet was appointed a member of the Board of Trustees of the University of Kentucky. Because he was deeply devoted to his alma mater, this was perhaps the most pleasing honor which came to him. For the University, it was a significant appointment. The following year, upon the retirement of Judge Richard C. Stoll, Mr. Huguelet became chairman of the Board's five-member Executive Committee. He served in this position until his death. Though a busy man, he devoted perhaps as much time to the problems of the University as any trustee since the founding of the institution. His objectives With intense love, loyalty, were ever betterment and expansion. business acumen, and energy, he helped make his alma mater one of the nation's growing institutions of higher learning. the years to come the people of Kentucky will further enjoy the maturing of his hopes and plans in an even better University.

Realizing fully the power and potential of the University's alumni, Guy Huguelet gave every possible encouragement and help to organizing local chapters of the Alumni Association. In this his vision was prophetic, accurate, and sound.

Guy Huguelet was an avid votary of athletics, with a special interest in football. A vigorous contest was ever to his liking. As an active member of the Athletic Board, he was instrumental in raising funds to launch an impressive football program. He loved the sport, and he loved athletics. His helpfulness and enthusiasm will be missed by the "boys", coaches, and the sports-minded public.

In all his work, Guy A. Huguelet was a man not only of vision but of bold plans, restless energy, singular confidence, and he possessed a keen intellect. He always looked to the future. He was fortunate above most men in being able to visualize the necessary action to bring progress and eventually to achieve great and noble objectives.

During his lifetime, Guy Huguelet made many personal friends. To these he was genial, warm and kind, but ever-ready for a spirited argument. These close associations were sincere and fine, deeply personable and richly meaningful to him.

In his passing, Guy Huguelet's friends lost a generous, helpful and affectionate companion. Among these are the members of the Board of Trustees. They, too, have lost an affectionate and helpful friend. The University has lost a faithful champion and benefactor.

BE IT FURTHER RESOLVED, that the Board of Trustees of the University of Kentucky have these resolutions spread upon its official minutes, and that a copy be sent to the bereaved family.
