State University of Kentucky. May 27,1910.

The faculty met at 3 P.M., those present being President Patterson, Vice-President White, Professors Patterson, Pryor, Anderson, Mathews, Miller, Pence, Mackenzie, Norwood, Wilson, Zembrod, Tuttle, Rowe, Frankel, Lafferty, Hooper, Jones, Terrell, Snow.

The minutes of the last meeting were read and approved.

On motion of Professor Frankel, seconded by Dr. Terrell, it was ordered that the faculty proceed with the discussion of the candidates for degrees.

Professor Miller presented the name of Miss Isabella West Marshall to be recommended for the degree of Master of Science, and on his motion, seconded by Dr.Tuttle, it was ordered that she be so recommended.

Professor Miller also presented the name of Mr.A.O.Bowden for the degree of Master of Arts, major subject being English. Attention was called to the fact that some of the conditions relative to fees had not been complied with in this and other cases, and it was ordered upon motion of Judge Lafferty, seconded by President Patterson, that all the recommendations for degrees be conditioned upon the payment of the proper fees and the compliance with all other requirements. This motion was carried, and Mr.Bowden was then recommended for the degree named, subject to this action.

On motion of Professor Miller, seconded by Professor Jones, it was ordered that these named Seniors be recommended to the Board of Trustees for the A.B. degree.

Professor Miller then called attention to the case of Mary Scott Spencer who on account of sickness in the household where she resides had not completed her examinations, and to the case of Esther Vaughan who had failed in history and sociology. On motion it was ordered that these two candidates

be recommended when they shall have complied with all the conditions and completed their work.

Professor Miller than called the faculty's attention to the case of Earl Benton Webb and stated that upon examination of his paper in geology it had become very manifest that Mr. Webb had completed his paper in collusion with W.B. Wilson of the same class. He stated further that Mr. Webb while at first not admitting his guilt had afterwards, on being confronted with the evidence admitted it. It was moved by Professor Frankel, and seconded that Mr. Webb's case be referred to the Committee on Morals and Discipline. The subject was discussed by Professors Terrell, Wilson and Mackenzie, and Professor Mackenzie moved as a substitute that Mr. Webb be summoned before the President and reprimanded in the presence of his Dean and that he be permitted to take an examination such as may make it possible for him to graduate with his class. The motion was seconded by Judge Lafferty. Remarks upon the question, pro and con, were made by President Patterson, Judge Lafferty, Professors Terrell and Miller. The ayes and noes were then called for, the vote for the substitute motion standing as follows:

Professor Anderson on behalf of the Committee upon Diplomas and Degrees stated that it had been suggested to the Committee that the degree of LL.D. be conferred upon Dean Capers, but that the Committee had not yet taken action and felt that the matter should be referred to the entire faculty for their consideration. On motion of President Patterson it was ordered that this question be restrained until next year. be postponed until next year. On motion the meeting adjourned.
