STOP BULLYING. NOW By Craig Cammack, Contributor

As we continue to hear stories of bullying and suicide among our youth, we are drawn to striking statistics. According to the 2009 National School Climate Survey by GLSEN:

•84.6% of students were verbally harassed at school because of their sexual orientation.

tion,
•40.1% were physically harassed,

Nearly 1 in 5 were physically assaulted,

•and almost 1 in 3 missed at least one day of school within a month because they felt unsafe

School is a place for learning, where you find yourself and your potential. However, for far too many, it is a prison, a torture chamber, a place of insecurity. According to the recent AC360 Bullying Study, over 35.5% of respondents believed schools could help combat bullying. There is a clear need for safety and bullying prevention to be more prevalent in daily school activity.

With Lexington Fairness' Project Speak Out program, we will provide GLSEN Safe Space Kits, as well as on hand training to school teachers, counselor and staff. There will be a multitude of adults in schools who are able to help prevent bullying, and comfort and support those who are being harassed.

In the month of November and December, Lexington Fairness rolls out it's STOP BULLYING. NOW. Campaign. This campaign raises awareness to the statistics mentioned above,



points a spotlight on the issue of bullying in our schools and supports the Project Speak Out programming. We are fortunate to have recently been selected as a recipient of the 2011 Cliff Todd Endowment grant from JustFundKY. By providing their resources, Lexington Fairness has only \$10,000 to raise in order to finalize the Project Speak Out program and bring the resources to Kentucky.

Help Stop Bullying

The Gay & Lesbian Alliance Against Defamation (GLAAD) has teamed up with Facebook to reduce the amount of hate speech and anti-gay bullying that goes on around the Internet.

Members of the gay community reached out to GLAAD recently when a Facebook page created to remember the victims of antigay bullying who had committed suicide was flooded with hateful, violent and derogatory remarks and images. Fortunately, GLAAD was able to work with Facebook to remove the content, and this organization's work with Facebook has just begun.

Recently, tragic events that included the use of technology to shame and harass a college student, Tyler Clementi, because of his sexual preference led to Clementi's suicide. And this sad news came just a couple weeks after 15-year-old Billy Lucas committed suicide after being tormented by other young people about his sexuality.

Since then, celebrities, organizations and social media users have taken to the web to spread words of encouragement and discourage bullying behavior. Columnist Dan Savage launched a YouTube channel, "It Gets Better," and many celebrities have spoken out on YouTube about LGBT issues and teen bullying. MTV Networks even rolled out an iPhone app to help combat bullying.

Still, the largest online destination for many beleaguered gay teens and young adults is Facebook — ironically, one of the platforms where hate speech, though prohibited, is unfortunately still carried out.

Facebook announced that its mak-



ing new efforts to respond quickly when hateful speech violates the terms of service and needs to be removed. And this isn't just routine TOS policing, either.

Facebook Public Policy Communications Manager Andrew Noyes wrote in an e-mail today that Facebook "intends to work closely with GLAAD and other LGBT organizations on future initiatives."

Stay tuned for more information on how exactly the social network plans to support LGBT teens and the larger gay community.

Gay Rights Pioneer Frank Kameny Passes Away by Mary Crone, Contributor

Frank Kameny, an early gay civil rights leader, died on October 11, 2011, National Coming Out Day. He was 86 years old. Kameny sued the Federal government in 1957 for firing him as a government astronomer because he was gay. His case is believed to be the first civil rights claim based on sexual orientation that reached the U.S. Supreme Court.

Born in 1925 and growing up during the depression, Kameny started college at age 16 but interrupted his studies when he enlisted in the Army during World War II. In an interview last year in the Washington Blade he said, "They asked, I didn't tell."

After the war, Kameny returned to school and eventually received a PhD in Astronomy from Harvard University. Kameny taught for a year at Georgetown University. In July 1957 he was hired by the United States Army Map Service. A few months later he was arrested in Lafayette Park, a traditional cruising area along Pennsylvania Ave. across from the White House.

Because of this arrest, Kameny was questioned by the Civil Service Commission but refused to give them information regarding his sexual orientation. The commission opened an investigation into his alleged "threat" to national security. Within a few weeks he was dismissed from his job, with his name placed on a list of people labeled as government security risks.

Kameny appealed his firing through the judicial system, losing twice before taking an appeal to the United States Supreme Court. The Supreme Court declined to hear the case. Nevertheless, he was the first known gay person to file a gay-related case before the high court and he did so without denying that he was gay. Through this process, Kameny became the first gay American to make an argument for gay and lesbian civil rights based on the ideal of equality that is the basis of the U.S. Constitution.

In August 1961, Kameny and Jack Nicols co-founded a chapter of the Mattachine Society in Washington D.C. They advocated aggressively for fair and equal treatment of gay employees in the federal government by fighting security clearance denials, employment restrictions and dismissals.

Kameny and Nichols organized some of the earliest public protests by gays and lesbians including a picket line at the White House on April 17, 1965. A picket sign from that demonstration is now featured in the Smithsonian Museum of American History.

In coalition with New York's Mattachine Society and the Daughters of Bilitis, picketing expanded to target the United Nations, the Pentagon, the United States Civil Service Commission, and Philadelphia's Independence Hall. In 1968 Kameny created the slogan "Gay is Good" for the blossoming gay civil rights movement. This slogan helped our community recognize and confront our internalized homophobia. Kereny's

We also had the wonderful opportunity to work with several of our university brothers, sisters and allies during October. We attended the annual event, Life's a Drag, hosted by MSU's



What's in a Word? By Pastor Karen Taylor, Contributor

Words carry meaning, but sometimes the meaning gets lost in the frequency and looseness of using it. Gay use to mean happy, which has always puzzled me as to how the word started being used to mean homosexual. I've always been interested in the origin of words. When I was in college I wanted to take a class on it but could never fit it into my schedule. In this article I want to take a look at the word salvation.

The dictionary defines the word as saving a person from sin or danger. My Bible dictionary says: deliverance from the power of sin; redemption. It continues to discuss how the word was used in the Old Testament. Salvation was used to refer to deliverance from danger (Jer. 15:20), deliverance of the weak from an oppressor (Ps. 35:9-10), the healing of sickness (Is. 38:20). The need for salvation goes back to the Garden of Eden. The main Old Testament experience of salvation is in the Exodus from Egypt (Ex. 12:40 -14:31). In the New Testament salvation comes through Christ and is found in all three tenses: past, present, and future. When a person accepts Christ as their personal Lord and Savior he is saved (Acts 16:31); but there is also a process of being saved (Rom. 8:13). Lastly, we shall be saved from the presence of sin (Rom. 13:11). "God releases into our lives today the power of Christ's resurrection (Rom. 6:4) and allows us a foretaste of our future life as His children (2Cor. 1:22)." Nelson's Illustrated Bible Dictionary pg. 939

My personal salvation experience includes a little of all of the previous experiences. I was a lonely little girl, full of hurt and pain from

a childhood full of abuses and neglect. I had no hope for a future or contentment in the present. Upon accepting Christ into my life as my personal Lord and Savior I found just that, hope, peace, and contentment. Now let's be perfectly clear here. It doesn't happen in a flash. It has been years of walking with Him (and help of a counselor) that I found these things. Jesus said He came to heal the broken hearted and set the captive free. Then He instructs us to go and do the same for others.

John 3:16, "For God so loved the world that He gave His only begotten Son, that whoever believes in Him should not perish but have everlasting life." The Greek word for loved in this passage comes from the Greek word agapao which means an unconditional love, love by choice and by an act of the will. When you stop and think about the intense extreme love He showed us how can you not respond to it? Jesus's death was cruel, extreme, and full of unimaginable pain.

Every one of us will one day bow before the creator of the universe. The decision is made at that point, no turning back. Will you spend eternity in heaven with God or in separation from Him? Are you crying out for deliverance from your present situation? Jesus is waiting for you, waiting to do just that. All you need to do is ask Him. Then give me a call and allow me the pleasure of walking with you in your quest of getting to know the One who gave His life for you.

God loves you with an everlasting love; He has plans for you that are intended to give you a hope and a future. Allow Him the opportunity to show you that love. God's richest blessing to you and remember to attend a church of your choice this coming Sunday.

the 60's lay a foundation that enabled post Stonewall organizations to flourish throughout the country.

After Stonewall, Kameny focused attention on several issues he believed to be major obstructions to gay lesbian civil rights. In 1963, Kameny and Mattachine launched a campaign to overturn D.C sodomy laws; he personally drafted a bill that finally passed in 1993. He worked with Barbara Gitting to remove the classification of homosexuality as a mental disorder from the American Psychiatric Association's Diagnostic and Statistical Manual of Mental Disorders (DSM). Kameny and Gitting attended many conventions where they spoke to psychiatrists and other mental health professionals about the absurdity of considering all gay and lesbian people to be mentally ill. They were rewarded in December 1973, when the classification was removed from the DSM.

Kerney continued to be a leader in the decades that followed. On June 29, 2009, John Berry(Director of the Office of Personnel Management) formally apologized to Kameny on behalf of the United States government. Berry, who is openly gay, presented Kameny with Working the Theodore Roosevelt Award, the department's

most prestigious award.

Chuck Wolfe, CEO of the Gay & Lesbian Victory Fund, said Kameny's death marked the "loss of a hero and a founding father of the fight to end discrimination against LGBT people." "Dr. Kameny stood up for this community when doing so was considered unthinkable and even shocking, and he continued to do so throughout his life," Wolfe said. "He spoke with a clear voice and firm conviction about the humanity and dignity of people who were gay, long before it was safe for him to do so. All of us who today endeavor to complete the work he began a half century ago are indebted to Dr. Kameny and his remarkable bravery and commitment."
