Mr. Peterson stated that he did not consider it in his province as Treasurer of the University to endorse checks made payable to the University to the Foundation, a corporation. He asked for guidance and authorization of the Board of Trustees.

Upon motion duly made, seconded and carried, the Treasurer of the University of Kentucky was authorized and directed to endorse the three checks made payable to the University of Kentucky to the Kentucky Research Foundation.

## F. Loan Agreement Project, Ky 15-CH-36 (DS) Approved.

Mr. Peterson submitted to the Board a negotiated loan agreement with the Housing and Home Finance Agency, Community Facilities Administration, Washington, D.C., for \$1,225,000, partially to finance the construction of central kitchen-dining room and dormitory facilities for girls. He explained that the loan agreement carries an interest rate of 3-1/8% per annum. Mr. Peterson recommended that the agreement be approved and that authority be granted for its execution.

Upon motion duly made, seconded and carried, the loan agreement, Project No. Ky-15-CH-36 (DS) for \$1,225,000, was approved and authorized executed on behalf of the University.

# G. Agreement with the United States Department of the Interior for Water Investigation.

Mr. Peterson submitted agreement between the United States Department of the Interior and the University of Kentucky for cooperation in the cost of investigation of water resources in the State of Kentucky. He stated that the funds involved came from State appropriations for statewide investigations of surface water, ground water and quality of water, and recommended that same be approved and authorized executed. Upon motion duly made, seconded and carried, the agreement for investigation of water resources in the State was approved and authorized executed.

# H. Alfred N. Brandon and Paul Parker to Do Consultation Work.

President Dickey submitted a request from Dr. William R. Willard, Vice President of the Medical Center, recommending that Mr. Alfred N. Brandon, Medical Librarian, be permitted to serve as a library consultant to the Temple University School of Medicine for the period of June 13-17. He stated that he felt that this work would add to the prestige of the Medical Center and its library, and that Mr. Brandon could render a valuable service to another academic institution.

President Dickey submitted a recommendation from Dr. William R. Willard that Mr. Paul Parker, Hospital Pharmacist, be permitted to continue to do consultation work in the planning and construction of hospital pharmacies as long as it does not interfere with his responsibilities at the Medical Center.

It was explained that Dr. Willard would periodically check and report on the consultation work of these gentlemen, to make certain that their outside work did not interfere with their duties at the University.

Upon motion duly made, seconded and carried, Mr. Brandon and Mr. Parker were authorized to do the consultation work requested.

# I. Mr. Saidi Pandjaitan, Free-Fee Scholarship Granted.

President Dickey recommended that Mr. Saidi Pandjaitan be given a free-fee scholarship. He stated that the Kettering Family Foundation was making available to Mr. Pandjaitan for the coming academic year \$750.00 per semester, to include tuition and room and board in the dormitory.

Upon motion duly made, seconded and carried, free fees for Mr. Pandjaitan for the academic year 1960-61 were authorized granted.

# J. Film Services Work Transferred to College of Education.

President Dickey reported that he had worked out with the head of Extended Services and Dean of the College of Education a transfer of handling the film library and rental of the film services to the campuses of the State school system. He recommended that the sum of \$26,563.00 be transferred from Account 1380 to a new account to be set up in the College of Education, Bureau of School Services. He also recommended that the funds in Account 3394, designated as Income Account, for Rental of Film Services, be transferred and made available to the College of Education, Bureau of School Services. He submitted a budget for the transfer and recommended that same be approved.

Upon motion duly made, seconded and carried, the recommendation of the President was concurred in, and the necessary budget adjustments authorized.

#### K. Budget Adjustment.

President Dickey recommended that \$1,000.00 be transferred from unappropriated surplus of the University to Account No. 100, to pay for extra expenses incurred by the Registrar's Office in connection with pre-registration of students.

Upon motion duly made, seconded and carried, the Board concurred in the recommendation of the President.

#### L. AFROTC and GFROTC Flight Training Contracts Approved.

Mr. Peterson explained that the University had, for the past two years, been carrying on air flight training programs for the Air Force and Ground Force ROTC units at the University under a contract with the Armed Forces. He explained that subcontracts for the flight training had been made, with all necessary insurance to indemnify the University from suits incident to the air flight training program. He stated that these contracts were subject to renewal and recommended that approval be given to renew them for the ensuing year under similar conditions as the previous contracts for these programs.

Upon motion duly made, seconded and carried, the Air Force and Ground Force ROTC contracts for flight training were authorized renewed and extended for another year, and contract was authorized entered into with Bohmer Flying Service as required.

# M. Appointment of Provost Approved.

President Dickey made the following statement regarding reactivating the position of provost, and made the following recommendation:

During the past four years continuing consideration has been given to the organizational structure of the University. The self-study which was completed a few months ago and the visit by the committee of consultants from other institutions have contributed to the knowledge that certain changes in the administrative pattern of the institution were necessary.

These changes are made necessary because of expanding programs of instruction and research, by increasing specialization and complexity in modern higher education, and by the rising need for effective communication, planning, coordination, and continuous study.

All administrative officers of a university should function in such a way that rapid decisions can be made--decisions which are based on a clearer understanding of the problems involved than the president as a single individual can possess. The president and the chief administrative officers should form an "operating committee" or a "cabinet" which will give thoughtful consideration to the alternative courses of action required for the operation and the advancement of the institution. At the present time we have an executive vice president (Dr. Leo M. Chamberlain), a vice president for business administration (Dr. Frank D. Peterson), and a vice president for the Medical Center (Dr. William R. Willard). These men are outstanding and this University is one of the most fortunate of which I know because it has persons in these key positions who have vision and great ability. It has been increasingly clear, however, that as the University expands, not only in numbers of students but also in a variety of programs, an additional top administrative officer is needed.

In 1954 the University Board of Trustees created and filled the position of Provost of the University. Upon the resignation of Dean and Provost Elvis J. Stahr, Jr., in 1957, I did not feel that I had had adequate opportunity to study the organizational needs of the University, and as a consequence, I did not recommend any one to fill that position. The position was not abolished, and after serious study, I am recommending today that the position be filled -- this time very much in keeping with the strict definition of the term "provost" as used in educational circles. I am recommending that Dr. A. D. Albright, Executive Dean of Extended Programs, also be named as Provost of the University, with duties to be primarily in the major functions and programs of instruction and research. The Provost's office will have the responsibilities of planning, coordination, and study of instructional programs, both on-campus and off-campus. It is hoped that the Provost with the assistance of the Deans of the various colleges can soon prepare an inventory of instructional research presently being conducted in It is proposed then that this group of persons charged the University. with the direct responsibility for the academic program of the institution can find increasingly effective means of coordinating the instructional program of the University.

As was pointed out in several sections of the self-study of the University, systematic efforts to improve communication processes are important in any large organization. However, more than the usual effort must be made in universities because of several circumstances which are inherent in these institutions'. In the first place, the interests of the several parts of the institution are infinitely more specialized than those of most organizations in modern society. Furthermore, they cover a wider range of subjects. In this respect there is no comparison between most large industrial corporations and a large university organization. Also, the essential but unusual individuality of thought and behavior of the academic person presents specialized problems in communication. problems are often seen in hospitals, in laboratories, and in other highly professionalized areas of both government and the corporation. It is one of the tasks of administration in these large and complex universities to find ways of improving methods of communication in order to create a reasonably cohesive total institution.

It is my belief that the refilling of the post of provost will give more opportunities for cooperative planning for the instructional program of the University and, therefore, improve communications internally and perhaps externally as well.

In naming a provost, we shall be able to shift certain responsibilities and reporting offices to equalize to a greater degree the administrative load of the University. The academic deans will report directly to the Provost in order that the coordination of efforts and communication already referred to may be strengthened. At the same time, the president of the University will be enabled to devote more time and effort to the long-range planning for the University and its various programs.

In recommending Dr. A. D. Albright for the position of Provost of the University, I do so with a great deal of confidence. Dean Albright is not only recognized in this institution for his exceptional ability as an educational planner and coordinator, but he has also been looked upon with great respect by a number of other institutions and organizations over the nation. A native of Tennessee, Dr. Albright received his educational training at DePauw University, Milligan College, the University of Tennessee, and New York University. His undergraduate program was done as a Rector and honor scholar, the Master of Science on a university fellowship, and the Doctor of Philosophy as a Rockefeller Foundation fellow. He has served on the faculties of George Peabody College for Teachers, the University of Tennessee, the University of Utah, Yale University, and Teachers College of Connecticut. Dr. Albright has served as consultant for the Fund for the Advancement of Education of the Ford Foundation, the Carnegie Foundation, and the Southern Regional Education Board. He was a director of the recent study of higher education for the state of Tennessee and has also served as a consultant in studies of education for the Governor's Fact Finding Commission of Connecticut. Several publications bear his name either as an editor or author and he has served on an editorial advisory board for a national publishing organization.

During his work as Executive Dean of Extended Programs for the University he has done a superior piece of work with the various college faculties which actually are responsible for instruction in the off-campus programs. It is with real pride that I recommend Dr. A. D. Albright to you to serve as Provost of the University and Executive Dean of Extended Programs. This appointment will be effective July 1, 1960.

Upon motion duly made, seconded and carried, the recommendation of the President was concurred in, and Dr. A.D. Albright was appointed Provost of the University, effective July 1, 1960.

# N. Approval of Resolution Creating and Establishing a Consolidated Educational Buildings Project of the University of Kentucky.

Attorney C. W. Grafton, Louisville, Ky., was invited to appear before the Board to explain "A Resolution creating and establishing a Consolidated Educational Buildings Project of the University of Kentucky; creating and establishing an issue of Consolidated Educational Buildings Revenue Bonds of the Board of Trustees of the University of Kentucky; providing for the issuance from time to time of said bonds; providing for the payment of the principal of and interest on said bonds and repealing all resolutions or parts of resolutions in conflict with this Resolution."

The Resolution was examined and explained in detail and members of the Board being advised, upon motion duly made, seconded and carried, was approved in principle, and the document was authorized put into final form.

# O. Radio Arts Department Changed to the Department of Radio, Television and Films.

President Dickey submitted a request from the College of Arts and Sciences that the Department of Radio Arts be changed to the Department of Radio,

Television and Films. The President recommended that the request be approved.

Upon motion duly made, seconded and carried, the name of the Department of Radio Arts was changed to Department of Radio, Television and Films, effective July 1, 1960.

#### P. Research Center at Spindletop.

Lt. Gov. Wilson Wyatt was invited to appear before the Board and explain the Kentucky Research Institute to be established upon a portion of Spindletop Farm. It was stated that it was the plan to purchase about 450 acres of the Spindletop Farm, 75 acres to be purchased by the State for the Kentucky Research Institute, to be placed under the control of the Board of Trustees of the University of Kentucky, and 350 acres to be set aside to be purchased by industrial concerns desiring to establish industrial research centers of their own.

It was further explained that the State would make available approximately \$1,300,000 to establish facilities for the Kentucky Research Institute, which would become a part of the over-all project to be known as the Industrial Research Center. The State would provide operating funds for the Kentucky Research Institute until the Institute might become self-supporting. It was further explained that the whole question of zoning was before the City-County Zoning Commission and that it would be necessary to await the decision of that body.

The Lieutenant Governor, Wilson Wyatt, explained in some detail the idea of the industrial center and the desirability of it being located at Spindletop Farm under the control and supervision of the University of Kentucky Board of Trustees.

After much discussion, a motion was made, seponded and carried unanimously that the University Board of Trustees authorize the establishment of the University of Kentucky Research Institute on a portion of Spindletop Farm, location to be jointly agreed upon by University officials and the Kentucky Research Foundation officers, with the understanding that funds for capital construction of the Research Institute, and the purchase price of the 75 acres, more or less, to be acquired by the State, will be provided in addition to the approved budget items for the University and that operating budget for the Institute until such time as it is on a self-sustaining basis be provided from state funds in addition to the amount already appropriated to the University of Kentucky for the coming biennium. The Research Institute, as a part of the University, will be under the jurisdiction of the Board of Trustees.

#### Q. Resolution on Zoning Property.

Mr. Floyd Wright stated that he had some friends that owned farms in the Spindletop area and they were much disturbed about subdivisions being permitted in that section of the County. He asked that the Board do something to see that the zoning law gives these people in that area protection.

The question was discussed, it being the concensus that the area would be properly protected. Lt. Gov. Wyatt stated that he thought the people would be proud of the Industrial Institute and some of the same persons Mr. Wright spoke of were willing to serve on the Board of Spindletop Research Park. Mr. Smith moved that "the Board of Trustees, in approving the Research Foundation, would like to convey to the Zoning Commission and local officers assurance of our full cooperation and hope that the area surrounding Spindletop will be preserved through appropriate zoning as attractive as it now is".

The motion was seconded and carried and ordered put to record.

#### R. Gifts.

President Dickey reported that the American Cyanamid Company had given to the University their check for \$2,000.00 for use in the Experiment Station's project on the study of bloat in dairy animals. He expressed his appreciation of this gift and recommended that it be accepted.

Upon motion duly made, seconded and carried, the gift of the American Cyanamid Company was ordered accepted, and the President was requested to write a letter of appreciation to officials of the Company.

From: Square D Company, Detroit, Michigan--\$360.00.

President Dickey reported receipt of check for \$360.00 from the Square D Company, given in support of their scholarship in the College of Engineering for the school year 1960-61. He recommended that the gift be accepted.

Upon motion duly made, seconded and carried, the check for \$360.00 from the Square D Company was ordered accepted, and the President was requested to thank the Company.

From: Anonymous Donor--\$100.00.

President Dickey reported that a friend of the University, who did not want his name mentioned, had given to the University his check for \$100.00 to be used for the Debate teams. He recommended acceptance of the gift.

Upon motion duly made, seconded and carried, the gift was ordered accepted.

From: Allstate Foundation, Indianapolis, Indiana--\$1,500.00.

President Dickey reported that the Allstate Foundation had given to the University of Kentucky their check for \$1,500.00 in support of the University's program for preparing teachers to give instruction in Driver Education in Kentucky high schools. He recommended that the grant be accepted.

Upon motion duly made, seconded and carried, the Board concurred in the recommendation of the President, and he was requested to write a letter of appreciation to the Allstate Foundation. From: Commercial Solvents Corporation— Terre Haute, Indiana—\$2,500.00.

President Dickey reported that the Commercial Solvents Corporation had given to the University their check in the amount of \$2,500.00 for use of one of the projects of the College of Agriculture. He recommended acceptance of the gift.

Upon motion duly made, seconded and carried, the gift of the Commercial Solvents Corporation was ordered accepted and the President was requested to thank the donors.

From: Western Kentucky Gas Company, Owensboro, Kentucky--\$500.00.

President Dickey reported that the Western Kentucky Gas Company had paid to the Kentucky Research Foundation \$500.00 to be used to furnish two scholarships at the University's Northwest Center. He recommended that the gift be accepted.

Upon motion duly made, seconded and carried, the gift of \$500.00 was ordered accepted and the President was requested to thank officials of the Western Kentucky Gas Company.

From: General Electric Foundation, Ossining, N. Y. -- \$128.50.

President Dickey reported that the General Electric Foundation had given to the University \$128.50, to match gifts of the University's alumni reported to the Foundation between January 1 and March 31, 1960. He recommended acceptance of the grant.

Upon motion duly made, seconded and carried, the gift of the General Electric Foundation was ordered accepted, and the President was requested to write a letter of appreciation to officials of the Foundation.

From: Hess and Clark, Ashland, Ohio--\$6,000.00.

President Dickey presented check for \$6,000.00 from Hess and Clark, Ashland, Ohio, to be used in support of the project, Growth Stimulants for Swine. He recommended that the grant be accepted.

Upon motion duly made, seconded and carried, the Board concurred in the recommendation of the President, and requested him to acknowledge the gift.

From: Chas. Pfizer and Company, Inc., Terre Haute, Indiana--\$1,000.00.

President Dickey reported receipt of check for \$1,000.00 from Chas. Pfizer and Company, Inc., to be used as a grant-in-aid for research projects dealing with growth stimulants for beef cattle. He expressed his appreciation of the continuing interest of this Company in the University and recommended that the check be accepted.

Upon motion duly made, seconded and carried, the Board concurred in the recommendation and requested the President to thank the donors.

From: Estate of Mrs. Louise F. Murrill --- \$56,250.00.

President Dickey reported that the firm of Lovejoy and Cuneo, South Norwalk, Connecticut, had sent to the Kentucky Research Foundation check in the amount of \$56,250.00, representing a portion of a bequest of Mrs. Louise F. Murrill to the Foundation, and stated that this sum would be added to the \$15,000.00 previously received by the Foundation. He recommended that this bequest be accepted.

Upon motion duly made, seconded and carried, the Board authorized acceptance of the bequest of Mrs. Louise F. Murrill, and requested the President to write a letter of appreciation to members of Mrs. Murrill's family.

From: National Plant Food Institute, Washington, D.C.--\$2,000.00.

President Dickey presented check for \$2,000.00 from National Plant Food Institute, to be used in support of the project, "Fertilization of Grass-Legume Mixtures and Small Grains". He recommended that the grant be accepted.

Upon motion duly made, seconded and carried, the Board concurred in the recommendation of the President and requested him to thank the donors.

From: Kentucky Utilities Company, Lexington, Ky. --\$700.00.

President Dickey presented check for \$700.00 from Kentucky Utilities Company, which is a gift toward matching Federal funds for a project under the supervision of the Kentucky Geological Survey and operating the gaging stations on Dix River. He recommended that the grant be accepted.
