Wing Headquarters will complete the applications by assigning a CAP Cadet serial number and issuing a Cadet Identification card. One copy of the completed application will be placed on file at Wing Headquarters. The duplicate application and FBI fingerprint card will be forwarded to National Headquarters.

# KENTUCKY PAROLE BOARD CONDITIONS OF PAROLE

'INSTITUTION KSR

It is the order of the Parole Board that you shall comply with the following general and special conditions of parole. The general conditions are as follows: (a) You shall report to your Parole Officer immediately upon arrival at your destination, and submit in writing, once a month, a report on forms prescribed by the Division of Probation and Parole unless excused by the Parole Officer. (b) Permit your Parole Officer to visit your home and place of employment at any time.

(c) You shall not indulge in the use of intoxicants or narcotics. (d) You shall support all of your legal dependents when physically able. (e) Work regularly. When out of work make proper effort, with the aid of your Parole Officer to obtain other employment. (f) You shall not marry without first obtaining the permission of your Parole Officer. (g) You shall not associate with persons having a criminal record or visit places of bad reputation. (h) You shall not visit or correspond with inmates of state prisons without permission of your Parole Officer. (i) You shall not leave the state, your district, your residence or employment without written permission of your Parole Officer. (j) You shall not operate a motor vehicle or hunt without license or obtain such license without the permission of your Parole Officer. (k) You shall not be permitted to own or have in your possession any legal firearms at any time when on parole except with the written permission of your Parole Officer. (l) You will not be guilty of any violation of law, felony or misdemeanor. (m) You will comply with all rules and regulations prescribed by the Parole Board and special instructions of your Parole Officer.

Special conditions of your Parole ordered by the Parole Board are as follows:

A failure to comply with the above conditions at any time while you are on parole will be deemed sufficient cause to declare you a parole violator.

It is suggested that when released from active supervision you contact your Parole Officer relative to restoration to citizenship. Otherwise, you will always be on parole.

The Parole Board and the Division of Probation and Parole have faith in you and believe that you will be sincere in your efforts to live up to the above conditions and thus benefit yourself as well as your community.



A.A. is a rapidly growing group of people for whom alcohol has become a major problem and who, admitting this, have decided to do something about it. They are honestly attempting to build a satisfactory mode of life without alcohol in any form.

A.A. is a fellowship of men and women who share their experience, strength, and hope with each other that they may solve their common problem and help others to recover from alcoholism.

A.A. now numbers many thousands of members with groups in nearly all large cities and many small places. We are adding new members at the rate of 1,000 per month. We believe that at least two-thirds of us have laid a foundation for permanent sobriety. More than half have had no relapse at all, despite the fact that many had been considered hopeless by doctors, families, and friends.

Although it may sound selfish, we have found by experience with hundreds of cases that it is essential for the alcoholic to say to himself, "I am doing this for myself and myself alone." It has been proven time and again that the alcoholic who is staying sober for his wife, job, mother, or any other reason will not retain sobriety. He may remain sober for a few weeks or a few months, but as soon as the motivating force disappears so disappears sobriety; however, by staying sober for himself he will automatically benefit others.

Many alcoholics go on for a period of years blaming the drinking on their various troubles, either real or imaginary. We in A.A. have found by our own experience and experience with others that the elimination of these does not solve the alcoholic problem. In A.A. we reverse the procedure and blame all of our troubles on our drinking. Thus by eliminating the cause, our old troubles begin to disappear and as new ones arise we have a clear mind and the stability with which to meet and conquer them.

A.A. is not interested in sobering up drunks who are not sincere in their desire to remain completely sober for all time. It is not interested in alcoholics who want to sober up merely to go on another bender; or because they fear for their job, their wife, or to clear up some trouble either real or imaginary. In other words, if a person is genuinely sincere in his desire for continued sobriety for his own good, is convinced in

It is your life, it is your choice. If you are not completely convinced to your own satisfaction, that you are an alcoholic; if you are not ready to part with alcohol for good, it would be better for all concerned if you discontinue reading this and give up all ideas of becoming a member of A.A.

## Have you an honest desire to stop drinking?

If alcohol is a problem to you and if the questions on the opposite page have convinced you that you are an alcoholic, perhaps you will say, "Yes, but I can quit by myself any time." More power to you if you can—and do.

All of us who are now members of Alcoholics Anonymous said that once, or a million times. "I can take it, or leave it alone." So we took it. With the result that later we got into further trouble and eventually reached an extremity when we had to admit we could not stop without help.

We define an alcoholic as anyone whose drinking disrupts his (or her) business, family or social life, and who cannot stop, even though he may want to. We regard alcoholism as an illness; an obsession of the mind coupled with an "allergy" of the body. We think of ourselves as sick people who cannot touch alcohol any more than a diabetic can eat sugar.

Now that you have decided that you are definitly an alcoholic and are sincere in your desire to be rid of the alcoholic habit, you will have many visitors and meet many members of A.A. at the regular meetings.

Some you will like; some you will resent; some will strike you as being silly, fantastic, or perhaps slightly insane; some will seem fanatics; some will doubtless tell you a story that will be "right down your alley." But remember this—never for one moment forget it:

### EVERY SINGLE ONE OF THEM IS A FOR-MER DRUNK AND EVERY SINGLE ONE IS TRYING TO HELP YOU!

Your visitor has had the very problems that are facing you now. In comparison with some, your problems are trifles. You have one thing in common with every visitor -an alcoholic problem. Your caller may have been sober for a week or for half a decade. He still has an alcoholic problem, and if he for one moment forgets to follow any single rule for sober living, he may be in your place tomorrow. He is going out of his way, taking up his time, perhaps missing a pleasant evening at home or at the theater by calling on you. His motives are twofold: He is selfish in that by calling on you he is taking out a little more "sobriety insurance" for himself; and secondly he is

# What does A.A. cost?

A.A. has no dues or fees. We pay our small operating expenses out of voluntary contributions from our own group only. We accept no outside contributions. No one knows whether or not anyone else contributes or how much. It is a privilege to those of us who are working to make regular donations for the necessary expenses.

## Does A.A. have or recommend a cure?

In our opinion, there is no such thing as a cure. The A.A. program, rather, is a way of living which relieves our obsession to drink. Depending on your condition, we may suggest that you call in a doctor of your own choice to get you over the rough spot and relieve you of the immediate physical urge for alcohol.

# Will my request for information be treated confidentially?

Yes, we are anonymous. We have learned to respect and hold inviolate any information we receive from another person.

# If I have a relative or friend who needs A.A. will you contact him for me?

No, we will not, unless you have his explicit consent. It would be much better if you passed the information on to him and had the prospect call us himself.

## Do you believe in prohibition?

As a group, we have no opinion on this subject. We are not reformers, prohibitionists, religious fanatics or professional Do-Gooders. We will try to extend a helping hand when honestly requested for help by an alcoholic.

# May I bring my wife or husband to a meeting?

Yes, we have open meetings which wives or husbands of alcoholics may attend if they so desire. They may also be included in the social activities of the group. We do have closed meetings, however, which are to be attended by alcoholics only.

# What happens when a member starts drinking, or slips?

Nothing, except that he automatically ceases to be a member of A.A. for so long as he is drinking. When he sobers up he is wanted and welcomed back into the group.

The moment he drinks so much as a drop of beer, wine, spirits, or any other alcohol as a beverage, he automatically loses all status as a member of Alcoholics Anonymous.

# Do any members start drinking again after going into the group?

About fifty per cent never take another drink. Twenty-five per cent make the program after more or less trouble. Eventually seventy-five per cent will make it.

# A New Way of Life

Our recovery program is based upon twelve clearly defined steps. As a whole they appear to be a big order, but don't let it frighten you. There are none of us who would say that we have mastered them all. Remember, we are just reformed alcoholics, not saints. We are not striving for perfection, but for progress. One of our favorite expressions is "easy does it," so don't try to take it all in at once. Only take what you can handle at the moment. As you attend your meetings and meet many others in your same position you will grow rapidly in the program.

In order to make it as simple as possible for the beginner, the steps may be roughly boiled down to this: First we admit, without reservation, that we are alcoholics and that our lives have become unmanageable. If this is so, then we should believe that some power greater than ourselves is needed to aid in our recovery. Turning our problems over then to a higher power, we start to do our share by helping that power. To do this, we take a real, honest look at ourselves and then set about righting some of our past wrongs. Finally, after we ourselves have benefited from the program, we maintain our stability by passing it on to others.

## The Twelve Steps of Alcoholics Anonymous Suggested for a New Way of Life

- 1. We admitted we were powerless over alcohol—that our lives had become unmanageable.
- 2. Came to believe that a Power greater than ourselves could restore us to sanity.
- 3. Made a decision to turn our will and our lives over to the care of God as we understood Him.
- 4. Made a searching and fearless moral inventory of ourselves.
  - 5. Admitted to God, to ourselves, and to another human being the exact nature of our wrongs.
  - 6. Were entirely ready to have God remove all these defects of character.
  - 7. Humbly asked Him to remove our short-comings.
  - 8. Made a list of all persons we had harmed,

and became willing to make amends to them all.

- 9. Made direct amends to such people wherever possible, except when to do so would injure them or others.
  - 10. Continued to take personal inventory and when we were wrong promptly admitted it.
- 11. Sought through prayer and meditation to improve our conscious contact with God as we understood Him, praying only for knowledge of His will for us and for the power to carry that out.
- 12. Having had a spiritual awakening as the result of these steps, we tried to carry this message to alcoholics, and to practice these principles in all our affairs.

Rarely have we seen a person fail who has thoroughly followed these steps. Those who do not recover are people who cannot or will not completely give themselves to this single program. An alcoholic is absolutely unable to stop drinking on the basis of self knowledge, and this spiritual program is not theory. We have to live it; and only by intimate personal contact and discussion and regular attendance at meetings can a full understanding be attained.

Somewhere in Italy July 20.

Received your letter today and was sure glad to hear from you. It had been a little while, and I was looking for your letter when it came this evening. Hope this finds every one well and getting along O.K. I am fine myself, and still kicking. I have quite a lot of work to do, but I am going to take a little time off this evening to answer your letter.

About my being saved:— Well, the story behind that is rather long, but I will try to give you some of what happened. Of course I can't give any dates or locations, but I will do my best to make it as plain as possible.

It was early one morning that I made up my mind that I really should stop dilly-dallying around and get down to brass tacks. As you remember I was always the type to put it off, but I never realized what it could mean till I got a touch of it. As usuar we went to the shelter and then began to wait for them. Nearly every man that is in his right mind really prays before they are over, and then after it's all over gives the credit to luck. But this was a special one, and we didn't know. Well, after about thirty minutes of pounding and the walls shaking, I came to the conclusion that I had better change my ways and live like I was taught. But after that I wasn't quite convinced that I should. So the Lord It was early one morning that I made up quite convinced that I should. So the Lord decided to let me know once and for all that He wanted me. It wasn't long after


that I was sitting at an Opera, and Jerry hit us before we knew it. The bombs lit so close that I was knocked out of my seat quite a few times, and that was enough for me. I was baptized on the 21st of June, and I sent Mom some pictures of the service. The Chaplain had them taken. He is really a swell fellow and is really a comfort to the boys. Well, that is a brief summary of what happened. I couldn't begin to tell you all of the things that run through my mind while all that was going on; but I will tell you one thing and that is that I don't want to go through and that is that I don't want to go through it again ever. I know that he Lord is looking over me, and will take care of me, and bring me home safe. So you see, I have a lot to be thankful for. Jerry has did a lot of damage and killed a lot of people in this war. In fact he is still killing, but if they would only turn to the Lord they wouldn't have to suffer.

I am ashamed of myself for having to do what I did to be saved. It took a war and a little farther than that to make me realize that I should live right. I only hope that it won't take the same thing to bring other people to the fold, because it is a terrible experience, and I can guarantee that it's no picnic.

Yes, I received the card and was really Yes, I received the card and was really happy to know you remembered. I didn't know you knew when my birthday was but I see you do. Well, any way I received a nice sard from the folks, and also tonight I received a letter from Pop, which is really a treat. But to top the whole thing off, he sent me a picture which is something he never did in his life.

Well, that is the whole story. The Chaplain has given the story to the boys at Sunday services, and will help any of them with their troubles. He gives them a chance every Sunday to testify that they believe in the Lord Jesus Christ. But it seems that there are so few.


