Minutes of the Meeting of the Executive Committee of the University of Kentucky, February 9, 1962.

The Executive Committee of the University of Kentucky met in the President's Office on the campus of the University at 1:35 p.m. EST, with the following members present: Harper Gatton, Robert H. Hillenmeyer, Smith D. Broadbent: absent, Dr. Ralph J. Angelucci. President Frank G. Dickey and Secretary Frank D. Peterson met with the Committee.

A. Meeting Opened.

President Dickey explained that the regular meeting date would have been January 19 but, because of weather conditions, it was impossible to get a quorum and a meeting was properly called for February 9. He called attention to the fact that Dr. Angelucci was unavailable and that we needed a temporary chairman; whereupon, on motion duly made, seconded and carried, Mr. Harper Gatton was called to serve as Acting Chairman of the Executive Committee

Mr. Gatton assumed the chair, welcomed the press and asked Mr. Broadbent to open the meeting with prayer.

B. Approval of Minutes.

Upon motion duly made, seconded and carried, the minutes of the Executive Committee of November 17, 1961, were approved as published.

C. Financial Report.

Mr. Peterson submitted financial report for the six months period ended December 31, 1961. He explained that a copy of the report had been mailed to members of the Executive Committee in January; whereupon, Mr. Robert H. Hillenmeyer stated that he thought the members of the Committee were familiar with the report and moved that it be received and filed. The motion, being seconded, was carried unanimously.

D. Approval and Ratification of Purchases Made.

F. Agreement between the University of Kentucky and Shriners Hospital for Crippled Children.

Mr. Peterson submitted an Agreement between the University-Medical Center and the Shriners Hospital for Crippled Children. Mr. Peterson explained that the Shriners Hospital agrees to serve as a clinical laboratory for College of Nursing students. He further stated that the respective responsibilities of the College and the Hospital were spelled out and proper protection to each was provided. The original Agreement was for a period from February 1 to May 31, 1961, and was subject to extension. This Agreement is now extended to May 31, 1962.

Mr. Peterson recommended that the Agreement be approved. Upon motion duly made, seconded and carried, the Agreement was approved and the extension was authorized executed.

G. Agreement between the University of Kentucky and the Lexington-Fayette County Health Department.

Mr. Peterson presented Agreement between the University-Medical Center and the Lexington-Fayette County Health Department. It is agreed that the Lexington-Fayette County Health Department will serve as a clinical laboratory for College of Nursing students in such numbers as may be mutually agreed upon. The duties and responsibilities of the College relating to students and faculty and the Lexington-Fayette County Health Department are detailed and each organization is properly protected under the Agreement. Mr. Peterson recommended the contract be approved.

Upon motion duly made, seconded and carried, the Agreement was approved and authorized executed.

H. Contract between the University of Kentucky and Kentucky Utilities Company for Easement.

Mr. Peterson explained that the Kentucky Utilities Company was now providing the Cumberland Extension Center with power to service existing facilities. He stated that the Company desired to secure an easement across a portion of the campus of the Cumberland Extension Center and that he had investigated and had secured a plat showing the proposed line. The Agreement provides for a payment of \$200.00 with the stipulation that the Kentucky Utilities Company will remove the line at its own expense if asked to do so by the grantor of the lease.

Mr. Peterson further stated that he felt that the line would give the Extension Center additional service and, at the same time, protect the University's rights in case of expansion and recommended its approval.

Upon motion duly made, seconded and carried, the Easement was granted and authorized executed.

I. Agreement between the University of Kentucky and the Kentucky State Department of Health.

The Agreement between the University and the State Department of Health provides that the Medical Center give three one-day training courses for nursing home operators in uniform accounting procedures and cost analysis. The University is to be reimbursed the sum of \$1,800.00 for expenses incurred in providing the courses. He recommended approval, and upon motion duly made, seconded and carried, the Agreement was authorized issued and the courses given.

J. Contract between Gilbert E. Brown and the University.

Mr. Peterson submitted the contract for consultive services with Gilbert E. Brown. He stated that, during the calendar year 1962, Mr. Brown would be used in performing the following consultive services as required by the Dean of the College of Agriculture or his designated personnel:

- a. To find markets for dimension and short hardwood lumber of the kind produced in Eastern Kentucky, etc.
- b. To identify the areas of Eastern Kentucky where supplies of these lumber raw materials can be most economically assembled, etc.
 - c. To inventory the facilities and costs needed at the assembly point, etc.

- d. To investigate and determine the feasibility of developing, at the assembly point, a market place for veneer logs, etc.
- e. Such other consultive services as may be related to the Eastern Kentucky Resource Development project.

Mr. Peterson recommended that the contract be approved and authorized executed.

Upon motion duly made, seconded and carried, the Executive Committee concurred in the recommendation and the contract was authorized.

K. Contract between the University of Kentucky and Smith Kline & French Laboratories.

Mr. Peterson submitted contract between Smith Kline & French Laboratories and the University whereby the University agrees to perform certain research studies relating to the development of products for use in ruminants in the manner and to the extent set forth in the Research Project outlined and marked Appendix A.

Smith Kline & French Laboratories agree to make a grant of \$4,000.00 to defray the cost of the Research Project. A schedule of royalties is provided.

Mr. Peterson recommended that the Agreement be approved and executed. Upon motion duly made, seconded and carried, the Agreement was approved and authorized executed.

L. Agreement between the United States of America and the University of Kentucky Approved.

Mr. Peterson presented an Agreement between the United States of America and the University of Kentucky to establish a basis upon which certain services and facilities will be provided by the Institution in connection with the foreign assistance programs administered by the Agency for International Development. It also provides for reimbursement to the Institution. He further explained that this Agreement stipulates that the University shall accept participants from foreign countries for varying periods of time and give them certain information and training, for which the United States Government will pay on an agreed scale. He stated that this is a contract that increases the stipend here-tofore provided. He recommended its approval.

Upon motion duly made, seconded and carried, the contract was approved and authorized executed.

M. Assignment Approved.

Mr. Peterson submitted Assignment from Stanley E. Leland, Jr., of certain rights that may exist under Letters Patent and otherwise. Mr. Peterson recommended that the University accept the Assignment, and upon motion duly made, seconded and carried, same was approved and authorized accepted.

N. Assignment Approved.

Mr. Peterson submitted Assignment to the Kentucky Research Foundation of Letters Patent that the University holds from Stanley E. Leland, Jr., with the expressed understanding that it assigns only those rights that were granted to the University. Mr. Peterson recommended that the Assignment be approved.

On motion duly made, seconded and carried, the Assignment was approved and authorized executed.

O. Contract for Parking Facilities Approved.

Mr. Peterson submitted contract between Thompson-King-Tate, local contractor, to build a parking lot on the east side of Limestone Street near the entrance to the campus. He recommended its approval in the amount of \$26,834.00.

Upon motion duly made, seconded and carried, the contract was authorized approved.

P. Budget Adjustment.

Mr. Peterson recommended that budget adjustment be made to take care of the construction of the parking lot and other pending major improvements and suggested that the sum of \$45,000.00 be appropriated for these purposes.

Upon motion duly made, seconded and carried, the Treasurer was authorized to make the necessary budget adjustments and to take from the unappropriated surplus \$45,000.00 and transfer same to Account 2450, Major Improvements.

Q. Report on Motor Pool.

Mr. Peterson presented a brief report to the members of the Executive Committee concerning the operation of the University motor pool, for a period of operation of approximately one year. Mr. Peterson stated that the pool consists of 27 cars which have been in operation for a period of a few months to twelve months. He stated that complete information was available on each car as to its operation and that the summary indicated operating costs, including depreciation, of 5.29 cents per mile. He stated that the cars were receiving an average mileage of 16 miles per gallon of gasoline and that the average mileage per trip was 338 miles. He added that the University had considered for some time establishment of a motor pool and the information at hand justified the decision to establish the pool.

R. Injuries.

Mr. Peterson submitted the following report on injuries:

While working in the tool shed, Mercer Farm, Harrodsburg, Kentucky, a piece of steel from a bolt he was driving into a wagon frame became imbedded in his right eye. He reported to Drs. Meredith, Keightley and Moore the next morning for removal of the foreign body. The following bill has been received for medical treatment and is recommended for payment:

Mr. Peterson went over each item and explained to the satisfaction of the Executive Committee the injuries involved. He recommended that the charges be paid without admitting negligence or establishing a precedent.

Members of the Committee being advised, upon motion duly made, seconded and carried, authorized the claims of Lillie Mae Griffin, Estill Slone, Homer McIntosh, James Minton, Roscoe Byrd, Eugene Hughes, Caryl Marsh and George H. Byrd paid with the expressed understanding that the University does not admit negligence in each or any of these injuries, neither does it establish a precedent by paying each or any one of these claims.

S. Purchase of Property Approved.

Mr. Peterson read the following letter:

January 15, 1962

President Frank G. Dickey University of Kentucky

Dear President Dickey:

Since the last meeting of the Board of Trustees, two pieces of property located in the immediate vicinity of the campus have become available for sale. I would like to submit these to the Executive Committee at its meeting on Friday and recommend that these properties be authorized purchased at the prices indicated.

258 East Maxwell Street is divided into two tracts. The house and front portion of the let, which is 50 feet by 173 feet, is owned by the Carrie B. Piersall Estate. The heirs are asking \$13,000 for this property. The back portion of the lot, which measures 50 feet by 235 feet, is owned by Mrs. J. S. Horine. Mrs. Horine is asking \$5,750 for this lot. The purchase of these two properties would give us a house on a lot 50 feet by 408 feet for a purchase price of \$18,750. We would not want one lot without the other.

322 Clifton Avenue belongs to Eugene Pearce Atkins and Eugenia Atkins. This lot is 50 feet by 302 feet and contains a frame house with two apartments of two bedrooms each. The asking price is \$23,000.

Members of the Committee being familiar with the property expressed the views that the property should be acquired and the price was in line.

Upon motion duly made, seconded and carried, the property at 258 East Maxwell Street and 322 Clifton Avenue was authorized purchased and the Vice President, Business Administration, was directed to consummate the contracts.

T. Staggs and Fisher Consulting Engineers Employed.

Mr. Peterson stated that the Food Storage Center refrigeration area needed to be enlarged. Staggs and Fisher Consulting Engineers were used on the original construction and he suggested that they be employed on a cost plus basis to look into the question of enlarging the facilities and to make plans and specifications necessary for constructing another refrigeration area in the Food Storage Center building. He stated that the work would not exceed a cost of \$1,500.00.

Upon motion duly made, seconded and carried, Staggs and Fisher Consulting Engineers were employed to do the work recommended.

U. Salary Schedule for X-ray Technicians Approved.

Mr. Peterson submitted a proposed salary schedule for x-ray technicians in the University. He stated that the schedule had been worked out by the Division of Personnel with Hospital personnel collaborating. He stated that the salary range had been checked with existing hospitals in Lexington and compared with those in adjoining states. He stated that, in his opinion, the scale recommended was in keeping with prevailing rates in this area for work rendered and recommended the approval of the schedule. He stated that the salary range would be between \$3,384.00 and \$4,320.00 for x-ray technicians registered, and for supervising x-ray technicians the salary would range from \$4,224 to \$5,400, based upon training and experience.

Members of the Executive Committee being advised, upon motion duly made, seconded and carried, approved the schedule, effective at once, and authorized same administered by the Division of Personnel.

V. Graduate Faculty Members Approved.

President Dickey presented a recommendation from the Graduate Council to add to the Graduate Faculty the following teaching personnel:

Upon motion duly made, seconded and carried, the recommendation was concurred in and the personnel listed above were approved as members of the Graduate Faculty.

W. Dr. Stanley E. Leland, Jr., Approved to Do Outside Consultive Work.

President Dickey reported that he had approved a request from Dr. Stanley E. Leland, Jr., Professor of Animal Pathology, upon the recommendation of Dr. William A. Seay, to serve as consultant to the Agricultural Research Group of the Eli Lilly Company, Indianapolis, Indiana. He stated that the consulting time involved would not exceed twelve days per year and that the remuneration would approximate \$1,200.00 per annum. The consulting services will be furnished during Dr. Leland's vacation time and at such other times as they will not interfere with his regular duties at the University.

Upon motion duly made, seconded and carried, the report was received and ordered put to record.

X. Dr. Jesse G. Harris Approved for Outside Consultive Services.

President Dickey submitted request of Dr. Jesse G. Harris, Associate Professor of Psychology, to serve as consultant in a VA Training Program in Clinical Psychology. Dean M. M. White approved the request and stated that the work would not require more than one-half day per week at the Veterans Administration. President Dickey concurred in the recommendation, and upon motion duly made, seconded and carried, the request was approved and put to record.

Y. L. J. Chapman Approved to Do Outside Consultive Work.

President Dickey reported a request of Dr. L. J. Chapman, Associate Professor of Psychology, to serve as consultant for the National Institute of Mental Health Clinical Neuropharmacology Research Center. Dean White concurred in the request and stated it was quite an honor for a member of the Department to be asked to serve in this capacity. He stated that Dr. Chapman would make two or three visits per year to the Center and that his remuneration would be nominal. President Dickey approved the recommendation and upon motion duly made, seconded and carried, the recommendation was approved and ordered put to record.

Z. Dr. William R. Willard to Do Off-campus Consulting Work.

President Dickey submitted a request from Dr. William R. Willard to furnish consulting services for a Governor's Commission to study medical education in New York State. Dr. Willard stated that the time involved would be nominal and would not interfere with his regular duties, and that this was a type of work in which he was much interested.

President Dickey concurred in the request, and upon motion duly made, seconded and carried, Dr. Willard was authorized to serve on the Governor's Commission to study medical education in New York State.

A-1. Change-of-Work Status for Dave Brady Approved.

President Dickey recommended approval of a request for change-of-work status effective February 1, 1962, of Dave Brady, janitor for the Division of Maintenance and Operations. He stated that Mr. Brady had been employed continuously at the University since April 2, 1946. Mr. Brady requested that his change-of-work salary be reduced to \$1,200.00 per annum, that his work assignment would be that of cleaning the Agriculture Building and directed by the Superintendent, and that, because of health reasons, he be granted this change, effective February 1, 1962.

Upon motion duly made, seconded and carried, change-of-work status was granted to Dave Brady at the suggested salary, and the work assignment was approved.

B-1. Change-of-Work for Lucas Walters Approved.

President Dickey submitted a request for change-of-work status for Mr. Lucas Walters, University Policeman, effective March 1, 1961. He stated that Mr. Walters is 69 years of age and has been continuously employed at the University since October 19, 1943. Upon advice of physicians, Mr. Walters requested change-of-work status and asked that his annual salary be reduced to \$1,200.00 per annum. President Dickey recommended that the request be granted and that Mr. Walters be assigned police duties for special functions on the campus, to control traffic and parking as directed by the Superintendent.

Upon motion duly made, seconded and carried, change-of-work for Mr. Lucas Walters was approved, effective March 1, 1961.

C-1. Change-of-Work for Professor Adolph E. Bigge, Jr., Approved.

President Dickey presented a request of Professor Adolph E. Bigge, head of the Department of Modern Foreign Languages, for change-of-work status, effective September 1, 1962. He stated that Dr. Bigge has been continuously employed at the University since September 1, 1925, and is entitled to change-of-work salary of \$6,281.40. He recommended that the request be granted and that Dr. Bigge's change-of-work assignment be to complete the translation of two early 19th century German publications and to collaborate in studies on the writings of Gerhart Hauptmann, a leading literary figure in the 19th and 20th centuries.

Upon motion duly made, seconded and carried, change-of-status was granted, with assignment of duties and salary as recommended.

D-1. Change-of-Work Status for Professor George K. Brady, Department of English, Approved.

President Dickey stated that Professor Brady has been continuously employed at the University since September 1, 1925, and requests change-of-status, effective September 1, 1962. He stated that Dr. Brady is entitled to change-of-work salary of \$5,187.00. He recommended that change-of-status be approved for Dr. Brady, effective September 1, 1962, and that Dr. Brady's work assignment be to experiment with the teaching of the humanities by television.

Upon motion duly made, seconded and carried, the recommendation was concurred in, the salary fixed, the work assignment made, and the effective date given as of September 1, 1962.

E-1. Change-of-Work Status for Professor Parl L. Mellenbruch Approved.

President Dickey stated that Professor Parl L. Mellenbruch had been employed at the University since September, 1945, a period of 17 years, and that he had reached the age of retirement and was entitled to change-of-work pay of \$3,330.00. He recommended that change-of-work be given, effective August 31, 1962, with change of assignment as follows:

- 1. Development of scales for assessment and analysis of job attitudes;
- 2. Development of life-space test for investigation of distortions in thinking of mental patients.

3. Collection of notes toward book on psychological principles found in Old and New Testaments.

Upon motion duly made, seconded and carried, the recommendation was concurred in and the change-of-assignment with salary recommended was approved.

F-1. Candidates for Degrees.

President Dickey submitted a list of candidates for degrees in the various colleges of those students completing academic requirements for a degree on January 26, 1962. He asked the Committee to approve and authorize the degrees granted subject to approval of the University Faculty, since the Faculty would not meet until February 12, 1962.

I-1. Senior Citizens Report Received.

President Dickey submitted a report from the Chairman of the Committee on Aging which proposes a program of teaching and research that has

as its purpose the improvement of health and productivity of the senior citizens of the Commonwealth and the Nation. He stated that the program had been prepared by a committee composed of persons on change-of-work status, members of the teaching faculties and administrative officials. He complimented the report and recommended that it be received and referred to the Extended Programs Division for implementation.

Upon motion duly made, seconded and carried, the recommendation was concurred in and so referred.

J-1. Budget Adjustments.

President Dickey stated that the third land note issued by the Kentucky Research Foundation, Inc., would be due on February 24, 1962. He recommended a budget adjustment to advance to the Kentucky Research Foundation the sum of \$95,638.50 from the Plant Fund section of the University Restricted trust funds, with the understanding that a document would be executed by the Kentucky Research Foundation stipulating the conditions of the advancement of funds.

President Dickey stated that the Board of Trustees approved the construction of one additional floor to the Women's Residence Hall and Central Kitchen-Dining Unit now under construction. He stated that the additional floor had received approval from the State Department of Finance and the Federal Housing and Home Finance Agency and that it would cost certainly less now than at some other time. He recommended that \$165,000 from the auxiliary reserve Restricted Fund balance and General Fund reserve for auxiliary enterprises as temporary advance to be repaid per schedule approved by the agencies concerned.

Upon motion duly made, seconded and carried, the recommendations were concurred in and the budget adjustments were authorized made by the Treasurer.

K-1. J. Stephen Watkins' Appointment Approved.

President Dickey concurred in a recommendation of Dr. William R. Willard to appoint Mr. J. Stephen Watkins to the Board of the FUND for the Advancement of Education and Research in the University of Kentucky Medical Center. He stated that Mr. Watkins had agreed to accept the appointment and he concurred in the recommendation.

On motion duly made, seconded and carried, Mr. J. Stephen Watkins was appointed to the Board of the FUND for the Advancement of Education and Research to serve for whatever period is established by the Foundation.

L-1. Extension of Waller Avenue Discussed.

President Dickey told the Executive Committee that the University had for several years been importuned to grant an easement across the University farm for the purpose of extending Waller Avenue to Cooper Drive, and Woodland Avenue to interconnect with the extension of Waller Avenue and Cooper Drive. He stated that the University had indicated its willingness to grant the easement and that he was now recommending that the Executive Committee so authorize and express its willingness to dedicate this land for a public roadway. He recommended that the Executive Committee formally approve the granting of the land and that the administration so notify the State and the City of this action.

Upon motion duly made, seconded and carried, the necessary land for the extension of Waller Avenue to Cooper Drive and the extension of Woodland Avenue to Waller Avenue and Cooper Drive extension was approved and the necessary documents were ordered executed.
