# THROUGH KISSING?

Because of recent discoveries about saliva and disease, there are questions about AIDS and its possible transmission by saliva.

We do not have answers to all the questions. We do have the best available information, medical opinions, and observations from leading AIDS researchers.

#### Contact with infected saliva passes many diseases.

Here's what we know:

Many viral diseases are passed from one individual to another as a result of contact with "infected" saliva. The common cold, flu, cold sores, cytomegalovirus (CMV) and mononucleosis can all be transmitted by contact with the saliva of an infected individual.

On the other hand, some diseases do not have the ability to easily and casually infect individuals. Even though Hepatitis B virus is present in saliva, there is little evidence that people have contracted Hepatitis B from . kissing.

#### There are different ways of looking at the problem.

Basically, there are two kinds of research being conducted in the study of the transmission of AIDS through saliva.

In one area of research, epidemiologists study the habits, lifestyles, and sexual practices of persons with AIDS to try and determine how they contracted the disease.

In a separate but related area, virologists have searched for the specific AIDS virus and antibody. While epidemiologists try to determine how the disease is spread, virologists try to locate the possible places where the virus can exist and the physical routes (called vectors) the virus uses to spread from one

person to another.

According to Dr. Edward Brandt, former Assistant Secretary for Health, "Epidemiologic patterns of transmission consistent over the past three years lead us to believe that AIDS is transmitted only through blood, blood products, and semen. After more than three years and more than 6,000 cases in the U.S., we have not seen a case where saliva seems to be the plausible route of transmission."

Epidemiologists who have been studying this disease since the beginning of the epidemic generally agree that saliva is not likely to be an effective means of transmitting AIDS.

Although researchers agree that AIDS is probably not spread by kissing, they are not certain. In one study, researchers found the suspected AIDS virus (HTLV-3) and its antibody in the saliva of some people who had been exposed to AIDS. There is no hard evidence that the virus is or is not transmitted through saliva.

Dr. Jerome Groopman, AIDS researcher, says, "Saliva is very unlikely to be an important

means of transmission for this disease...but it is a potential vector (means of transmission)."

Because of the possible risk, "wet" kissing is defined as "Possibly Safe."

#### Make an informed decision.

If you are making decisions about safer sex and intimate kissing, remember: Epidemiologists say there is no evidence that saliva is an effective means of transmitting AIDS. However, the AIDS virus has been found in saliva; consequently, saliva could be a method of transmission. Also remember that, as with all "Possibly Safe" sex practices, risk increases with multiple partners.

Use your judgment. But do not use the uncertainty of the saliva issue as an excuse to engage in known Unsafe Sex practices.

Researchers don't have all the answers. but medical experts agree that safer sexual practices can help stop the spread of AIDS. There's some question about what's completely safe. There's no question about what's completely unsafe.







GEORGETOWN GIVES IN

Georgetown University, Washington DC, has finally reversed its long-lived policy of refusing to recognize Gay groups on campus. The Jesuit-run university's Board of Trustees voted on May 2 to okay the student government's right to grant recognition to "all non-academic student organizations, including ethnic, racial, and Gay student groups."

The DC Gay Activists Alliance had initiated a bill in city council requiring the mayor to withhold DC revenue bonds from the university unless it agreed to provide the Gay campus groups with all the priveliges that go with official university recognition: activity funds, office

space, telephone, etc.

The news of the Trustees' vote came to council in the form of a letter from Mayor Marion Barry. The same day the letter arrived, council passed a bill giving Georgetown \$70 million in low interest

revenue bonds for renovation and construction. --from an article by Lou Chibbaro, Jr. in

ABA REJECTS MEASURE ON GAY BIAS from Associated Press

WASHINGTON - The American Bar Association narrowly defeated a measure opposing discriminatory

treatment of homosexuals. By a 161-152 vote, the ABA's policy-making House of Delegates rejected a resolution that would have urged federal, state and local governments "to adopt legislation prohibiting discrimination in employment, housing and public accommodations on the basis of sexual orientation."

When adopted, such resolutions spark lobbying efforts by the organization representing 350,000 of the nation's 650,000 lawyers.

The vote followed a lengthy and often emotional

debate. "We should not succumb to that ugly urge to ridicule those who are different," Henry Miller of

White Plains, N.Y., told fellow delegates.

But Joe Stamper of Antlers, Okla., said,
"Lawyers should not be advocates of indecency."

Augustine Smythe of Charleston, S.C., said homosexuality "goes against American mores" and should not be endorsed by the ABA.

Other delegates, however, said passage of the resolution would not represent an endorsement of homosexuality. The resolution was amended before homosexuality. The resolution was amended before the ABA's weeklong convention began to add language that pointedly denied "approving or endorsing homosexual activity.'

#### MUTTERINGS OF A MINISTER

On June 30th (Gay Pride Sunday, Chicago) the voting members of the Second Unitarian Church of Chicago voted 110 "yes", 2 "no" to call me to be their permanent, full-time minister. The vote culminated a nine day candidating process during which I preached on two Sundays, and in between met with individuals and committees so they could question me, get to know me, and to decide whether or not I should be their minister.

I presented myself as a minister who is openly gay and self-affirming. (I am not a gay minister.) Second Unitarian in Chicago is in many ways the "typical" Unitarian Universalist church: they include a broad section of peoples in their congregation, people of diverse creeds, color, ages and sexual orientation. Ten percent of that church is lesbian or gay. Their calling me, near-unanimously, is a testimony to the openness and inclusiveness taught and practiced in Unitarian Universalism.

My sexual orientation has never been an issue here. I am leaving solely because I feel my personal development and spiritual growth require this change.

ACLU Executive Director Ira Glasser and ACLU President Norman Dorsen said that with the creation of the project the ACLU would be able to take a more aggressive and visible role in fighting for

equal rights for Gays and Lesbians.

The first priority of the ACLU Lesbian/Gay Rights Project will be the eradication of sodomy laws. Sodomy laws are used as the legal basis for police harassment of Gay men, and to justify differential treatment of Lesbians as well as Gay men in housing, employement, and domestic relations (e.g. child custody) cases. Even where sodomy laws are not vigorously enforced, their mere existence defines Gay relationships as a crime, perpetuating common myths and stereotypes about Gay

men and Lesbians, and inhibiting Gay people from living openly and freely.

ACLU, along with the Lambda Legal Defense and Education Fund, (LLDEF), has already filed a legal challenge to the Louisiana sodomy law, and ACLU is now exploring the possibility of bringing similar

challenges in Arkansas and Minnesota.

The ACLU Gay Rights Project will also target discrimination against Gays and Lesbians in housing and employement — with emphasis on education and the uninformed municipal services (police, firefighters, etc.). In addition, the project will pursue several cases in which local laws interfere with Gay people's First Amendment rights, including laws barring teachers from "advocating" laws barring homosexuality in the classroom.

The project will work closely with Lambda to assure there is no duplication of effort and to avoid diverting contributions from other gay rights groups. Litigation and strategies will be developed in consultation with an advisory board now being formed. The board will include leading gay rights activists such as Jay Kohorn, Roberta Actenberg, Leonard Graff, Tim Sweeney and Abby Rubenfeld, in addition to several members of the Rubenfeld, in addition ACLU Board of Directors.

The ACLU said it would require \$50,000 to begin and was now actively seeking project

contributions.

Doctors in Boston say an experimental anti-viral drug should be added to the growing list of medicines that appear effective in test-tube medicines that appear effective in studies against the AIDS virus.

Phosphonoformate, or PFA, appears to be capable of stopping the AIDS virus from spreading, but has

not yet been tested on humans.

When Francis Coppola (Apocalypse Now) and George Lucas (Star Wars) present a film directed by Paul Schrader (Taxi Driver) about Yukio Mishima, the homosexual, imperialistic Japanese writer who homosexual, imperialistic Japanese writer disemboweled himself in 1970 after trying restore Emperor Hirohito to political power, controversy is sure to break out. The breakout occured last month at the first Tokyo International Film Festival (TIFF) when the festival refused to show "Mishima." Earlier, the film's producers accused the festival of reneging on its commitment and circulated an open letter protesting TIFF's action that was signed by more than 70 big movie names, including Louis Malle and Woody Allen. Mishima's widow waded into the fray, charging that the moviemakers had violated their contractual agreement not to show Mishima's homosexuality or

his gory suicide. his gory suicide.

Meanwhile, the \$6 million film (with Ken Ogata as the adult Mishima) opened in Paris following its showing at the Cannes festival, where it won a special award for artistic contribution. Variety called it a "boldly conceived, intelligent and consistently absorbing study." So why did TIFF cause a tiff? "This film has got Coppola, it's got luras it's got fame and notoriety," says Lucas, it's got fame and notoriety," says co-producer Tom Luddy. "Why weren't they chasing us to get it?" Although Tokyo critics claim Schrader bit off more than he could chew directing a Japanese cast in a language he doesn't speak, Luddy accuses the festival of knuckling under to threats of violence from right-wing groups, some of which don't like their hero being appropriated by Americans. Mishima remains an embarassing figure in Japan. "So many Japanese hated Mishima," says the movie's production designer, Eiko Ishioka. "They had the same complexes inside themselves, and he laid bare for all to see what it meant to be Japanese." Americans will get to see "Mishima" this fall. But is may be a long time before it's shown in his own country.

#### CDC EXPECTS AIDS CASES TO DOUBLE

The number of people diagnosed as having AIDS should double to 20,000 in 1986, according to Dr. Harold Jaffe, chief epidemiology of the AIDS program at the Centers for Disease Control in Atlanta.

Jaffe also said that studies showed that more than 1 million people nationwide may be carring the HTLV-III virus, which is believed to cause AIDS. Researchers don't know how many of these carriers

will go on to develope AIDS.

Jaffe spoke at a conference on the disease, sponsored by the National Institute of Allergy and Infectious Diseases and more than 30 health groups in southern Florida.

Speakers throughout the conference stressed that AIDS is not a homosexual disease, noting that in Central Africa most AIDS cases have been in heterosexuals.


GAY MEN AND LESBIANS, 55 AND OLDER
Previous research in the gay/lesbian community
has indicated a preference for retirement housing

Sixteen years ago Walter Carlos, the acclaimed young composer of the revolutionary electronic young composer of the revolutionary electronic recording "Switched-On-Bach," was invited to perform on the famed Moog synthesizer with the Saint Louis Symphony. The occasion was important for the new musical and technical wizard who, by turning the 18th-century composer's notes into electronic tones, had transformed the sounds of classical music—and at that point had sold more copies of one album than any other classical musician in history. But in what should have been his most triumphant moment. Carlos. 30. was his most triumphant moment, Carlos, 30, was distraught. In his Saint Louis hotel room he began to cry hysterically and told his producer, Rachel Elkind, that he didn't want to go onstage. Walter Carlos had kept what he thought was a terrible secret from the world: He suffered from a psychological condition known as gender dysphoria. For nearly two years he had been receiving estrogen treatments to help him become a woman. En route to Saint Louis he had dressed in women's clothes, as

he had done habitually in the preceding months.

In his room Carlos, still feeling miserable, touched up his face, which the estrogen had softened. He pasted on sideburns, stuffed his long hair under a man's wig, ran an eyebrow pencil over his smooth chin to simulate 5 o'clock shadow and went on stage. The performance was acclaimed, but thereafter Walter Carlos refused to perform in

public again.

public again.

In the fall of 1972 Walter has a sex change operation but did not publicly reveal her new identity. Until 1979, when Wendy at last told her story in a Playboy interview, eight successive records came out under Walter's name. "Unlike Horowitz I was never there to take my bows," she says. "I was effectively a prisoner in a closet."

Now with the release of her 15th album, Digital Moonscapes (CBS Masterworks), the 45-year-old Carlos (whose credits include the scores for "A Clockwork Orange," "The Shining" and "Tron") can rise for an ovation long overdue. The nine-movement Moonscapes suite, inspired by the major moons of the solar system, is performed by what Carlos calls a "digitally synthesized orchestra." It is technically and musically her orchestra." It is technically and musically her most accomplished work. During the last three years she not only composed the score but electronically created more than 500 "voices" that replicate symphonic instruments. "Wendy has built up lyrical sounds nobody ever heard coming out of a digital synthesizer before," says Robert Moog, inventor of the synthesizer. "Nobody is in her league."
"Switched-On Bach" was the pioneer classical

crossover album," says R. Peter Munves, marketing director at CBS Masterworks.

At the time he was recording "Switched-On Bach" Carlos was getting counseling from Dr. Harry Benjamin, author of "The Transexual Phenomenon." "I was willing to see if I wouldn't be happier as a woman than being in the trap I was in," Carlos

says. Instead the 1972 operation only complicated Carlos' life. Stevie Wonder, George Harrison and Keith Emerson wanted to pay calls on Carlos. But friends convinced her that for the sake of her career, she must not reveal her change of identity. So all visitors were told by Rachel Elkind—Carlos' producer, collaborator and housemate—that Walter was away. "I would listen to them from upstairs," says Carlos. "I accepted the sentence, but it was higher to have life eneming up on the one hand and says Carlos. "I accepted the sentence, but it was bizarre to have life opening up on the one hand and to be locked away on the other." When Stanley Kubrick asked Walter to write the score for "A Clockwork Orange," Wendy would dress in men's clothing for their meetings. "I could tell he felt something was strange," she says. "But he didn't know what." She even appeared on The Dick Cavett Show disguised as a man. Finally, Eluding the limitation of the seven took up the esoteric hobby limelight, Carlos even took up the esoteric hobby of eclipse chasing. She treked to Siberia, Bali and Australia. By the end of the 70's--according to Annemarie Franklin, whom Carlos met in New York and who is now her loft-mate and business partner--she had acquired a reputation as a leading

After her "coming out" interview in 1979 Carlos hit her stride composing. "The public turned out to be amazingly tolerant or, if you wish, indifferent," she says. "There had never been any need of this shared to have taken place. It had

need of this charade to have taken place. It had proven a monstrous waste of years of my life."

As "Digital Moonscapes" suggests, Wendy Carlos may have finally found peace. In the Greenwich Village loft that is her studio and is nicknamed by friends "the Spaceship," Carlos is creating her next album, "Catalyst," on an even more complex synthesizer.


"What I'm doing now is very profound," she says.
"A lot of people who drop by get their socks knocked off. I've never done that to anybody before." She is even planning to resume performing regularly in public. "It will be fun, "she says, "to get out into the open again."
