There has been one bill pre-filed to make discrimination on the basis of sexual orientation or gender identity illegal throughout the state of Kentucky. We will need many of you to come to Frankfort to help us lobby for this bill.

Another bill is expected to be filled seeking to nullify any anti discrimination ordinances enacted by city or county governments which would probably nullify all local Fairness ordinance, including those in Lexington, Louisville, and Jefferson County. Needless to say, we will be lobbying against this bill.

COULD SOMEBODY PLEASE DEFINE DISCRIMINATION FOR ME?

As many of you have already heard, Central Baptist Hospital recently made the Herald-Leader for discriminating against little old gay candy stripers! "RSVP" stands for the "Retired and Senior Volunteer Program" which is run by the Community Action Council in Lexington. Area hospitals contract with the CAC to obtain retired volunteers to help with odd jobs that do not require medical training.

Central Baptist Hospital and the CAC have worked together without incident until this year, when it came time to renew their contract. The difference? In the spirit of the 1999 Fairness Ordinance, the CAC altered their non-discrimination policy for the RSVP to include sexual orientation.

Other "religious-affiliated" hospitals like Saint Joseph's signed the new contract with no complaint, but Central Baptist chose to scratch through "sexual orientation" in the contract before signing it. When challenged, they said that they do not discriminate against anyone. However, they did feel the need to

consult with their lawyers, who assured them that though they are bound by the Fairness Ordinance in hiring and public accommodation (Central Baptist receives a significant amount of money from state and Federal funds) the Ordinance does not cover volunteers.

Am I missing something here...? I don't think so. Sounds like the same old line to me: "We don't discriminate against anybody - but you people are not welcome here." The Community Action Council has chosen to stand by their non-discrimination policy, so Central Baptist stands to lose at least some of their volunteer force to the same old fear and predjudice

. Offended? Make your voice heard! Send your thoughts to Mr. William Sisson, Central Baptist Hospital, 1740 Nicholasville Rd, Lexington, KY 40503. While you're at it, if you can afford the postage, why not send him a copy of Webster's Dictionary. "Discrimination" is clearly defined within.



Homophobia, Transphobia, and Heterosexism Hurt Everyone

We all know there is prejudice against LGBT people in our society but we don't often pause to consider how these oppressions hurt everyone, not just members of our community. Looking at the broader effects of homophobia and talking about them with family and friends as well as with legislators, can help us change minds

First some definitions to distinguish the variety of oppressive attitudes we are facing. Homophobia is the negative beliefs, values, and behaviors learned, manifested and perpetuated in many (but not all) cultures including ours. It is directed toward those perceived to be lesbigay. Homophobia encompasses hatred, fear, and revulsion as well as milder forms of discomfort and is based on misinformation, myths, religious teachings, and stereotypes. I will use the term Homophobia in this article to include the following prejudices as well.

Transphobia is the culturally conditioned bias against individuals who by presentation (dress, hair, makeup, personality, etc.) or behavior, cross traditional gender expectations, or who's gender is ambiguous to the observer.

Heterosexism is the culturally learned biased belief that relationships between men and women are preferable, more natural, healthier and better for society than gay/lesbian relationships. Heterosexism comes in the form of ignorance, naivete, and insensitivity to our differences. Heterosexism includes the belief that lesbigaytrans individuals want to be as much like heterosexuals as we can be. Most of us value our differences.

We work to lessen the oppression of homophobia and heterosexism in our society because any form of oppression is wrong and because it is harmful to ourselves, our friends, and our community. It is helpful to consider how these oppressions are hurtful to the larger community. Here are a bakers dozen.

 Homophobia stigmatizes, silences, and targets people who are perceived or defined by others as gay, lesbian, or bisexual whether or not they self define as such. Homophobia is implicated in many hate crimes and suicides. It is the most common form of harassment in our public middle and high schools. The spiritual and emotional well being of those who are targeted as well as those who do the targeting is put at risk.

- Homophobia is a destructive force within some families, it separates us one from another. It damages family relationships, impose silences that restrict communication, and leaves young people isolated and afraid.
- 3 Homophobia, transphobia and sexism create ridged gender-based role expectations that inhibit creativity, personal choice, and spontaneous self expression. For example, it encumbers boys and men in healthy emotional development and expression.by teaching that expressions of empathy or grief are unmanly. It imposes artificial restrictions on aggressiveness in females and tenderness in males.
- 4. Homophobia inhibits the ability of some men to form close, intimate relationship with other men.
- Homophobic conditioning compromises the integrity of heterosexual people who are taught to ridicule, hate, lie about GLBT people, and act in other prejudicial ways.
- 6. Homophobia isolates and restricts social interaction and communication with a significant portion of our population. It hinders the appreciation of the talents and gifts brought to society by GLBT people.
- 7. Homophobia helps to limit the availability of accurate sexuality information to teens and adults. It is one cause of premature sexual activity as some young people have a need to prove that they are not gay.
- 8. Homophobia contributes to the difficulty male sexual abuse and rape victims have in seeking help and healing. Victimization that is not healed is more likely to be passed on to others.
- Homophobia inhibits a unified and effective governmental and societal response to AIDS.
- Homophobia diverts energy from other personal, spiritual, national and global issues that need our attention.
- 12. Homophobia inhibits appreciation of other forms of human diversity and makes individuals more susceptible to accepting other prejudicial attitudes and practicing discriminatory behavior.
- 13. Homophobia impedes our national progress towards achieving liberty and justice for all.

Believing Is Seeing By Reinette F. Jones

Three weeks before Christmas it arrived in Masterson Station Park from a dark cloud on a sunny day. It was an early weekday morning. that period of time when households are preparing for a day at work and school. Only one person saw the opaque colors leading from the clouds to the ground. A neighbor's child, four-year-old Emma Jesse, had come outside to look at what she described as a diamond in a rainbow; maybe it was Santa Claus coming to bring her... Her father told her that the rainbow diamond would have to wait, because it was time for Emma Jesse to get her hair combed and braided before she went to school.

The thing, that the child had seen, sautéed from the clouds and landed without a sound. Emma Jesse had called it a diamond; the object looked like two pyramids that had been glued together, base to base. One point was on top and one point on the bottom. The top

pyramid was coppercolored and the bottom one looked like gold. Then the colors shimmered and exchanged places, again and again.

There should have been a blinding reflection of sunlight from the object, but there was not. Instead, the sunlight dripped from its sides into the seam that held the two pyramids together. People who were out with their dogs, walked past it and people walked through it. It was as if they were blind to the obvious. The dogs

walked around it.

There is a history to the land. Legend has it that there was a village of people who lived on what are now the grounds of Masterson Station Park and the federal prison. The people of the village had told the first European settlers about the thing, a chunnnga, which comes from the clouds. They also told of the places revealed by the land waves. The places were answers to questions in life. The chunnga would take you there and bring you back. The settlers regarded it all as superstitious hocus-pocus. Around 1780 the people of the village packed their belongs and left the village, taking the history with them. The area was then used as farmland.

The grounds were surveyed in the early 1900s due a claim that phantom images sometimes appeared within the heatwaves of the land. The easy dip of the small decline that now leads to the subdivision was said to be dockland, an aerial tunnel where warm air and cool air deposit and dispatch throughout the entire year. It was concluded that depending on the tilt of the earth, one might think that they were seeing mountains and other visions because of the distortion created by the refraction of light within the tunnel.

One hundred years later, three weeks before Christmas, a chunnnga arrived from a dark cloud on a sunny day and settled on the dockland half a mile from the area used for parking during special events in the park. It could have been a mirage. But a mirage would not stick around for four days. Would it? Though, the park does ride upon the bald curve of the fourth millennium equator, which

intensifies the slant of the sun's rays during the winter axis.

And that should be enough to explain it all away. But, four-year-old Emma Jesse saw the rainbow and the diamond each morning. On the fourth morning she ran down to the fence that borders her backyard and she yelled to her friend Josiane, who was walking her Labrador, Miss Butter Bean. She asked Josiane if she could see the

big diamond in the park. Josiane told the child that she did not see the diamond, but if Emma Jesse could tell her what it looked like



and where it was, then she would be able to see it in her mind.

So, Josiane got to hear about the copper and gold diamond that had slid down the rainbow and landed in the park. According to Emma Jesse, it was right there in front of Josiane and she should walk inside of it and tell Santa Claus what Emma Jesse wanted for Christmas, because she was not allowed in the park without her parents and her daddy would be out in a minute, and he was going to tell her that it was time to get her hair braided before her mother took her to school. And sure enough, her father came to the door with the comb and brush in his hands.

Children have very vivid imaginations. Josiane and her partner had no children, though she wanted children. Each time the subject had come up, her partner had told Josiane that if they had children, then she wanted to be an equal parent and not the nebulous housemate who slept in the spare bedroom ...continued on page 14

when family and co-workers came to their house. They had been together for five years. Each time the question of children had come up, there had been a fight. Josiane did not see the connection between outing herself and having children. She had outed herself to her father before he passed away last year and that should be enough.

Single women have children all the time, and of late, Josiane had been thinking that maybe it would be better if she were on her own. She wanted two children and it was a want that lived in every fiber and spirit of her existence. Maybe she should go inside the diamond and tell Santa Claus what she wanted also. Where did Emma Jesse say that it had landed? Josiane was sure the child had pointed near the area where Miss Butter Bean was now raising her leg to water the grass. Her dog had never done that before.

Josiane walked toward the area and when she got to the spot that Miss Butter Bean had marked, she raised her right foot and found that she was standing in front of a sign that read Tsankawi Trail, Bandelier National Monument, Santa Fe. New Mexico. She had a backpack on her shoulders and it was filled with a guide map, bottles of water, snacks, a notebook, and pens and pencils. It did not bother Josiane that she might be having an out of mind experience, she had had a few of those when she had been a drug addict, but she was a little upset that Santa Claus might live in the mountains of New Mexico and not the North Pole. How was 1

she going to explain that

to Emma Jesse?

Josiane decided that since she was where she was, whether in person or in her mind, and she had the backpack, it was probably meant for her to walk the two-hour trail. Luckily, it had not snowed. With the guide map in hand, she started on the trail that would lead her to the tan and orange-crème colored cliffs once inhabited by ancestral Pueblo people. The sun was shining brightly and a constant cool, dry December breeze brushed the face of the mountain.

After about an hour, Josiane stopped to have another sip of water and a snack. She found what looked like a seat that had been wind blown and molded into the face of the cliff. For the most part, she had been walking with her head down; the Tsankawi is at a 6,600-

foot elevation and the cliffs stand a few more thousand feet in the air. The trail ledge is about three feet

wide and it narrows in some places. Josiane was not afraid of heights, but she did not want to misstep and find herself falling off into yet another world.

It had been a peaceful walk and she had done a lot of thinking and rationalizing about her life. When she sat down on the rock seat, it was the first time that she had noticed that she could see for miles across the land. She also noticed that she was not wearing her glasses, yet everything was so clear. To the west was the Jemez Mountains; to the east were the Sangre De Cristo (Blood of Christ) Mountains and the Espanola Vallley. It was a beautiful sight in the



mind of reality.

She had not run into Santa Claus during here walk, so Josiane took the paper and

pencil from the backpack and wrote a 'Dear Santa' letter, telling him what Emma Jesse and she wanted for Christmas. She was going to stuff the paper into a crevice of the mountain, but the guide map had specifically mentioned, "Leave No Litter." Josiane put the notebook and the pencil, the water and the snacks back into the backpack. If and when she got back home, she would mail the letter to Santa. She continued on the trail, which ended on flat sandy land near a stream.

The water looked inviting and Josiane wanted to get her feet wet. She placed one foot in the water and she was back with Miss Butter Bean in Masterson Station Park, in the same spot she had left from. The backpack and all of its contents were gone. Her dog, Miss Butter Bean, placed her front paws on Josiane's chest, then liked her face. She was glad to see Josiane was back. Josiane took a minute to absorb the resolve that she felt to be so right within herself.

Emma Jesse was standing near the fence in her back yard. She had two fresh braids, one on each side of her head. Her mother had added a red barrette to the end of each braid. Emma Jesse was frantically waving her hand for Josiane to hurry over to the fence; she had to ask her something.

Emma Jesse wanted to know what Josiane had seen inside the diamond. ...continued on page 1.5

She wanted to know why Josiane had walked inside the diamond then came right back out. Did Santa kick her out because she had been a bad girl? She wanted to know how Josiane had sent the diamond back up the rainbow into the dark cloud. She wanted to know if Josiane had had enough time to tell Santa what she wanted for Christmas, before he kicked her out. And could Josiane hurry and tell her because her mother was waiting for her in the car.

Josiane told her that she had told Santa what they both wanted for Christmas. And before she could say another word, Emma Jesse started shouting, "Yeah! Yeah!" She thanked Josiane and took off running toward her mother. Miss Butter Bean and Josiane, wearing one wet shoe, headed for home.



GLSO Needs You


