#### PREFACE

The Historical Records Survey program operated as a series of state-wide projects in the several states under the Research and Records Section, Division of Community Service Programs, Work Projects Administration.

This program was organized in Florida in 1936 under the national direction of Dr. Luther H. Evans. On March 1, 1940, Dr. Evans left to become Director of the Legislative Reference Section of the Library of Congress, and was succeeded by Sargent B. Child. The Survey is engaged in the preparation of inventories of, and bibliographical guides to, source material hitherto inaccessible to research workers. The Survey program in Florida, as throughout the nation, includes an inventory of state, county, municipal and church archives, of American imprints, and of manuscript depositories and collections.

A List of Municipal Corporations in Florida was prepared as a preliminary to the inventory of municipal archives in Florida. It was compiled from published acts of the Legislature of Florida, county records, municipal records, and records in the office of the Secretary of State. An effort was made to list for every municipal corporation that has ever functioned in Florida an exact reference to all records of incorporation, reincorporation, charter amendment, and abolishment. This effort was not entirely successful, however, as some of the references given indicate prior records that were not located, and records of abolishment were not always found for municipal corporations that are no longer functioning. The first list of municipal corporations in Florida was published June 20, 1939. Because of the many requests for this published information the project continued research on municipal corporations and issued a revised list in September, 1939, and is now issuing a second revised list. Every effort has been made to obtain complete information for this publication.

Further search of municipal, county, and state archives was made under the direction of field supervisors, Helen S. Wells, May L. Touchton, and Eric R. Klar. Search of the session laws of Florida from 1822 to 1937, for the compilation of this second revised list, was made by Walter N. McEachern. The research in public records and in the session laws, and the arrangement of the list, was made under the editorial supervision of the public records editor, Dorothy Dodd.

This list, like other publications of the Survey, is issued for distribution to a selected group of public and institutional libraries. Contract arrangements have been made by the sponsor, The State Library Board, for purchase of this particular publication by interested persons. #### INTRODUCTION

Incorporation of towns and cities in Florida by special legislation from 1822 to 1845 was predicated upon authority given the Legislative Council of the Territory, by an act of Congress of March 30, 1822, to enact laws upon "all rightful subjects of legislation."(1) From 1845 to 1861 the basic law provided for the incorporation of towns and cities by special act.(2) The Constitutions of 1861, 1865, and 1868 specifically prohibited the incorporation of towns and cities by special act of the Legislature. (3) In 1885 the Constitution gave specific power to the Legislature to create and abolish municipal corporations by special act. (4) An amendment to the Constitution, ratified in 1934, (5) if operative, would take away this power from the Legislature, but the Florida Supreme Court has ruled that the provision is not operative until supporting legislation is enacted, which has not been done. (6)

The Legislature in 1846 prescribed a method of incorporating towns and cities by the people of the particular locality wishing so to create a municipality. This law required a record of the proceedings whereby the community became incorporated to be filed with the clerk of the county commissioners' court. The same record was required of proceedings to dissolve a municipal corporation. (7) These requirements as to recording remained in force until 1868, when the clerk of the circuit court in the county in which the community incorporating itself was located was designated as the officer to receive and record the proceedings to incorporate or abolish. This has remained, and now is, the law.(8) Since 1881 records of abolishment of municipal corporations have also been required to be filed in the office of the Secretary of State. (9) Since 1915 all proceedings to incorporate, or to amend the charters of, cities and towns have been required to be recorded among the ordinances of the city or town and in the office of the Secretary

of State, as well as with the clerk of the circuit court.(10)

An 1887 act declared to be legally incorporated all cities and towns which then were, and for the preceding 10 years had been, exercising municipal government, but the legality of whose corporate existence had been brought in question because, among other reasons, of loss of, or failure to preserve, a record of the proceedings under which they organized.(11) The laxity in recording prior to 1887 implied by this act probably accounts for many instances where a validation act is the first record found of the incorporation of a town.

Two lists are given for the convenience of the user. In the first, towns are listed alphabetically, with citations to records of incorporation, charter amendment, and abolishment arranged chronologically thereunder. In the second, counties are listed alphabetically, with all towns in each county arranged alphabetically thereunder.

Towns which are known to be no longer functioning as municipal corporations, but for which no records of abolishment were found, are marked with an asterisk in the alphabetical list. The name of the county in which the town is now situated is given in parentheses immediately after the name of the town.

In the records citations, the date of incorporation is given for all incorporations effected under general law. The date of approval by the Governor is given for all incorporations effected by legislative enactment, except in a few cases where the act became a law without the approval of the Governor. In the latter cases, the year date is followed by the symbol (L). Acts subject to a referendum are designated (R).

Where archival records are cited, the location of the record is indicated in parentheses following the record title. If it is a county record, the name of the county is given, if a municipal record, the name of the town is given. All county records cited are in the offices of the several clerks of the circuit courts, municipal records in the offices of the city clerks. The location of records found in the office of the Secretary of State at Tallahassee is indicated by the words "Secretary of State."
