

GAY BASHING BILL SIGNED IN CALIFORNIA

California Governor George Deukmejian has signed a bill which will enable gay and lesbian victims of anti-gay violence to sue their attackers, and harassers who threaten them with violence, for a \$10,000 penalty plus any damages.

\$10,000 penalty plus any damages.

"I have signed this bill because I don't believe anyone should be singled out for violent attack for any reason," the governor wrote in a letter distributed to assembly members on September 26, the day he signed the bill.

The new law takes effect on New Year's Day.
Earlier, Deukmejian had vetoed a gay civil rights bill, claiming that there was no evidence that anti-gay job discrimination existed.

SPERM RESEARCH YIELDS CLUES TO AIDS

Five years before the first American was stricken with AIDS, researchers at the University of Cincinnati Medical Center began a study of sperm that is now yielding intriguing clues about the mysterious disease.

The work began in 1976 in the lab of Dr. Evelyn Hess, the director of the division of immunology and a national authority in the field. Hess was interested in exploring the consequences a vasectomy has on the male immune system.

After this operation, in which a physician severs the sperm-carrying duct in the scrotum, many men begin to absorb components of sperm into their own bloodstream. Not only that, but a significant percentage also develop antibodies to the fluid.

Hess watched this unusual occurrence and demonstrated in a test tube that seminal plasma-one of the main ingredients in sperm-could interfere with the intricate defense system the body mounts against disease.

Normally sperm doesn't find its way into the blood of men or women. A female's reproductive organs apparently have protective mechanisms of their own, Hess said, which make it almost impossible for them to absorb sperm into the blood.

But a vasectomy provides a unique circumstance for men. With the duct cut, some of the fluid can not get out. The body soaks it up instead. These findings assumed a fresh significance when

These findings assumed a fresh significance when AIDS began to spread through gay communities on the East and West coasts a few years ago. Although the devastating syndrome has also been contracted by Haitians, hemophiliacs, the recipients of blood transfusions, intravenous drug users and their hetersexual mates, male homosexuals have still been the hardest hit. More than 70% of AIDS patients are gay.

As the blood of these victims was scrutinized, data began to accumulate from around the country showing that many gay patients were carrying sperm antibodies in their blood. Hess explained that the sperm probably seeps through the walls of the rectum after repeated episodes of anal intercourse

and then undergoes chages in the blood.

Man must curb attraction to boys

Dear Ann: I am a male in my mid-20s who is sexually attracted to 10- to 14-year-old boys. I have always been able to control my desires and have never had sex with a boy, but it is becoming harder and harder to resist my urges. I don't think it would be morally wrong because I would never use force or threats, but I do fear the possible legal consequences.

I would prefer to have normal sexual desires, but I don't believe I can change my sexual orientation any more than a heterosexual can change into a homosexual. Castration seems to be the only sure way to put an end to my attraction for young boys, and I certainly don't want that. I should tell you that I have an excellent position and am well-respected in my community and that no one would suspect my problem in a million years.

It appears that my only hope is to continue to fight these desires, but I don't think I can win indefinitely.

Do you have any realistic suggestions, Ann? I am convinced that counseling would be useless. — No Name in Lubbock, Texas

Dear Lubbock: Counseling will not rid you of your sexual preference, but it will make you aware of the psychological damage you might inflict on some youth should you succeed in seducing him.





A good therapist will help you understand what wreckage you might make of your life if you should succumb to your anti-social desires and be apprehended. You must, for your sake, as well as for the sake of potential victims, get some help in directing your sexual energy toward other activities.

Dear Ann: I am begging you to print a letter that might mean life or death for some teen-agers.

A month ago I went to a party. Most of the kids there were chums from school. One of the fellows (a good friend of mine) was loaded when we arrived. He kept drinking until he passed out.

When it was time to leave, "Larry" was still lying on the couch, out like a light. We poured cold water on him, slapped his face and tried to stand him up. Nothing worked. Finally I got smart and insisted that we take him to the hospital emergency room.



I stood beside Larry while the doctors worked like crazy to bring him around. I was scared to death he might not make it. It never occurred to me that getting drunk might be fatal.

Thank the good Lord that after two hours Larry regained consciousness. The doctor told us if we hadn't taken him to the hospital he might have died.

Methodists affirm ruling on homosexuals

Avowed, practicing homosexuals will not be ordained as United Methodist ministers, according to a ruling last week by the Judicial Council, the church's "supreme court."

The nine-member council unanimously upheld legislation passed at the 1984 General Conference banning the ordination and appointment of practicing homosexual clergy.

In its decision, the council reaffirmed the General Conference's power to set standards and the annual conference's right to decide whether clergy candidates meet those requirements. (The General Conference is United Methodism's "Congress," while the annual conference is similar to a state legislative body.)

"I hope this (the decision) puts a lot of things at rest," the Rev. Albert Sweazy said. Sweazy, treasurer and director of fiscal affairs for the Kentucky Annual Conference, made his debut on the Judicial Council at its semiannual meeting in Chicago.

"This issue is over, at least for four years," Sweazy said. "There can

be no appeal. This is the law of the church until 1988. But that's not to say the issue won't come back again."

The Rev. David Seamands, who led the fight at the General Conference for precise language on the issue, said the decision "preserved the connectionalism of United Methodism and preserved the church."

Seamands, who retired as a pastor in June and is now a professor at Asbury Theological Seminary, said the issue involved more than the ordination and appointment of homosexual clergy.

"The constitutional issue was similar to states' rights versus federal rights," he said. "All they did was reiterate every prior decision of the Judicial Council." He cited past examples as women's ordination and racial issues in which the council backed up General Conference decisions.

The Rev. Jim Heidinger, the editor of Good News magazine based in Wilmore, said he hoped all segments of the 9.4-million member denomination would abide by the decision. "We feel encouraged by the ruling and agree with it," he said.

Good News, an unofficial caucus that serves as a forum for scriptural Christianity within the United Methodist Church, filed a brief supporting the General Conference's legislation.

Good News contended that the General Conference, which meets every four years, has the right to set qualifications for ministers. The annual conferences, in turn, must follow those qualifications in accepting, ordaining and appointing ministers.

"The General Conference (in Baltimore last May) had decided the issue and enacted legislation," Sweazy said. "Our job was to look at the constitution. The General Conference has the power and authority to define and fix the powers and duties of an annual conference."

Sweazy was impressed with his first experience on the council.


"I found the members very genuine and concerned about the life of the church and its image," he said. "They don't take their roles lightly. If we have a question, we won't deal with an issue until we get the answer.

"Nothing we did was slipshod or haphazard, but it was done prayerfully. It gave me a feeling of confidence about the church and what it stands for." --The Herald-Leader




PHONELINE VOLUNTEERS CAN MAKE A DIFFERENCE

Hess hypothesizes that seminal plasma weakens the immune system, making it more vulnerable to assualt from the HTLV-3 virus that has been closely

linked with AIDS.

A year ago UC's researchers and a collaborating team from New York University were awarded a \$25,000 grant from the National Cancer Institute to continue their studies. Other AIDS research being conducted at UC focuses on the abnormal T-cells and B-cells in the immune systems of AIDS patients. Biochemists have also gotten involved by testing procedures to diagnose AIDS earlier.

Hess is among a growing group of scientiest who believe that AIDS is a "multi-factorial" phenomenon. She doubts that any pathogen would have the power to single-handedly dismantle the immune system and leave its host unguarded against

any number of infections.

"None of us know of a single virus that could do this," she said. "There are many viral diseases, but not one that can completely wipe out the immune system. It may be true that there is one, but I am

a little skeptical."

Hess builds her case not only on the basis of sperm antibodies and the assaults they make on the immune system, but also on evidence that has just surfaced about the HTLV-3 virus, which was isolated

and implicated last spring.

A study of a large number of healthy homosexuals in San Francisco revealed that 65% had been exposed to the virus. The determination was made by searching for HTLV-3 antibodies, which Hess calls the telltale "footprints." These same prints have been found in perfectly healthy Japanese, Europeans and Africans, she said.

On the other hand, when the test for HTLV-3 antibodies was given to a group of AIDS patients,

fewer than 50% scored positive.

"I think what this means is there must be other mechanisms that come along to further weaken the immune system," Hess said. "That's not to say the virus is not extremely important. All I'm saying is we haven't seen the data that says it's this virus and this virus alone that causes AIDS."

The discoveries that Hess and other scientiest have made about seminal plasma an the body's ability to transmit the HTLV-3 virus through blood, blood products and sperm have prompted widespread warnings to gays about the dangers of absorbing semen through the rectum.

In Cincinnati, the health department's Sexually Transmitted Disease Clinic has distributed pamphlets outlining "safe sex" techniques, which depend on using a condom and on protecting against Therapists are body fluids. exposure to discouraging casual sex with multiple partners and are encouraging monogamous relationships.

Safe sex is the alternative, siad clinic director Michael Ritchey. "You can have sex and not exchange body fluids. There is no other alternative except to repress desire."

HIGH COURT TO HEAR OKLAHOMA CASE

For the first time in almost two decades, the U.S. Supreme Court has announced it will decide a gay rights case.

The court has decided to review an appeals court ruling that prohibits Oklahoma public schools from firing teachers for advocating gay or lesbian

conduct.

The justices said they will hear arguments on an appeal by the Oklahoma City Board of Education. At issue is the constitutionality of a state law that allows the firing of teachers for "advocating, soliciting, imposing, encouraging or promoting public or private homosexual activity."


The challenge to the law was originally brought by the National Gay Task Force (NGTF). The lower court, in making its ruling, stated that the law was invalid on its face because it could be invoked if a poteacher merely appeared before the Oklahoma Legislature or on television to urge repeal of the state's antisodomy statutes or in support of other gay rights causes. The Board of Education, on the other hand, argued that while public school teachers have free speech rights, "these rights are not absolute and may be subject to certain restrictions.

Virginia Apuzzo of NGTF would not speculate on how the Supreme Court may rule in the Oklahoma case, and other leaders were cautious about the final outcome.



Spiced Apple Cider

Pour a half-gallon of sweet cider into a large pot. Add one half pound of brown sugar, one half teaspoon of whole cloves, one and a half cinnamon sticks, one and a half teaspoons of ground allspice, one fourth teaspoon salt and a pinch of cayenne pepper. Mix it all up, bring to a boil and simmer for fifteen minutes. Serve hot in mugs. This makes 12 ample servings.

Russian Tea

Mix together. Use approximately 2 teaspoons (more or less to taste) per cup of hot water.
