To the Faculty of the A. & M. College of Kentucky,

Gentlemen:-

The undersigned Alumni and Undergraduates of the A. & M. College of Kentucky, respectfully represent:

First, That they frankly acknowledge the error which was committed in allowing Messers Swope and Bruce Campbell to be initiated as charter members when the chapter of Phi Delta Theta was installed on the night of the 25th. inst., in as much as, the sanction of the faculty had not been obtained for their incorporation; and while acknowledging the error committed, express deep regret therefore.

Second, That they acknowledge the justice of the action of the faculty taken by the faculty upon the 27th. inst., and accept it as a rebuke for the error committed and acknowledged in the foregoing paragraph.

Third, They desire to renew the application which they made to your honorable body on the 23rd. inst., for permission to establish a chapter of the Phi Delta Theta Fraternity, pledging themselves to abide by the conditions set forth by the Faculty.

Fourth, That Messers Armstead Swope and Bruce Campbell have voluntarily withdrawn and will no longer participate in the meetings and proceedings of the chapter unless and until the Faculty pass upon and sanction their application to become members.

Fifth, They will esteem it a special favor to secure the permission of the faculty to reorganize the chapter of Phi Delta Theta and will be ever grateful therefor.
