## MINUTES OF THE UNIVERSITY SENATE Feb. 19, 1934

The University Senate met in the Lecture Room of McVey Hall Monday, February 19, with President McVey presiding.

The minutes of January 8 and January 24 were approved as read.

Minutes of the University Senate - March 12, 1934

"The activities of the Music Committee since the last report was made to the Senate on March 14, 1932, have continued along the same general lines.

As stated in the pregious report, the extra-curricula musical activities are financed in the main by 50¢ a semester of the incidental fee paid by each full time student. The SuKy circle assists to the extent of about fifty per cent in financing the trips of the Band to out of town foot-ball games. Other organizations and individuals have contributed small amounts for specific purposes such as Sunday Afternoon Musicales and trips of the Glee Club and Orchestra.

Minutes of the University Senate - March 12, 1934

The Committee on duplication of work presented the following requests for new courses:

Mathematics 220 a-d. Seminar in Mathematics. Two credits per semester. Education 218. Problems in Pre-school and Nursery School Education. Two credits.

Professor Holmes gave arreport of the meeting of the American Association of Trachers of Spanish, held in Cleveland, Ohio, December 27-28, 1933.

The special committee appointed by the Senate to prepare resolutions on the death of Professor Reid P. Meacham, presented the following report:

"The Senate desires to express its deep sorrow and its great sense of loss since Professor Reid P. Meacham met death by accident on February 13. He was a man who had won the friendshop of his colleagues and their respect and admiration for his attainments as a teacher and a scientist. His life of usefulness had not spanned a great period of years, yet he had lived and worked among us with genuine fruitfulness as a man of character, as a beloved teacher, and as a research worker in geology.

Reid Meacham joined our faculty in 1928. He had graduated from Vanderbilt University with the bachelor's and the master's degrees and had practically completed requirements for the doctor's degree at Johns Hopkins. He was a member of Sigma Xi and other scientific and educational societies. In addition to the faithful performance of his teaching duties, he had found interest and time to complete certain researches in Kentucky geology that are of real importance not only to the pure scientist but also to the practical gas and oil producer.

To his bereaved wife and mother the Senate extends its heartfelt sympathy. We grieve with them and we will long hold in memory our colleague's life and work.
