

A. and M. College of Kentucky.
March 28, 1901

The faculty met in adjourned session in the Presidents room at 4 pm.

Present: President Patterson; Prof White, W.K. Patterson, Mackenzie, Werneck, Miller, Pease, Pryor, Carpenter, Brooks, Kastle, Anderson,

Prof. White made a few remarks after which he was excused on account of illness.

The roll was then called on the following question:

Does the evidence before the faculty show that Cadet Reho was guilty of giving or receiving aid during the examination in Calculus.

Aye - Kastle, Miller, Pease, Werneck, Mackenzie, Carpenter - 6

No - Pryor, Anderson, Brooks, - 3.

Prof W.K. Patterson was excused from voting,
since he was not acquainted with the accused.

Prof Kastle stated that he was not present on the 27th, but that he had heard the evidence before the Engineering Faculty, and that he believed the accused to be guilty.

The roll was then called on the question above with respect to Cadet Siskert,

Result follows:

Aye - Kastle, Miller, Pease, Werneck, Mackenzie, Carpenter, - 6

No - Pryor, Anderson, Brooks, - 3

The roll was then called on the above question with respect to Cadet Shephard.

Result follows

Aye - Kastle, Pease, Werneck, Mackenzie, Carpenter - 5

No - Pryor, Anderson, Miller, Brooks, - 4

It was moved that Cadet Rehne be dismissed
The vote was as follows,

Aye - W.K. Patterson, Kastle, Miller, Peuce,
Wernicke, Mackenzie, Carpenter, - 7
No - Pryor, Anderson, Brooks, - 3

Prof. Patterson explained his vote by saying that since
these cadets had been found guilty by the faculty
he would vote for this dismission.

It was moved that Cadet Leibert be dismissed.
The vote was as follows:

Aye - Patterson, Kastle, Miller, Peuce, Wernicke Mackenzie
Carpenter, 7
No - Pryor, Anderson, Brooks.

It was moved that Cadet Shephard be dismissed
The vote was as follows;

Aye - W.K. Patterson, Miller, Peuce, Wernicke
Mackenzie 5
No - Kastle, Pryor, Anderson, Brooks.

Prof. Kastle explained by saying that he ^{regards} _{as being} thought the guilt of Cadet
Shephard different in kind and degree from that of the others,

Prof. Miller explained by saying that after the cadets are adjudged
guilty there is nothing left but dismission

Note - On the 2nd of April, President Patterson submitted the following

That Messrs. Shephard, Kehoe, and Seibert be suspended from all college duties and privileges from date until the 22nd day of May of the present Collegiate year, with the privilege of re-examination in Calculus after that date and with the privilege of examination in the subjects allotted to this present term, their general standing in the latter subjects to be determined by the marks which they make upon examination in same.
