Minutes of the Meeting of the Board of Trustees, University of Kentucky, Tuesday, February 16, 1971

The Board of Trustees of the University of Kentucky met in regular session at 2:00 p.m. (Eastern Standard Time) on Tuesday, February 16, 1971 in Room E on the 18th floor of the Patterson Office Tower on the campus of the University with the following members present: Mr. Jesse M. Alverson, Mr. Thomas P. Bell, Mrs. Rexford S. Blazer, Mrs. Robert O. Clark, Mr. Albert G. Clay, Mr. Richard E. Cooper, Mr. George W. Griffin, Mr. Eugene Goss, Mr. J. Robert Miller, Mr. James H. Pence, non-voting faculty member Professor Paul G. Sears, and non-voting student member, Mr. Stephen Bright. Absent from the meeting were Governor Louie B. Nunn, former Governor Albert B. Chandler, Mr. William P. Butler, Dr. N. N. Nicholas, Mr. Floyd H. Wright, and non-voting faculty member Professor Robert W. Rudd. Members of the University administration present were: President Otis A. Singletary; Vice Presidents Alvin L. Morris, Lewis W. Cochran, A. D. Albright, Glenwood L. Creech, Stanley Wall, Robert G. Zumwinkle, Peter P. Bosomworth and Lawrence E. Forgy; Dr. Donald B. Clapp, Budget Director; and Mr. John C. Darsie, Legal Counsel. Representatives of the various news media were also in attendance.

# A. Meeting Opened

Mr. Clay, Vice Chairman of the Board, presided in the absence of Governor Louie B. Nunn. He called the meeting to order at 2:00 p.m. The invocation was pronounced by Mr. Clay.

# B. Oath of Office Administered

Mrs. Robert O. Clark was welcomed as a new member of the Board of Trustees and the oath of office was administered by Mr. John Darsie, Legal Counsel of the University. Mrs. Clark was appointed by Governor Nunn as an alumnus member of the Board of Trustees for a term expiring December 31, 1974. She replaces Mr. Robert H. Hillenmeyer, whose term expired December 31, 1970 but who continued as a member of the Board until Mrs. Clark's appointment was made and she qualified through taking the oath of office.

# C. Roll Call

The Secretary reported a quorum present and Mr. Clay declared the meeting officially open for the conduct of business at 2:03 p.m.

# D. Minutes Approved

On motion by Mr. Cooper, seconded, and passed, the reading of the Minutes for the January 19, 1971 meeting of the Board of Trustees was dispensed with and the Minutes were approved as published.

## E. Executive Committee Member Election

A vacancy existing on the Executive Committee due to the termination of Mr. Hillenmeyer's tenure on the Board, Mr. Clay called for nominations for a replacement to complete his term. Mr. Pence placed the name of Mr. George Griffin in nomination. Mr. Goss seconded the nomination. Mr. Cooper moved that the nominations be closed and that Mr. Griffin be elected by acclamation. Mr. Cooper's motion was seconded by Mr. Alverson, and passed, with all present voting "aye".

# F. Resolutions Committee Appointed

Mr. Clay mentioned that Mr. Hillenmeyer had served on several committees of the Board and that Governor Nunn would name his replacements at a later meeting. However, he felt it appropriate to name a committee to prepare resolutions on the two Board members whose terms expired on December 31, 1970--Mr. Robert H. Hillenmeyer and Mr. B. Hudson Milner. He named Mrs. Blazer, Mr. Cooper, and Professor Sears to this committee and requested that the resolutions be prepared for reading at the March meeting of the Board.

## G. President's Report to the Trustees

President Singletary reviewed briefly items in PR 1, President's Report to the Trustees, which he felt would be of particular interest. He closed his report with the announcement that the commencement exercises in May would be held on May 8 at 4:00 p.m. rather than at 10:00 a.m. on May 10. Mr. Clay accepted the report with thanks and ordered it filed.

# H. Announcements by Mr. Clay

Mr. Clay extended congratulations on behalf of the Board of Trustees to Mr. Lawrence E. Forgy, Vice President for Business Affairs and Treasurer, and to Mr. Thomas P. Bell. Mr. Forgy has been named as one of the five Outstanding Young Men in Kentucky in 1970, and Mr. Bell has been named Cutstanding Pro Official of the National Football League for the 1970 Season. In addition, Mr. Clay noted that a fellow Board member, Mr. Wright, was a

patient at the University Hospital as was Coach Adolph Rupp. The Secretary was asked to write both men expressing the Board's concern and wish them speedy recoveries.

# I. Recommendations of the President (PR 2)

President Singletary in presenting PR 2, Recommendations of the President, indicated that these were routine matters although he thought it worthy of attention that the three persons recommended for retirement had contributed a total of 90 years of service to the institution.

There being no questions, on motion by Mrs. Blazer, duly seconded, and carried, PR 2, Recommendations of the President, was approved as a whole and ordered made an official part of the Minutes of the meeting. (See PR 2 at the end of the Minutes.)

# J. Somerset Community College Buildings Named (PR 3)

President Singletary asked Dr. Stanley Wall, Vice President of the Community College System, to distribute copies of PR 3 which had been received too late for inclusion in the materials mailed to the Board members prior to the meeting, and to make the presentation since it was concerned with the naming of the Somerset Community College buildings.

Dr. Wall said that the Advisory Board of the Somerset Community College had recommended that the first building on the Somerset campus be named the Leonard Ephraim Meece Hall, and that the new building just completed be named the George Michael Stoner Hall. He gave some biographical information on the two men for whom the buildings would be named and indicated that the University's Building and Campus Development Committee had reviewed the recommendation and concurred in it as did the University administration.

Mr. Cooper moved that the recommendation in PR 3 relative to the naming of the two buildings on the Somerset Community College campus be approved. His motion was seconded by Professor Sears and all present voted "aye". (See PR 3 at the end of the Minutes.)

## K. December Degree Candidates Approved (PR 4)

On motion by Mr. Pence, seconded, and carried, the President was authorized to confer upon each individual whose name appeared on the list attached to PR 4 the degree to which he is entitled at the commencement exercises on May 8, 1971. (See PR 4 at the end of the Minutes.)

# L. Designations for Henderson Community College Buildings (PR 5)

President Singletary called attention to PR 5 recommending that the three buildings on the Henderson Community College campus be designated the Student Center Building, the Arts and Sciences Building, and the Administration Building. On motion by Mrs. Blazer, seconded, and passed, the designations recommended for the Henderson Community College buildings were approved. (See PR 5 at the end of the Minutes.)

# M. Transfer of Kentucky Life Museum (PR 6)

At the request of the President, Dr. Creech explained the proposed transfer of the Kentucky Life Museum from the University of Kentucky to the Commonwealth's Department of Parks. He gave some facts relative to the development of the museum under the direction of Dr. Hambleton Tapp and said that the collection of Kentuckiana artifacts was outstanding. The museum appeals to a broad segment of the public but is largely unrelated to the University's teaching or research functions, thus it is a more appropriate function of the Department of Parks than of the University. The Department of Parks has indicated its willingness to accept the museum but it is necessary to have approval of the Board of Trustees prior to further negotiations.

On motion by Mrs. Blazer, seconded, and passed, the recommendations in PR 6 were approved. (See PR 6 at the end of the Minutes.)

#### N. 1970-71 Budget Revisions (PR 7)

There being no questions, on motion by Mrs. Blazer, seconded by Mr. Cooper, and passed without dissent, the budget revisions for 1970-71 recommended in PR 7 were authorized and approved. (See PR 7 at the end of the Minutes.)

# O. William R. Willard Department of Family Practice Established (PR 8)

President Singletary requested Dr. Bosomworth to present the recommendation relative to the establishment and naming of the Department of Family Practice in the College of Medicine. Dr. Bosomworth said that under legislation passed by the 1970 General Assembly, the College of Medicine must have within its curriculum a Department of General Practice of Medicine under the direction of a qualified general practitioner. In establishing this new department, its designation as the Department of Family Practice is being recommended because "Family Practice" is the terminology approved by the Council of Medical Education and the House of Delegates of the American Medical Association.

Dr. Bosomworth continued that Dr. William R. Willard has been a leader at the state and national level in the provision of primary care and it is most fitting that the new department carry his name. Dr. Willard, who was present at the meeting, was recognized by Mr. Clay and received a round of applause from the Board members.

On motion by Mr. Alverson, seconded by Mr. Goss, and passed, the establishment of the William R. Willard Department of Family Practice was authorized and approved. (See PR 8 at the end of the Minutes.)

# P. Amendment to Section IV of the Governing Regulations

At the January 19, 1971 meeting of the Board of Trustees, a proposed amendment to Section IV of the Governing Regulations was presented by President Singletary with his recommendation that it be approved after the required month between presentation and action had elapsed. Mr. Clay called for a motion to bring the motion off the table. Mr. Steve Bright moved adoption of the proposed amendment to Section IV of the Governing Regulations as presented at the January 19, 1971 meeting of the Board of Trustees. His motion was seconded by Mr. George Griffin.

Mr. Thomas Bell then moved to amend Mr. Bright's motion, stating that since the January 19 meeting he had given much thought to the matter, had discussed it at length with members of the Board of Trustees, the administration, and some faculty and students, and had come to the conclusion he could not agree with the amendment in its present form. On the other hand, there were a number of issues with which he was in complete agreement, such as the concept of a wider participation of students in the Senate. The idea of an elected student representative from each college in the Senate was attractive to him inasmuch as this would make it possible for the student voice to be balanced and diverse. In order to obtain responsible student representatives, he felt that students elected to the Senate should be upperclassmen and should be in good standing in their respective colleges.

Mr. Bell's own thinking, plus his conviction that the amendment to Section IV of the Governing Regulations as presently before the Board would not pass, prompted him, therefore, to move that Mr. Bright's motion for adoption of the proposed amendment to Section IV be amended. He then read the amendment to the proposed amendment, a copy of which is included at the end of the Minutes.

His motion was seconded by Mr. Cooper. In the discussion that followed, Mr. Bright indicated that it was as apparent to him as to Mr. Bell that the proposed original amendment would not pass in its original form and it was with some regret and disappointment that he acceded to the changes in the January 19 amendment as recommended by Mr. Bell. Dr. Sears, speaking for himself and

Dr. Rudd, indicated his support of Mr. Bell's amendment to the proposed amendment of January 19. Dr. Singletary said when it became clear to him that in its original form the motion would not pass, he too began to seek alternatives that would preserve some of its better features. After talking with Steve Bright and the Chairman of the Senate Council, as well as members of the administration, it was his best judgment that Mr. Bell's amendment was as satisfactory a resolution of the problem as was possible and he endorsed it. Mr. Clay stated that the institution has already proven that it endorses the concept of student participation through the presence already in the University Senate of five voting student members. This is further endorsement of this concept and, though it may not provide as many students in the Senate as had been hoped for, it presents an opportunity for students to fulfill their responsibilities. Later the matter can be reviewed to see what input the students have made into the academic programs of this campus. He then called for a vote on Mr. Bell's motion to amend Mr. Bright's motion. All present voted "aye". Mr. Bright requested permission to speak before his motion as amended was put to the vote. A copy of his statement appears at the end of the Minutes.

The vote on the original motion made by Mr. Bright and seconded by Mr. Griffin as amended was called for. All present voted "aye". Mr. Bright indicated that Student Government would set up the machinery to carry out the elections of the student Senators.

# Q. Interim Financial Report (FCR 1)

There being no questions, on motion by Mr. Griffin, seconded by Mr. Pence, and passed, the interim financial report for the six-months' period ending December 31, 1970 was accepted and ordered made a matter of record. (See FCR 1 at the end of the Minutes.)

# R. Employment of Auditors for 1970-71 (FCR 2)

Mr. Forgy recommended that the firm of Peat, Marwick, Mitchell and Company be engaged to perform an independent audit of the financial statements of the University of Kentucky and its affiliated corporations for the fiscal year 1970-71. Mr. Alverson moved approval of FCR 2. His motion was seconded by Mr. Cooper, and passed. (See FCR 2 at the end of the Minutes.)

# S. Exchange of Properties (FCR 3)

Mr. Forgy explained that the University needed the property presently owned by the Kentucky High School Athletic Association in order to expand its educational facilities. An agreement has been worked out with the KHSAA to exchange this property for approximately an acre of University land (adjacent to

ETV facility on Cooper Drive) and Mr. Forgy recommended approval of the recommendation made in FCR 3.

On motion by Mrs. Blazer, seconded by Mr. Griffin, and passed, FCR 3 was approved. (See FCR 3 at the end of the Minutes.)

# T. Lexington Banks Designated as Depositories

Mr. Griffin, acting as Chairman of the Finance Committee since Mr. Hillenmeyer's retirement from the Board, said that the Finance Committee had made a study of the banking requirements of the University and its affiliated corporations and proposed a rotation of bank accounts for a five-year period in accordance with a schedule submitted as part of the recommendation, a copy of which was made available to the Trustees and is included at the end of the Minutes. Mr. Hillenmeyer and Mr. Griffin had personally discussed the rotation schedule with the president of each bank involved and had received their endorsements of the schedule.

Mr. Griffin moved that the Board of Trustees authorize the banks listed in the recommendation to act as depositories for University of Kentucky funds and affiliated corporation funds for the period April 1, 1971 through June 30, 1976. His motion was seconded by Mr. Pence, and passed without dissent. (See recommendation at the end of the Minutes.)

# U. Student Code Revision Committee

Mr. Griffin reported that the Student Code Revision Committee had received some suggestions for revisions in the Student Code and had these under consideration at the present time. A final report will not be ready for presentation before April or May.

# V. Hearing Committee Report

Mr. Clay said that the Board had heard a presentation by Mr. Mike Campbell, a student, at the January meeting in which he recommended that any student who had acquired 300 signatures (or an agreed upon number) be permitted to present his petition to the Board directly without a preliminary hearing. Mr. Clay asked what disposition the Board wished to make of Mr. Campbell's recommendation.

Mr. Griffin responded that he had been informed that it would be a relatively simple matter for a student to acquire 300 signatures on any issue within a matter of an hour or two over the lunch period in the Student Center. From a practical standpoint, the Board could easily find itself involved in

very long meetings at which numerous students would wish to discuss proposals of interest to them. Under such an arrangement, the Board would be distracted from the performance of its primary business and, at the same time, Board meetings could end up merely providing a highly publicized platform for students to gain visibility as they express their own personal views. The Board through its student member has a legitimate and official spokesman for students' concerns. Matters of great importance to the student body should be brought to the attention of the Board by the student member. Petitions should, therefore, be routine through the Student Government President who would refer them to the appropriate agency within the University or to the Board.

Mr. Griffin then moved that the proposal received at the January 19, 1971 meeting of the Board of Trustees be disapproved. His motion was seconded by Mr. Bell, and passed unanimously.

# W. Meeting Adjourned

There being no further business to come before the meeting, on motion duly made, seconded, and carried, the meeting adjourned at 2:55 o'clock.

# PRESIDENT'S REPORT TO THE TRUSTEES

February 16, 1971

#### 1. DRUG ABUSE BEING FOUGHT ON SEVERAL FRONTS

Several positive steps are under way to combat drug abuse at the University, which neither condones the illegal use of drugs nor denies drug abuse is cause for concern within the University or within society as a whole. A University Committee on Drug Education has been formed to coordinate planning and evaluation of its programs dealing with drug abuse. The committee, to place emphasis on methods to make the University's drug-related programs more widely known and utilized, will make its first report by April 15. "I believe the University must pledge its resources and cooperation in an effort to reduce and control the drug problem as it exists in our community, in the state, and in the nation," Dr. Singletary stated.

In recent weeks various members of the UK community have been reviewing the University's present effort in drug education. Some of these activities include: a day-long drug abuse seminar, held January 8 for the Student Affairs staff, featuring Dr. Dale Farabee, state commissioner of mental health; Dr. Charles Walton, College of Pharmacy; Dr. John A. O'Donnell, Department of Sociology; James Amato, Lexington police judge, and Sgt. Frank Fryman, Lexington Police Department; continuing conferences between administrators and Lexington officials; an agreement by the Medical Center to provide drug identification services to Fayette Circuit Court when the State Toxicology Laboratory is unable to run tests; a Student Center Board drug seminar, held in December, with discussions led by representatives of the Student Health Service, College of medicine, Lexington Police Department, and the Clinical Research Center; a Rap Room program, sponsored by the Human Relations Center, and counseling and treatment of students who seek help from the Student Health Service.

# 2. ACCREDITING TEAM ENDS VISIT

Inspection of the University by an accrediting team from the Southern Association of Colleges and Schools was completed on schedule Wednesday. Despite the snowfall, which hampered work Monday and closed the University on Tuesday, the team of 31 educators met their deadline. Dr. Singletary was given oral impressions by the visitors. Next, he will receive a draft of the report which eventually will determine whether UK will retain its accreditation unconditionally or will be asked to make some recommended changes to continue as an accredited institution.

#### 3. WENDELL BERRY IS DISTINGUISHED PROFESSOR

A leading Kentucky author, Wendell Berry, has been named the College of Arts and Sciences Distinguished Professor of the Year, Dean Wimberly C. Royster announced. A professor of English, Prof. Berry was elected to the post by his fellow faculty members in the college, and as recipient of the award is released from his duties for one semester to write. He will continue on full salary. Prof. Berry will deliver the College of Arts and Sciences Distinguished Professor Lecture next fall. He is the 27th winner of the coveted award, established in 1944 as a means of recognizing outstanding academic achievement in the college. Dr. S. M. Shah, professor of mathematics, was the holder of last year's award. A native of Henry county, Berry attended Millersburg Military Institute, graduating in 1952. He received the bachelor of arts and master of arts degrees from the University. He has been the recipient of a Haggin Grant from the University, a Stegner Fellowship in writing from Stanford University, a Guggenheim Fellowship, and a Rockefeller Foundation grant. Prof. Berry began his teaching career as an instructor at Georgetown College in 1957. He was E. H. Jones Lecturer in Creative Writing at Stanford University, 1959-60, and assistant professor of English at New York University, 1962-64, when he joined the University.

Berry has written two novels, "Nathan Coulter," and "A Place on Earth." Among his major works are four books of poetry, "Openings," "Findings," "The Broken-Ground," and "Farming-A Hand Book." Two books of essays, "The Long-Legged House," and "The Hidden Wound," also are by Prof. Berry. Another book, "The Unforeseen Wilderness," written about the Red River Gorge, with photographs by Gene Meatyard, will be published in April by the University Press of Kentucky. Prof. Berry lives at Port William in Henry county with his wife and two children, Mary Dee and Pryor Clifford. Mrs. Berry is the former Tanya Amyx, daughter of Art Professor and Mrs. Clifford Amyx.

# 4. 30 VIE FOR UNIVERSITY HONORS SCHOLARSHIPS

the 30 semi-finalists for two \$500 scholarships to the University Honors Program were on campus recently for final competition, according to Dr. John L. Greenway of the Honors Program. Money for the one-year scholarships was made available by President Otis A. Singletary, to be awarded by the Honors Program. The semi-finalists all are seniors in Kentucky high schools and include many who ordinarily would not come to the University, Dr. Greenway explained. He said the Honors Program committee plans to award the scholarships to students who not only have outstanding acacemic records, but also evidence creativity in their specialized fields. "Mathematics can be as creative a discipline as art or literature," Dr. Greenway said. The Honors Program is an instructional and advisory program providing a special academic track for students with superior abilities.

# 5. RESEARCHERS STUDYING FLIGHT OF THE ALBATROSS

Dr. Richard Birkebak, professor of mechanical engineering, and two colleagues are continuing their research on the albatross on Midway Island in the central Pacific Ocean which serves a dual role as a sanctuary for tens of thousands of baby albatross and as a U.S. Navy installation. Dr. Birkebak's team was on Midway in February, 1970. He says that at one time during the hatching season "we estimated there were more than 40,000 adult and young birds there." His co-workers on the project are Jerry Hoskins, a mechanical engineering undergraduate from Stanford, and Ariono Abdulkadir, a graduate student from Indonesia. The three UK men, along with Dr. Gene LeFebvre, Department of Zoology of Southern Illinois University, currently are at Midway (until Feb. 20) to continue the study being funded by the National Science Foundation. During their visit to Midway last year, Dr. Birkebak and his associates developed ways to test flight time integrators (FTI), a device for monitoring the behavior of the birds away from the nest. This year a transmitter is being used in tracking the birds by radio to determine numerous behavior patterns about the wanderer of the seas. According to the engineers' plan some facts that will be collected are: how far the birds travel from Midway, flight time in a particular direction, the total time in flight, the total time spent resting on the water, and daylight flying time. FTIs, along with the tiny transmitters, will be glued to the breasts of 30 albatrosses. Neither device is larger than a quarter. The transmitter's signal can be received for 50 miles and its lifetime is 35 days. The FTI weighs 30 grams, or about one ounce, while the transmitters weigh six grams. During part of the study, Dr. Birkebak and his associates will be aboard U.S. Navy helicopters that operate on routine patrol in the vicinity of Midway. The military unit, among other duties, operates as an air-sea rescue group. Military and civilian population combined is about 2,000 persons.

# 6. DR. ALBRIGHT REVISITS BELGIUM

Dr. A. D. Albright, vice president for institutional planning, was invited by the Institut Administration-Universite of the Belgian government to assist with two colloquia (seminars) in Belgium on university management and administration. The colloquia began January 29 and concluded February 6. Each lasted approximately two days. The first seminar was composed of university rectors (presidents), some deans, and members of university administrative The other was designed for ministers and selected staff of the ministries of national education and culture and members of Parliament committees on education. The seminars, the first organized on a national scale in Belgium, resulted from a study and recommendations made by Dr. Albright while he was in Belgium on a Fulbright Lectureship award in 1969-70. The topics discussed included planning in an institution and nationally, program goals and evaluation, academic and financial management, policy formulation, systems and coordination among universities, and relationships of universities to government. At the conclusion of the sessions, future action was discussed for a continuing program to assist in the further development of university management and administration in that country.

# 7. 15 NEW MEMBERS ON ALUMNI BOARD

Twenty-four University alumni have been elected to serve on the Alumni Association's board of directors. There are 15 new members; nine won re-election. Half were elected to four-year terms. The others will serve three years. Elected to threeyear terms were: District I--Brent D. Thompson, Cadiz bank executive; District II--Philip E. McIntosh, Somerset contractor; District III--James W. Stuckert, Louisville stockbroker; District IV--Cecil Bell, Lexington tobacco warehouseman and Mrs. B. L. Kessinger Jr., Lexington housewife; District V--Mrs. G. D. Beach, Frankfort housewife; District VI--Dr. Layton L. Rouse, Carrollton dentist; District VII--Dr. George P. Archer, Prestonsburg physician; District VIII--George L. Atkins Jr., Hopkinsville insurance man, and John C. Nichols II, Louisville bank executive; District IX--W. Hugh Adcock, Atlanta, Ga., industrial executive, and District X--William T. McClain, Winnetka, Ill., patent attorney.

Elected to serve four-year terms were: District I--H. Hamilton Rice Jr., Owensboro attorney; District II--Walter "Dee" Huddleston, Elizabethtown radio executive; District III--Robert E. Lee Jr., Louisville accountant; District IV--J. Carlisle Meyers Jr., Lexington businessman, and Richard A. Rushing, Lexington real-estate executive; District V--Edward L. Swift Jr., Winchester, manager of the UK department of printing. District VI--Merwin Grayson Jr., Covington bank executive; District VII--Don R. Batten, Pikeville engineer; District VIII--Joe C. Creason, Louisville newspaper columnist, and the Rev. W. Robert Insko, Frankfort minister; District IX--Dr. Harvey M. Pewitt, Huntsville, Ala., physician, and District X--C. Robert Yeager, Attleboro, Mass., industrial executive.

Those re-elected include Huddleston, Bell, Mrs. Kessinger, Rushing, Archer, Mrs. Beach, Creason, Adcock and Yeager. In the past, 12 new directors were elected each year, but a change in the association's by-laws called for the election of 24 this year. Eventually, all directors will be elected for four-year terms exclusively, but a division between three - and four-year terms at this time was necessary to provide for future elections, an association spokesman said.

# 8. PHARMACY ALUMNI ASSOCIATION ORGANIZED

Officers were elected and a constitution and by-laws approved for the new University Pharmacy Alumni Association at a meeting at the College of Pharmacy recently. The new officers are Tom Bernard, Jeffersonville, Indiana, president; Jack Cecil of Owensboro, vice president, and Dr. Harry Smith of the college's staff, secretary-treasurer. Prof. Richard M. Doughty is the representative of the pharmacy branch to the board of directors of the Alumni Association.

#### 9. TWO GRAD STUDENTS WIN WILSON FELLOWSHIPS

Mrs. Olga Impey and Mr. Richard Stoffle, doctoral candidates at the University, have been awarded Dissertation Fellowships from the Woodrow Wilson National Fellowship Foundation for 1971-72. Mrs. Janet Mitchell, director of the program, said Stoffle will be the first student to receive a Ph.D degree in the Department of Anthropology at the University. Mrs. Impey is a graduate student in the Department of Spanish. She was born in Rumania and began her studies in Spanish language and literature at the University of Bucharest. She came to the U.S. in 1968 to join her husband, Michael, a faculty member at the University of Kentucky. The Dissertation Award will enable her to complete her research and write her dissertation on the stylistic and linguistic aspects of medieval Spanish prose. Mrs. Impey has held a Haggin Fellowship for the past two years, and has been a teaching assistant in the Department of Spanish. Stoffle was born in Kansas City, Missouri, and received his BA degree from the University of Colorado. For the past three years he has been a research assistant with the Center for Developmental Change. The Dissertation Fellowship will provide funds to complete his research in Barbados, West Indies, for his dissertation on the influence of industrialization on family structure. He previously lived there as a member of the Peace Corps, 1965-67. He will return to the University to finish writing his dissertation. About 200 Dissertation Fellowships, averaging \$3700 each, are awarded every year to outstanding graduate students who give evidence of being able to complete their Ph.D degrees in a fouryear period.

## 10. FORMER PCC PRESIDENT "RETIRES" SECOND TIME

Dr. R. G. Matheson, president of Paducah Junior College (now Paducah Community College) for 30 years prior to his retirement in July of 1968, and since that time coordinator of self-studies for the UK Community College System, is returning to Paducah after more than two years' work in the central office. Dr. Matheson has been assisting the individual colleges in preparing for accreditation. The major portion in his assignment is now completed, and he left full-time employment on December 31. He will continue to perform numerous selected duties for the University and the Community College System. Dr. Matheson spent 35 years as the chief executive of two-year colleges. He was at a Presbyterian junior college in North Carolina before coming to Paducah. He believes "the instructional philosophy of any institution should be compatible with its admissions policy." He sees in the community colleges an "open door" admissions policy which will allow each student admitted the opportunity to study in programs that are congruent with the students' interests and abilities. Accordingly, success rather than failure is stressed, he says.

## 11. TECHNICAL PROGRAMS IN COMMUNITY COLLEGES BOOSTED

Several community colleges have received federal grants through the Kentucky Bureau of Vocational Education that will be of benefit to disadvantaged and handicapped students preparing for two-year technical programs. The colleges include Ashland, Elizabethtown, Henderson, Hopkinsville, Jefferson, Lexington Technical Institute, Madisonville, Prestonsburg, and Somerset. Support for the programs is under Part A of the 1968 amendments to the Vocational Education Act. Over 400 students at nine of the colleges will participate in the programs. Basically, provision is made for intensive vocational and educational counseling, tutorial services, and job placement. In addition, three colleges, Ashland, Hopkinsville, and Madisonville, have received federal grants to assist in the development of vocational programs for physically handicapped students. Support for the projects comes from Part B of the 1968 amendments to the Vocational Education Act. Both programs are designed to increase the opportunities for disadvantaged and handicapped students to enter technical programs that will prepare them for immediate employment. This is the first year for these programs in the Community College System. They have been made possible by cooperation between the State Board of Education and the University Community College System.

# 12. 2,000 ATTEND OPEN HOUSE AT SOMERSET

An open house at Somerset Community College on January 10 entertained 2,000 persons, who took advantage of the opportunity to view the facilities of the college. Highlight of the guided tour was the new Technical Building, which was completed August 1, 1970. The building houses an auditorium where many dramatic productions will be performed for the benefit of students and townspeople. Included in the building is a low-power radio station, WSCC-FM, which operates on 90.7 kilocycles between 10 a.m. and 5 p.m. weekdays. The station can send out programs within a 15-mile radius of the college. Students studying Broadcast and Communications Technology operate the station as part of their course of study. Additional facilities located within the Technology Building include home economics, nursing, engineering, and communications laboratories.

#### 13. LEARNING LAB INITIATED AT MADISONVILLE COLLEGE

Madisonville Community College is installing a Learning Lab to provide remedial work for students in math, English, and reading. The lab will expand its resources in the future to provide help in other areas as well. The Learning Lab is a cooperative venture with the Madisonville Area Vocational School. It was established in connection with Madisonville's Disadvantaged Program, which was federally funded through the Kentucky Bureau of Vocational Education.

#### 14. ASHLAND COLLEGE RECEIVES HARM PRINTS

The Altrusa Club of Ashland has presented to the Ashland Community College four framed Ray Harm prints for the library of the new building. The four famous prints, the Kentucky Cardinal, the Bald Eagle, the Red Headed Woodpecker, and the Owl, are valued at over \$800.

#### 15. PRESTONSBURG DEBATE TEAM DOES WELL

The Prestonsburg Community College Debate Team traveled to Morris Harvey College to participate in its second debate tournament this year. The team placed well by defeating teams from Concord College, Olderson-Broadus and Fairmont College. The PCC team also debated the teams from Wake Forest University and West Point Military Academy, the two schools which placed first and second respectively. Seventeen colleges from Kentucky, Virginia, West Virginia, Ohio, North Carolina, and New York participated.

## 16. HOUSING SHORTAGE PREDICTED ON CAMPUS

Applications for housing for the Fall semester 1971 have reached an all-time high. All indications are that the housing shortage experienced in the past two years will be even more severe in 1971, says Larry Ivy, director of University housing. He said that all students who have not submitted an application and who are interested in on-campus housing for the semester are urged to do so immediately. Priority will be given to community college students moving to the Lexington campus—by date of application—and they will be assigned immediately after students presently living in University housing. Final acceptance to the University will not be a criterion for assignment of community college transfers. No housing assignments will be made until after May 1.

#### 17. FRESHMEN APPLYING EARLIER

Keller Dunn, associate dean of admissions, reports a marked increase in the number of freshmen who are applying early to the University. For the Fall semester, 1967, 50 per cent of the freshmen applications had been received by April 15. If projected enrollment figures bear out, 50 per cent of the freshmen applications for Fall 1971 already have been received, Dunn said. As of January 25, 2,188 freshmen applications had been processed. This includes all application forms, ACT scores and Advising Conference date confirmations. Dunn attributes the increase to two major factors. First, the trend nation-wide is for high school students to begin the process of applying to college as early as possible, a result of increased enrollments at most colleges and universities. Secondly is the work done by the Pre-Admissions Office. Information about application, ACT, housing, etc. is sent to students through their high school, making the process of applying early smoother.

#### 18. GROUP NAMED TO STUDY RESIDENTIAL LIFE

Vice President for Student Affairs Robert Zumwinkle has announced the appointment of an ad hoc advisory commission to study the quality of student residential life. The committee, chaired by Dr. William Bryan, director of student services in the College of Nursing, is designed to identify the "major successes, problems, needs, and trends" of student residential life, and submit recommendations for immediate and long-term changes. The 24-member group will submit its report and recommendations by May 1.

Specific study areas for the commission are: studying and summarizing national trends in student housing; studying the findings of studies concerning the impact of various kinds of housing and also various housing programs and policies; identifying University needs and problems in the area; estimating future trends with respect to student and parental expectations, construction costs, the University's official attitude toward its obligation to meet student housing needs, and legal developments which may affect the University's role; evaluating the feasibility of "life-style" halls, and such options as women's hours and visitation policies; studying ways in which the student's residential setting can contribute more effectively to his educational experience; evaluating the validity of requiring certain categories of students to live in residence halls, and evaluating the effectiveness of the current residence hall staffing pattern.

The commission will study the entire spectrum of student residential life--residence halls, graduate apartments, married student apartments, cooperative housing, fraternities and sororities, and off-campus housing. Student members are: Damon Talley, fraternities; Mary Harrison Gilpin, sororities; Steve Daub, Graeme Browning and Jeff Gumer, off-campus; Barbara Brundage, graduate and professional students; Carol Mace, co-operative housing; Steve Cosby, north campus residence halls; Mickey T. Smith, Haggin Hall; Nancy Jeanne Clark, Donovan, and Richard Jones and Martha Knight, Complex representatives. A married students' representative has not been named. Faculty members are: Dr. John Stephenson, dean of undergraduate studies; Dr. Richard Warren, associate professor of social and philosophical studies; Dr. Randolph Daniel, assistant professor of history; David Spaeth, assistant professor of architecture; and Dr. Rudolph Schrils, associate professor of physics. Staff appointees are: Arvil Reeb, psychiatric social worker; Dr. Robert Harman, associate director, counseling and testing center; Dr. Roy Jarecky, director, admissions and student services, Medical Center; George Ruschell, assistant vice president for business affairs; James King, business manager; Rosemary Pond, associate dean of students in charge of housing; Robert Elder, assistant dean of students and advisor to the interfraternity Council, and Walter F. Maguire, assistant dean of students in charge of off-campus housing.

#### 19. RUSSIAN ATHLETES VISIT UNIVERSITY

The University hosted members of the Russian Olympic Boxing team January 27. They arrived about noon from Louisville, where they competed with American boxers, and visited Coach Adolph Rupp. They were at Delta Delta Delta sorority house for lunch. Dr. Mischa Fayer, chairman of the Department of Slavic and Oriental Languages, and professor of Russian language and literature, met the group and served as interpreter. Also joining the boxers were Victor Dechitiarenko, instructor of Russian, and three students majoring in Russian. They were Miss Rosemary Shields, Ron Miller and John Lawrence. The group toured the campus, Spendthrift horse farm and Coldstream farm, with Pete Head of the College of Agriculture acting as guide. The Russian athletes' tour of the University was conducted by student guide Miss Susan Baggerly of the Public Relations Department's tour service. The visit was sponsored by the Athletics Department.

# 20. COLLEGE OF AGRICULTURE'S DUTT, MITCHELL HONORED

Two University animal science department personnel were honored at the Southern Section of the American Society of Animal Science's annual meeting. Dr. Ray H. Dutt, physiology of reproduction specialist, selected by the Society for it's 1971 Distinguished Service Award in recognition of outstanding contributions to the livestock industry and the Society. The annual award recognizes Dr. Dutt's 22 years' research and teaching at the University, plus his six years' research on the Journal of Animal Science, cluminating with two years as editor and chairman of the editorial board. He served as vice president of the American Society of Animal Science in 1967 and president in 1968.

Dr. George E. Mitchell Jr., nutrition specialist, has been elected president of the Southern Section of the American Society of Animal Science and director of the national organization. Dr. Mitchell received his doctor's degree in animal nutrition and biochemistry at the University of Illinois in 1956, at which time he became assistant professor of animal science at that institution. He joined the faculty of the University Animal Sciences Department in 1960 as associate professor and was promoted to professor of animal sciences in 1967. He is a member of the University Senate, the Graduate Faculty and the Area Personnel Advisory Committee for Biological Sciences. At present, Dr. Mitchell is serving as coordinator of the animal nutrition research program of his department, and also coordinates graduate instruction. Mitchell was the first winner of the University's Sang Award of \$3,000 for excellence in graduate research and instruction in 1967. He also won the Thomas Poe Cooper Award for outstanding agricultural research at the University in 1969, and the Kentucky Research Foundation Award for outstanding research that same year.

#### 21. FOUNDATION AWARDS NOW STAND AT NEAR \$8 MILLION

During the period January 1-31, a total of 28 agreement awards was received by the University of Kentucky Research Foundation, amounting to \$853,691.71. Fifteen grants received additional funds amounting to \$150,672.53. One grant was decreased by \$9,393. Three Inter-Disciplinary funded projects were established, amounting to \$19,200.00. Inter-Disciplinary project funds are not included in the above totals. The total of awards since July 1, 1970: \$7,973,318.22.

Judge T. Calton, associate administrator of University Hospital, was elected president of the Lexington Hospital Council at the group's December meeting.

<u>Dr. Louis Swift</u>, chairman of the Department of Classical Languages and Literatures, read a paper entitled "St. Ambrose on War and the Coercive Powers of the State," at the annual meeting of the American Philological Association in New York. He was elected a member of the five-man steering committee of the North American Patristic Society.

<u>Dr. Howard Bost</u>, assistant vice president for the Medical Center, has been elected to the board of trustees of Appalachian Regional Hospitals.

Random House will publish the book "The Politics of Exploitation," by Drs. Gene Mason and Fred Vetter, assistant professors of political science, scheduled to appear in time for the spring semester, 1972.

The essays are concerned with world library resources, the humanist as librarian, bibliographical control of literature, and fine books and book collectors.

<u>Dr. Glenwood L. Creech</u>, vice president for University relations, has received the honorary Kentucky Young Farmer Association degree. The award presentation was made February 6 at Park Mammoth Resort, near Park City, during YFA's 13th annual convention.

# RECOMMENDATIONS OF THE PRESIDENT

# I. Departmental Name Changes

Recommendation: that (1) the name of the Department of Radiation Medicine, College of Allied Health Professions, be changed to the Department of Health Radiation Sciences; and (2) the name of the Department of Therapeutic Radiology, College of Medicine, be changed to Department of Radiation Medicine.

Background: These are administrative changes in names to more nearly reflect the activities of the departments and do not affect the academic programs of either department.

# II. Ballots Ordered Destroyed

Recommendation: that authorization be given to the President to destroy the ballots cast in the election for alumni members of the Board of Trustees for the year 1970.

Background: The ballots cast in 1970 by the alumni of the University of Kentucky in the election for an alumnus member of the Board of Trustees, having been duly counted and certified by the proper officials, are currently on file in the President's Office. Following the election the report on the election was accepted by the Board of Trustees and certification of the top three nominees made to the Governor. The report is a part of the Minutes of the Board of Trustees and the results of the election are a matter of record.

#### TRANSFER OF KENTUCKY LIFE MUSEUM

#### Recommendation:

- 1. That the Board find, in accordance with Section 164.270 of the Kentucky Revised Statutes, that the property more particularly described in section 2 of this recommendation, is more suitable for use by the Commonwealth's Department of Parks than in its present ownership by the University of Kentucky and that such use is consistent with the interests of the University.
- 2. That the President of the University and the Vice President, Business Affairs and Treasurer be authorized to execute the necessary documents to transfer to the Department of Parks the following described real property, together with all appurtenances thereto, including museum collections housed in the structures located upon the property. The Vice President, Business Affairs and Treasurer is authorized to exempt from the transfer of personal property authorized herein, any personal property, if the donor thereof specifically objects to such transfer. The real property to be transferred is more particularly described as follows:

Beginning at a point in the center of Higbee Mill Road, corner to Dale, said point being the east right of way line of the Southern R. R.; thence, with the center line of Higbee Mill Road for two (2) calls, S 68° E-260'; S 71° E-740'; thence, with the Commonwealth of Kentucky for three (3) calls, N 14° E-480'; N 76° W-525'; N 73° W-396'; to the east right of way line of the Southern R. R.; thence, with the Southern R. R. right of way line, S 23° W-420' to the point of beginning, containing 10 acres more or less.

#### Background:

To offset the dwindling acreage of its Experiment Station Farm, a loss brought about by the southward expansion of the main campus, the University in 1956 purchased a 202 acre farm at Higbee Mill Pike's junction with US Highway 27, since known as the South Farm. It was acquired

from the estate of James A. Hulett for the sum of \$270,000. The mansion, built in the mid-19th century by a kinsman of Daniel Boone, was designated by the University in 1957 as the Kentucky Life Museum, and Dr. Hambleton Tapp was appointed director.

Chiefly as a result of Dr. Tapp's remarkable energy and zeal, the mansion since has been fully restored, finished and decorated authentically. Additionally, it has been made the repository of some 10,000 Kentucky relics or antiquities, many of which are exceedingly rare and valuable. Portions of the collection are housed, according to the items' intended use, in the nearby servants' quarters, smokehouse, barn, icehouse, and country store. Under Dr. Tapp's direction, Waveland has become a unique storehouse of Kentuckiana portraying many phases of the state's pioneer heritage. In recent years, it has attracted about 8,000 visitors annually.

Although Waveland's appeal to a broad segment of the public is clearly recognized, it is largely unrelated to either the University's teaching or research functions. A faculty committee reached that conclusion in 1965 and, questioning the University's maintenance of a museum which--however valuable--was of primary interest to tourists, recommended that consideration be given to transferring Waveland's collections to the State.

That view recently was given added support by Dr. Carl Cone, chairman of the History Department, who reported a consensus among the history faculty that "If Waveland came under the State Park System, with a greater likelihood of generous financial support, its potential would be more fully realized than if it remained under the jurisdiction of the University . . . We do not think that, under the State Park System, Waveland's usefulness for teaching purposes will be in any way diminished but might actually be enhanced because the entire program would be a more ambitious one."

In view of growing financial needs throughout the University and of Waveland's relatively low priority in the allocation of limited resources, it is evident that this fine museum, for as long as it remains under University control, must continue to be handicapped by lack of the support that could assure its development on a scale commensurate with its potential as a visitor attraction. The Department of Parks' assumption of responsibility for Waveland would provide considerable financial relief for the University and, at the same time, increase the worth of Waveland as a tourist attraction through the development and promotion that logically and legitimately can be supplied by the Department.

Transfer of Waveland at this juncture is made even more timely by the fact that Dr. Tapp is within a few months of retirement, a circumstance that would require his replacement as director even if the University were to retain the property.

In recent conversations initiated by officers of the University, Parks Department officials have expressed awareness of Waveland's potential as a tourist attraction and have indicated a willingness to consider any proposal by the University for transfer of this property and its subsequent management and operation.

#### ESTABLISHMENT OF A DEPARTMENT OF FAMILY PRACTICE

Recommendation: that the Board of Trustees approve the establishment of a Department of Family Practice in the College of Medicine to be known as the William R. Willard Department of Family Practice, effective immediately.

Background: Legislation enacted by the 1970 Session of the General Assembly of the Commonwealth of Kentucky, requires that "each and every Medical School established and assisted financially by the state of Kentucky shall include in the curriculum a Department of General Practice of Medicine under the direction and supervision of a qualified general practitioner. The minimum requirements of the Department shall include courses of study in family care, including clinical experience, a program of preceptorships, a program of internships or general residencies in a hospital, and such other teaching techniques that in the judgment of the management of the school shall be best suited to encourage and implement the preparation of students for the general practice of medicine."

The College of Medicine proposes to establish a Department of Family Practice to strengthen and coordinate the undergraduate programs already in existence and to develop a special postgraduate residency program.

The creation of a Department of Family Practice within the College of Medicine represents the culmination of many months of planning for this important program. Dr. William R. Willard has provided important national leadership in redirecting the interests of organized medicine, academic medical centers, and the Federal Government towards the provision of primary care. He has chaired important committees on the national level, supported the creation of a specialty board in this field, and actively encouraged the creation of the program on this campus. Therefore, it is recommended that the department be named the William R. Willard Department of Family Practice.

AMENDMENT TO THE MOTION RECOMMENDING AMENDMENT OF SECTION IV

OF THE GOVERNING REGULATIONS AS PRESENTED ON JANUARY 19, 1971

(Underlining denotes additions; brackets denote deletions to Proposed Amendment)

#### IV. THE UNIVERSITY SENATE (University System)

The University Senate shall be composed of both elected and ex officio membership.

The elected membership shall number [200] 177, of which 160 members shall represent the faculty and [40] 17 members shall represent the student body.

The elected faculty membership shall consist of and represent proportionately the members of the full-time teaching and/or research faculty with the rank of assistant professor or higher in the various colleges and the University Libraries, so that the total elected membership shall equal 160. Each elected faculty member shall serve for a term of three years and shall be eligible for re-election for a second consecutive term, but ineligible for further reelection until one year has elapsed. If a faculty member of the Senate should at any time during his term become ineligible to serve (e.g., by reason of assuming an administrative title, resignation or by official leave which precludes attendance) the administrative head of the group represented shall declare a vacancy and designate that member from the eligible faculty who at the last election received the next highest vote to serve for the duration of the elected faculty member's ineligibility.

The elected student membership shall consist of and represent the members of the fulltime student body in the various colleges of the University System and the Student Body President. Each college shall be allotted [at least] one student representative. [The remaining student membership positions shall be apportioned among the colleges on the basis of relative student populations of those colleges for the school year in which student membership elections are held.] Students with no declared major shall be represented through the College of Arts and Sciences. [Yearly adjustments shall be made to keep apportionment equitable, with the student membership maintained at 40.] Each elected student member shall be a junior, senior, graduate or professional student, and shall not be on either academic or disciplinary probation and shall serve for a term of one year and shall be eligible for re-election as often as he remains a full-time undergraduate, graduate, or professional student in the University System. If a student member should at any time become ineligible to serve (e.g., by relinquishing his position as a full-time student, being placed on academic probation, or violating the Senate attendance regulations), the administrative head of the group represented shall declare a vacancy and designate that member from the eligible student body who at the last election received the next highest vote to serve for the duration of the elected student member's ineligibility.

The ex officio membership shall include the President, all Vice Presidents, all Deans, Director of the Libraries, the Professor of Military Science, the Professor of Air Science, the faculty [and student] members of the Board of Trustees, and the chairmen of the several standing University Senate Committees, including Senate advisory committees, if not already members of the Senate. Other ex officio members may be added by the University Senate Council for the purpose of supplying information and viewpoints on problems considered by the Senate. Ex officio members shall enjoy all the privileges of the elected membership except the right to vote.

(No other changes in THE UNIVERSITY SENATE section)

#### STATEMENT MADE BY MR. STEVE BRIGHT

I HAVE ALREADY SAID IN THE UNIVERSITY SENATE THAT THE PROPOSAL TO INCREASE STUDENT MEMBERSHIP TO 40 IN THAT 200-MEMBER BODY IS A VERY MODEST SUGGESTION. I CAN HARDLY PRETEND TO BE HAPPY ABOUT THE VERY SIGNIFICANT REDUCTION OF THE NUMBER OF STUDENT REPRESENTATIVES.

I have been told that "half a loaf is better then none." I have always had considerable difficulty accepting that idea, and I have even more difficulty accepting a little less than half.

MY DISAPPOINTMENT IS GREAT.

BUT MY CONVICTIONS ON THE NEED FOR SIGNIFICANT, LEGITIMATE STUDENT PARTICIPATION IN MATTERS WHICH AFFECT THE LIVES OF THE 17,000 YOUNG MEN AND WOMEN AT THIS UNIVERSITY HAVE BEEN ENTERED IN THE MINUTES ON SEVERAL PREVIOUS OCCASIONS.

I SEE NO NEED TO REITERATE MY RATIONALE AT THIS TIME, OR TO DWELL ON THE UNHAPPY ASPECT OF THE BUSINESS BEFORE US AT THIS TIME.

INSTEAD, I WOULD LIKE TO LOOK AT THE POSITIVE APSECTS OF THE PROPOSAL,

I CANNOT OVERLOOK THE MAJOR PSYCHOLOGICAL BOOST WHICH THE STUDENT BODY RECEIVED WHEN THE ORIGINAL PROPOSAL WAS APPROVED BY THE UNIVERSITY SENATE BY A VOTE OF 100 TO 59, AND RECOMMENDED TO YOU BY THE PRESIDENT.

THIS IMPORTANT VOTE OF CONFIDENCE HAS DONE MUCH TO RESTORE THE RELATIONSHIPS BETWEEN THOSE WHO MUST WORK TOGETHER ON OUR CAMPUS DAY-BY-DAY-THE STUDENTS, FACULTY AND ADMINISTRATION.

INDEED, THE ADOPTION OF THIS PROPOSAL WILL HELP TO REDUCE THE BARRIERS WHICH SEPARATE THOSE THREE GROUPS.

IN ADDITION, THE PROPOSAL, AS BEFOREYOU NOW, WOULD ALLOW MUCH MORE ACCURATE AND EXTENSIVE STUDENT INPUT THAN HAS EVER BEEN THE CASE IN THE PAST.

THE NEW MODEL OF STUDENT REPRESENTATION SET FORTH IN THE PROPOSAL WILL INSURE A DIVERSITY OF STUDENT OPINION AND MAXIMIZE THE VALUE OF STUDENT PARTICIPATION. EACH COLLEGE WOULD BE REPRESENTED. WITH SEPARATE ELECTIONS IN EACH COLLEGE, NO ONE GROUP OR NO ONE POINT OF VIEW WITH A CONCENTRATION OF STRENGTH IN A PARTICULAR AREA CAN DOMINATE THE CHANNELS AVAILABLE TO STUDENTS IN THE SENATE.

VOTING PARTICIPATION IN THE BODY WILL OFFER ACCESS TO UNDERSTANDING THE IMPORTANT DIFFICULTIES OF FORMULATING AND APPLYING POLICIES. IN ADDITION, IT SOLIDIFIES A BASIC SENSE OF OBLIGATION TOWARD THE SYSTEM OF GOVERNANCE.

STUDENTS SHOULD AND DO HAVE SOMETHING TO SAY ABOUT THE QUALITY OF EDUCATION AT THE UNIVERSITY OF KENTUCKY. AND THERE IS NO MORE APPROPRIATE PLACE FOR THEM TO SAY IT THAN IN THE UNIVERSITY SENATE.

If the past is any indication, you can expect the student members of the Senate to respond to their responsibility with active and full participation. The student members of the Senate have been conscientious, very hard working and most active. They have spent considerable time and energy outside of the Senate becoming familiar with pending business and studying alternatives. They have not hesitated to put forward their proposals or opinions.

ALTHOUGH I AM OF COURSE DISAPPOINTED THAT THE PROPOSAL IS NOT BEING ADOPTED AS ORIGINALLY RECOMMENDED, I STRONGLY URGE THE ADOPTION OF THE PROPOSAL BEFORE YOU AT THIS TIME.

### EMPLOYMENT OF AUDITORS FOR 1970-71

Recommendation: that the Board of Trustees engage the firm of Peat, Marwick, Mitchell and Company, Certified Public Accountants, to perform an independent audit of the financial statements of the University of Kentucky, the University of Kentucky Research Foundation, The Fund for the Advancement of Education and Research in the University of Kentucky Medical Center, the University of Kentucky Athletic Association, for the fiscal year ending June 30, 1971 for a fee, including expenses, of not more than \$40,000.00.

Background: The firm of Peat, Marwick, Mitchell and Company examined the accounts of the University of Kentucky and affiliated corporations for the fiscal year ended June 30, 1970. The audit was both thorough and timely. The experience of the members of the firm in the examination of accounts of colleges and universities enables them to render an audit report which verifies the fiscal status of the University and evaluates the integrity of fiscal controls. The firm also possesses the ability to evaluate policies, procedures and practices utilized in fiscal management. This ability is especially valuable to administrative officers responsible for the conduct of financial administration.
