

PREFACE

The <u>Inventory of Federal Archives in the States</u> is one of the products of the work of the Survey of Federal Archives, which operated as a nation-wide project of the Works Progress Administration from January 1, 1936 to June 30, 1937, and has been continued since that date as a unit of the Historical Records Survey, also operating as a nation-wide project of the Works Progress Administration, and a group of state or local projects of that Administration.

The plan for the organization of the Inventory is as follows: Series I consists of reports on the administration of the Survey, acknowledgments, and general discussions of the location, condition, and content of federal archives in the states. Succeeding series contain the detailed information secured by workers of the Survey, in inventory form, a separate series number being assigned to each of the executive departments (except the Department of State) and other major units of the Federal Government. Within each series No. 1 is a general introduction to the field organization and records of the governmental agency concerned; the succeeding numbers contain the inventory proper, separate numbers being assigned to each state in alphabetical order. Thus, in each series, the inventory for Alabama is No. 2, that for Arizona No. 3, that for Arkansas No. 4, etc.

For each local office information regarding each series, or unit of related records, is presented in the following order: title, inclusive dates ("to date" indicating an open file at the time the information was secured), general description of informational content, description of the system of filing or indexing (if any), a statement of frequency and purpose of use, form of the record itself (bound volumes, sheets in folders, etc.), linear footage, description of the containers, physical condition of the records (not stated if satisfactory), location by room number or other identifying information, and finally, the number of the Form 58SA on which this information was originally recorded by a Survey worker and from which it was abstracted for the Inventory. This form is on file in The National Archives. When it contains substantial information on addenda sheets which has not been included in the mimcographed abstract, indication of this is given by use of the reference "See addenda."

In Arizona the work of the Survey was directed by Dr. H. A. Hubbard of the University of Arizona, with Mrs. Meryl E. Morgan as his assistant, until June 30, 1937. Since that date the state project has been directed by Mrs. Morgan. This inventory of the records of the Department of Justice in Arizona was prepared in the Phoenix branch office of the Survey, with Mr. G. V. Hays as chief editor. It was edited before final typing

by Mr. A. R. Kooker of the Washington office.

A Deputy Marshal was first stationed at Globe, Arizona in 1910, under the old Federal Court system and the office has been maintained since the reorganization of the Federal District of Arizona. This office handles the Marshal's business in the northeast portion of the state.

The present office of United States Attorney was created in February 1912. Prior to that time a prosecuting attorney's office was maintained in connection with the old territorial District Courts, but with the advent of statehood in 1912 a new Federal District Court was organized known as the District of Arizona, and simultaneously the office of United States Attorney was established for such district. Headquarters have been variously at Tucson and Phoenix, the present incumbent being located at Phoenix with assistants at Tucson. All of the closed criminal case files numbered from 1 to 1967, with the exception of numbers 1674 and 1952, were destroyed in 1929 but none of the present office force can advance any reason as to why this was done. Cases tried in the Phoenix and Prescott divisions of the District Court are handled by this office.

Originally the Marshal's headquarters were at Phoenix with a Chief Deputy at Tucson. In 1933 a newly appointed Marshal moved the headquarters to Tucson and now stations his Chief Deputy at Phoenix.

The office of United States Marshal for Arizona was created in 1863 following the organization of Arizona's territorial government. During the years preceding statehood the Marshal's office was maintained at the Territorial Capitol which at different times was at Prescott, Tucson and Phoenix. With the coming of statehood in February 1912, headquarters were established at Phoenix and remained there until 1933, during which year a newly appointed U. S. Marshal moved the office to Tucson, where it has remained since.
