I'll get things started with the following question.

At present, the "Green Bean" serves primarily as an announcement sheet for meetings and job opportunities (an important service, to be sure). What additional kinds of information should be included?

Some suggestions have already come my way.

- 1. Articles submitted by staff members to describe the primary functions and services of the various departments and branches. The articles would especially benefit new staff who have been unable to take advantage of the excellent branch tours.
- 2. Reports from committees (including university and association committees) and departments on new and ongoing projects.
- 3. New book and article announcements of interest to the UK library community. Even with our excellent journal routing system, keeping up with the literature is difficult—the growing number of relevant journals can hardly be read by any one individual. If you read an article that might be of particular interest to a "Green Bean" reader, send the citation or a summary to me.
- 4. Paper and article summaries. If you've heard, read, or written a paper or article you wish to share, put a summary in the "Green Bean."

The Center for Research Libraries

Because of our membership in the CRL, we have access to a massive collection of materials. The collection is especially strong in foreign doctoral dissertations; foreign, U.S., and state government documents; area study materials; and newspaper backfiles.

Since 1981, the Center has added its records to OCLC and is now adding retrospective records. The CRL microfiche catalog and an explanatory brochure are available in Reference and ILL.

Kentucky Council on Archives

The Kentucky Council on Archives, an association of archivists, historians, librarians, record managers, and others, promotes cooperation and information exchange and encourages "repositories to properly administer archival materials."

Recent topics at the fall and spring meetings have included an overview of archives in Kentucky, religious archives, conservation and preservation techniques, oral history, and information systems for wider accessibility to archival holdings. The biannual newsletter, The Kentucky Archivist, comes out prior to each meeting.

Membership is open to any interested individual or institution. Dues are \$6. See Rob Aken for applications.

University Microfilms International

On November 1, UMI will begin offering the UMI Article Clearinghouse, a new document delivery system. Articles can be ordered electronically from 'more than seven thousand of the most frequently indexed and requested periodicals ...(with) prices (ranging) from \$4 to \$6 per article for deposit accounts, and from \$8 to \$10 for credit card billing..." Most files extend back to 1978. The catalog and electronic ordering capability will be available on the OCLC IIL subsystem; articles will be shipped within 48 hours of ordering by first class mail.
