I left Kentucky when I was 22 years old and traveled to Hingham, Mass. to join the novitiate class of the Maryknoll Fathers and Brothers. I was idealistic, naive, vulnerable, and inexperienced in the harder lessons of the world. I was in search of identity, hope, love, family, and a way to find my own gifts so I could give them to others.

The next seven years as a seminarian, in what thankfully turned out to be a progressive Catholic missionary order, gave me real experience of brotherhood (old terminology) and community. During my overseas stint in Korea, culture chock knocked me on my ass as I was challenged to learn a new language, eat strange food (spicy!) and experience being a foreigner and minority person for the first time. I thought I would surely go crazy at times but the Korean people took me in, protected me, and taught me. I came back to the States with a deeper sense of self, a different view of the world, and an adventurous and less fearful spirit. (In case you're wondering comrades, while in Korea I fell in love with a classmate from Pennsylvania, had a brief "first time affair" and found a wonderful new energy inside that sustained me the next 2 1/2 years in Asia).

My desire for community today is just as real and important to me here in Lexington as it was in Hingham or Korea. I think often about where we are in building our gay, lesbian, bisexual, and transgendered community. I think of how we can become

## LEGISLATIVE UPDATE: REACH OUT AND JUST SAY NO

Kentucky Rep. Danny Ford, a Republican (surprise!) from Mount Vernon has filed a floor amendment to replace the bill with a measure that would overturn a 1992 state Supreme Court decision by giving the legislature the right to recriminalize sodomy, even between consenting adults of different sexes. "I think an antisodomy amendment would be far more acceptable to the people than one aimed at destroying the two-party system in this state," Ford said. The amendment has been offered to be attached to HB 219 (the redistricting bill sponsored by Greg Stumbo). There has been no vote yet on whether to accept this amendment. If it is accepted, it will gut HB 219 and change if from a redistricting bill to one to recriminalize sodomy

A similar Ford measure in 1994 killed a House amendment that would have allowed legislative committees to cancel certain state contracts between legislative sessions. House Democratic leaders killed the bill to avoid a vote on the sodomy issue, which was being pressed by social conservatives. New House rules make Ford's latest measure clearly out of order, but he said he will make a motion to force a vote on the issue.

According to David Williams, editor of The Letter, two more pieces of anti-gay legislation have been introduced in the House. The first is an amendment to SB 68 which would provide that: "If any resident of this state marries in another state, the marriage shall be valid if valid in the state

where solemnized, provided however, that in no case shall a marriage between persons of the same gender be recognized as valid."

The 2nd bill (HB 500) provides that "A marriage between members of the same sex which occurs in another jurisdiction shall be void in Kentucky," and further provides that any marriage between members of the same sex performed in or out of Kentucky "shall be void." The Fairness Campaign is asking that people call the above 800 number with a message for their House representative that they "oppose House Bill 500." The sponsors of the two anti-marriage bills introduced today are Kathy Hogancamp (House floor amendment 1 to Senate Bill 68) and Sheldon Baugh (HB 500).

We at the GLSO News urge you to call your representatives, you can call 1 800 372-7181 with a message for your House representative telling them that you oppose the Ford amendment to House Bill 219, House floor amendment 1 to Senate Bill 68, and House Bill 500. People can also fax a message to the legislature at 502 564-6543.


Phone calls against the amendment are coming in and are apparently being heard! Linda says that the calls are working, so keep things up.

It seems to me that, for the time being, the gay and lesbian community can breathe more easily, as it appears there will not be a vote on this matter until sometime late next week at the earliest. This doesn't mean we should let our guard down; continued pressure through phone calls, letters, and email is needed. And this breathing space will definitely give the religious right time to rally their troops and inundate Frankfort with messages supporting Floor Amendment One to House Bill 219. So we need to keep up the fight. On the other hand, I understand that HB 219 is Greg Stumbo's baby and he will do everything to see that it gets passed and is not gutted by such amendment.

Finally, Danny Ford says that he wants to force a vote on the issue anyway. Why? So that the Republicans can get on record just who is "pro-

sodomy" and who isn't. Paul Patton refused to back a sodomy amendment during the gubernatorial election, and so Frank Simon labeled him "pro-sodomy" and worse. Any Democrat or Republican who is seen to vote against Floor Amendment One will be considered "pro-sodomy" and you can bet the Republicans will use this against them in the fall elections.

At print time the legislation was still unresolved. Please stay informed and continue to call your representatives and let's keep up the fight.▼

## LESBIAN APPEALS CHILD'S CUSTODY TO CONVICTED MURDERER

TALLAHASSEE — The father is a convicted murderer but the mother is a lesbian, so a judge decided that the couple's 11-year-old girl should live with dad. "This child should be given the opportunity and the option to live in a nonlesbian world," wrote Circuit Judge Joseph Tarbuck of Pensacola in his ruling awarding primary custody to the father and giving the mother, Mary Ward (with whom their daughter has lived since 1992) only standard visitation rights. The judge cited Mary Ward's relationship with a woman, another relationship between two other women around the house and the showing of R-rated movies there. "I don't condemn the mother of this child for living the way she does," Tarbuck said. "But I don't think that this child ought to be led into that relationship before she has a full opportunity to know that she can live another lifestyle if she wants to."

Ms Ward, has asked the 1st District Court of Appeal to reverse Tarbuck's ruling. Lawyers for the 46-year-old Pensacola woman say the case marks Florida's first chance for a ruling on whether sexual orientation can be a deciding factor in child custody cases. "We think this case is very important," Charlene Carres, a Tallahassee lawyer representing Mary Ward, "We feel sexual orientation is not relevant to someone's ability to raise children well."

Supreme courts in eight other states have said a homosexual parent should not automatically be denied custody. Five others have ruled the opposite. The U.S. Supreme Court has never dealt with the question.

The Wards married in 1983 shortly after the husband was released from prison where he served time for murdering his first wife, Judy, in 1974. Ward pleaded guilty to second-degree murder for shooting his first wife in the parking lot of a Pensacola restaurant after they argued over custody of their children. Ward was questioned about the slaying during the custody hearing, "I done my time for it, and it was something that shouldn't have ever happened," he said. "It was stupidity, jealousy and anger."

Tarbuck made his ruling in August in an order modifying the final divorce judgment, giving the father primary custody and the mother standard visitation rights. He did not comment on the killing when he ruled on the custody question but said Ward would give his daughter ''decent living accommodations'' and that nothing derogatory had been said about his new wife, Rita.▼

## GINGRICH SHOWS SHOCKING IGNORANCE ON HIV MILITARY POLICY

House Speaker Newt Gingrich , at a recent appearance in Georgia commenting on a letter that he received from "Magic Johnson" last week stated that Johnson doesn't understand "the nature of being in the military, the danger of being in combat and what happens in a field hospital if you have people bleeding, people wounded and you don't have any idea who has HIV. He went on to call the President "totally irresponsible" for his stance on the amendment.

Johnson wrote to ask Gingrich and Senate Majority Leader Bob Dole to help pass legislation to repeal the measure to discharge all service members with the virus that causes AIDS. The measure was part of the defense authorization bill signed into law by President Clinton last week. Clinton himself has

said that in his estimation the measure is unconstitutional and has directed the Justice Department not to defend it in court. The amendment was attached by California Republican Representative and very vocal homophobe, Bob Dornan.

"The speaker is making a big mistake if he thinks he can go one on one with Magic Johnson on this issue," said Daniel Zingale, the Human Rights Coalition's political director. "Clearly, it is Speaker Gingrich who does not understand the realities of the U.S. military. Service members who test positive for the AIDS virus are not engaging in warfare or spending time in military field hospitals — contrary to Gingrich's statements."

Service members with the virus that causes AIDS currently are allowed to serve their country as long as they can perform their duties, but they are not deployed overseas. The same policy is applied to service members who have other chronic medical conditions such as diabetes, asthma, heart disease or cancer.

The Pentagon has said that about half the HIV-positive service members are married, and on average, have served for a decade. Nearly 20 percent of them are officers. The Pentagon said Thursday it hopes to reverse the provision. Department spokesman Ken Bacon said the Pentagon has "several lines of defense" on the matter, the most desirable being legislative action by Congress. Bacon said Sens. Sam Nunn, D-Georgia, Barbara Boxer, D-California, and Ted Kennedy, D-Massachusetts, have all suggested they may take action in Congress to overturn the provision. A repeal bill was introduced in the House on Feb. 1 by Reps. Peter Torkildsen, R-Mass., Jane Harman, D-Calif., Connie Morella, R-Md., and Ron Dellums, D-Calif. It is expected to be introduced in the Senate by Sens. William Cohen, R-Maine and Edward Kennedy, D-Mass. Currently, the bill has 90 co-sponsors in the House and 36 in the Senate.▼

## SAME-SEX MARRIAGE BAN OK'D

OLYMPIA — Saving there is "a compelling state interest" in recognizing that marriage is intended between men and women, for procreation and for development of children, the Washington state House voted on Saturday to prohibit same-sex marriages. Several lawmakers said the language sounded much like Catholic Church doctrine known as the "Baltimore Catechism" — the primary instruction given by the church to all Catholics. The intensely emotional debate left some Democrats sobbing quietly in the back of the House chamber after the 60-36 vote for House Bill 2262, which could be presented to all state voters this fall. The bill contains a clause sending it to a public vote.

"Does love between a man and a man hurt us more than hate against a man and a man?" said Rep. Mary Lou Dickerson, D-Seattle. "This vote is a vote between love and hate ... between courage and fear."

State law currently does not recognize same-sex marriages, prompting House Minority Leader Marlin Appelwick to say, "This is addressing a problem that doesn't exist. It's a fight we should not be picking."

## GLAAD CRITICAL OF NEWSPAPER'S DISCRIMINATION AGAINST GAY EDITOR

According to The Gay & Lesbian Alliance Against Defamation (GLAAD), Todd Camp, the openly gay graphics editor of the Fort Worth Star-Telegram's children's section, who also worked for a gay community newspaper, The Texas Triangle, was removed from his original post after the paper's Executive Editor, received a letter from from the Fort Worth chapter of the American Family Association (AFA).

"This is a shocking example of discrimination," said William Waybourn, GLAAD's

Managing Director, "Camp's work for The Texas Triangle has no bearing on his competency. Job performance should be based solely on job related criteria. This transfer shows the crucial need for workplace protections for lesbians and gay men, especially since Texas is one of those states where lesbians and gay men can be fired without recourse."

This evidently part of AFA's campaign to drive the Texas Triangle out of business. In December, they threatened advertisers of the weekly paper with dissemination of their names to local preachers and broadcasting their names on a local radio station advocating a boycott. The Star-Telegram has actually been praised by local gay organizations in the past for offering domestic partnership benefits to same gender employees and for being one of the leading papers in Texas to support gay rights. "It saddens us to hear that a paper, like the Star-Telegram, which has had a good track record with the gay community, has buckled to the pressure of the Radical Right," said Chuck Donaldson, Interim Chair of the GLAAD's Dallas chapter, "By caving in to the AFA, the Fort Worth Star-Telegram has opened a Pandora's Box to future transfers and/or firings. If you don't think this will affect the rights of reporters to cover stories on the AFA and other extreme right organizations, then think again."

## SCHOOL CENSORS GAY POLICY LETTERS

MERRIMACK, N.H. — High school principal Timothy Mayes has censored two letters to the school newspaper, citing concerns that they violate the district's policy restricting discussion of homosexuality.

The letters are critical of the policy, which bans anything that has the "purpose or effect of encouraging or supporting homosexuality as a positive lifestyle alternative." A group of local, concerned parents have filed a suit to overturn the policy which has led to drastic curriculum modifications, including censoring Shakespeare's The Twelfth Night.

## ANTI-MARRIAGE BILLS SPREADS ACROSS STATES

## NATIONAL FREEDOM TO MARRY COALITION FORMED IN RESPONSE

Washington, D.C., Feb. 8, 1996...Aided by an unprecedented national coalition of gay movement groups focused on winning and keeping the freedom to marry, gay, lesbian, bisexual and nongay activists around the country are fighting a rash of anti-marriage bills. With state legislatures in session for hardly a month,the bills have been introduced by Radical Right lawmakers to block recognition of same-sex couples' marriages in 18 states.

Although gay and lesbian couples cannot legally marry in any state, archconservative legislators are attempting to rush through antimarriage bills in Alabama, Alaska, California, Colorado, Georgia, Hawaii, Idaho, Illinois, Iowa, Kentucky, Missouri, New Mexico, Rhode Island, South Carolina, South Dakota, Tennessee, Virginia, and Washington. The measures would declare that a couple's legal marriage from one state would not be recognized when they crossed the border to another state. In addition, an anti-gay ballot measure in Oregon, if passed this year, would prohibit same-gender couples' civil marriages as well as overturn gay-inclusive nondiscrimination laws.

"The goal of these anti-marriage bills is to shut down the public discussion that has begun around the injustice of denying same-sex couples the freedom to marry," said Evan Wolfson, Lambda Legal Defense and Education Fund Marriage Project director. "The state attacks offer us an excellent opportunity to push our political and educational work alongside the legal efforts that will us the freedom to marry."

Numerous media reports, editorials and talk show programs have already addressed the unfairness of denying the freedom to marry to gay people. For example, the Economist magazine endorsed equal marriage rights in a cover story, the Des Moines Register opposed a local anti-marriage bill, and Oprah and Nightline have covered the struggle.

Last year, measures to block recognition of marriages were defeated in Alaska and South Dakota. Unfortunately, Utah passed such a measure, which civil rights groups have vowed to challenge in court. So far this year a measure in Maine was withdrawn by its sponsor after public uproar.

Although each measure is worded slightly different, most of the bills are virtually identical. For example, California's A.B. 1982 states, "A marriage contracted outside this state between individuals of the same gender is not valid in this state." The bill was passed 41-31 by the Assembly last month, with a Senate battle still to come. South Dakota's House Bill 1143 goes a step further, stating, "Marriage is a personal relation, between a man and a woman, arising out of a civil contract to which the consent of parties capable of making it is necessary. Consent alone does not constitute a marriage; it must be followed by a solemnization."

According to Robert Bray, National Gay and Lesbian Task Force (NGLTF) media director. "Marriage is a basic human right. And whether I choose to get married or not, that choice should be mine and my partner's to make — not Pat Robertson, Lou Sheldon, Newt Gingrich or homophobic state lawmakers."

The National Freedom to Marry Coalition, comprised of more than 250 organizations, is helping activists battle the bills, educate communities and brief the media. It has sponsored a Freedom to Marry sign-on resolution, which has gathered hundreds of signatures from individuals and organizations, including religious leaders.
