Buell that the Board of Trustees express their disapprobation of the appropriation of \$280 for the Military Department in excess of the appropriation made at their first meeting during the year, but they confirm the appropriation. Adopted, Mr. Gibson not voting. Moved & adapted that the resignation of Mr. W. L. Davis, is accepted with great regret. The committee on nominations consisting of Judge Hagan, Maj. P. P. Johnston & Hart Gibson reported the following Executive Committee, W. B. Kinkead, Dr. R. J. Spurr, R. A. Spurr, D. H. James & Jno. F. Hager with Judge W. B. Kinkead as Chairman. General Buell submitted his report on "Salaries." The Board of Trustees adjourned until 3 O'Clock P. M. The report of General Buell was accepted & adopted & ordered to be filed. The report of Maj.
