AUTHORIZED BY THE ACT OF CONGRESS, C.S.A. OF AUGUST 19. 1861.

On the first day of January 1878. The Confederate States of America will pay to the Bearer of this Bond, at the Seat of Government or such place of Deposit as may be appointed by the Secretary of the Treasury, the sum of **ONE HUNDRED DOLLARS** with Interest thereon from this date payable at the same place, semi-annually, at the rate of Eight per Cent. per annum, on surrender of the annexed Warrants or Coupons. This debt is authorized by an Act of Congress, approved August 19, 1861, entitled "An Act to authorize the issue of Treasury Notes, and to provide a War Tax for their redemption."

In Witness whereof the Register of the Treasury, in pursuance of the said Act of Congress, hath hereunto set his hand, and affixed the seal of the Treasury at RICHMOND.
