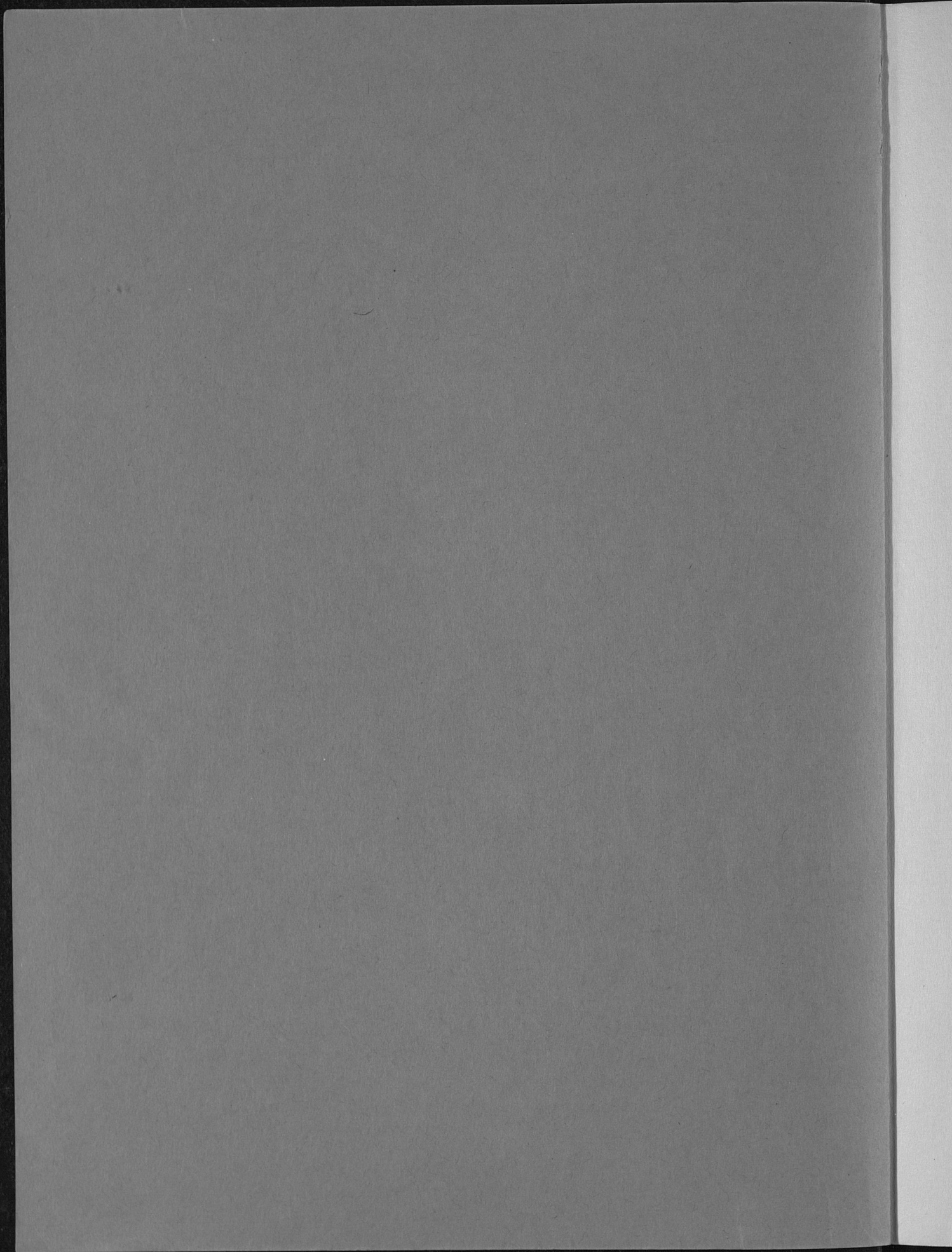

PREFACE

The Inventory of Federal Archives in the States is one of the products of the work of the Survey of Federal Archives, which operated as a nation-wide project of the Works Progress Administration from January 1, 1936 to June 30, 1937, and has been continued in Mississippi since that date as a state project of that Administration.

The plan for the organization of the Inventory is as follows: Series I consists of reports on the administration of the Survey, acknowledgments, and general discussions of the location, condition, and content of federal archives in the states. Succeeding series contain the detailed information secured by workers of the Survey, in inventory form, a separate series number being assigned to each of the executive departments (except the Department of State) and other major units of the Federal Government. Within each series No. 1 is a general introduction to the field organization and records of the governmental agency concerned; the succeeding numbers contain the inventory proper, separate numbers being assigned to each state in alphabetical order. Thus, in each series, the inventory for Alabama is No. 2, that for Arizona No. 3, that for Arkansas No. 4, etc.

For each local office information regarding each series, or unit of related records, is presented in the following order: title, inclusive dates ("to date" indicating an open file at the time the information was secured), general description of informational content, description of the system of filing or indexing (if any), a statement of frequency and purpose of use, form of the record itself (bound volumes, sheets in folders, etc.), linear footage, description of the containers, physical condition of the records (not stated if satisfactory), location by room number or other identifying information, and finally, the number of the Form 58SA on which this information was originally recorded by a Survey worker and from which it was abstracted for the Inventory. This form is on file in The National Archives. When it contains substantial information on addenda sheets which has not been included in the mimeographed abstract, indication of this is given by use of the reference "See addenda."

In Mississippi the work of the Survey was under the direction of Mr. Stanley C. Arthur, regional director for Arkansas, Louisiana, and Mississippi, with Mr. George E. Schilling as state supervisor, until June 30, 1937. Since that time Mr. Schilling has been in charge of the state project. This Inventory of the records of the Federal Courts in Mississippi was prepared in the New Orleans office of the Survey under the direction of Mrs. Norris Fazekas, editor-in-chief and assistant state supervisor, and was edited before final typing by Dr. Richard R. Stenberg of the Washington office.

INTRODUCTION

The Act of Congress of April 7, 1798, which established Mississippi Territory, provided for a Superior Court of three judges; the act was amended May 10, 1800, so as to lay down a more definite program of government. The Territorial legislature conferred upon the Superior Court the title "Supreme Court of the Mississippi Territory," giving it appellate jurisdiction over all matters originating in the county courts. It also provided that this court should act as a circuit court to sit in Adams, Jefferson, and Claiborne Counties once each year. It had civil jurisdiction in cases involving amounts in excess of \$200.

By Act of Congress of March 27, 1804, an additional judge for Mississippi Territory was provided, to sit "at Tombigbee near Washington." An act of the Territorial legislature gave this judge the same powers as those of the Supreme and circuit courts, and also provided for a competent number of justices of the peace in each county. These justices acted as committing magistrates, had final jurisdiction over crimes involving fines of less than eight dollars and had civil jurisdiction in matters up to \$20.00; any three justices of the peace constituted a county court, a court having jurisdiction over cases involving less than \$100, probate matters, and the care of orphans, from whence arose its colloquial name of "Orphan's Court." An act of the Territorial legislature of May 10, 1803, incorporated the town of Natchez and conferred upon the mayor certain judicial powers out of which grew the "Mayor's Court," which had jurisdiction of a nature similar to that of the justice of the peace court.

Although the United States had been in physical possession of the area now known as the State of Mississippi since 1798, it was not until March 3, 1805, that Congress provided that the superior courts in the territories should have Federal jurisdiction until a Federal court should be established. "The Superior Court of Law" in Mississippi, therefore, was the Federal judiciary in Mississippi Territory until April 3, 1818, a year after Mississippi had been given statehood, when Congress provided for a Federal district court for the new District of Mississippi. This court sat at the state capital, Washington, Adams County, until April 1822, when Congress authorized its removal to Natchez, where it sat in the newly erected Adams County Courthouse. On March 3, 1835, Congress authorized its removal to the newly established state capital, Jackson, situated at the geographical center of Mississippi and named in honor of General Andrew Jackson.

On June 18, 1838, Mississippi was divided into two judicial districts. Court for the Southern District sat at Jackson, while that for the Northern District sat at Pontotoc. In 1866 the court at Pontotoc was removed to Oxford, where it presently sits.

The Southern District of Mississippi is now composed of four divisions, namely, the Jackson, Western, Eastern, and Southern divisions.

The district court for the Southern District has been domiciled at Jackson since March 3, 1935, being interrupted only during the period of the War Between the States, 1861 - 1865. The Jackson division has jurisdiction over Amite, Copiah, Covington, Franklin, Hinds, Holmes,

Jefferson Davis, Lawrence, Leake, Smith, Scott, Wilkinson, and Yazoo Counties. Terms of court, as fixed by the present statute, are held at Jackson on the first Mondays of May and November of each year.

By Act of Congress of February 28, 1887, the Western division, Southern District was created, with court seat at Vicksburg. This division is comprised of Adams, Claiborne, Humphreys, Issaquena, Jefferson, Sharkey, Warren, and Washington Counties. Terms of court are held at Vicksburg on the third Mondays of May and November of each year.

The Southern division of the Southern District was established by Act of April 4, 1888, with its court seat at Mississippi City, where court was domiciled in the courthouse. On March 2, 1899, the court was moved to Biloxi, where it was housed in the City Hall until April 1, 1918; the court is now located in the U. S. Post Office Building, 240 Lameuse Street. The Southern division includes Forrest, George, Greene, Hancock, Harrison, Jackson, Lamar, Perry, Pearl River, Stone, and Walthall Counties. Terms of court are held at Biloxi on the third Monday of February and the first Monday of June of each year.

An Act of July 18, 1894, established the Eastern division of the Southern District, with court seat at Meridian. This division includes Clarke, Jasper, Jones, Kemper, Lauderdale, Neshoba, Noxubee, and Wayne Counties. Terms of court are held at Meridian on the third Mondays of March and September of each year.

The Northern District of Mississippi is now composed of three divisions, the Western, Eastern, and Delta division.

The district court for the Western division of the Northern District was established by Act of June 18, 1838, at Pontotoc, where it remained until May 18, 1866, when the court was moved to Oxford and domiciled in a red brick building facing the public square opposite the Federal Building; its present site in Oxford is the United States Post Office and Courthouse at North Lamar and Jackson Avenue, which it occupied in 1884. The Western division consists of Benton, Carroll, Calhoun, De Soto, Grenada, Lafayette, Marshall, Montgomery, Panola, Tate, Tippah, Union, Webster, and Yalabusha Counties. Court is held at Oxford on the third Monday of April and the first Monday of December of each year. The old records, stored in the attic of the Federal Building, are continuous from 1838 to the present day, excepting a gap for the period of the War Between the States.

The Eastern division of the Northern District was established in October 1882, with court seat at Aberdeen. The Eastern division includes Alcorn, Attala, Chickasaw, Choctaw, Clay, Lowndes, Monroe, Oktibbeha, Pontotoc, Prentiss, Tishomingo, and Winston Counties. Terms of court are held at Aberdeen on the first Monday of April and October of each year.

The Delta division of the Northern District was established at Clarksdale in October 1912, in the U. S. Post Office and Courthouse, where it remained. The Delta division consists of Bolivar, Coahoma, Leflore, Quitman, Sunflower, Tallahatchie, and Tunica Counties. Court is held at Clarksdale on the fourth Monday of January and the third Monday of October of each year.

Circuit courts were established concurrently with district courts in Mississippi. The circuit courts maintained quarters in the various buildings occupied by the district courts and its sessions were frequently concurrent with those of the district court. In some instances records of both courts were kept in the same files. The Act of Congress of March 3, 1911, abolished the circuit courts.

When the Federal court was moved from Pontotoc to Oxford on May 18, 1866, court sessions were held in the old brick building facing the public square nearly opposite the present post office building. Since 1884, when the U. S. Post Office and Courthouse was erected, the court has held its sessions in the rooms set aside for its use therein. In 1936 extensive remodeling was done and the old court records, stored in the attic, were moved several times. Many of these old court documents have been offered to the National Archives.
