I have been affiliated with the club work in Kentucky since the organization of the Federation of Clubs work in the State; and was at one

time a vice-president of the State Federation.

I have always been on the Board of the Ky. Equal Rights Asso. in various offices.

I am vice-president at-large of the Southern States Woman Suffrage Confeagace.

I am a member of the W.C.T.U., and was for a long time the State Superintendent of the Frenchise Department. Occasionally I make temperance speeches; but anally I limit mysely to the subject of suffrage.

My dear Miss Dunlap,

Your letter of the Ist inst. is at hand; and I am sending some press material, and ,under another cover, a photograph.

The personal sketch, written mostly by Miss Blackwell, is entirely too long, but you can cut it to suit yourself.

I am very glad that I shall be able to go to Iowa to help in your great campaign; and I shall be perfectly willing to go on the automobile tour, or otherwise, as suits you best. I travelled part of the time in Mansas in an auto, making out-of- door speeches principally, and enjoyed it. If it interrupts your proposed tour to have me stop before June third I will stay until that time; but at present I do not think I can stay till the 5th of June. I am going to St. Louis with the Mentucky part to the Democratic Convention, and must be at home a short time before that.

I have just been sending off press material to Mrs. Walter thorp, to advertise the Miss. Valley Conference; and she asked me to give my church affiliations and activities, as well as that with clubs, etc. It has

on Sundays an address I have used with acceptance by evangelical people called a "Bible Reading; The Bible for Equal Rights". I am a member of the Protestant Episcopal Church; and whilst the discipline of our church does not allow women to occupy its pulpits, I have several times addressed the Diocesan Council of the Diocese of Lexington on church subjects. When I was in Kansas the management said they did not expect me to speak on Sunday; and I told them that if any of the churches would like to hear this Bible Reading I should be glad to give it on Sunday. Itxmpress happened that some church every Sunday wanted to hear it; and I really think that was as useful work as any I did in Kansas. I have used this Bible Reading in evangelical churches of every denomination, it seems to me, except in my own.

I also give a Peace speech, with a large bearing on suffrage, which some churches and audiences may think more appropriate for sunday than a gregular suffrage sppeech. Though I am a member of the w.C.T.U. I have always thought it the best policy never to link temperance and the suffrage cause together; and I shall not do so in Iowa, unless you request it specially. Please let me hear from you on this point, so that if you wish me to do so I shall be prepared.

Any suggestions about my speeches will be gladly received by me; and I would like to hear them as soon as possible, as I shall begin at once to arrange my addresses for your campaign. Tell me how long my shortest speech should be, and how long the longest one should be. You see I want to be prepared as you have laid out the campaign.

My Dear Miss Clay:

Thank you for the photographs and press material.

Of course, our speaking will close June 3, but we shall be glad to have you as our guest until after the election day, if you find it convenient to stay.

I note what you say about the Sunday meetings, and I think we will probably be able to arrange for your speaking in churches on Sunday. The Iowa pastors, as a whole, have been very nice about that. I think "The Bible for Equal Suffrage" is the address to give.

There is so much discussion here about preparedness that we are finding it safer not to mention preparedness any more than we can help. We are trying very hard to keep Suffrage a single issue. The W. C. T. U. of the state is doing splendid work, but we have felt it was wiser for them to do it through theirown organization, and for us to do suffrage work only, so we would prefer that you do not link suffrage with temperance.

I think I have no suggestions for your speeches, except that the Iowa laws are on the whole very fair to women. We have equal guardianship of children and the inheritance laws are fair, so that the general arguments for suffrage of justice and fairness, and that Iowa women have done their share in making this a progressive state, are the best arguments to use. Also the antis are talking a great deal about Colorado, about the increased cost of elections and about increased tax rates, citing California especially in regard to taxes. They are trying rather secretly, to talk about Mormanism also. It is well to have in mind an answer to these arguments.

E Apr. 7, 19 167 #2- Miss Laura Clay, Your longest speech would probably be an hour, and the shortest one fifteen minutes, the average being nearer half an hour. We are so glad you are coming and the newspapers of the state have already given the matter a good deal of publicity. I will write you a little later where you are to begin. Cordially yours, FD-FC

Miss Rebecca Averill, Chairman of the 7th District, called a meeting and arrangements were made by the Franklin League. A "Dutch Treat" luncheon was given at the Frankfort Hotel and Miss Walker, our National organizer, was our guest. Mrs. W. F. Lillard, Chairman of the 8th Congressional District, will call a meeting in Lexington at the Phoenix Hotel next Wednesday, April 19th.

Mrs. Breckinridge entertained suffragists of the 7th District at luncheom yesterday, and made such successful plans that she suggests that we have a get-together luncheon (at the cost of 55 cents) at the expense of the State Association. We think it will pay. Are we authorized by the Board to make such expenditure? The Congressional Committee and Chairmen are new at the work and have no, finances at their command. We hope, in the future, that the Congressional Committee and the District Chairmen will be able to finance their own work. Mrs. Ed C. O'Rear of Frankfort has accepted the Chair man of the Committee to get a suffrage plank in the National Republican Platform at the Chicago Convention June 7th.

Appointments: The President has appointed Miss Emma Hast of Louisville. Chairman of the State Poster Contest Committee and of the National Poster and Slogan Contest Committee. The President has asked Mrs. John Sower of Frankfort, Chairman of our State Publicity work, to also serve as Kentucky Member of the National Publicity Council. She will ask Mrs. J. B. Judah of Louisville, Miss Anne S. Baird of Paducah, and Mrs. Abbie Meguire Roach of Louisville? to act as members of this committee.
