MINUTES OF THE SENATE APRIL 12, 1923

President McVey called the Senate to order in the Little Theatre at 3:55 p.m., Thursday, April 12, 1923.

In the absence of the Registrar, the reading of the minutes was omitted.

The President stated that the principal business was to make recommendations to the Board of Trustees in its quarterly meeting of Apr. 13. next.

For the Graduate School Committee, Dr. F. E. Tuttle reported the following persons as candidates for the honorary degree Doctor of Laws:

George Colvin, of Frankfort, State Superintendent of Public Instruction.
Ellen Churchill Semple, of Louisville, Author and Scholar.

It was moved and seconded, that these names be recommended to the Board of Trustees for this degree, to be conferred at Commencement. The motion was carried.

The President made several announcements and the Senate adjourned.

MINUTES OF THE SENATE MAY 14, 1923

The University Senate met in the Little Theatre Monday, May 14, President McVey presiding.

The minutes of March 12 were read and approved.

Senate approved the request of a group of pre-medical students to organize

an honorary pre-medical fraternity, to be called Xi Chi.

The petition of Tusitalia to be allowed to ask for a charter from one of the national literary clubs was referred to the Dean of Men for a recommendation.

The following recommendations from the College of Arts and Sciences were approved:

- Art 11a,b - changed to Art 11 - 2 hrs. per week - one semester - 1 credit
- Art 14b - changed from 2 credits to 3 credits
- English 121 - Conferences on Life Interests - Juniors and Sophomores, one hour a week. One credit.
- Economics 110 - Business Forecasting. Prerequisite Ec. 107 - 3 credits.
- Economics 109 - Business Law changed to 109a and 109b - 3 credits.
- Economics 111 - Production and Marketing - 3 credits.
- Econ. 4a and b - changed to Ec. 7a-b - extending the laboratory work from two hours a week to four hours a week and giving 4 semester credits instead of 3.

Romance Languages -

- 110a,b - French Literature XIX C - 3 crs. per semester
- 109a,b - French Literature XVII C 3 crs. per semester (108a,b and 109a,b for a 2 year cycle) to replace 102a,b- French Classic Literature of the XVII and XVIII Century.

Vocational Teacher Training

- 165 - Problems in Vocational Home Economics Education - Lectures, Class discussions, individual assignments and reports. Two credits.
- Zoology 7a,7b - Comparative Anatomy - Lecture 1 hour, recitation 1 hour, Laboratory 2 hours per week. 3 credits. (Primarily for pre-medical students.)
- Zoology 8a,8b - Principles of Zoology - Lecture, 3 hrs. per week. Limited to Juniors and seniors and major students in zoology.
- Zoology 106 - Name changed from "Insect Ecology" to "Animal Ecology and Field Biology". Lecture 1 hr., recitation 1 hr. lab. and filed work 2 hrs. per week., Second semester only.

Senate approved also the following provision for independent work for seniors of ability, recommended by the Arts and Sciences faculty:

"Any senior in the College of Arts and Sciences whose standing for his junior year has been not less than 2, may with the approval of the dean and his major professor, register for work in his major subject, which work may be carried on outside of the regular courses of instruction. Credit for this work will be given to the amount of not more than 3 credits, and is conditioned upon the presentation, not later than May 15, of a paper before the staff of his major department. It is understood that any department may ask for such a course under the name of Individual Work in (name of subject)."

Upon recommendation of the Graduate School Committee, the following men were recommended to the Board of Trustees for the degree of Doctor of Laws:
