PREFACE

The publication herewith presented, an index to the probate cases filed in Titus County, Texas, is No. 225 of the Texas series of counties. The publication is intended to meet the requirements of day-to-day usage by the officials of the county, attorneys, businessmen, and other citizens who have occasion to consult probate case records for the proper conduct of their affairs. The publication may be used by historians and genealogists to obtain references to unpublished source material.

The names of the deceased persons, minors, and other principals are arranged alphabetically, with reference to the filing date of the case and the case number. The following numbers in series 1-1230 were not used as case numbers: 18, 57, 194, 202, 226, 227, 240, 277-279, 530-573, 575, 583, 588, 592, 615, 625, 626, 634, 664, 667, 673, 682, 698.

In Titus County all probate records are in custody of the county clerk. The case papers, in individual file jackets, are contained in steel file boxes and are arranged numerically by case number.

Since the transfer of territory from one county to another has affected the venue in probate cases and has determined the county in which the probate case should have been filed, a map and table of territorial changes are included herein. Notations concerning present location and availability of records pertinent to Titus County follow:

Nacogdoches County, records extant.

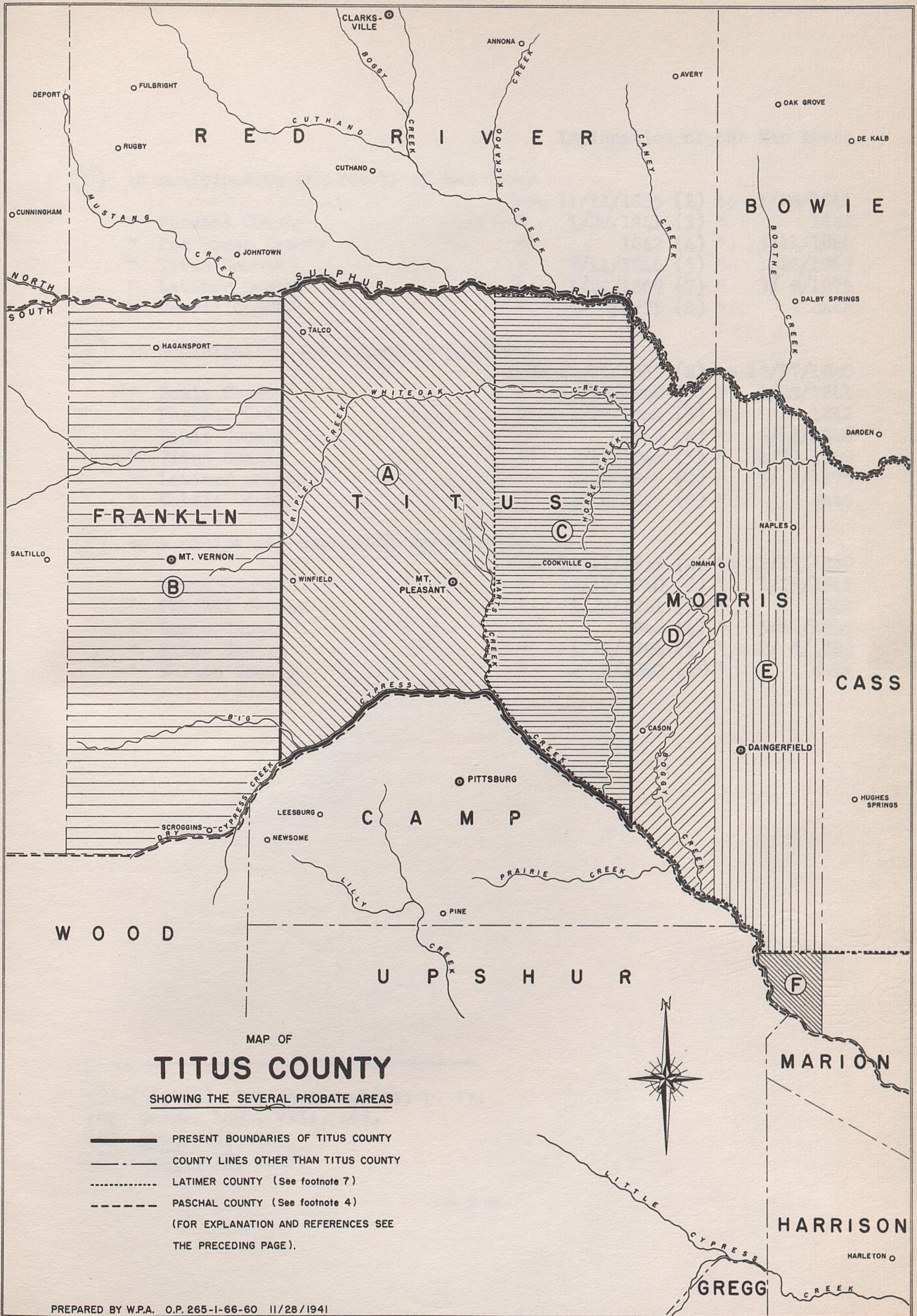
Red River County, records extant.

- (1) It is assumed that the municipality of Nacogdoches had jurisdiction over the territory later called the "Department of Nacogdoches" and which was defined on January 31, 1831. (See Gammel I, 281).
- (2) Gammel, Laws, I, 532. In this act, the municipality of Red River was not given a boundary definition. It is probable, however, that its boundaries were the same as those defined in the 1837 act to "Define the boundaries of Red River County." (See Gammel I, 1431).

- (4) Paschal County was a "judicial" county and acts attempting to create such counties were held unconstitutional by the Texas Supreme Court in 1842. (See Dallam's Texas Reports, Stockton v. Montgomery, p. 473). Therefore the area remained in the original county.

- (7) Ibid., 122. Latimer County was created by declaration of the Constitutional Convention of 1868-69. The assumption is that the county was never organized because: 1) The Constitutional Convention of 1875 did not see fit to recognize it; and 2) In the same year the Legislature created Morris County out of Titus, over part of the same territory Latimer would have occupied. Therefore Area C must have reverted to Titus County.
