MINUTES OF THE UNIVERSITY SENATE November 18, 1940

The University Senate met in the Assembly Room of Lafferty Hall Monday, November 18, 1940. President Cooper presided.

The minutes of October 21 were read and approved.

Professor R. H. Weaver read to the Senate the following report from the Curriculum Committee:

The Committee recommends that the Senate approve the following recommendations from the College of Arts and Sciences:

1. Geology 208. Structural Geology. Three credits. A study of the structural features of the earth's crust with an analysis of the mechanics involved in the production of such structures. (Three lectures and recitations or two lectures and two hours of laboratory. Will vary at different times.)

Prerequisites: Physics la,b; Geology 26a,b; Geology 124 a,b.

2. Geology 125. Methods of Subsurface Correlation. Three credits. Methods of and practice in subsurface stratigraphic work in petroleum geology.

Prerequisites: Geology 122 and 123a,b.

- 3. Drop <u>Geology</u> <u>207a</u> <u>Petrology</u>: <u>Optical Mineralogy</u> and <u>207b</u>, Petrology.
- 4. Geology 212a. Petrology: Optical Mineralogy. Three credits. A study of the optical properties of minerals in thin sections by means of the petrographic microscope. An introduction to the classification of the igneous rocks. One lecture and four hours of laboratory per week.

Prerequisites: Physics la,b and Geology 123a,b.

5. $\frac{\text{Geology}}{\text{sedimentary rocks based on microscopical analysis.}}$ One lecture and four hours of laboratory per week.

Prerequisite: Geology 212a.

6. Reduce the credit of Music 34a,b Advanced Harmony, Dictation and Ear Training from 5 credits each to 4 credits each.

The Committee also recommends the approval of the following requests from the College of Agriculture.

1. Change Farm Economics 10. Farm Accounting to Farm Economics 125, Farm Accounting. Three credits. Inventories and enterprise accounts, farm accounts and farm records. Principles in making and interpreting farm accounts and their application to the organization and management of farms. Lectures 2 hours; laboratory 2 hours.

Prerequisite: Farm Economics 113.

- 2. Change Farm Engineering 11. Engineering Practices in Soil Management to Farm Engineering 105, Engineering Principles and tices in Soil Management. Surveying, mapping, and determining the areas of farm lands; designing farm drainage systems; controlling erosion by terraces and gully structures. Lecture 1 hour; laboratory 4 hours.
- 3. Markets and Rural Finance 207. The Effects of Political, Economic and Cultural Forces Bearing on Rural Life in America. A course in the heritages and political and economic forces that have affected the life and the property of the people engaged in agriculture. The period covered is from colonial times to the present. Lectures, readings and assigned topics, two hours per week, one meeting. Two credits. The committee recommends the approval of this course as a course to be taught by Dr. McVey.

The report of the Curriculum Committee was approved as read.

A report of the special committee on the class schedule was read by Professor Scherago. After some discussion of the need for the standing committee proposed in this report, the Senate voted to table the report until its next meeting and requested that the Committee have the report mimeographed and copies mailed to the members of the Senate.

On recommendation of the College of Arts and Sciences, the following changes were approved in the curriculum leading to the degree of B. S. in Music:

- a. Music 33a,b. Elementary Harmony and Dictation. Four credits each. Reduced from five credits. This change in course has been approved.
- b. Music 42. Seminar. One credit. Reduced from two credits. This change in course has been approved.
- c. Education C44. Fundamentals of Elementary Education. Three credits. To replace Education 44, five credits.
- d. Education 105. Fundamentals of Secondary Education. Three credits. To replace Education 147. Foundations of Secondary Education, three credits.
- e. Education 16. Educational Psychology. Three credits. To be added to requirements.

- f. Music 34a,b. Advanced Harmony, Dictation and Ear Training. Four credits each.
- g. Elective, one credit, to be added, to bring total credits for the degree to 127.7 credits.

The Senate also approved the following recommendation from the faculty of the College of Arts and Sciences:

"The faculty recommended the appointment of a committee to serve with an equal number of students selected by the Student Government Association, these to compose a joint committee to consider the enforcement of existing rules concerning cheating among students or the adoption of a new plan."

The Senate Committee as subsequently appointed, is made up of John Kuiper, Chairman, C. C. Ross, and Lawrence Bradford.

President Cooper asked for an expression of opinion from the Senate as to how student petitions for new organizations should be handled. He suggested that such petitions might either come directly to the Senate for approval, or that they might first be reviewed by the University Council and submitted to the Senate by the Council, with such recommendations as seemed desirable. After some discussion of the present Senate regulations regarding new student organizations and of the practices that have been observed in reviewing petitions for such organizations, the Senate voted that a committee of three be appointed to study the procedures to be followed in reviewing and passing on requests for new organizations; this committee to report back to the Senate at its next meeting. The committee subsequently appointed by President Cooper, includes Professor Trimble, Chairman, Dean Blanding, and Professor Koppius.

President Cooper also asked the Senate whether or not it wished reports from its standing committees. On motion duly seconded, the Senate voted that the standing committees of the Senate should report to that body annually.

MINUTES OF THE UNIVERSITY SENATE December 9, 1940
