Motion Pictures Project as outlined in my memorandum of February 8, supplemented by memorandum of Mr. Camiland March 20, in status quo awaiting developments your New York trip and general approval, at which time we are to transmit proposal in writing to RC, State. Photographs Informal conference with Mr. Pierson, RC, relative series of photographs with captions depicting the scenic, recreational, historical and industrial attractions of the United States, together with human interest shots, as per my memorandum of July 14. Mr. Candland, by arrangement with WPA Writers' Project, has secured approximately one hundred glossies, captions of which are now being added. Mr. Pierson has given general approval of subject matter with definite approval of the project awaiting our communication to RC, State Department, outlining same. It is now suggested that these photographs be compiled in folders and placed in consulates and embassies of latin American countries and Ottawa, Canada. Individual photographs would be made available to appropriate interests as a loan, to be returned to individual offices, thereby keeping entire series intact. Supplemental distribution from this office of appropriate subjects as they become available is suggested and duplicates supplied when needed because of wear and obsolescence. This project enlarged in Mr. Candland's memorandum of March 20, which awaits developments your New York trip and general approval, at which time we are to transmit proposal to MC, State Department.

#### Literature and Publications

Informal conference with Mr. Pierson, RC, relative distribution of Calendar of Events to consulates and embassies in Latin American countries and Ottawa, Canada. Same relative placing of these offices on regular mailing list for copies of OFFICIAL BULLETIN. Through cooperation of Mr. Pierson, formal requests for both have been received as of January 9 and 50, respectively. Confirmation of same forwarded State Department from this office and copies of CALENDAR OF EVENTS and of Gurrent issue of OFFICIAL BULLETIN have already gone out.

List of consulates and embassies, latin American countries and Ottawa, Canada, have been supplied this office and have been added to the regular mailing list for subsequent issues of each publication.

#### Re: BUREAU OF PUBLIC TO ADS Photographs

Contacted Mr. A. C. Rose, Senior Highway Engineer, Division of Information, and he has offered this office the full facilities of their photograph section. They have a comprehensive file of technical and scenic photographs covering the United States generally. A number of the scenic photographs are being supplied at once, with other to follow at such time as we wish to make a complete selection. Same to be supplied this office without cost.

#### Re: NATIONAL RETAIL DRY GOODS ASSN.

Informal discussion with Mr. Saul Cohn, former President, and Mr. Young of the local office, relative participation among their 5700 affiliated stores. This feature would comprise display in such departments as men, women and children's wear, equipment, luggage, photographic supplies, books and publications. This feature ties in with suggestions contained in my memorandum of January 50, relative Times-Herald feature, and has been given general approval. However, nothing further has been done awaiting your approval and suggestions. In the meantime, Mr. Frank Mayfield, President of Scruggs, Vendervoort & Barney, one of the MRDCA affiliates, has been elected President at their annual conference held in New York January 15-17.

Appointment with Mr. Young, of the local office, and possibly with Mr. Mayfield early next week to follow up the above outlined program. (Please note letter of February 15 to Mr. Frank Mayfield.)

### Re: CHAMBER OF COMMERCE NACOS

Miss Norma McKellep, Secretary and Director of NACOS, has offered the facilities of this organization insofar as policy will permit. This organization is made up of State and community Chambers of Commerce representatives who deal directly with commercial interests. Miss McKellep has sent this office a selected list of these representatives and especially requested the OFFICIAL BULLETIN be mailed to each. Mr. Candland added a flyer" asking for a response to those not already on our mailing list. General commendation of the program of the Travel Bureau was received, with appropriate cooperation offered from each.

Have suggested to Miss McKellep and a number of NACOS officials who have visited here during the past year that the Travel Bureau program be presented direct to them at one of their conferences. Inasmuch as it is this group of representatives who could be directly responsible for the development of the travel program in their individual States, it would seem to be a logical approach.

Their annual convention is held in October; however, it is suggested that subsequent to passage of legislation, an earlier presentation might be made at one of their executive sessions held periodically throughout the year.

A Deleware official, confidentially, has indicated that the DuPont Interest might consider the production of a color motion picture, depicting the scenic, industrial and recreational attractions of their State. Mr. Lamont DuPont would be the one most amenable to a suggestion of this nature. With your approval, would like to develop this contact subsequent to passage of legislation.

Re: CHESAPEAKE AND ONIO RAILROAD

Conference with Mr. Singer, Advertising Manager, Cleveland Office, regarding changes which they anticipate making in their film, "George Washington's Railroad." There was a preponderance of advertising which detracted not only from the excellent theme of the picture but was generally objectionable to officials of RC, State Department, and others at the showing.

Mr. Singer advises that Chesapeake & Chio will use the President's Proclamation in their new "time table", to be released in the near future. He requested this office to supply their advertising department with several photographs of Skyline Drive and especially one of the Chio River. Contact has been made with Division of Information, WPA, with Public Roads, and the Times-Herald. Several of each shot are available and have so advised Mr. Hilliard of the local office, who will make a tentative selection subject to Mr. Singer's and Mr. Spain's approval.

Discussed a program particularly directed to women's organizations, schools, and colleges and they consider it has merit. This is much the same program which I have outlined in "Travel Guild". Mr. Spain particularly thought this worthy of their consideration and expects to take it up with passenger traffic officials at an early date and report progress upon his next visit to Washington.

Re: SHELL OIL Following up my letter to Mr. Charles A. Foster, District Sales Manager, Shell Oil, Baltimore, Maryland, their London representative for seven years, he advises that Mr. D. C. Marschner, Advertising Representative, will be in Washington this week. With your approval, wish to discuss with him the "See America Series". Shell Oil might sponsor this project, thereby providing the necessary funds of around \$200,00. Good will for their interests should ensue if this series of films were made available to RC, State Department, as outlined in my memorardum of February 8. In the meantime, "Shell Touring Service" was used in the OFFICIAL BULLETIN, February issue. (Please note my letter of February 15 to Mr. Foster and excerpts of his letter of March 21.) RO: TIMES-HERALD FEATURES The status of this project to date is for special resort edition on April 14 with features as outlined in my memorandum of January 30, together with certain ones developed by Mr. Claser within the past ten days. Feature article by you has been supplied Mr. Claser by Editorial Section of the office. If, when published, this issue appears to be a really good piece of advertising promotion, it might well be circulated among a selected list of State and municipal travel agencies as a "suggestion". Rot WOMEN'S PROGRAM Following up activities of last spring, have continued contact with officials of the General Federation of Women's Clubs and the D. A. R. relative the participation in 1940 travel program. Subsequent to passage of legislation, it would seem advisable to develop this project and present a concrete program for consideration of their directors who meet in the executive session in late spring. 

Dear Doctor: This will serve to introduce Mrs. Florence Jones Vining, whom I have known for several years and was formerly Chief of the Womens Section of the Federal Housing Administration, directing the activities of fifty-four women field representatives assigned to States' district offices throughout the United States. Mrs. Vining has had very broad experience in Liberty Loan Campaigns; merchandising director; consultant in house design and decorating; hostess at exhibitions at various world's fairs; editorial work; publicity director, etc. With the F. H. A., besides directing the women's division, acting through the Federation of Women's Clubs, civic, social, church and school organization, as well as industrial groups, she directed women's activities in the housing program which resulted in the organization of some 1500 women's divisions of local better housing committees. At the present time she is with the United States Travel Bureau of the Department of the Interior engaged in public relations work. It is doubtful if the Department of the Interior will secure the passage of its bill appropriating for this Bureau. I am therefore suggesting to Mrs. Vining she should see you for it does occur to me that a woman with her experience and ability would be of value in your department. C. Dear Mr. Foster: As you know, Mrs. Florence J. Vining has been employed by the United States Travel Bureau from September 1938 to June 30, 1940. She was employed here in what is known as a noncertified capacity in connection with the WPA Project under the jurisdiction of this Bureau. During her service here she handled special assignments particularly in regard to motion pictures, still photographs, and cooperative projects with other government agencies. At the close of the past fiscal year it was necessary to re-new the authority to operate a WPA Project under this Bureau. The application for this authoraty requested us to make a number of administrative changes, among them the defi-nite classification, duties, and functions of the non-certified employees allotted to the project be classified as Supervisor and Chief Clerk, respectively. Mrs. Vining's experience did not qualify her for either of these positions. Consequently, since no other funds were available for continuing her employment, it was necessary that her services be terminated as of June 30. Notice of the action taken by the WPA in our request for authority to continue the project was not received until July 6. This delay made it impossible to make any final decision on the disposition of personnel at an earlier date.

Mr. Addison Foster July 13, 1940 It should be definitely understood, however, that this action does not jeopardize her opportunity for securing a permanent position with the Bureau at a later time. Although any funds appropriated subsequently will require all employees, with certain specified exceptions, to have a Civil Service status. It can be assumed that Mrs. Vining may have an opportunity in the meantime to secure such a rating. I have the kindest personal regard for Mrs. Vining and sincerely regret that this situation has arisen. She has my assurance that I shall endeavor personally to be of every possible assistance to her. I would be pleased to give her any recommendation based on my knowledge of her qualifications. Washington, D. C. December 22, 1939 Mr. Edward Stanley, Washington, D. C. My dear Mr. Stanley: In the interest of time, I am using as a guide for suggested activities, material prepared while with the Federal Housing Administration. This is indicative of the scope of a program which would be readily adaptable to campaign activities. The build-up and organization work would be relatively the same, with only the theme different. Mr. McNutt has an enviable record of achievement along civic and welfare lines which would have general appeal to members of outstanding women's organizations. The activities of the agencies under his direction at present vitally concern the welfare and security of women and their families. He has personal appeal. These facts, together with the sound policies for which, undoubtedly, he would stand as a candidate, should make it a relatively simple matter to interest women nationally. A broad educational program, developed slowly and thoroughly, should be productive of the best results. At first, appropriate literature, direct mail, and newspaper publicty and feature stories for national publications with wide consumer appeal, directed particularly to women. Subsequently, a more direct appeal with appropriate local organization work on a national scale, following carefully, approved campaign policies. This activity should be under the direction of national, state and community leaders who have proven their worth in previous campaign work of a like or similar nature. These women would be the nucleus of the ultimate organization work which might well develop into thousands of local "McNutt for President Clubs". If given the opportunity, I feel certain that I could do a really credible job of general contact, organization work and public speaking if desired. As indicated by the enclosed material, I have excellent contacts in almost every metropolitan community in the United States as well as in many rural communities. I have on file the names of six hundred and eighty newspapers together with the names of city, feature, and women's page editors, who have in the last several years used my material. Many I know personally and have been their guests on feature programs of their own as well as features which have been developed for them under my direction with the help of women field representatives.

Also on file are the names of over twenty thousand women, which list would be subject, of course, to current revision. These include the names of all the Reporter Group Leaders, a function of the Women's Division of the Democratic National Committee, many of whom I know personally, through appearances on their programs. Also included in the list are the names of the Chairmen of Women's Divisions under my direction in the housing program, many of whom are active leaders in Democratic circles in their communities. I have kept in touch with these women and visited in their communities at least once a year during the duration of our program.

Contacts with radio stations in most every part of the country have been in connection with personal broadcasts while on speaking tours. The women field representatives were even more active in this field and from this contact I have been able to maintain close relations with the studios. This is particularly true of the small urban stations.

I am at present working with motion picture, hotel, transportation, and travel interests in general, in liaison with other governmental agencies as a representative of the United States Travel Bureau. Have a good understanding of office routine and contacts, a working knowledge of the typewriter and am accustomed to strenuous programs and daily routine.

I am free to devote the necessary time to produce results, and am also free to travel within reason, if reimbursed for the expense. Can work in New York as well as here, however, wish to maintain my headquarters in Washington, where I am agreeably domiciled. In this connection, I should like to state that it would seem to the best interest of all, were I to begin on a small scale in the Washington office, in order to gain information and experience along campaign lines. In this manner I would be at no additional expense immediately and would be able to finish up my work at the Travel Bureau in a commendable way.

It is my understanding that you are to take up the matter of my suggested appointment, discussed with you previously, and will advise me of the results. I trust that this material will prove adequate and assure you that I shall be glad to enlarge on any point, at your suggestion.

This Institute has been in operation now for four years and we are more convinced than ever that it is an excellent activity and of great value to the public in general and to dealers in building materials of various kinds. For some time it has been definitely established as the center of information of this kind over a wide area. We make no charge for the space, but the exhibitor agrees to give it reasonable advertising support in our Saturday paper, which is the issue of the week we have used since 1928 in promoting our Institute, which in the early days was called the Modernising Bureau. We are carrying regularly four and five pages every Saturday devoted to this alone. Back through '29 we carried twelve to sixteen pages every Saturday through the year. This is def-inite proof that a real need was being served. We turn the room over to women's organizations, men's organizations, bank clerks clubs, bridge parties, grocer's organizations and general meetings. Sometimes there is hardly a single night in a month but what the Institute rooms are taken. We now have three demonstration kitchens, one operated by the electric light company, one by the gas company and the other by our largest furniture house. Inquiries, all kinds of time, come in to us daily. The Institute is attracting the attention of newspapers as evidenced by the fact that the Hearst organization have gotten out a complete survey of operation, results, reactions and pictures. This survey has been sent to the key men of all Hearst papers throughout the country. I know they were particularly interested because very rarely has a newspaper worked out and promoted an activity that builds up advertising and interest in a Saturday afternoon paper. We feel that it is most logical because our paper comes on the street Saturday noon and the advertiser
