

OCLC Local Systems Development Advisory Committee

To provide for better communication among all parties involved in OCLC's new local systems development, a 15-person advisory committee has been formed.

It includes representatives of libraries already using a version of the Integrated Library System of the National Library of Medicine before it was adopted by OCLC (the Pentagon and the University of Maryland Health Sciences Library); regional networks participating in the marketing of the LS/2000 system (SOLINET, SUNY/OCLC, NELINET, and PALINET); and libraries which will install the LS/2000 local system. THE UK LIBRARY SYSTEM

The following is another in a series of descriptive articles concerning various aspect of the UK Library System.

Appalachian Collection

The Appalachian Collection, located in the Department of Special Collections, has been developed during the past seven years in conjunction with the Appalachian Center's Appalachian Studies Program. This is a comprehensive research and reference collection dealing with all aspects of the Appalachian Region. The core collection consists of over 3,000 books and numerous periodicals relating to the region, supplemented by Kentucky county records and newspapers from the 19th and 20th centuries. Manuscript collections include the papers of regional literary figures such as John Fox, Jr., Harriette Arnow, Rebecca Caudill; the papers of American folk musician John Jacob Niles; and files from organizations in the mountains such as the Frontier Nursing Service and the Commission on Religion in Appalachia. Audio-visual materials include audio and video tapes of lectures, conferences, workshops, and other Appalachian events. The Oral History Program has coordinated a number of Appalachian projects including the Big South Folklife Study, the Frontier Nursing Service, and John Jacob Niles.
