

THRUSH SUSPECTED LINK TO AIDS

Thrush, a common fungal infection of the mouth, can be an early warning sign of AIDS, according to a report in the New York Daily Times. Doctors at Montefiore Medical Center in New York City reported that the infection seems to be a better warning sign than other symptoms used for early detection of AIDS.

Thrush is fairly common in children, but usually does not occur in adults unless they have been treated with antibiotics or steriods. Between September 1981 and July 1983, doctors at Montefoire saw 22 apparently healthy adults with Thrush. All were drug users, homosexuals or bisexuals, high risk groups for AIDS. Thirteen of these 22 have since developed AIDS.

To date, there have been over 5,000 diagnosed cases of AIDS. The death rate appears to be over 70 percent.

A RENDEZVOUS WITH OUR PAST by Greg Lee

For a long time, what we now know as The Bar was just another building with little significance. If anyone tells you that it has been a gay bar for years and years, don't believe it. The first bar to appear on this site was called the Menlo Club Saloon in 1902, and despite its unusual name (unusual becase neither of its operators, Lee Baker and Dunlap Barker, were named "Menlo"), it was not a gay bar. It wasn't even around in the gay 90's, and it only lasted one year, 1902. (I wonder if it had a proper funeral with a casket and all?)

Since that's neither here nor there, let's move on. The actual date of construction for the

Since that's neither here nor there, let's move on. The actual date of construction for the buildings we now bump in is unknown. They did not appear on the Sanborn Insurance map of 1907, but there is reason to believe that this map was a little outdated when it was put together. On the other hand, the buildings were definately there in 1923 when the Chinn photos were taken. To add to the confusion, before the new buildings were put there, there were of course some old buildings on the property. In these old buildings were a few businesses which evidently moved into the new buildings when they were erected. Because of this uncertainty, we'll start with 1907.

Before we go on, let me make sure that you realize that The Bar did not settle down in just one building. It is composed of two buildings; 224 East Main (the two story section where the lounge is downstairs and where the marble bar is upstairs), and another building that was originally divided in half to make 226 and 228 East Main. The latter building is now used for storage on the

first floor. Part of the flooring has been removed between the second and third stories to give us the spacious dance floor and a cathedral ceiling in part of the office space. The part of the third floor that remains intact is used for the rest of the office space and the DJ booth.

Now we can start on the history. In 1907 Preston White occupied 224, but his business is now unknown. Two twenty-six housed the Kelly Storage and Distributing Co., the Fayette Warehouse Co., and Spotswood Specialty (which dealt with advertising novelties). By 1911 the Stanford Furniture Co. had moved into 226. As of yet the other half of the building, 228 appears to have been vacant.

In 1912 another member of the Spotswood family opened a hardware store at 224 and the Beard and Lyons Co. moved into 228. Beard and Lyons Co. was concerned with stoves, furnaces, skylights, roofing and sheet metal works. During 1914, Spotswood's hardware store had moved out of 224 and was replaced with the Ten Broeck Tire and Rubber Co. and A.W.T. Davis (a distributer). By 1916, 224 changed hands again and now was rented by S. A. Reynolds, a plumber. In the same year, J. M. Kelly of Kelly Storage and Distributing Co. opened the Sher-a-Coca Bottling Co. in 226. Also at this time, Beard and Lyons gave over to the Fischer Electric Co. to occupy 228 East Main.

224 changed hands again and now was rented by S. A. Reynolds, a plumber. In the same year, J. M. Kelly of Kelly Storage and Distributing Co. opened the Sher-a-Coca Bottling Co. in 226. Also at this time, Beard and Lyons gave over to the Fischer Electric Co. to occupy 228 East Main.

Evidently no other changes were made until 1918, which proved to be an interesting year. Up until 1918, all the property was owned by the Kelly Storage and Distributing Co. In this year, the property was acquired by the Phoenix and Third Trust Co. This is the most probable year that the old buildigs were torn down and the new ones erected.

Then in 1919 the Phoenix and Third Trust Co. passed all this on to the Shipp family. The latter retained the property until 1976. The name of Shipp resurfaces again in the deeds as part owners of the Living Room, Inc., but that's a long way off yet, so let's not get so excited.

Also supporting the theory of the 1918 construction is the fact that all but one of the businesses changed. The Lexington Directory of 1919 shows the Service Tire Co. as the sole business in 224, the Quencho Bottling Syrup Co. (with yet another Kelly as manager) and Spotswood Specialty sharing 226, and the Nevitt Company (auto accessories) in 228.

Abraham Salmon got the notion to put in a pool hall at 226 in 1921. Thank goodnss someone took a picture of it, because by 1923 he was out of business. If you would, now you can look at the Chinn photo. This is a composite of several pictures probably taken within a year or so of one That's why you see Miller's Auto Accessories picture of 224 was obviously not taken until 1923, the only year that Miller's appeared in the city directory under this address. That's John Boy's truck you see there.

Also disappearing in 1923 was the name of Spotswood. As far back as the 1880's the Spotswoods had some business or another in that area (back in the 1880's it was the E. Spotswood Son Lumberyard, which was one of many lumberyards lining Main due to the proximity of the

railroad that used to be behind the property).

If you did't notice the big "hole" in the building, look at the picture again. The building shown in the Chinn photo included a garage opening in the center section (many of the lumber company sites on East Main were replaced by comparably land-extensive garages and auto-repair shops, as well as large department stores and warehouses in the early 20th century). Unfortunately, no record has been found as to when the garage door was eliminated. Just think, The Bar could have had a drive-thru service if it had been left alone (would you believe a "pick-up window"?). Apparently the buildings were vacant in 1925 except for T. C. Henry's real estate office. He left soon afterwards and in 1927 the Duro Co. (water systems), the Kohler Co. (electric lamps), and Southern Taxi moved into 224. The Woman's Exchange Restaurant moved into 228 in the same year. During the next year, a deli took over where the Woman's Exchange was and Joe's Music Shop ended the five year vancy of 226. The deli, by the way, was the Baldassare Amato Son Delicatessen.

By 1930 Southern Taxi was replaced with the D. Bohon Co. (auto supplies), and Joe's Music Shop had made way for Wilfred Joseph's Billiards. During the following year, the Manhattan Restaurant and the Karmelkorn Shop (confectionary) came to share 226 with Joseph's Billiards. Karmelkorn became the Caramel Crisp Shop in 1933 and the pool hall was now known as Majestic Billiards. The Amato Deli then became the Matthew Amato Restaurant. By 1935, 224 was vacant, Manhattan

Restaurant moved out of 226 and into 228, and Martin's Barber Shop became the only business in

Finally things began to settle down a bit in the late '30's. The Manhattan Restaurant remained in 228 until 1949, sharing the building with the Arch Liquor Dispensary through 1944. Congress Bowling Alleys also moved in and sharred 228 with others from 1940 to 1968.

The Mayfair Bar and Restaurant occupied 224 from 1938 to 1950 or 1951. According to one interview, the Mayfair was a restaurant for little old ladies. By 1953, 224 East Main had become the Southern Cocktail Lounge. Pal Optical also moved

into 224 in 1955.

As for 226 East Main, there was still a bit of financial unrest as the building changed occupancies quite a bit. Martin's Barber, as mentioned earlier, remained there until 1942, but shared the address with the Benevolent Protective Order of Elks in 1939 for less than a year. In 1943 Casey Clell's Barber Shop took over and shared the building with Arch Liquor Dispensory for two or three years when they moved from 228 in 1944. In '47 the H. A. Lucas VFW Post 1885 came to 226 as well. During the following year, Clell's and Arch made space for Thom McAn Shoes, which remained there with the VFW club for less than two years. In 1952 the VFW club moved to 224 for one year after Mayfair had abandoned it and before the Southern Cocktail Lounge came around. In the same year, Holbrook's Shoe Repair filled the space that the VFW had left in 226. Holbrook's and the VFW club had to share 226, though, when Southern Cocktail did make its appearance. Holbrook's stayed there until some time in 1955. The VFW club stayed there until some time in 1956, sharing remained there for one last year in 1956, sharing the newly arrived Seaboard the building with the newly arrived Seaboard Finance. Remaining there as the only business in 226, Seaboard Finance did not leave until 1970.
Two twenty-six then housed A V C O Finance for three years, and was vacant until 1978.
Now back to the action in 228 East Main. As

was brought up before, Congress Bowling Alleys made its home here in 1940. When the Manhattan Restaurant left in 1949, it was replaced with the Masterson's place from 1958 to 1959, and left Congress Bowling Alleys as the only business at 228 in 1960. Then in 1962 Hagar's Beauty Academy came to share 228 with the bowling alley and remained there in 1968 when Congress Bowling Alleys moved away. Hagar's stayed on at 228 for a few more years and then moved down the street in 1971. When Hagar's left, the Morris Bookstore came into 228 and remained there as the sole business until they

closed in 1977.

If you're fairly observant, you'll notice that I left off everything at 224 East Main past 1955. There is reason for this. The Southern Cocktail Lounge and Pal Optical both remained here up until 1962. The lounge then closed and Pal Optical stayed on for about a year more in 1963, sharing the building with a new and interesting business... The Gilded Cage...



Celebrating the Gay Experience

This is to introduce Aunt Mary to all 650 Newsletter readers. As a participant in a local church study group, Aunt Mary was encouraged to reach out and form understanding and loving relationships with those she once may have shunned. As a very conservative and lifelong resident of Berea, Kentucky, (Aunt Mary refuses to devulge her age, but does admit that she is over 60) picking out one category of individuals to stop shunning certainly no small task. However, after careful consideration, Aunt Mary has put aside her considerable prejudices and asked 650 to help her correspond with as many gay individuals as possible. In the following months 650 will record as much of this correspondence as space permits. The subjects to be explored will be limited only by our readers imagination and our editors good taste. As you will see, her first letter is a plea for advice on how to handle a delicate social situation.

Dear Aunt Mary:

I need your advice. I recently had an experience I didn't know how to handle, and next time I would like to be better prepared. A friend and I were sitting at the bar of a local Mexican restaurant. Sitting in the lounge across from us were two businessmen. They were sitting diagonally across from each other, talking. The one facing us was very attractive. We were both watching him (discretely, I assure you), when he began an unusual display. He would cup first one hand, then the other, then both, over his crotch. This went on for about 25 minutes. I was unsure what was going on, but my friend was sure it was intended for one of us. Regardless, neither of us knew how







A U.S. Court of Appeals panel has upheld the Navy's mandatory policy of discharging homosexuals.

James L. Dronenburg was discharged after serving more than nine years as a Korean linguist and cryptographer with a top-secret clearance after he admitted he was a homosexual.

Dronenburg argued that the Navy's policy violated his constitutional rights to privacy and equal protection under the law. But the three judge panel said the Supreme Court has established the right to privacy in cases relating to marriage, procreation, contraception, family relationships and child rearing and education. The panel also said the Constitution has provisions that protect, among other things, racial, ethnic and religious minorities.

"It need hardly be said that none of these covers a right to homosexual conduct. If a court refuses to create a new constitutional right to protect homosexual conduct, the court does not thereby destory established constitutional rights that are solidly based in constitutional text and history. We conclude, therefore, that we can find no constitutional right to engage in homosexual conduct and that, as judges, we have no warrant to create one," said the panel.

The court also said the effects of homosexual conduct within a naval or military unit are almost certain to be harmful to morale and discipline.

This press conference was held by the co-chair of Gay and Lesbian Democrats of Kentucky, Keith D. Elston, along with the co-chairs of the National Association of Gay and Lesbian Democratic Clubs, Gwenn Craig and Peter

Vogel.

The newly amended by-laws of the Democratic Party require that gay men and lesbians be appointed to positions of responsibility within the Party; the 1988 Delegate Selection Rules will require each state Party to develop Party Out-reach Programs, including recruitment, education and training designed for lesbians and gay men; all three Democratic Presidential candidates have been very outspoken in their support of Gay Rights Legislation both nationally and locally; the Lesbian and Gay Caucus is now larger than 25 state delegations (including Kentucky); yet the Governor of Kentucky, Martha Layne Collins, who is serving as the permanent chair of the Democratic National Convention, has refused to meet with Gay and Lesbian lobbyists since her election this past Noveber.

When Governor Collins was asked if she would support a Gay Rights bill in the Ketucky Legislature, she claimed that no one has ever tried to lobby her. Governor Collins has also adamantly refused to sign an executive order banning discrimination in Governmental hiring practices and

refuses to discuss the issue futher.

In the state of Kentucky, oppressive "sodomy" laws explicitly make any homosexual activity illegal. There is no legal recourse for any gay man or lesbian who is discriminated against in employment, housing or public accommodations. Governor Collins has thus far shown by her words and her actions that she is totally insensitive to the concerns of between 250,000 and 300,000 gay men and lesbian Kentuckians. Furthermore, the Governor has, by her coments at the home of Melvyn Belli, in effect endorsed discrimination based solely on sexual orientation.

This homophobic attitude the Governor has displayed is completely at odds with the Democratic Party's stand on Gay and Lesbian Human Rights.

If Governor Collins truly intends to establish a leadership role in our National Party, then we urge her to begin by reading the 1984 Democratic Platform which calls for an end to discrimination based on sexual orientation in employment, immigration and the military.
