Your note to hand  
in reply will say, I will present  
the Evangelistic cause just as early  
as possible, and will do all I  
can to secure a good contribution.  
I expect to have Rev. W. T. McElroy  
with us at an early day to engage  
in a protracted meeting - We can  
hardly expect much in the way of  
additions at this time - The fact  
work here for a while must largely  
consist in strengthening what  
we have - I want to say to you  
that if the Lord opens the way I will  
be disposed to go elsewhere -  
I have three resources - My work is

so situated that I am away from my home & family too much of my time - A young (single) man I think would accomplish more in the field than a man with a family. In the second place the growth of our church here has been phenomenal, and the next five years must be years of indoctrinating. We can hope for but little beyond that - In the third place, we are fearfully persecuted and maligned by the Cumbriauds - this is telling on my nervous constitution -

I might add to this the fact that during the seven years I have labored with these people the Cumberland Church has had four pastors & the fifth one entered upon his work last Sabbath - The Methodist church has had four. The Baptist four with the fifth one

just entering upon his work - Every thing taken into consideration I am disposed to think that a change would be the best thing for me & probably the best thing for my people - I will abide the Lord's time - Yet if a field of one or two churches presents itself I will be disposed to take it as an indication that I should change - I don't want to go from sky - Some one mentioned Crittenden & Lebanon to me, but I know nothing of the field either for its promise for usefulness or its ability to support the ministry - So far as I know there is no necessity for my going elsewhere - my people & I understand each other so far - Yet there is a little matter - too little and remote to mention, & with which I am not personally connected
