#### ARL PRESERVATION PLANNING PROGRAM STUDY

The UK Libraries will soon be involved in a system-wide preservation self-study which is expected to last from six to nine months and will result in an overall preservation plan. With the assistance of a consultant, Michelle Cloonan, Preservation Librarian at Brown University, a library preservation study team and a number of task forces will be formed to gather information and prepare reports on such issues as environmental conditions, physical condition of the collections, organization for preservation, disaster control, preservation resources, staff and user education, and inter-institutional cooperation.

In 1989, the UK Libraries were chosen by the Association of Research Libraries' Office of Management Services to conduct the consultant-assisted Preservation Planning Program. The program typically lasts from six to nine months and will involve two to three visits from the preservation expert assigned to us by ARL. Michelle Cloonan and Jutta Reed-Scott from the OMS office will conduct the first of the visits on March 20-21.

During the first visit, the consultants will meet with Paul Willis, Director of Libraries, the study team, and the library faculty and will also tour the facilities. The study team is made up of Judy Sackett, chair, Judy Brown, Cindy Cline, Cheryl Jones, Mike Lach, and Steve Savage. (Submitted by Judy Sackett.)

Since an item record cannot be attached to more than one bibliographic record and since a barcode cannot be attached to more than one item record, accurate status information at all bibliographic records representing one physical piece cannot be provided in LS/2000. To remedy this limitation of LS/2000, a pointer system has been devised to direct the LS/2000 user to the bibliographic record whose item record contains the correct status information of the requested piece. This involves the creation of a cart named SHELF?? ASK AT DESK, of a local note (a 590 field in all bibliographic formats) directing the user to the correct bibliographic record, and of item records containing system-supplied identification numbers—not barcodes.

The following procedures must be followed when inputting into LS/2000 multiple bibliographic records representing one physical piece.

Attach the item record containing the barcode to the bibliographic record of the first title in the piece. Include the price of the piece in this item record only. Attach an item record containing a system-supplied identification number to the bibliographic record of each succeeding title in the piece. Use the item record containing the barcode for check-out.

Add a 590 note in all CAPS to the bibliographic records whose item records contain system-supplied identification numbers. This note explains how to retrieve the bibliographic record which when requested displays the accurate item status information of the piece. The search strategy selected for inclusion in the note depends on the uniqueness of the title in the bibliographic record.

When the bibliographic record contains a fairly unique title, the preferred search strategy is by title. The form of the note in this case is as follows: [supply library location as found in item record] - TO SEE IF THIS [supply library material type, e.g., BOOK, CASSETTE, VOLUME, etc.] IS CHECKED OUT, SEARCH THE FOLLOWING TITLE BY ENTERING: /TI=[supply title of item record containing barcode].

When the bibliographic record contains a title that is identical to other titles in LS/2000, the preferred search strategy is by OCLC number or author/title. The form of the note when using the OCLC number is as follows: [supply library location as found in item record] - TO SEE IF THIS [supply library material type] IS CHECKED OUT, SEARCH THE FOLLOWING OCLC NUMBER BY ENTERING: /ON=[supply OCLC number of item record containing barcode]. When the author/title search is preferred, substitute the author/title information where the OCLC number information appears in the above note.

Create a cart whose name is as follows: [surply two- or three-letter library location mnemonic, e.g., KG, ED, GPD, AVL, etc.]/
SHELF?? ASK AT DESK. When it is best to direct the user to a
particular library department, the name of the cart is as follows:
[supply two- or three-letter library location mnemonic]/SHELF??

ASK IN [supply library department mnemonic, e.g., GPD, etc.]. The
name of the cart must be composed of 23 characters in length,
including spaces. The description of the cart is entered in LS/2000
as: Bound-withs. When cataloging audiovisuals, the description is
entered as: Audiovisuals with two or more titles in one unit. Use
the transfer subfunction within the add/clear cart function to
transfer to the cart those titles whose bibliographic records
contain the above 590 note. Thereafter, the status of those titles
will be On [name of cart]. The system supplies the On. This
eliminates the available status which may or may not be correct
since only one item record may be used for check-out. Since the
cart function is location specific, each location must create its
own cart.

In the spirit of the Kentucky Lottery, a raffle will be held for several attractive artifacts. Also, coffee mugs bearing a new logo for the section will be on sale.
