Sexual Orientation Not a Factor in Security Clearances, GAO Finds

Washington, D.C. (AP): Federal agencies appear to have ended their practice of using homosexuality as a basis for denying security clearances, a congressional report says. The agencies for years had denied clearances to homosexuals on the assumption that all gay people are at risk of being blackmailed.

In a report released Friday, the General Accounting Office said it "judgementally" reviewed records for civilians and contractors from eight agencies: the departments of Defense, Energy and State; the Office of Personnel Management; the U.S. Information Agency; the FBI; the Secret Service, and the U.S. Customs Service.

All eight told the GAO, which is the investigative arm of Congress, that homosexuality is not a criterion in considering the granting of security clearances. Six of the eight agencies have written policies and procedures that prohibit direct questions on an applicant's sexual orientation. The other two - Defense and the Secret Service - said sexual orientation is not a criterion but that

House Members Blast Gingrich For Effort To Restore Ban On Gays in the Military

Bipartisan Group Speaks Out at HRCF Press Conference

Washington, D.C.: The House National Security Committee today blasted House Speaker Newt Gingrich for advocating that the Republican Congress restore the military's old policy against lesbian gay service members. Republican and Democratic members of the House committee that oversees the armed forces joined a Capitol Hill press conference today called by the Human Rights Campaign Fund (HRCF), the nation's largest lesbian and gay political organization.

Appearing at today's press conference were Rep. Marty Meehan (D-Mass.), who hosted the event in his Congressional office, and Reps. Peter Torkildsen (R-Mass.), Gerry continued on page 9

they had not revised their written policies and procedures to reflect this.

All of the agencies indicated that concealment of any personal behavior that could result in exploitation, blackmail or coercion constituted a security concern.

The GAO also contacted gay rights organizations, attorneys and a paralegal who have represented gays in security clearance cases, and individuals who had had their clearances denied or revoked, allegedly on the grounds of sexual orientation. They told the GAO that clearances have not been recently denied because of sexual orientation.

"In addition, our detailed review of selected security clearance denials, revocations and suspensions during fiscal year 1993 showed that none were attributable to sexual orientation," the GAO said.

The requirement for federal employees who handle classified information to be trustworthy wasderived from a loyalty program established by Pres. Truman in 1947, a time of growing concern over the communist threat. Executive Order 10450 modified the program in 1953, and for the first time, included "sexual perversion" as a basis for removal from the federal service.

It was not until 1975 that the Civil Service issued guidelines prohibiting the federal government from denying jobs to people on the basis of sexual orientation. But policies regarding security clearances remained generally vague or restrictive with regard to homosexuals until the early 1990s.



Rediscovering our History

In late 1988, I began intense therapy for the abuse I had experienced as a child as well as an adult. In 1989, once I had gotten through the worst of my mother's abuse toward me (and my own hatred of her!), I found myself being physically and sexually attracted to a very close female friend I had known for four years. By then, I had a number of gay male and female friends from 12-step programs, so I was free to talk with them about what I was experiencing.

As I learned more about the coming out experiences of these friends, I realized that I was, in fact, a lesbian - and had indeed been born a lesbian. My heterosexual 12-step support system stuck with me through all this, and today I am still close friends with many straights. Since my coming out to myself was also both a spiritual and recovery experience, I did not experience the hurt and rejection that many of my gay friends had experienced. I consider myself blessed and am very grateful for this. After all, I could not

accept the gayness of my friends and not accept it in me!

My younger son was killed in July, 1989. He knew about my coming out process and had been totally accepting of this. I am only sorry that he did not live to meet my spouse, as I know he would have loved her as much as I do. My older son had already separated himself from me due to my continued 12-step recovery process, is very homophobic, is married and my grandson was born the day after my mother's funeral in 1992.

My son joined a fundamentalist church when he met his wife, and he does not want me to see my grandson who was named for my dead son. My dad has a lovely, nurturing ladyfriend; my spouse and I immediately adopted as our mother, and she is everything that my mother wasn't and could not be, and because both of my spouse's parents are dead. Dad and his lady love and accept us as a couple, and they sneak pictures of my grandson to me periodically.

My spouse and I met at the GLSO coming out support group in early 1990, and we celebrated our five-year anniversary in January, 1995. We have very different backgrounds. She went through

years of pain and self-doubt because of this, and never acted on it until her own coming out in 1989. I now believe that my 22 years of successfully playing "Mrs. Brady of the Brady Bunch" probably shielded me from those feelings of social ostracism that my spouse and other G/L/B persons felt because they could not fit into the socially acceptable mold. We are out to our immediate families, and I actually have more close in-laws than my own relatives due to my spouse's larger family.

The GLSO support structure was in place for me and my spouse in our separate coming processes. The gay friends I had already made in 12-step programs were there for me, and my straight 12-step program friends remained there for me, always accepting me as a person, and not just a "sexual orientation." While my blood family is very small and often fails me, my "recovery family" is enormous and has never failed me.

Homophobia is a terrible social and spiritual evil that exists in our culture, both within and outside the gay community. One very important lesson I learned in therapy is that

Studds (D-Mass.), Jane Harman (D-Calif.) and Neil Abercrombie (D-Hawaii). Staff members for Sens. John Warner (R-Va.), a high-ranking Republican on the Senate Armed Services Committee, and Sam Nunn (D-Ga.), ranking Democrat on the committee, have told HRCF that no plan exists for reviving the old policy while the issue remains before the courts. Similar positions were stated by Reps. Floyd Spence (R-S.C.), chairman of the House National Security Committee, Sen. Strom Thurmond (R-S.C.), chair of the Senate Armed Services Committee,* and Dan Coats (R-Ind.) of the Senate Armed Services Committee.

"Gingrich seems to be the only person in Washington who wants to revive the old policy on gays in the military," said HRCF spokesman Daniel Zingale. "The Speaker is obviously trying to score points with the extreme right wing by singling out gay and lesbian people for discrimination."

In a weekend interview show, Gingrich said that Congress should reverse the Clinton Administration's "don't ask, don't tell" policy and return to the outright ban on gays in the military, stating on ABC's This Week With David Brinkley: "The fact is that we're going to probably go back to the rules that existed prior to President Clinton changing them."

"The 'don't ask, don't tell' policy is the same ban on gays in the military, except that the government now admits that gay and lesbian serve with distinction in the armed forces," Zingale said. "Both of these policies discriminate against qualified personnel, and both of them should be scrapped."

Several of the speakers noted that Gingrich seems to be playing to the radical right special interest groups in reviving the issue that Congress dealt with in 1993.

"The Speaker lost favor with radical right special interests when he voted against the ban in 1993." Zingale said. "He should stop playing politics with the lives of servicemembers and stop singling out gay people for discrimination. All troops should be held strictly and equally to the same high standards of conduct. They should be treated based on their job performance. No one should be discriminated against for reasons unrelated to their abilities." -The Human Rights Campaign Fund (HRCF).▼

"hurt people hurt people" regardless of the nature of the hurt. I have now lived on both sides of homophobia; like most of the gays I have been privileged to know, I, too, have given up certain career and personal goals due to my own sexual orientation. I do not regret this, and love the work I am doing as a substance abuse counselor. And the other work I do is unaffected by my sexual orientation. While it is very important that we continue to stand up against all discrimination based on sexual orientation, I believe that a lot of the healing process must begin within our own G/L/B community, perhaps indeed within ourselves. We must learn to overcome our own divisive attitudes and behaviors, learn to accept and even celebrate the many differences within our own group before we strike out in anger against those who would persecute us. It's basically an inside job. How can we expect outsiders to accept us when we often cannot and do not accept ourselves! We must commit ourselves to work harder at learning to work together. We owe it to ourselves and to whose who are still in the process of coming to us.

COMING OUT IN THE MENTAL HEALTH PROFESSION: OPTIONAL? contributed by Sue Strong

National Coming Out Day, which is celebrated October 11 of each year encourages individuals to "take their next step. The focus of the 1994 visibility celebration was coming out at work. Often this is the "last step" for individuals involved

in the process of coming out, primarily because of the potential loss of livelihood. There is no

legal protection for work discrimination on the basis of sexual orientation in 42 of the 50 states, including Kentucky.

Shifts in the workforce in the 1990's make coming out at work frought with even more anxiety. The current competition for jobs is keen and prejudicial attitudes and discriminating behaviors are usually more covert than overt, shrouded in denial and rationalization. It is difficult to determine how long the ripple effect continues once the closet is dropped. The greater the value of your work to your sense of identity or status, the more fearful the prospects of its loss.

A quality of life focus exists in the workplace today. More and more

workers concerned with are including work as a piece, but not the sole piece nor the center-piece of their lifestyle. Therefore, the personal blurs with the professional and the two often collide when the personal includes a non-exclusively heterosexual orientation and the professional includes the field of mental-health. Being maximally closeted and being maximally mentally health tend to be mutually exclusive.

The Corporate Closet cites three ways of dealing with a nonexclusively heterosexual lifestyle in the workplace: hiding or counter-

feiting, avoiding, and integrating.

"Hiding or counterfeiting" means inventing a fictional life to cover reality;

" a v o i d i n g " r e q u i r e s continuous self-

editing and half-truths; "integrating" involves successfully managing the consequences of coming out. In essence there are two choices: living a lie or living the While living a lie is detrimental to any human's mental health, it is particularly damaging to a professional in the field of mental health. The mental health profession rests on the principles of selfdisclosure. authenticity, openness, genuineness, congurence. Principles difficult to maintain while hiding, avoiding, lying.

In the past few years, the military set the standard for lesbigays in the workplace by implementing "Don't Ask, Don't Tell". This sent a message that openness about sexual orientation was not wanted on the job. Ed Mickens commented on this policy in his book 100 Best Companies for Gay Men and Lesbians,

"But we have to tell. Mostly because it's the only antidote we have for the stream of poisonous propaganda that tells us we are inferior humans. It's our chief defense, as we try to live honest, loving, protective lives against self-loathing and self-destruction".

Mental health professionals guide people on their journey to live honest, loving lives and to meet their needs for safety from physical and emotional harm, obtain a sense of belonging and acceptance, experience truth, justice and self-actualization. Self-actualization does not occur in an atmosphere of "Don't Ask, Don't Tell". Is it really mentally healthy for a mental health professional to not come out?
