

Minutes of the University Faculty, November 11, 1957

The University Faculty met in regular session at 4:00 p.m., Monday, November 11, 1957, in the Assembly Room of Lafferty Hall. Vice President Chamberlain presided. Members absent were Howard W. The minutes of October 14, 1957 were read. Dr. Trimble, Chairman of the Committee on Committees, then stated that an error had been made in the recording of his report of the two responsibilities of the Committee on Committees. He stated that the second responsibility of this Committee should be corrected to read "to study the present standing committees with a view to determining whether or not additional committees should be appointed". The minutes, as corrected, were then approved by the University Faculty.

The Chairman asked Dr. Raymon Johnson, representing the University Extended Programs, to present the resolutions on the death of Professor Louis Clifton.

The death of Louis Clifton, Associate Dean emeritus of Extended Programs, removed from the ranks of the University one of its most loyal and devoted servants, a man dedicated to the service of his institution, his field of labor, and his fellowmen. From the day that he joined the Extension staff in 1926 until his death on November 3, 1957, Louis Clifton's entire life was focused entirely on improving and expanding the services of the University to the citizens of Kentucky, without regard for the weight of the burdens his task frequently imposed on him. He served humbly, unstintingly, and gratefully. He fashioned not merely a secure foundation for the future development of these services to the state, but, of far greater importance, a tradition of guiding principles in rendering them embodying humility, justice and devotion.

In the light of Dean Clifton's long and dedicated service and the loss to the University family and the entire state brought about by his death, be it hereby resolved that the gratitude of his fellow-workers for his labors and their sense of loss at his death be expressed and recorded in the official records of the University.

The Faculty accepted the Resolutions and directed that they be spread upon the minutes of the University Faculty and the Board of Trustees and requested the Secretary to send a copy to Mrs. Clifton.

In the absence of Dean White, Dr. Arthur L. Cooke presented to the Faculty recommendations from the College of Arts and Sciences for dropped courses and changes in number, title, credit and description of courses for the Department of Zoology, which were approved by the University Faculty.

In the absence of Dean Shaver, Professor Crouse presented a request from the College of Engineering that the Senior Class of the Student Chapter of the American Society of Civil Engineers be permitted to make an inspection trip Monday, December 9 through Thursday, December 12, to visit industrial and engineering projects in the Chicago area including The Inland Steel Company, The Metropolitan Sanitary District of Greater Chicago and the Illinois Toll Road Commission headquarters. This request was approved by the University Faculty.

Dean Matthews referred the Faculty to recommendations of the faculty of the College of Law which had been circularized under date of October 24, 1957. He stated that a phrase in the course description under section (1) a. which reads "programs necessary for a decent minimum standard of living" should be amended to read "modern social problems". The Faculty concurred in the recommendation as amended.

Section (1) b. was approved by the Faculty as circularized.

(1) a. New course to be added: Law 155, Modern Social Legislation (3 semester hours). An elective course for second year Law students with the following course description: A study of statutes, administrative reports, regulations, legislative hearings and judicial decisions relating to modern social legislation including Social Security, Workmen's Compensation, medical care insurance, unemployment insurance, wages and hours, and public assistance.

b. Authorization for seminar course numbers: The various seminars offered in the College of Law carry the general course number Law 197, and the particular seminar is designated by addition of an alphabetical letter to this number. These alphabetical designations have been used up from a through n and authorization is asked to use the rest of the alphabet in order to avoid any possibility of duplicating course numbers in connection with the seminars offered.

Dean Matthews then referred the Faculty to section (2) of the recommendations of the Law College Faculty entitled Rules for dropping and readmission of Law students. He stated that the Rules Committee is presently codifying the Rules of the University Faculty and in keeping with a suggestion from the Dean of Admissions and the Chairman of the Rules Committee, he should like to recommend the approval of section (2) in principle, with referral to the Rules Committee for incorporation into such codified statement of Faculty rules as it may prepare, and with authority to make such editorial changes as this codification may require. The Faculty concurred in the recommendation of Dean Matthews.

(2) Rules for dropping and readmission of Law students: The present statement of University rules concerning probation, dropping and readmission as shown on page 29 of the General Catalog provides for exception in the cases of the Colleges of Law and Pharmacy. The College of Law for a number of years had had a set of rules to govern these matters, and it seems appropriate that they should be stated in the General Catalog. Approval of the University Faculty is sought for the statement set out below. The statement reflects the existing rules as described in the College of Law bulletin and as posted on the bulletin board of the College of Law for the information of all students:

In the College of Law, a student will be dropped if he fails to attain the following designated standing (except that he normally will not be dropped if he makes a standing of 2.0 in the semester just completed):

- 1.5 at the end of one semester of Law;
- 1.8 at the end of two semesters of Law;
- 1.9 at the end of three semesters of Law;
- 2.0 at the end of four semesters of Law;

Any student who fails to make a standing of 2.0 in any given semester will have his academic record evaluated by the Law faculty and may be dropped or placed on probation as the facts warrant. If placed on probation, he normally will be expected to make a standing of 2.0 in the probationary semester or will then be dropped. Once dropped, a Law student will not be recommended by the Dean for readmission to the College of Law until he has remained out of the College for a

semester and a summer session and has received favorable consideration by the Law faculty of a written petition stating good reasons why he can do satisfactory academic work. Any student dropped twice will not be recommended for readmission.

Dr. Clark reminded the Faculty that Walter Prescott Webb would present the third in the series of five Blazer Lectures that evening at 8:00 o'clock in the Guignol Theatre, the title of his Lecture to be "When the South Turned the Corner". He urged attendance of faculty members at this Lecture.

The Faculty adjourned at 4:25 p.m.
