A. S. N. College, Sept 13th 1889

Faculty met in called session at 12. M. in the President's room. All present. The President appointed the following members of Committees: Committee on Dormitory: Col Clark Prof. Peterman, Prof. Peace. Military Committee: Col. Clark U.S.A., Prof. White Prof. Helvesti. The Military Committee is instructed to prepare a list of Cadet-Officers for the ensuing year. Col Clark moves that Societies must close their exercises at 10 o'c. P.M. Motion seconded and carried. The Secretary is instructed to inform Societies of this order. There being no other business Faculty adjourned.

A. S. N. College, Jan. 10th 1890.

Faculty met in called meeting at 12 M. in the President's room. All present. Cause of meeting: Investigation of charge of intoxication and bringing intoxicating drinks into the College grounds and Dormitory, preferred against Cadets W. H. Camp, J. S. Stays and W. L. Hardy. The case was referred to the Faculty by the B. O. D. The accused appeared before the Faculty one at a time and one and all admitted the truth of the charge stated. Prof. W. H. Patterson moves that they be publicly reprimanded and that the propriety of their further stay at the Dormitory be referred for decision to the Dormitory Board. The motion is seconded by Prof. Shaleford. Prof. Kastle agrees by moving that they publicly reprimanded, put under arrest for 4 weeks and walk post duty one hour every day for the same period (Sundays excepted) Prof. W. H. Patterson called for the ayes and Nays on the amendment. The call is seconded. The vote being 5 ayes, resulted in ten ayes for and four Nays for the amendment. The original motion, as amended, was then voted on and carried. On motion of Prof White

A. M. College, February 21st 1890

Faculty met in called session at 12 M. in the President's room. In the absence of Pres. Patterson, Prof. Stanleford takes the chair. All members present except Prof. Pence. Objects of meeting to hear the appeal of Casels Mills & Hardin from the decision of the Dormitory Board. Col. Clark, Chairman of the Board, states that Casels Mills and Hardin having been accused of committing a nuisance in the Dormitory, the Board had heard them; they had denied the charge, but testimony being very strong against them, the Board had held them and especially the room orderly responsible and had decided that they must leave the Dormitory unless they could point out the guilty party. Faculty decided to punish the room orderly, Casel Hardin who had been absent from his room (residing another room) by two weeks confinement to quarters and walking daily one hour each weekday during the two weeks.

Casel Wallis presented petition of several Casels to be allowed the use of the mess hall in the new Dormitory once a week (Saturday night) for the purpose of having a dancing school. The Faculty not deeming themselves competent to dispose of any rooms in the College Buildings the petitioners were so informed. Faculty then adjourned.
