# ACLU Requesting Help in Support of Domestic Partner Benefits

There is an effort underway to prevent Kentucky public universities such as UK and U of L from allowing their employees to include same-sex domestic partners in their health care plans. The American Civil Liberties Union is working in support of the public universities' effort's to be inclusive. The ACLU is asking people to contact them by filling out a simple online survey at: www.freedomtomarry.org/stories/page1

If you are a gay or lesbian employee of UK or U of L, or a heterosexual employee who has a sponsored dependent, the ACLU would like to know your story. How would you be affected if health benefits were stopped? Personal stories often have an impact on legislators and the people who elect them to office.

Anti-gay activists claim that offering benefits to gay couples violates the Kentucky marriage amendment which defines marriage as between a man and a woman. The ACLU and most of us in the GLBT community believe that hardworking university employees should be able to provide benefits for their families no matter the sex of their partner or their marital status. Since marriage is not available to same-sex couples in Kentucky, it is unfair to deny gay and lesbian people the opportunity to provide health coverage for their loved ones.



### **Bluegrass Fairness**

Huegrass Fairness of Central Kentucky (BFCK) would like to congratulate the winners of the November 6th election. We were glad to see profairness candidates including Governor-Elect Steve Beshear and Attorney General-Elect Jack Conway voted in by a landslide. Bluegrass Fairness will work with the winners and encourage them to lead Kentucky in a progressive and fair manner for all of its residents.

We also congratulate Senator Ernesto Scorsone for being named to Beshear's transition team. Scorsone will keep fairness for all in mind as he helps Beshear's administration move smoothly into Frankfort. Coming out publically as gay has certainly not hurt Scorsone's ability to work with fellow democrates in government.

Although a large majority of Kentuckians voted for pro-fairness candidates, BFCK knows the work is not finished. We expect that anti-fairness legislators will propose bills that would knock down domestic partner benefits at Kentucky's public universities. Such legislation failed in the last legislative season, but the threat is ever-existent, so

we will work just as hard to defeat such legislation in the long 2008 session.

On a positive legislative note, Rep. Mary Lou Marzian of Louisville has pre-filed the hospital designee bill. This bill will allow anyone over the age of 18 to designate a non-blood person as having the right to visit him or her in the hospital. Upon passing into law, gay people will have the capacity to designate their partners as having hospital visitation access. BFCK will fully support Marzian's efforts.

The Employment Non-Discrimination Act (ENDA), first proposed in 1974, finally cleared a major hurdle. In an historic move, the House voted to pass ENDA. The bill provides employment protections for gay, lesbian, and bisexual people. Although BFCK would like to see the bill go further to protect people of the trans community, we view its passage as a major progressive step forward. We encourage everyone to thank Rep. Ben Chandler for his affirmative vote. The bill still faces hurdles. It must pass the Senate and face a possible veto from the President. We will continue to work for its complete approval.

# The Positive View By Dr. Sherry and Prof. Skippy Part 11: Exploring sexuality and relationships

A consequence of freedom from gender role expectations (a topic we discussed last month) for some gay men and lesbians is a feeling of being freer to explore different expressions of their sexuality and different constructions of intimate relationships.

Freedom in gender roles may allow lesbians and gay men to more freely engage in various types of sexual behaviors and relationships with partners. Freedom from heterosexual relationship scripts allows for the creation of new relationship norms.

One gay man summed it up as "a freedom to explore [sexuality] that comes with being openly gay." Another gay man stated, "Being in a skirt has a different feel to it than western pants. I am not talking about drag per se. Just as being naked has its own feel. Most straight men can't go there."

Another gay man wrote, "Our relationship was 'unconventional' to start with which has given us the opportunity to work on it with a lot of freedom [including] more sexual freedom;" while another offered, There is considerable freedom for a gay couple to communicate, negotiate, and establish their own rules and traditions."

A lesbian participant shared that, "Being a lesbian is positive because it provides the opportunity to create a lot of the rules of life and relationships. ... It has a freedom to create new types of relationships."

Another lesbian wrote, "... a built-in separation from societal mainstream [sexual] norms, which frees me somewhat from having to conform to

those norms." One lesbian expressed her sense of freedom as "I do not feel that I am bound by any rules or regulations in a relationship."

Another lesbian elaborated a similar point, "There are no gender limitations on anything - we do what we do best and what we like to do. For example, I'm very feminine and my partner is more masculine. However, I'm physically stronger and I don't mind getting dirty. So I do the heavier work. It's great to not have to fall into society's predefined categories based on appearance."

Creating relational scripts that are free from gendered prescriptions allows for flexibility within roles and may even help prepare gay men and lesbians for later life. The concept of gender role flexibility for older gay men and lesbians is a strength which allows for greater adaptation to the demands of aging and greater flexibility in relationship roles as we grow older (Berger & Kelly, 1986; Friend, 1987, 1990). Gender nonconforming behavior is therefore a positive aspect that allows individuals to "have a wider repertoire of available coping tools and responses at their disposal as they age" (Ritter & Terndrup, 2002, p. 141).

How has being LGBTQ freed you to explore your sexuality and the norms of sexuality? How have you gone about creating your relationship scripts? What are the positive things you have learned about sexuality and relationships that you think heterosexuals could benefit from?



### Same Sex Married Debate

The effects on GLBTQ People

In May/June and November of 2006, Dr. Sherry Rostosky and Dr. Ellen Riggle conducted a study related to the debate over marriage rights for same-sex couples. Over 2500 individuals participated including participants from 48 states (and D.C.). They have finished an initial analysis of the data.

They believe the findings from the data suggest the following:

A. Having a marriage ban amendment on the ballot increases political participation and voting by GLB citizens in a state.

B. Having a marriage ban amendment on the ballot increases exposure to both positive and negative messages about GLB issues in that state.

C. Having a marriage ban amendment on the ballot increases the level of active coping efforts by GLB individuals in that state.

D. Passing a marriage ban amendment is associated with less positive affect and increased negative affect for GLB individuals in that state.

E. Passing a marriage ban amendment in a state results in higher levels of stress and depression for GLB individuals in that state F. Passing a marriage ban amendment may suppress future voting by GLB citizens in that state in some circumstances.

The researchers believe that these effects are temporary. Given the lack of significant differences on these measures between states with no marriage ban amendment and states that had an amendment passed prior to 2006, they suggest that the effects noted above may be relatively short-term.

However, this does not negate the reality of the effects. Three-fourths of the sample (75%) believe that marriage ban amendments have "a major impact" on the lives of same-sex couples. Based on the

data, many people are finding positive, active ways to cope with these challenges.

GLBTQ people engage in positive conversations about and become more active around GLBT rights issues. People find social support from friends, family and the community. And people recognize and talk about their feelings, which can help alleviate stress.

More research is needed to help identify the positive as well as the negative effects of the current political and social climate in the U.S. For more information about our findings, or to access a copy of the complete paper, go to www.PrismResearch.org.
