Minutes of the regular monthly meeting of the Executive Committee of the Board of Trustees, University of Kentucky, Wednesday, July 7, 1920.

The Executive Committee of the Board of Trustees, University of Kentucky, met in regular monthly session on Wednesday, July 7, 1920, in the President's office at the University at 12:00 o'clock, noon. The following members were present: Richard C. Stoll, Richard P. Ernst, Robert G. Gordon, and Rainey T. Wells. President McVey was present at the meeting and in the absence of Mr. Patrick, Secretary of the Committee, Senator D. H. Peak acted as secretary.

The minutes of the special meeting of the Committee for June 1, 1920, were approved.

- (1) Purchase of Gordon Property. The President was authorized to purchase the Gordon property on Lexington Avenue adjoining Maxwell Street Presbyterian Church from Mrs. Mary C. East, as of date June 30, 1920, on the best terms possible, the deferred payments to be due in one, two, three and four years. The building is to be used as a dormitory for girls and such expenditures for repairs as may be necessary properly to fit it for the purpose stated are hereby authorized. The President is further authorized to make such expenditures as may be necessary for the proper furnishing of the building.
- (2) Purchase of Engineering Equipment. The following resolution relative to the purchase of engineering equipment was passed: Whereas by the acts of the General Assembly of the State of Kentucky at the session of 1920 there was appropriated the sum of thirty thousand dollars for the fiscal year ending June 30, 1921 and thirty thousand dollars for the fiscal year ending June 30, 1922, for the purpose of purchasing engineering equipment for the College of Engineering of the University of Kentucky, and whereas it will be greatly beneficial to contract for this engineering equipment at once, therefore be it resolved that the engineering equipment provided for in said acts of appropriation be and the same is hereby ordered to be purchased to be paid for as the money becomes available under the law.

- (3) Stop and Rates in Front of Experiment Station Farm. Mr. H. P. Pope, General Manager of the Kentucky Traction and Terminal Company and Colonel John R. Allen, attorney for the company, appeared before the Committee relative to the stop and rates of fare to be charged to the stop in front of the Experiment Station farm. Mr. Stoll stated to the Committee, immediately upon their first appearance before the Committee that he is the general counsel of the Kentucky Traction and Terminal Company and a number of the Board of Directors of the Company; that it would be highly improper for him to take any part in the discussion of the matter and he stated that he declined to take any part in it. He did not enter into the discussion of the matter, nor did he vote on the matter or relative to anything connected with it. Mr. Stoll requested Mr. Rainey T. Wells to take the chair, and Mr. Stoll retired from the Chair and took no further part in the proceedings. No action was taken on the matter.
- (4) Plans for Men's Dormitory. It was ordered that the tentative plans for men's dormitory submitted by Coolidge and Shattuck be accepted and that the company be authorized to prepare complete plans for the building.
- (5) <u>Nemorial Building</u>. Report was made on the progress of work of the committee on Memorial Building, and the continuance of the work toward raising funds was approved.
- (6) Fire Escapes. The report of the Committee on fire escapes was approved and ordered incorporated in the minutes as follows:

June 1, 1920

To the Honorable Board of Trustees

University of Kentucky

Gentlemen:

We herewith submit report of your Committee on Zire escapes for Girls' Dormitories.

Patterson Hall. This building has one large entrance from the front and one from each end of the main floor. From the main floor there are two separate and distinct stairways leading up to all the upper floors, both being accessible from any floor.

There are two iron fire escapes: one in each wing of the building at the rear. We consider the means of exit in case of fire are excellent and cannot understand why the question of fire escapes was ever raised.

Maxwell Hall. This is merely a two-story residence with one stairway in the front part of the house and one outside wooden stairway at the rear. This latter is not used ordinarily, but would serve as a rear exit from the upper floor in case of fire at the front. This building also has a front porch on second floor from which escape could be made by ladders or ropes. We see no hazards here over that of any residence.

The back stairway mentioned above would need repairs after another winter.

- (7) Free tuition for Ex-service men. Mr. Rainey T. Wells was appointed to ask the Attorney General to give an opinion on the act of the General Assembly of 1920 relative to free tuition, etc., in the University of Kentucky and other schools for ex-service men.
- (8) Secondary Education. The offer of the General Education Board as contained in the following letter was accepted.

We received this morning the joint letter of Mr. Colvin and yourself regarding the cooperation of the General Education Board in the field of secondary education in Kentucky. We are happy to know that Mr. Rhoads becomes

professor of secondary education in the University of Kentucky. The Board provides a salary of \$3,600 with an additional allowance of \$250 for traveling expenses, in order to enable Mr. Rhoads to keep in touch with the secondary schools within easy reach of the University. As you will remember, the resolution of the Board stipulated that its appropriation for this work will terminate at the close of a five year period.

- (8) Transfer of Moneys on Books. The Business Agent having heretofore paid a portion of the unpaid purchase price of the property referred to in the contract approved March 21, 1917, out of the general fund instead of out of the fertilizer fund, he is now ordered to reimburse the general fund for such sums so so paid out of the fertilizer fund and to make such additional payments on said property as may be due out of the fertilizer fund.
- (9) Dr. Patterson's Residence. On account of the illness of Dr. James K. Patterson and his inability to get up and down stairs, the installation of a bathroom on the lower floor of his residence was approved and the necessary funds for that purpose appropriated.
- (10) Contract with the Federal Board for Vocational Education. The contract with the Federal Board for Vocational Education for instruction of disabled soldiers was approved. The contract of the previous year is changed only by the insertion of a clause relative to work in the Department of University Extension.
- (11) Shortage in Government Ordnance. It was ordered that \$148.24 be paid to the Director of Finance, Washington, D. C., on account of shortage in government ordniance as shown by the inventory of Captain Tucker, the army officials not accepting the statements in the inventory as sufficient to cancel shortage.
- (12) Improvement of Roads on Campus. The improvement of roads on the campus as now in process under budget appropriation was approved.
- (13) Increase in Water and Electricity Rates. A letter from Lexington Hydraulic and Manufacturing Company showing an increase in rate of one cent per thousand gallons of water was filed, and also a letter from the Lexington Utilities Company showing an increase of 10% surcharge was filed.

- (14) Carey-Reed Account. The certifications of H. E. Curtis and D. H. Peak as to the bill of the Carey-Reed Company for \$181.28 for building road connecting Graham Avenue and the University campus were deemed sufficient and the amount was ordered paid as follows: three-fourths out of the Experiment Station Fund and one-fourth out of the General Fund, the road being three-fourths on Experiment Station lots and one-fourth on the University campus.
- (15) Cafeteria Quarters. It was ordered that part of the basement of Science Building be reconstructed and repaired for use as cafeteria rooms, the cost to approximate \$4,500.
- (16) Rooms for the Department of Music. It was ordered that part of the basement of Patterson Hall be reconstructed and repaired for use by the Department of Music, the cost to be approximately \$1,800, and that pianos be purchased for use therein not more than five in number, to be paid for out of rental earnings.
- (17) Rebuilding of African Baptist Church on Winslow Street. It was ordered than an investigation be made as to the report of rebuilding African Baptist Church on Winslow Street.
- (18) B. C. Hagerman Claim. The Business Agent was ordered to investigate the claim of B. C. Hagerman for gymnasium goods and typewriter purported to have been sold to the University in 1909, and report at the next meeting of the Committee.
- (19) Use of Automobiles and Payment Therefor. The following recommendations of Dean Cooper were approved:

Referring to my recent memorandum to you, I wish to recommend that permission be given for the payment of the sum of \$50 a month to county and home demonstration agents using personally owned automobiles in lieu of any other expense such as livery hire, vehicles, or expenditures on their own automobiles, with the provision that such payments may be made to such agents as may within the discretion of

the Director of Extension and the Dean of the College of Agriculture, be entitled to such payment.

In explanation of the above, I will say that certain men and women will evidently not be entitled to the payment of such a sum as they either make very slight use of a personally owned automobile or utilize horse and livery. The payment named will not sufficiently recompense the men or women who use their cars for continued travel in their work and I think this is as fair an arrangement as we can afford.

I trust that this will receive the approval of your-self and the Committee.
