PREFACE

The publication herewith presented, an index to the probate cases filed in Newton County, Texas, is No. 176 of the Texas series of counties. The publication is intended to meet the requirements of day-to-day usage by the officials of the county, attorneys, businessmen, and other citizens who have occasion to consult probate case records for the proper conduct of their affairs. The publication may be used by historians and genealogists to obtain references to unpublished source material.

The names of the deceased persons, minors, and other principals are arranged alphabetically, with reference to the filing date of the case and the case number. Differentiation between probate cases assigned duplicate numbers is accomplished by the addition of a letter following the case number, except in lunacy cases the prefix "L" is used. Case numbers preceded by "O" were assigned to previously unnumbered cases. The following numbers in series 1-966 were not used as case numbers: 16, 48, 52, 91, 104, 135, 139, 149, 157, 161, 162, 170, 175, 184, 196, 211, 231-234, 237, 242, 261, 262, 314, 354, 468, 541, 675, 717.

In Newton County the probate case papers are in the custody of the county clerk, and are filed in his office along the east wall in 32 file boxes numbered from 1 to 32, inclusive. The case papers are arranged in separate file jackets in steel file boxes in chronological order according to the filing date.

Since the transfer of territory from one county to another has affected probate jurisdiction and has determined the county in which the probate case should be filed, a map and table of territorial changes are included herein. Notations concerning present location and availability of records pertinent to Newton County follow:

Jasper County, Jasper, records destroyed by fire October 28, 1849.

Liberty County, Liberty, majority of records destroyed by fire 1876.

Sabine County, Hemphill, records destroyed by fire December, 1875.

San Augustine County, San Augustine, records extant.

The lower third of Newton County was included in the "judicial" county of Neches, created January 29, 1842 (8). It is doubtful that Neches was ever organized, however, for in the same year, a decision of the Supreme Court of Texas held acts attempting to create "judicial" counties unconstitutional (9).
