Israel To Grant Posthumous Citizenship

Jerusalem (JTA) - The 6,000,000 Jews who perished in the Holocaust and those "righteous gentiles" who died while saving Jews during the Nazi reign of terror, will be granted posthumous Israeli citizenship, according to a recent declaration issued by the Knesset.

This unprecendented expression will be officially announced at the 40th anniversary observance of the defeat of Nazi Germany scheduled for May 5 to 9 in Jerusalem.

Each participant in the assembly will receive a certificate designating him or her as a witness to this memorial rite. The world assembly is expected to serve as a time of rededication to the memory of those whose lives were extinguished by the Nazis and to those who survived to restore and revitalize the Jewish nation.

The Central Kentucky Jewish Association held its annual Yom Hashoah observance on April 18, 1985 at Temple Adath Israel. Coordinated by Stanley Saxe, the program featured Mr. Ken Kurtz, News Director of WKYT-TV, who has just recently returned from a special media tour of Israel.

In addition instrumental music was provided by Michael Lerner and Lawrence Sherman, vocals by Arthur Graham and Oscar Haber, and readings by Rabbi William Leffler, Kenneth Germain and Harriet Rose.

Of note this year, which marks the fortieth anniversary of the liberation of the Nazi death camps, is the fact that CKJA was not the only sponsor of a memorial program. The week of April 14-21, 1985, proclaimed by Governor Collins as "Days of Remembrance", was marked by a similar proclamation issued by the Student Government Association at the University of Kentucky and a movie presentation on April 17th.

AMERICAN JEWISH RESPONSE TO PRESIDENT'S TRIP TO GERMANY

San Francisco, April 22, 1985 ...

During the weekend marked by the poignant pleas voiced by Elie Wiesel and others imploring President Reagan to cancel his visit to a German cemetery in which former German SS troops are buried, the Council of Jewish Federations Board met in San Francisco and authorized the following telegram be sent to the President:

"Knowing how deeply you feel about the Holocaust, we welcome your decision to visit a Nazi concentration camp to remember those who were martyred by Nazi genocide. But we are disturbed and perplexed by the decision and its justification for visiting a cemetery in which SS troops are buried and recognized. We believe along with veterans' groups, that those whose memory should be cherished are those young men and women who gave their lives to liberate Europe from Nazism. The fortieth anniversary of the end of World War II should not be marked by paying tribute to those who served -- voluntarily or involuntarily -- as instruments of Nazi tyranny and brutality. With you, we do believe in reconciliation, and in that spirit we should recall those Germans who had the courage to stand up to Nazism, even though it cost them their freedom and, in most cases, their lives."

New York, April 26, 1985 ...

Responding to President Reagan's visit to the German military cemetery in Bitburg, a delegation of Jewish and Christian leaders from the United States and from European countries will visit Munich to honor Germans who gave their lives resisting Hitler.

On Friday morning, May 3rd, memorial services will be conducted in memory of the White Rose, a German group of young anti-Nazis who paid with their lives for their resistance. It will be followed by a memorial service in Dachau.

Our memorial tribute to the White Rose is intended as a declaration to the world that we do not oppose reconciliation with democratic and anti-Nazi forces in Germany, but we reject the lie that the Nazi armies were victims, rather than Hitler's tools in the unprecendented evil unleashed by Hitler on the world.

There cannot be reconciliation with the chapter of German history that is symbolized by Bitburg.

NOBEL NOMINEE

Bonn (JTA) - Eli Wiesel, the Jewish writer whose best known works have been on Holocaust themes, has been nominated for the Nobel Peace Prize by several members of the Bundestag faction of the ruling Christian Democratic Union (CDU) and its coalition partner, the Free Democratic Party (FDP).

The German politicians wrote to the Norwegian Prize Committee proposing Wiesel for his contributions to promoting understanding and conciliation in the post-war world. Wiesel, born in Hungary in 1928, is a survivor of the Auschwitz and Buchenwald concentration camps.

Mengele Search Urged

Sen. EDWARD KENNEDY (D-Mass.) and Rep. ROBERT MRAZEK (D-N.Y.) have written to the chairman and ranking members of the House and Senate Appropriations Committees urging them to include in the next appropriations bill a provision "for the Department of Justice to pay a reward of one million dollars for information leading to the apprehension of (Nazi war criminal) Joseph Mengele.

We feel that a reward by the United States Government is especially fitting, in light of reports that our Government itself may have permitted Mengele to escape justice in the period immediately following

World War II.'

In other action, 79 Representatives have cosponsored a resolution initiated by Rep. JAMES FLORIO (D-N.J.) expressing the "sense of Congress that the United States should continue its investigation into the residence and activities of . . . Mengele.'

PRIME MINISTER SHIMON PERES' STATEMENT TO WORLD JEWISH COMMUNITIES ON ISRAEL'S 37TH INDEPENDENCE DAY


Israel's 37th Independence Day is a day of tears and of pride -- tears for the lives of the young people through whose courage we have renewed and maintained our independence and pride in what has been achieved, thereby changing the course of Jewish history.

Zionism has sought to build a state through peaceful means, through friendly relations with our Arab neighbours and mutual assistance. We have not fostered hostility, but we have been forced to stand up against it. We have not sought wars, but when we were attacked, we had no choice but to win them. We are the smallest of nations, and a small part of our own people -- and in the wars we have had to fight, we have been a handful against many. Only the burning vision of the founders, and the supreme heroism of the defenders -- only these have made it possible for the Jewish people to live anew on its land.

Vision and sorrow unify our people, and bestow upon it a uniqueness and a strength without equal. Our outlook is guided by victory in war, but even more by the hope of achieving peace. Tranquillity is not yet ours, but the improvement of relations with Egypt shows that peace is possible. And our departure from Lebanon will show that we can secure peace for Galilee from our own border.

Our strength derives from within, from the closing of our ranks, from the bravery of our sons and daughters, from the revitalization of our economy. We shall maintain our defensive strength, and we shall not tire in the search for peace.

We shall always feel the harsh yoke of destiny and the deep hope that accompanies it -- the destiny of a people facing enmity and danger and the hope of a people that likes people, that believes in freedom and that calls for justice.

CHARLES STERN APPOINTED AS GENERAL CHAIR OF ISRAEL BOND CAMPAIGN

STERN ALSO HEADS REINVESTMENT EFFORT

Charles Stern has recently been named as General Chairman of the 1985 Central Kentucky Jewish Association Israel Bonds Campaign. One of the most active leaders of the Jewish community, Stern is a past president of Temple Adath Israel, has served as treasurer of CKJA, and was once more elected to the CKJA Board this past December. Stern's first assignment was the post of Chairman For Reinvestment of Israel Bonds for Central Kentucky.

"This is the beginning of a major community effort to secure early reinvestment of Israel Bonds which will mature in 1986," Mr. Stern explained.

1985 Campaign Committee Chair Erle Levy pointed out that a large number of Fifth Development Issue Savings and Coupon Bonds, purchased in the period beginning in March, 1971, will mature beginning in March, 1986.

"The Government of Israel has agreed to permit these Bonds to be reinvested a year early," Mr. Levy explained. "This means that Bonds maturing in April, 1986 will be available for reinvestment in April, 1985, and so on.

"Israel's current economic difficulties make it more important than ever that Israel's friends demonstrate their partnership with Israel by reinvesting their Israel Bonds," he continued.

"Maturing Israel Bonds represent an excellent potential for extra investment dollars to further develop Israel's industries. Friends who purchased Bonds are confident that the nation's economy will soon be restored to its former growth. If they are reminded in advance that their Bonds will soon come due, I am sure they will reaffirm their commitment to Israel."

As part of the advance reinvestment effort, Stern said that holders of Bonds due to mature next year will soon be contacted by the Reinvestment Committee.

Both men expressed the hope that, given the opportunity to reinvest, friends of Israel will once again express their partnership with Israel.

BAR/BAT MITZVAHS IN ISRAEL

Bar Mitzvah and Bat Mitzvah ceremonies at both Jerusalem's Western Wall and at Masada are among the highlights of "Israel for Families" tours, sponsored by the American Jewish Congress' International Travel Program.

Tour dates for 1985 are July 11 to 25, August 8 to 22 and December 19 to January 1, 1986.

In addition to the dual Bar Mitzvah/ Bat Mitzvah ceremonies at the Western Wall and in the Zealots' Synagogue on the summit of Masada, other events include a half-day archaelogical dig, a folk dance party at a kibbutz, a poolside party with Israeli families, an evening tour of "illuminated" Jerusalem, a concert/dance performance and an "ethnic" food and entertainment evening with a Yemenite or Kurdish community near Jerusalem.

COMMUNITY RELATIONS COMMITTEE CHAIR REPORTS FROM NJCRAC PLENUM

The opening session of the annual meeting of the National Jewish Community Relations Advisory Council (NJCRAC) began with a talk by Dr. Albert D. Chernin, Executive Vice-president of the organization. Dr. Chernin provided a "lookahead" toward priorities for the coming year.

He identified the first priority to be a strong defense against the attack on the Bill of Rights. Some of the issues which have come before us in this area include religious tests for public office, the push for prayer in the public schools, and the recent decision in Pawtucket regarding the right to place religious symbols on public property. He urged all of the communities to continue to fight at the local and national level for a strong separation of church and state. The recent Supreme Court decision in Pawtucket did not mandate the placement, so we can still legally request and insist that what happened in Pawtucket does not happen in Central Kentucky.

His second priority was to counteract the trend against social justice in this country. Almost 20% of our citizenry are living in appalling conditions, with high unemployment and decay of the inner cities. He saw two major problems:
1) the fact that 20% of our populace is in such a bad state, and 2) the fact that no one seems to recognize problem number one.

Issue <u>number 3</u> is the plight of the <u>Soviet Jews</u>. This problem has existed for over 20 years. Recently the Soviet Union has been more restrictive than in many years. Dr. Chernin pointed out that the new discussions between our government and that of the Soviet Union provide us a new opportunity to help our brothers trapped within the USSR.

Last and most certainly not least will be the continual need for our strong support of the State of Israel. Although Dr. Chernin believes that US-Israel relations have never been better, Israel still needs our help. Inflation in the country is rampant, its defense budget is huge and it has a large national debt. We must continue to educate our elected representatives about the importance of Israel to American and to us.

With this overview of what the next year portends, the NJCRAC meeting began. Future issues of this bulletin will bring you highlights of specific sessions.





FORUM ENDS ON HIGH "MUSICAL" NOTE

On April 29, CHAVA ALBERSTEIN, Israel's most popular singer, appeared in Lexington Welcomed by a large and enthusiastic crowd, Ms. Alberstein presented a repertoire that ranged from popular Israeli numbers to traditional Yiddish folk songs.

Unlike most of the Israeli musicians with which we are familiar, Chava did not rely on the songs most of us know to reach her audience. REPORT FROM THE FIELD

The JDC office in Addis, Ethiopia is in operation. It is now expected that JDC will take delivery of the 7,500 metric tons of food offered at the end of February by the Office of Food for Peace of the Agency for International Development (AID) in Washington within two months.

The JDC will distribute a total of 30,000 tons of wheat flour, soy flour, dry milk and vegetable oil in the Gondar region over a twelve month period. The total value, including ocean transport, is \$8.2 million.

The JDC, along with other American agencies operating in Ethiopia, is waiting for Congressional approval of funding in the inland transportation of the food, which in the case of JDC could amount to an additional \$5.5 million.

JEWS HELPING JEWS

MATZA REACHED JEWS OF BULGARIA ... The 3,400 Jews of Bulgaria received a shipment of Matza from the Jewish community of Yugoslavia. The Yugoslav Jewish community numbers between 5,000 and 6,000. It makes its own kosher wine and bakes its own Matza.

JDC programs in Yugoslavia help support an old age home, provide assistance to the elderly and handicapped, and fund a summer camp.

WINE AIRLIFT

The Manischewitz Wine Company has once again been able to airlift Kosher for Passover wine into East Berlin.

Working in association with the American Jewish Committee, Manischewitz kosher wines were provided to the few remaining Jews in East Berlin who struggle to maintain their Jewish identity and traditions.
