From the beginning of time man has had some form of punishment for the offenders of societies rules and regulations. These forms of punishment ranged from decapitation, loss of one or more limbs, to just plain confinement. Who devised the system of confinement as a means of punishment, I do not know, but it has through the years proved inadequate and far from the answer to the problem.

Today our prison population is at an all time high. Is the allure of crime so great? I think not, with our modern day means of detection. Who has failed? The individual who comes from a broken home? The man of poor environment or the sick and frustrated man? No, society, the people have failed. They have not found the solution to the problem, so they hide their failures behind high stone walls and iron bars.

It has become almost axiomatic to say that a man becomes a criminal not by his first offense, but by his first imprisonment. He has become a jail-bird, and that is how society looks at him, with very rare exceptions, when he is released. If society doesn't want to meet that man again in five or ten - years at the wrong end of a gun, it had better study the needs, fears, drives, and pathologies of that man and its own evils that helped create them. It had better give him a real second chance. Society will have to decide whether it wants animalistic revenge or solution to crime. It cannot have both.

While progress is being made, penal wise, in dealing with the offender, the people of this state as well as other states must give more attention to the problem, keeping in mind the changing attitudes is more than an institutional question, but ultimately resolves right back into the communities.

More interest must be shown in the man in prison. Is he being trained so that he might adequately support himself and his family? Is he being given the medical or psychiatric help he may require? Is this man given adequate clothing and funds upon his discharge to sustain him? Is his job sufficient for his family's support? These questions are important to the man in prison, but more so to our society or they may face that man again under adverse conditions. Why? Societies indifference. (Turn Page)

The average man sent to prison, is not a "Professional" Criminal, but a man who has made a mistake. They are what you would call a nuisance criminal. They are men who cash petty checks while drinking or men who rob "juke" boxes for drinking money. These men are not dangerous to society, but they are held in prison at a cost of better than \$2.00 per-day as against the cost of .37 per-day to maintain a man on parole. I mention these figures because sometimes the cold hard financial facts sink deeper than any words could.

There is nothing more discouraging to the man in prison, who is trying to rehabilitate himself, than to have his efforts completely discounted by the apathy of the public in general. The man's been punished for his crime, but he must forever bear the stigma of his offense in the eyes of the public. This in itself makes a mockery of rehabilitation and penology.

We must face the fact that there will always be crime and as a result prisons, but the man who does work hard and does rehabilitate himself deserves the constructive help of society and until help is evident, crime shall continue to soar.

The reason for submitting this article is that I was asked to write something on penology. I am not a chicken and I cannot lay an egg, but I can make a fairly good omelet. I am not a penologist or a psychologist and cannot analyse the complexities of penology, but perhaps I did whip up a little omelet from one inmate's point of view.

SCHOOL FOR YOUTH

When I was growing I had the craziest idea that a convict, inmate or whatever you would call them, were big, had a 3 day full growth of beard, could be seen only at night and had an I.Q.of an idiot. These ideas were brought about by such mediums as T.V. and comic books. Now that I have lived, slept, eaten and otherwise become very closely associated with this type of person because I am one of them, I wonder if the young people of today feel as I did as a youngster. This, I feel, is an important question in this day of juvenile deliquency To enlighten the minds of our young people who have little knowledge if any of the convict and his true life other than what he reads in the newspapers or through the aforementioned mediums.

But How? This is a question that psychiatrists, child guidance officials and what have you have been studying for sometime. I myself believe if some of these youngsters could have the opportunity to tour our penitentiaries and other places of confinement and see the glamour of prison life that we would then have a small start in rectifying a bad situation. The majority of teen-agers do not realize how easy it is to become involved in trouble and its everlasting stigma.

Its not a pretty sight to see fifteen sixteen year old youngsters entering a prison. I have witnessed many and have wished at the time that I could have given all my gain time if the parents of those and other teen-agers could be there to witness this sad sight. Yes these were kids devoid of a mature mind of an adult and being thrown literally, into the best school of all for furthering their education in-crime. Here are youngsters whose minds are at the point where they should be taught the wonders and mysteries of life, but instead their eager minds will absorb all the phases of criminal life. Who is to blame?

What a tragic way for these youngsters to start out their young life.

Almost immediately you can observe the change in their lives as they mix in with the groups.

These different groups boast of every type of crime known. They begin to talk con talk and think on wise. When their course is completed they have received the best possible training, in crime. Their teachers are experienced although not experts because they have been caught but they will have majored in them all.

Young people in the period of life called adolescence or the period of transition from childhood to adulthood is the age of pattern making. The kind of pattern they cut now will very likely be the model of their future. They are at an age when their thoughts and desires fill an important place in their lives and when properly directed can be developed into useful citizens. This also, is a period in life when they often feel alone and confused and need the guidance of their parents, their understanding and counsel, but if the parents are too absorbed in their own problems or just lack interest then the road very often will lead to prison.

A little more attention in behalf of the youngsters of today would be a start in remeding the element of the criminal mind. The girls working in the mail room state that they have seen a vast improvement and changes made for the better in the regulations of mail since their arrival to the institution. One reason, as they put it, is that more interest is being shown in mail procedure by the officials of the institution which consequently attract better services for prompt delivery of the inmate's mail, which in turn makes far better relationship between inmates and their respective love ones back home. In the mail censors own words, "Even though there have been tremendous and wast improvement here in the mail room we have not reached our peak, and are constantly striving toward betterment and improvement in further premises. "We try to please everyone although it is to be understood that pleasing everyone would be impossible due to the fact that many inmates don't seem to understand that we out here in the mail room have rules and regulations to abide by as do those wearing numbers out on the hill, but we do want to make it clear that we are interested in getting the mail out and in of the institution to each and everyone depending upon us for delivery. "We shall alway stand ready and willing to assist any inmate with any reasonable cause he may have dealing with this department, "it does our hearts good out here in the mail room to see the inmates getting steady correspondence from home, and it does our hearts equal good to see the inmates writing to their respective love ones back home regularly. "We want each and everyone of you to know that we are here to help the each of you in anyway we can.

The only class of people who can be relied on to render an intelligent and just verdict in a complicated case are men of learning. Savants. Yet it is common practice, in fact it is the law, to select men and women at random, without regard for their education or intelligence from the tax list of property owners. The rule seems to be, if the persons own property they automatically become first rate jury material.

The law also states one must be tried by a jury composed of his peers equals. If the law ever were followed faithfully, then a moron would have to be tried by a jury of morons. Since the law is not adhered to with strict scrupulousness in this respect, it would not be an infraction of the U.S. Constitution for legislatures to enact statutes requiring juries in complicated and all capital cases to be selected from a group of learned men and women.

WE FIND THE JURY GUILTY

The jury system is proclaimed to be the most advanced method devised by man for obtaining justice. This may even be true, but a methodical accumulation of critical information would probably reveal a great many faulty aspects in this system, too. For the facts are, justice under the jury system depends altogether on the quality of the jurors selected. A jury that has but a vague idea what a complicated case is all about will, in consequence, render a verdict conforming only to their understanding of it. This may be completely at variance with justice as later revealed by a review court.

The verdicts rendered by some juries have become classical American folk humor, but apparently this has not shaken the faith of the general public. The only persons gravely concerned are judges, prosecutors and lawyers. They are in the front lines, so to speak, and directly exposed to the inconsistent and often bewildering verdicts of the "twelve good men and true". But afte the verdict has been brought in the jurymen can go home and forget about it; the judge, prosecutor and lawyer, however, must live with it sometimes for year

In many cases the real victim is the defendant. Caught between the crossfire of incompetency on one side and the inability of a judge to change a jury's blunder on the other the defendant, although innocent, or, if guilty, possibly only to a minor degree, must pay the full price.

The following three cases histories point up the necessity for a change in the statutes (in these particular cases, however, the defendants were the victors and justice was relegated to the grass grown siding of indifferentism.)

In a celebrated case that caused a local furor a jury brought in and delivered the solemn pronouncement that we the defendants find the jury guilty It is not recorded how the judge squirmed out of this one but it is probably safe to say the presecutor and defense attorney would have-decided to sentence the jury to the state hospital.

In another case where the defendant was being tried for murder in the first degree(the victim was the defendant's mother-in-law), the jury found the defendant "not guilty by reason of sanity"Only God knows what the verdict would have been had the defendant been a raving maniac.

In still another case involving theft of a car the jury stated, with solemn countenance," we find the man who stole the car not guilty "Only one person in the courtroom was not embarrassed by that verdict.

There have been many reasonable and just verdicts rendered by conscientious and intelligent juries, of course, but this doesn't mitigate the risk involved in the present system. There is always the possibility an innocent man will be sentenced to life or even executed by incompetency in the jury room.

It has happened before, men have served part of a life sentence, others have been executed for other men's crimes, and it will happen most likely again unless safeguards are instituted.

In reference to Rehabilitation Programs in the penal Institutions, I do not agree with some of the methods used in rehabilitating at the institutions, due to the fact, in dealing with prisoners for the last sixteen years in Penal Institutions and Prisoners of War Abroad, I have found that rehabilitation is somewhat exagerated and looks good on paper only. I do believe in rehabilitation to a certain extent but I do not believe in putting rehabilitation before discipline and security.

Through my experience in institutions that I have been associated with and listening to other so-called penologist speak, I have found that it is very easy to get up and make a long speech and then at the end of the speech say"I don't know the answer". My firm belief is that if a man doesn't know the answer to his speech or lecture, he is not only wasting his time but also the time of those listening.

I do not believe that you can rehabilitate anyone unless they want to be rehabilitated and if they do want to be rehabilitated, it doesn't take too much effort. I think if you place adequate rehabilitation sources in front of an inmate and do not make it compulsory, if he is willing to be rehabilitated, it will be a success, however, on the other hand, I believe that if he is not willing to be rehabilitated all the rehabilitation programs that can be thought of will not help the individual. I've heard speakers make statements to put four men private tables in the dining room and not censor their mail, that it would be a big step toward rehabilitation. In my opinion, this is unimportant. I think the main things are required of an institution are to have adequate food and clothing, good housing, a good medical department, a good athletic department providing good sport programs, religious services and resources to keep each inmate's time occupied and also strict discipline both in the inmate body and the personnel and above all fair and impartial treatment.

In my opinion, all rules and regulations should be written as brief, to the point, and as short as possible, and enforced 100 per-cent. No rule is worth the paper it is written on if it is not enforced from the top to the bottom.

I think that it is a must that first you should let the inmates know what you expect of them, and second you should see that the rules are carried out -, without fail.

I think that all prisoners should be treated the same in an institution no matter what his crime was, what his standing was, or what his job is. I do not think that the degree of the crime for which he is committed should have any thing to do with how he is treated after he is committed to the institution.

I do not believe in using big college words in speeches in an institution due to the fact that 75 per-cent of the inmates in the State Institutions have less than a ninth grade education.

In my opinion, there have been some inmates somewhat spoiled in institutions by giving them more advantages than their fellow inmates receive. I don't believe in this kind of treatment and I do not believe the inmates expect it.

DEPUTY WARDEN'S THEORY CONTINUED

I think that any prison official should conduct himself in such manner that the inmates will understand that he will help them when help is needed the same as he will discipline them when discipline is needed.

I do not think that any one human being on earth is smart enough to answer the question, "What causes crime?" I do not think that the individual himself, in most cases, can answer why he committed the crime. This subject dates back several thousand years and I don't believe that anyone, at this date, is but very little advanced on this subject than they were back many years ago.

In my opinion, until some laboratory invents a little green pill that will curtail crime, there will still be need for enlargement of institutions due to the overwhelming increase of population.

In my opinion, all the rehabilitation programs that can be crowded into an institution will have very little to do with the amount of people that get into trouble. Simply because unless an individual has been in an institution, he has very little knowledge of what goes on inside the institution, frankly he doesn't care. Only a very small amount of the general public throughout the country that have any knowledge, what so ever, of a penal institution, unless they have been misfortunate enough to have been in one or have had some relative with whom they have visited.



DETAINERS A DEFEAT

REHABILITATION

U.S.Bureau of Prisons Director James V.Bennett two years ago wrote:

"A careful survey of those inmates now serving sentences in federal prisons shows that 37 % had one or more detainers on file.Now, 14 years later, I can find no evidence that the detainer problem has declined in seriousness. In our large penitentiaries the detainer problem seems actually worse."

Mr.Bennett added:

"The use of detainers must be branded a vestigial remnant of the old age concept of retributive justice. No purpose is served except the destructive expression of a primitive urge for vengeance".

Many men now serving time reacted to the threat of confinement just the way a hit-and run motorist reacts his crime. An overwhelming urge for self-preservation motivates men into actions which they would never consider undertaking in normal circumstances and situations.

Fear of prosecution of their original crime had driven these men to commit a series of desperate crimes in a futile attempt to escape. They now face impossible amounts of time and usually in different institutions.

Consequently many prisoners are in confinement, some for the first time, who are not eligible for trusty status, vocational training, conveniences and privileges of minimum custody and provisions for good-time diminution of sentences or paroles. Detainers have been filed against their releases; they face further court actions and sentences.

Until a man starts serving his final sentence at the last institution of a series, he can hardly be expected to be enthusiastic; until then the detainers make him penology's forgotten man.

Detainers should be subject to time limitations of validity and required to be reinstated periodically within that duration or automatically lose recognition of authority. Reciprocal agreements could be worked out with adjoining states concerning the particulars similar to those of extradition.

For instance, a man wanted by several counties or states should be tried by the court which makes the most serious charge from the stand-point of largest minimum of time to be served in case of conviction, and then each of the others in their turn. The first court obtaining conviction would then place limited detainers for the minimum time required by statute for their charges; expiring concurrently with the time being served on the original conviction, and providing they were renewed at the specified intervals. A man, serving time under these conditions would know exactly when his sentence would expire, and could be eligible for parole. He would be more interested in vocational training, trusty status, work and conduct records and more important he would welcome a place in the rehabilitation program.

With the problem of overcrowded prisons being universal these detainers will soon become a subject of interest to penal directors in trimming their budgets. This would be an ideal time to set up such a program as outlined. Why maintain a prisoner on a charge in one state when another state wants him?

By dropping detainers on prisoners held in other states and releasing prisoners to detainers on hand from other states quite a reduction in populations and expenses could be realized.

After all the prisoners are still doing time and paying their debt to society as a whole. Additional time served would accomplish destructive over-punishment and defeat any attempts to rehabilitate now.
