He stated that he would estimate that about sixteen (16) out of twentyone (21) fraternities did not have a standing of 1.3. Dr. Donovan made
the statement that he felt if the ruling were postponed a year, the
students might take care of the situation themselves. After considerable
discussion the motion was made, seconded and carried that Section 1 be
revised to read as follows:

1. Any fraternity or sorority which, at the close of the school year 1952-1953 or any year thereafter, has an average standing for both actives and pledges lower than 1.3 (the all-men average) shall be placed on social probation for the following year. Social probation shall prevent the fraternity from holding any social affair to which other than members are invited.

The motion was then made, seconded and carried that the recommendations on Social Organization Scholarship be adopted in entirety with Section 1 as amended.

The Faculty adjourned.

Minutes of the University Faculty, May 12, 1952

The University Faculty met in the Assembly Room of Lafferty Hall Monday, May 12, at 4:00 p.m. In the absence of President Donovan, Vice President Leo M. Chamberlain presided. Members absent were H. P. Adams*, A. J. Brown, Louis Clifton, Lyle R. Dawson, H. H. Downing, W. P. Garrigus, Ellis Hartford, Sarah B. Holmes, A. D. Kirwan, A. C. McFarlan, C. N. Mount*, Frank D. Peterson, A. E. Slesser, H. E. Spivey, and Frank J. Welch.

The minutes of April 21 were read and approved.

Dean White presented for the College of Arts and Sciences changes in title and catalog descriptions, which were approved by the University Faculty as follows:

I. CHANGE IN TITLE AND CATALOG DESCRIPTION

English 101. Change title from Current English Usage and Grammar to The Grammar of Structure and Usage.

New Catalog Description: Descriptive grammar for advanced students. Analysis of sentence structure; consideration of standards of usage; investigation of current practice.

English 102. Change title from Introduction to the Study of the English Language to Modern British and American English.

New Catalog Description: A survey of modern British and American English with respect to pronunciation, syntax, spelling, and usage. Historical developments will be examined insofar as doing so sheds light on modern practice.

English 204. Change title from Middle English and Modern

^{*} Absence explained

English to History of the English Language. New Catalog Description: A survey tracing the development of modern standard English from its Indo-European origin. Emphasis will be placed on the history of sounds, inflections, and vocabulary and the varying concepts of "correctness."

Dean White presented a request from the Department of Military Science to allow the members of Pershing Rifles to be absent from classes May 15 to 18 in order to attend the Pershing Rifles Annual Drill Meet at Ohio University, Athens, Ohio. The University Faculty voted approval of the request.

Dean White also presented recommendations from the College of Arts and Sciences to change the Rules of the University Faculty, page 21, section 11, relating to the requirement in physical education. Dean Carpenter presented a substitute motion, which was adopted by the Faculty, as follows:

- A. Beginning in the fall of 1952, all undergraduate students except those mentioned in paragraph B will be required to acquire two semester hours credit in physical education. Credit will be granted on the basis of one credit for each semester course and quality points shall be computed on the basis as other University courses. Time spent in the one-credit course shall not exceed three hours per week.
- B. The following students will be exempt from meeting the physical education requirements:
 - 1. Students entering the University with junior standing or above.
 - 2. Students who have successfully completed two semesters of physical education in another college or university.
 - 3. Students who have passed their twenty-fifth birthday
 - prior to enrollment at the University of Kentucky.
 4. Students who are excused from physical education by the Dean of the College involved upon the written recommendation of the University physician.
 - 5. Students who offer evidence to the respective Deans of Military Service exceeding three months. Such cases shall be certified to the Registrar by the appropriate dean.

It is anticipated that each service (required) course shall Note: carry one semester hour of credit and that the required two semester credits will be in addition to the present minimum of 128 credits required for graduation. (This does not apply where graduation requirements are in excess of 128 credits.)

Dean Terrell presented a recommendation from the College of Engineering that a new course be added. The University Faculty approved the course, as follows:

New Course to be added:

Civil Engineering 126, Hydrology. 2 sem. hrs. Occurrence, control and utilization of water particularly as a problem of Civil and Sanitary Engineering. Prerequisite: Civil Engineering

Professor W. S. Ward read to the Faculty the following resolution:

Whereas we the members of the University Faculty share with others a deep concern about the widely publicized athletic situation in out University;

And whereas it is our belief that the University Faculty should assume its full share of responsibility by participating actively in the efforts to clarify the issue and formulate the governing principles which should guide our athletic policies in the future;

Therefore be it resolved that a committee of eleven members (five of them to be the members of the present athletics committee of the College of Arts and Sciences) be elected by this Faculty and that this committee report its conclusions and recommendations back to this Faculty;

And be it resolved that this committee be elected at this meeting from those members of the University staff who are eligible for membership in this Faculty;

Finally, be it resolved that the Chairman of this Faculty present these resolutions, with the action of this body to the Board of Trustees at its next meeting for its sanction.

After some discussion the University Faculty approved the resolution, with the following amendments:

- 1. That the committee shall include representatives from each of the colleges.
- That the present Chairman of the Arts and Sciences Committee be authorized to call the new committee together for organization and election of a permanent chairman.
- 3. That the Committee be authorized to elect alternates, when necessary, to serve during the summer.

Following the adoption of the resolution the following college representatives were elected: Agriculture and Home Economics, Stephen Diachun; Engineering, H. A. Romanowitz; Law, F. W. Whiteside; Education, Ellis Hartford; Commerce, W. A. Tolman; and Pharmacy, J. W. Miles. The members of the present Arts and Sciences Committee are C. A. Anderson, T. D. Clark, George P. Faust, James Ward, Ralph Weaver.

Dr. Chamberlain spoke briefly to the importance of the Committee to investigate athletics. He emphasized the need for recommendations of a positive nature and pointed to a great opportunity as well as public support for appropriate action.

The Faculty adjourned.
