PREFACE

The <u>Inventory of Federal Archives in the States</u> is one of the products of the work of the Survey of Federal Archives, which operated as a nation-wide project of the Works Progress Administration from January 1936 to June 30, 1937, and has been continued in North Carolina since that date as a state project of that Administration.

The plan for the organization of the Inventory is as follows: Series I consists of reports on the Administration of the Survey, acknowledgments, and general discussions of the location, condition, and content of federal archives in the states. Succeeding series contain the detailed information secured by workers of the Survey, in inventory form, a separate series number being assigned to each of the executive departments (except the Department of State) and other major units of the Federal Government. Within each series No. 1 is a general introduction to the field organization and records of the governmental agency concerned; the succeeding numbers contain the inventory proper, separate numbers being assigned to each state in alphabetical order. Thus, in each series, the inventory for Alabama is No. 2, that for Arizona No. 3, that for Arkansas No. 4, etc.

For each local office information regarding each series, or unit of related records, is presented in the following order: title, inclusive dates ("to date" indicating an open file at the time the information was secured), general description of informational content, description of the system of filing or indexing (if any), a statement of frequency and purpose of use, form of the record itself (bound volumes, sheets in folders, etc.), linear footage, description of the containers, physical condition of the records (not stated if satisfactory), location by room number or other identifying information, and finally, the number of the Form 58SA on which this information was originally recorded by a Survey worker and from which it was abstracted for the Inventory. This form is on file in The National Archives. When it contains substantial information on addenda sheets which has not been included in the mimeographed abstract, indication of this is given by use of the reference "See addenda."

In North Carolina the work of the Survey was under the direction of Dr. C. C. Crittenden, regional director, with Miss Mattie Erma Edwards as assistant, from its inception until June 1937. Since that time it has been under the supervision of Miss Emily Bridgers. This Inventory of the records of the Department of the Navy in North Carolina was prepared in the Raleigh office of the Survey and was edited before final typing by Dr. Henry P. Beers of the Division of Navy Department Archives of The National Archives.

ASHEVILLE

NAVY RECRUITING SUBSTATION
Post Office and Court House, Otis St.

This station was established in Asheville on March 5, 1934. It reports to the Main Recruiting Station in Raleigh, and has jurisdiction over the following counties: Ashe, Avery, Burke, Buncombe, part of Caldwell, Cherokee, Clay, Graham, Haywood, Henderson, Jackson, Madison, Polk, Rutherford, Swain, Transylvania, and Yancey. Applications and correspondence are destroyed every two years.

CAPE HATTERAS (BUXTON)

RADIO DIRECTION FINDER STATION
Beach, 1 mi. N. of old Cape Hatteras Lighthouse

This station was established about 1903 by private individuals. It was taken over by the Government on April 1, 1919, from the Marconi Wireless Telegraph Company. It is under the jurisdiction of the Commandant of the Fifth Naval District at the Naval Operating Base in Norfolk, Va. Monthly reports are forwarded to Washington. Useless papers are destroyed after two years.

CAPE LOOKOUT (BEAUFORT)

RADIO DIRECTION FINDER STATION Coast Guard Reservation Harker's Island

This station was established at Beaufort on October 22, 1919. It was under the jurisdiction of the Commandant of the Fifth Naval District at Norfolk, Va., until 1931, when it was transferred to the jurisdiction of the Sixth Naval District at Charleston, S. C. It is located in a wooden building constructed in 1888. Records are burned after eighteen months.

CHARLOTTE

NAVY RECRUITING SUBSTATION Federal Bldg., 401 W. Trade St.

This station was established in Charlotte on May 22, 1934. It reports to the Main Recruiting Station in Raleigh, and has jurisdiction over the following counties: Alexander, part of Alleghany, Cleveland, part of Davidson, Gaston, Lincoln, Mecklenburg, Mitchell, Richmond, Rockingham, and Stanly. It occupied an office in the First National Bank Building from May to August 1934, when it was moved to its present location.

NAVY RECRUITING SUBSTATION

This station was established April 1, 1935. It has jurisdiction over Alamance, Caswell, Davie, Forsyth, Granville, Guilford, Montgomery, Moore, Orange, Person, Stokes, and Surry counties. Records were not surveyed.

NEW BERN

NAVY RECRUITING SUBSTATION
Post Office Bldg.
New and Middle Sts.

This station was established in New Bern on May 16, 1934. It reports to the Main Recruiting Station in Raleigh, and has jurisdiction over the following counties: Beaufort, Bertie, Camden, Carteret, Chowan, Craven, Currituck, Dare, Gates, Greene, Halifax, Hertford, Hyde, Jones, Lenoir, Martin, Onslow, Pamlico, Pasquotank, Pender, Perquimans, Pitt, and Washington. It was located in the old post office building at Craven and Pollock streets until 1935, when it was moved to its present location. All papers are preserved, with the exception of the waiting list which is prepared each month, when the old copy is destroyed. Records are sent to the Main Recruiting Station in Raleigh, and very few are filed in this office.

POYNER'S HILL (POPLAR BRANCH)

RADIO DIRECTION FINDER STATION
6 mi. E. of Poyner's Hill, across Currituck Sound

This station was established on March 7, 1921, on property of the Coast Guard. It is under the jurisdiction of the Commandant of the Fifth Naval District at the Naval Operating Base in Norfolk, Va., and reports through the Commanding Officer of Naval Radio Station at that Base. The station works in conjunction with Naval radio direction finder stations at Virginia Beach, Va., and Cape Hatteras, N. C., in furnishing radio bearings to ships at sea. It is located in a wooden building constructed in 1878 for the use of the Poyner's Hill Life-Saving Station. The building was slightly damaged in a storm in August 1933 but no records were destroyed. All records are sent to the Naval Operating Base in Norfolk, and recent records only are on file in this office.

RALEIGH

NAVY RECRUITING STATION Rogers Bldg., 10 W. Martin St.

This station was established in Raleigh about 1917. It has jurisdiction over all Navy Recruiting Substations in North Carolina and South Carolina. Substations are located in Asheville, Charlotte, Greensboro, New Bern, Salisbury, and Wilmington, N. C., and Charleston, Columbia, Florence, Greenville, and Spartanburg, S. C. The officer in charge in Raleigh reports to the Navy recruiting inspector of the Southeastern Recruiting Division in Baltimore, Md.; to the Chief of the Bureau of Navigation in Washington; and to the Commandant of the Sixth Naval District at the Navy Yard in Charleston, S. C. In North Carolina, the station has jurisdiction over the following counties: Alamance, Anson, Chatham, Durham, Edgecombe, Franklin, Harnett, Hoke, Johnston, Nash, Lee, Tyrrell, Union, Vance, Wake, Warren, Wayne, and Wilson. The station was located in the Rogers Building at 10 West Martin Street until 1933, and in the Wachovia Bank Building on Fayetteville Street from 1933 to 1935, when it was again moved to the Rogers Building, where it was located when the records were surveyed. In 1938 it was moved to the Federal Building on Fayetteville Street. Useless papers are destroyed after three years. Reports are filed in Washington.

This station was established at Salisbury on May 2, 1934. It reports to the Main Recruiting Station in Raleigh, and has jurisdiction over the following counties: part of Alleghany, part of Caldwell, Catawba, Cabarrus, part of Davidson, Iredell, Macon, McDowell, Rowan, Scotland, Wilkes, and Yadkin. Records are forwarded to Raleigh daily. The small number of records on file in the station are not open to inspection. Useless papers are destroyed.

It reports to the Main Recruiting Station in Raleigh, and has jurisdiction over the following counties: Bladen, Brunswick, Columbus, Cumberland, Duplin, New Hanover, Robeson, and Sampson. It was formerly located in the Post Office Building.
