

MINUTES OF THE SENATE JULY 23, 1923

The University Senate met in the Little Theatre Monday, July 23, at 3:45 p.m., President McVey presiding.

The following recommendation of the Rules Committee was adopted:

"That the University add to the high school units acceptable for entrance the following:

In Group A, under History and Civics, add Sociology, $\frac{1}{2}$ unit.
In Group B, add Salesmanship, $\frac{1}{2}$ unit. "

The following recommendations from the College of Arts and Sciences were approved:

Substitute for Hygiene 4a and 4b,

✓ Hygiene and Public Health 4, General Hygiene for Engineers, 2 hrs. a week, one-half of semester, .3 credit.

✓ Ancient Languages 14 - Teachers' course, first semester 3 credits.

The following courses were approved for the College of Education:

Requirements for Graduation:

The College of Education grants two degrees - a Bachelor of Arts in Education and a Bachelor of Science in Education.

Students who major in Education and select their group work in English, mathematics, social science, natural science, or the languages, will be entitled to consideration for the degree of Bachelor of Arts in Education.

Students who major in Education and select their group work in art education, agriculture, engineering or home economics will be entitled to consideration for the degree of Bachelor of Science in Education.

For a degree in Education, the student is required to present a total of 127 credits with a standing of 1.

MINUTES OF THE SENATE OCTOBER 8, 1923

The University Senate met in the Little Theatre Monday, October 8, President McVey presiding.

The minutes of July 23 were read and approved.

The following action of the Graduate School Committee of August 1, 1923, was approved:

"Graduate students pay annually a fee of \$15, for the regular session, and when registering in the summer session or sessions they pay the same fees as other summer students."

The application from Messrs. Moore, Mosely and Kirk to be permitted to publish a comic magazine at the University was referred to the Committee on Student publications with power to act.

The recommendation of the Committee on University Extension that as much as two years' credit in extension be counted toward graduation was considered and action postponed until the next regular meeting of the Senate.

The following committee was appointed to arrange a program for the University Assembly: Messrs. Jesness (Chairman), Crouse, Chalkley, Knight, O'Bannon.

Messrs. F. E. Tuttle and Geo. Roberts were elected Senate representatives in the University Council for the year 1923-24.
