ARL Statistics 1982-1983

Kentucky ranked 49th in the ARL Library Index for 1982-83 (down one position from 1981-82). In number of volumes, Kentucky ranked 53rd with 1,894,632 (down three slots from 1981-82). In number of volumes ordered, however, we moved up from 81st to 75th (by adding 49,749 volumes).

The ranking for microform holdings slipped from 12th to 14th and for current serials from 19th to 20th. A marked jump came in the current serials expenditures ranking, from 49th to 34th (\$1,428,876).

A noticeable change in total staff (FTE) moved Kentucky up to 61st from 67th (232 FTE).

The ranking for materials and binding expenditures (\$2,388,887) moved up one slot from 47th to 46th, while salaries and wages changed from 61st to 53rd (\$3,301,072). Total operating expenditures (\$6,152,707) moved Kentucky up from 58th to 54th. Library expenditures as a percentage of University expenditures were 2.7%.

New Issue of Kentucky Review

Volume V, number 2 of The Kentucky Review, the triannual journal of the Library Associates, has just been published and is available for \$3.50 from Brad Grissom in the Reference Department (257-1631). Included in this issue are printing historian John Dreyfus's tribute to artist-typographer Victor Hammer, a resident of Lexington during his last years; and Professor Thomas D. Clark's reminiscence of the Book Thieves, a Lexington circle of scholar-collectors that numbered two University of Kentucky presidents among its members. A felicitous addition to our list of contributors is Samuel Langhorne Clemens, whose sketch "A Song Composed in a Dream," first published anonymously in 1903, is printed for the first time under the nom de plume Mark Twain from the original manuscript in the Peal Collection. With the spring semester rapidly drawing to a close, attention turns to summer travel, research trips, and even vacations. Various departments of the M. I. King Library maintain extensive collections of information useful to the traveller.

The Reference Department has the latest editions of the Hotel and Motel Redbook (listing 8,000 hotels and motels in the U. S. and 1,500 hotels and motels worldwide); the Official Airline Guide: North American and WorldWide editions (with information on 50,000 scheduled flights in the U. S. and 284,000 connecting flights); the South American Handbook (a guide for vacation and business travellers in 32 countries, 1700 cities in the Caribbean, Mexico, and Central and South America); and Information Moscow (the definitive guide to the Russian capital).

The Map Library (basement, M.I. King South) owns road maps, city maps, Mobil Travel Guides, and Michelin Green Guides to Canada and parts of the U.S.A.; country maps, city maps, and brochures for Latin America; road maps, city maps, Michelin Green Guides and Rand McNally Blue Guides for Europe; and country maps, some city maps, and travel brochures for Africa, Asia, and the Middle East.

The Government Publications Department (116, M.I. King South) owns area handbooks for most countries, pocket guides to others, and brochures on national parks, battle grounds, and seashores. (Brian Coutts/Gwen Curtis)

THE UK LIBRARY SYSTEM

The following is another in a series of descriptive articles concerning various aspects of the UK Library System.

Kentucky Maps

One of the most valuable holdings in the Map Collection of the M. I. King Library is the set of Sanborn fire insurance maps of Kentucky cities. Covering over 150 cities and towns, the collection is the largest in the state. These maps were originally designed to be used in determining the risk involved in insuring buildings in urban areas. The maps depict in detail the location, size, structure, and use of buildings in the developed areas of a city or town. Most of the maps date from the 1800s to the 1940s. Only Lexington and Louisville were revised in the 1970s. The maps have since become an important source of information to architects, historians, geographers, genealogists, and urban planners. INFORMATION FROM THE PRESERVATION COMMITTEE

Besides air-drying wet books, several other techniques have been tried, such as dielectric drying, microwave drying, and vacuum drying. At the present time, the vacuum-dry technique seems to be the most efficient and economical way to dry large numbers (two thousand or more) of wet books. This process involves subjecting frozen books to a high vacuum in the presence of heat. This causes a physical process to happen that turns ice crystals to vapor without first melting and rewetting the books.

There are currently at least two private firms who use vacuum-dry techniques for drying books and records. One of these firms has the ability to move equipment on site to avoid shipping damage to fragile material. (Jessie Adams)
