

A. & M. College of Kentucky Sept 20 1907.

The faculty met in the Presidents room at 3.30 P.M. those present being Pres. Patterson, professor Nevele, Patterson, Poyor, Mathews, Miller, Mackay, Horwood, M. White, Wilson, Tuttle, Jumbrod, Rowe and Frankel.

The minutes of the last meeting were read and approved.

*Miss Cravens.* Miss Cravens appeared before the faculty with a request that she be permitted to undertake a course of advanced study in this institution for the present term or possibly longer, with a view to becoming eligible for her bachelors degree. She stated that she had received credits for 117 units of work out of a required 120 to enable her to secure such a degree at the University of Cincinnati.

Attention was called to the fact that by the rules governing such cases Miss Cravens could not receive her degree here without a year's work in residence.

Upon motion of Prof. Miller, seconded by Prof. Jumbrod, it was ordered that her certificates for work done at Chicago Univ., Harvard Univ. and Univ. of Cincinnati be accepted toward her bachelors degree, and that a certificate of any work done at the State College during a shorter period than the college session, would be made to the University of Cincinnati in order that she might receive her degree there where the major part of her work toward such a degree, had been done.

*Prof. John Patterson.* A letter was read from Prof. John Patterson of Louisville, Ky. asking that he be permitted to submit certain literary work which he had completed, with a view to securing from this institution

the degree of Doctor of Philosophy.

After some discussion it was ordered upon motion of Prof. Miller seconded by Prof. Frankel, that Prof. Neveille or author be called to explain to Prof. Patterson why it is inexpedient for this institution to grant the degree asked for. Professors Mackenzie and Mathews were appointed to cooperate with Prof. Neveille in this matter.

Prof. M. White presented an application <sup>I E Darnaby</sup> from Mr. G. E. Darnaby for his admission as a candidate for the Masters degree in this college. On motion of Prof. Miller, seconded by C. W. Mathews, it was ordered that Mr. Darnaby be accepted as a candidate for the degree of M. A.

On behalf of Prof. James White, Prof. M. White presented the following named as those of candidates for the degree of M. S.

Howell Spears major Chemistry.

Chas. A. Mahan major Entomology.

J. M. Davis " mathematics

Mrs. Mary Maguire .. mathematics

Prof. Rour submitted the name of Homer Puckett as a candidate for the degree of C. E. and Prof. M. White the name of J. W. Lancaster for the degree of

On motion of Prof. Wilson, seconded by Prof. Miller, it was ordered that Mr. Puckett's name be given to the Board of Trustees for the C. E. degree, at the Dec. meeting.

On motion, it was ordered that the candidate for the M. S. degree, be accepted.

On motion it was ordered that Miss Haunes be allowed to substitute a third year of German in place of the usual second year of French, she having changed her course from the scientific to the classical. The meeting adjourned
