Demand for dorm space is one of the first signs of a growth spurt at a university. UK will be opening three new dorms in fall 2005 located near the Complex and near Jewell Hall. And that reminds me of when I was a freshman here in the late Sixties.

I lived in Jewell Hall on Euclid Avenue. It's a grand old dorm, named for the wife of UK's third president, Frank L. McVey. Three of us lived in a 10' x 12' room! About the only thing we had in common at first was that we were all from out-of-state. After the first day of registering for classes, paying fees and buying books, we realized that we had a new friend. Each of us met Mike in one of the long, long lines that snaked around the Memorial Coliseum floor or at the bookstore. Today, Mike is retired from the U.S. Air Force and lives in Maryland. (His daughter is a UK alum, too.) My roommate Jeanne met her husband at UK a few years later and they returned to Georgia. My other roommate Stephanie left UK before graduating to marry a young doctor she had met and last I knew she was living in Kan-

The eponyms chosen for the new dorms are classic examples of what a university that dreams big and takes on all challengers to that vision celebrates in the success of its students and alumni

Dale E. Baldwin is a former UK cheerleader and 1990 graduate of UK. He is also a quadriplegic as a result of a cheerleading accident in November 1986. A native of Leitchfield, Baldwin is now co-owner of MPM Financial Group in Lexington, and he and his wife live in Simpsonville. Despite the changes for safety's sake made after Baldwin's accident, I still hold my breath when I watch how cheerlead-

ers throw their bodies around in striving to go higher and somersault more times in the air. I admire the example of success that Dale Baldwin is.

John T. Smith, who received his doctor of philosophy degree in education from UK in 1961, is also an honoree in the UK Alumni Association Hall of Distinguished Alumni. He was a graduate of Lexington's old Dunbar High School and an

Dale E. Baldwin alumnus of Kentucky State University. His career included serving as the first chief administrator of a Kentucky community college (Jefferson Community College) and the first African American to serve as a vice president in a UK administration. He was vice president for minority affairs. The title changed to vice chancellor in 1982 and he served in that position until he retired in 1984. Smith

John T. Smith died in July 1994. What a kind, smart, genuine person he was!

Margaret Ingels was born Oct. 25, 1892, in Paris, Ky. She earned a bachelor's degree in mechanical engineering from UK in 1916. She returned to UK after serving in several

private companies, and in 1920 became the first woman in the United States to earn a graduate degree in mechanical engineering. Her early research at UK and her other posts, including a public relations position for the Carrier Co. until her retirement in 1953, contributed to pioneering efforts in air conditioning. I didn't know Ingels personally, but she's a lady of success that always made me feel proud to be a UK

That's one of the things we try to do in the Kentucky Alumni magazine: share with you the stories of Margaret Ingels alumni that make us all feel good about the results of

our shared experience that is UK. Every summer I think of air conditioning and how UK alums were on the cutting edge of that technology. Yep; it makes me feel "cool."

RESEARCH NOTES



Large Gift for Equine Research

A gift of approximately \$6.2 million for equine research at the Maxwell H. Gluck Equine Research Center becomes one of the largest gifts ever made to the College of Agriculture. The gift is eligible for matching funds from the state's Research Challenge Trust Fund.

The gift represents the residual estate of the late Janet H. Koller, formerly of Valley View Farm, Danville. Koller

had a life-long affiliation with both Thoroughbred and American Saddlebred horses.

It's a Small World

Eight students are taking advantage of a unique undergraduate certification program in nanotechnology at the UK College of Engineering. The Nanoscale Engineering Certificate Program, headed by mechanical engineering professor M. Pinar Mengüç, prepares students for emerging career opportunities in nanoengineering with courses in fundamentals and principles of nanomaterial engineering and fabrication.

Nanomaterial refers to a manufactured substance measured at the molecular level. Nanomaterial is generally smaller than one-thousandth the size of a human hair, and researchers are exploring a number of uses for nanomaterials, from faster computers to sensors for a variety of purposes.

In addition to the eight students seeking certification, a total of 20 students are taking program courses.

3-D Face Recognition

The UK Center for Visualization and Virtual Environments is using laser and infrared cameras and projectors for accurate 3-D face-recognition that could be used in airports and other facilities in conjunction with the nation's homeland-security efforts. Led by Dan Lau, assistant professor of electrical engineering, UK is collaborating with Western Kentucky University and the University of Louisville on the \$650,000 project.

Lau's approach represents a divergence from many face-recognition techniques that are based on algorithms to achieve identification. Instead, his system uses sensors to offer precise measurements of facial features

and contours.

The Road "More" Traveled

The Kentucky Transportation Center at UK is collaborating with the Lexington-based Asphalt Institute on a \$500,000 joint research project that studies the relationship between good pavement construction practices and the long-term durability of asphalt pavements. The study has benefits for local, state and federal transportation agencies nationwide.

"This project is important because so much of our nation's economy and standard of living relies on the quality and conditions of our highways to move people and goods. I am pleased to see continued support for this important work," said Wendy Baldwin, UK's executive vice president for research.

Business at Coldstream

Coldstream Research Campus gained another tenant as Lexington-based Immpheron Inc. expands and creates 15 new jobs when it relocates its existing laboratory on Nicholasville Road to the Kentucky Technology Center. The biotech startup, co-founded by Heniz Kohler in microbiology and immunology, is currently working with the Canadian company InNexus Biotechnology to produce secondary antibodies for diagnostic kits.

Meanwhile, ASTeCC graduate LevTech has also moved to Coldstream. Alex Terentiev and Lance DeLong, physics and astronomy, use superconductivity levitation as a novel method of mixing hermetically sealed, high-purity solutions, such as those found in the pharmaceutical and biotechnology industries.

UK, China & Earthquakes

Earthquake experts from UK and the People's Republic of China will benefit from each other's research as a result of an agreement involving the Kentucky Geological Survey (KGS), UK's Department of Geological Sciences, and the Lanzhou Institute of Seismology in China's Earthquake Administration.

Three Chinese experts in seismology, geology and geophysics will visit UK in April to share their knowledge and learn about seismic research in Kentucky, including the state's network of seismic instruments

monitoring earthquake activity in the region. The KGS and the Department of Geological Sciences will send three seismic experts to China in the summer.

UK & Fayette Schools Partner

UK and the Fayette County Public Schools announced a new partnership to raise student achievement.

"Thanks to the University of Kentucky, more of our kids will have access to learning enhancers like music, foreign language and health care services," said Stu Silberman, Fayette County Public Schools superintendent.

UK President Lee T. Todd Jr., at a news conference at The Academy at Lexington, said that UK was excited to be playing a key role in this important partnership. "Inside the walls of schools such as The Academy lies the future of this community, this state and this country. We will raise student achievement in Fayette County one child, one life at a time."

The first phase of the program will focus on two schools, The Academy at Lexington and Booker T. Washington Elementary School.

Griffith Tops in Awards

Dr. Charles H. Griffith, associate professor, UK College of Medicine, Division of General Internal Medicine and Geriatrics, is one of four medical school faculty members from across the nation to receive the 2004 Alpha Omega Alpha medical honor society's Robert J. Glaser Distinguished Teacher Award. The award was presented at the annual meeting of the Association of American Medical Colleges and is given annually to two clinical and two basic science medical school faculty members in the partien

Griffith has received more UK teaching awards and recognitions than any other faculty member in the history of the UK College of Medicine.

Center Marks Anniversary

The UK Center for Aluminum Technology recently celebrated five years of association with one of Kentucky's leading industries. The center, a partner-ship between the UK College of Engineering and the aluminum industry, the Kentucky Cabinet for Economic Development and the U.S. Department of Energy, was established in 1999, with headquarters on UK's Coldstream Research Campus.

The multidisciplinary research center trains undergraduate, graduate and postgraduate students to provide leadership in aluminum technology; develops programs in aluminum technology for non-degree students in conjunction with community colleges and technical schools; and provides research on the fabrication and use of aluminum.

Aluminum processing is a leading industry in Kentucky. There are 142 plants or other aluminum-related facilities in the state; industry shipments of over \$4 billion per year; the industry employs 17,500 people in Kentucky, with average earnings of \$44,876 per year; and Kentucky tax revenue from the industry totals \$47 million per year.

Harassment Prevention Training

UK's new online sexual harassment prevention training program is available to small companies free of charge. "Preventing Sexual Harassment" is a product of New Media Learning, which serves business, education and government employers with online, interactive training courses.

As a public service, UK alumni worldwide employed in or owning businesses with up to 50 employees and those with significant ownership in private companies employing up to 200 may use the tool free of charge for employee training. The browser-based course can be used 24 hours a day on any desktop or laptop computer and meets all federal and state accessibility standards. It takes about 60 minutes to complete.

Two Med Appointments



Belcan Engineering Group opened a new engineering design center in Lexington for Sikorsky Aircraft Corp., with up to 40 jobs initially and as many as 300 by the end of 2005 that could benefit UK engineering graduates.

For more than three years, Belcan has provided engineering services to Sikorsky Aircraft, the Connecticut-based manufacturer of advanced helicopters for commercial, industrial and military uses. Belcan already has provided the support for a laboratory in the Ralph G. Anderson Building, named for the founder of Belcan who also is a member of the college's Hall of Distinction.

"Belcan, the university, and the state all benefit from this type of cooperation," said UK President Lee T. Todd Jr. "It creates opportunities for our students and faculty, Belcan capitalizes on UK's talents and resources, and the state's economy grows from the addition of significant jobs."

Lori Stewart Gonzalez, associate dean for academic affairs and professor of communication disorders, is the new dean of the UK College of Health Sci-

She joined the faculty of UK in 1991 as assistant professor of communication disorders in the College of Health Sciences Department of Clinical Sciences, was named associate pro-

fessor in 1997, and appointed in 2000 the associate dean for academic affairs and served as associate professor in the Division of Communication Disorders. She was named full professor in 2004.

Gonzalez succeeds Thomas C. Robinson who stepped down after 20 years of leadership to return as a faculty member in the college's Clinical Leadership and

Management Program.

Dr. Stephen W. Wyatt, former interim associate dean for research at the UK College of Public Health and associate director for Cancer Control, UK Markey Cancer Center, has been named dean of the UK College of Public Health. Wyatt also is an associate professor, Department of Preventive Medicine and Environmental Health, UK College of Public Health.



Since joining the UK faculty in 1998, he has received several research grants funded by the National Cancer Institute and was the principal investigator for the Prevention Research Center, which is funded by the Centers for Disease Control and Prevention. His research interests include cancer surveillance, access to cancer care, and cancer education and outreach programs.

A UK Love Story

Marjorie and Stanley "Pete" Warner shared a love for each other, UK, and their family farm.

Marjorie Palmore graduated from Horse Cave High School in the

spring of 1941. That fall she enrolled at the University of Kentucky. Stanley A. "Pete" Warner graduated from New Albany Indiana High School the same spring. Both entered UK that fall, and they met at a sock hop in the Student Union.


Then came Pearl Harbor. Pete joined the U.S. Air Force, and Marge returned to UK. In the spring of her junior year, Pete received a copy of the *Kernel* sent to students in the service, and Marge's picture was in it as captain of the K-dets. Pete wrote Marge from Wright Patterson Air Base in Columbus, Ohio, and asked to come visit. It was wartime and both were ready for romance, which is exactly what followed!

Marge and Pete continued to visit and exchange correspondence that summer. Their long-distance courtship resulted in an engagement. To be together as long as possible, Marge and Pete decided to marry. Marge and her mother, carrying one sister's wedding dress and the other

sister's veil, took the train to Gulfport, Miss., and Pete and Marge exchanged their vows in Chapel #5 on October 29, 1944.

Pete went overseas and Marge returned to UK, finishing her degree. When the war ended, Pete surprised Marge by flying his bomber home. He was anxious to move to Michigan where he had a job waiting. Their children — Reg, Brooke, and Melinda — were born there. Later, they moved to Bluffton, Ind., where Pete became president of Mix-Mill Inc., a manufacturer of automatic feeding equipment for livestock.

Nearing retirement, the Warners returned to Indiana to be near their aging parents. By then, all that remained of the Warner's farmland was 40 acres of prime, well-tilled land not far from Fort Wayne. Marge and Pete gave the acreage to the UK Development Fund, a gift that embodied their love for each other, for UK, and for the land.



"President Patterson, your building is back!"

That's how UK President Lee T. Todd Jr. opened a "conversation" with President James K. Patterson, at the dedication of the restored Main Building October 25 celebrating the completion of this extensive restoration project.


"This is a great day in University of Kentucky history," said Todd.
"Built in 1881 with clay and stone found right here on campus, the Main Building is an important Kentucky landmark. Opening it again, not just to administrators but to the entire campus community, is a tremendous feeling. I look forward to this building remaining a university icon for many years to come."

Thomas D. Clark, alumnus, Kentucky historian laureate and emeritus professor of history recalled his first encounter with the Main Building when he arrived as a graduate student in 1928.

"I landed in Kentucky without knowing anybody. I got out of a taxi cab right there," he said, pointing to the drive in front of the building. "Never could I have imagined that this building would mean so much in my life."

Re-establishing the Main Building, Clark said, re-establishes Kentucky's goal to make UK a nationally prominent university. "On that day historians will have an opportunity to write a very happy chapter about a Commonwealth that had the courage, the energy and the imagination to realize its full possibilities."

Patterson's statue still holds court between the Patterson Office Tower and the Main Building, known to students and alumni as the Administration Building since 1948. The original building was designed by Harry P. McDonald of McDonald and Brothers (Architects) of Louisville. Patterson guaranteed completion of the building by pledging all of his personal funds to cover the \$81,000 construction money borrowed to complete the project. Other buildings constructed at the same time included a men's dormitory (later named White Hall), the president's house and the campus heating plant.

The tower feature once again graces the building.

Solemn dedicatory ceremonies for the new campus took place February 15, 1882. Students and faculty, along with assorted dignitaries, marched to the new campus just off Nicholasville Road for the formal ceremony dedicating the new buildings and campus.

All of the academic and administrative operations of the college were encompassed in the Main or College Building as it was often called in the early days. There were campus offices, classrooms, and related facilities including the college armory and the classrooms used by the Commandant of Cadets; a shop; the President's Office (equipped with fireplaces and a classroom); a natural history museum; two laboratories; the Normal, French, German, English, Mathematics, Classical, and Preparatory departments; an assembly room containing an organ; a smaller chapel (which was able to seat the entire student body, faculty, and staff); the headquarters of the Union Literary and Philosophian societies; and the Kentucky Geological Survey.

Those interested in the history of the university and historic preservation will find much to like. The brick shell of the building was stabilized after the fire that severely damaged the structure on May 15, 2001, preserving the authenticity of the original building. The third generation of windows, installed in 1971, remains in place as does the keystone window element adopted throughout campus.

The foundation that had been back-filled at sometime in the past 120 years was dug out to its original grade exposing the full depth of the limestone base. The grade around the building was lowered to the original mark in front about two feet and about four feet in the rear for a walk-out level to the plaza.

The roof ridge is exactly the same elevation as the original roof line and the tower was reclaimed at the top. The roof is made of lead-coated, standing-seam copper. Initially the tower and cupola formed a weather observatory 157-feet tall with a captain's walk and a clock. The flattened, gabled roof most alumni of today remember was constructed in 1919, although a previous remodel also had shortened and altered the tower before

At night the tower, Todd says, is symbolic of UK as a beacon of education and outreach. "Light will shine from the four tower windows equally in all directions toward downtown Lexington and Northern Kentucky, toward the adjacent neighborhoods and Western Ken-

tucky, toward the Medical Center and Southern Kentucky and toward the main campus and Eastern Kentucky — because we are one university and our campus is the Commonwealth."

A panoply of light characterizes the interior. Sunshine coming in from the skylight above bathes a third floor meeting room. Additional interior light borrowed from large windows provides natural lighting to most interior spaces in the building. Soft yellow walls contrast with deep cherry, bead board wain-

The Main Building houses the Visitors Center, two "smart" classrooms, meeting rooms, a public room and offices for the president, provost, executive vice president for research, executive vice president for finance and administration, other senior administrators and staff, the Commission on Women, the Commission on Diversity and the councils for the University Senate and Staff Senate.

Original cast iron columns were relocated to the new public room. (These were used in a decorative manner to support a light frame over the podium). TV stations can connect to pre-wired cable at curbside which will make for easier remote transmission from the public room during news conferences.

The facility is connected to the campus central heating and air conditioning system and the central utility management system via a utility tunnel to the Patterson Office Tower building.

The architect of record is James W. Potts and Associates of Lexington; the design architect is Kliment-Halsband Architects of New York City; and Messer Construction Company of Lexington is the construction manager.

The \$17.35 million, state-of-the-art facility contains 43,243 square feet, featuring a new fourth floor, a fifth floor mechanical room, and two balconies. The renovation increased the building's square footage by 12,543.

This time around, insurance plus an \$8 million fundraising endeavor among alumni, friends and corporations is funding the restoration.

An historical marker has been placed in front of the Main Building and a time capsule is sealed in the cornerstone. Among the items it contains are a CD directory of alumni and a copy of the Kentucky Alumni magazine.

By Robin Roenker As she prepared to graduate from UK's medical school in 1998, Dori Granger Thompson thought she'd do her family practice residency someplace warm, along the coast. Someplace with sand and waves, like Savannah or Virginia Beach.

After that, she thought she'd end up working "in some practice in middle-class suburbia"— much like the setting she had known in Ashland, Ky., where she'd grown up

Instead, Thompson, now 33, finds herself practicing in downtown Dayton, Ohio, at a homeless clinic.

It may not be quite what Thompson, who also earned her bachelor's degree in biology at UK in 1993, had envisioned for herself. But she feels it's where she's meant to be.

"I love it here," Thompson says of her job

at Dayton's Samaritan Homeless Clinic, where she's practiced since August 2001.

"I just think that everybody has to find their niche, and find where they are comfortable. And I feel comfortable here. I love my patients. I love my staff. I love the benefits of working here. And that's why I'm here."

Finding Her Niche

When Thompson tells people she practices at the Samaritan Homeless Clinic, she sometimes gets a trite, "Oh, that's so sweet" response — a look that assumes her choice stems from charity or activism.

It's a reaction that seems to irk the goodnatured, unassuming doctor just a little.

She's quick to point out that for one thing, she *is* paid well —"I didn't go to school for 11

Opened in 1992 and run by Dayton's Good Samaritan Hospital, the Samaritan Homeless Clinic offers health, dental, psychiatric, counseling, and social services as well as prescriptions free of charge to Dayton's homeless residents.

On any given night, some 600 people may be homeless in Dayton and surrounding Montgomery County, Ohio, says Judith Barr, the Homeless Center's program coordinator. But for 80 – 85 percent of them, "homelessness is a passing thing," she says. "Homelessness is not permanent like a chronic illness or a disease," Barr says. "It's simply a period in these people's lives. Most people are homeless for six months or less."

for free," she insists. And for another, the regular hours as the clinic's only full-time physician — 8 a.m. to 4:30 p.m. Monday through Friday - allow her to focus her free time on her family that includes husband Michael Thompson '96 AS, '97 ED, a science teacher at Fairborn

High School, and children, Alex, 4, and Lyndsey, 2.

It's clear that "charity" is too belittling a word to describe how deeply she cares about her patients — including going so far as to sponsor holiday parties for them with her husband and kids during Christmas and Fourth of July. But she sees her patients as people who deserve good health care, just like anybody else.

"I'm not there to feel sorry for my patients," she ex-

plains

"I'm there to give them the respect that they deserve. These are regular people who just took a wrong turn

along the way to end up here.

"I don't want anyone to think that I had these grandiose plans going into medical school that I was going to save the world and be this activist physician and work with poor people and the homeless. Because that was not my intention," she admits modestly. "But I feel comfortable here."

Thompson's comfort at the Homeless Clinic equates to a straightforward, easy rapport with her patients there, says Bari Stasko, a nurse at the clinic.

"She's very honest with her patients, and they respect her and recognize that she's trying to do everything she can to improve their quality of life," Stasko says.

Having moved to Ashland from Michigan with her family when she was in the first grade, Thompson always knew she wanted to be a doctor, she says, despite coming from a family full of teachers. She chose UK to do her pre-med undergraduate work thanks to a "good scholarship" and a desire to stay in-state for college.

Her eight years at UK as an undergraduate and medical school student were "the greatest years of my life," says Thompson, whose sister, Jodi Granger, '95 BE, also

graduated from UK and whose brother, Greg Hardin, will graduate from UK this spring with hopes of attending medical school at UK in the fall. "My UK education was wonderful. My professors were excellent, and I loved Lexington," Thompson says.

Thompson also found love in Lexington, reuniting during her freshman year of college with her elementary school boyfriend, Michael, with whom she'd lost touch after his family moved to Lexington. The pair, who married in 1997, made the most of their undergraduate years together at UK, regularly attending football, basketball, and baseball games as officers in the Student Athletics Council.

Despite their move to Ohio, the couple's True Blue spirit still runs deep. Their home sports a special satellite TV package so they can catch all the UK basketball games, and their son's room has a UK theme, she says.

"Two of Alex's first words were, 'Go Cats!' "laughs Thompson.

Serving the Underserved

While Thompson always knew she wanted to be a doctor, she admits to sometimes being a bit surprised at how her career has unfolded. For that, she's got her friends to thank.

It was a medical student pal at UK who recommended she look into the family practice residency program at Dayton's Franciscan Medical Center in 1998. While Dayton couldn't boast proximity to a beach like all the other residency programs she was considering, it did offer something more important: the promise of a balance between work and family.

It was the advice of a friend, again, three years later that ultimately took Thompson to her position at the Homeless Clinic in 2001. The Franciscan Medical Center closed during Thompson's third and final year of residency and her nurse, Bari Stasko, left to take a job at the Samaritan Homeless Clinic. When the clinic's physician position opened up, Stasko called Thompson and recommended that she check into it, knowing she'd be looking for a job once her residency was up.

Thompson was initially "hesitant," about applying for the clinic job. She checked it out, and she's glad she did. "I will stay here as long as they'll keep me," she jokes.

Still, Thompson admits there are certain critical challenges to working with patients who are homeless.

She can't tell patients to go home and rest or to watch their diets, for instance.

"For me to sit and lecture someone with diabetes or high cholesterol about their diet is ridiculous," she admits. "They eat what they can. They're on the streets."

For practical purposes, she can't prescribe medica-

tions that must be refrigerated or are difficult to transport or that have any sort of street value, for risk that they might be stolen.

And there's the challenge of simply convincing someone who's homeless who, she says, may also be dealing with serious issues of addiction or abuse or trying to find a place to stay warm at night — that her healthcare is also important. Often Thompson's patients miss appointments or fail to take their medications.

Thompson doesn't let those setbacks get her down, though.

"I try not to take things personally," she says. "I always tell my patients, 'You're the boss. I'm just here to give you some advice based on my professional opinion and what I know about keeping healthy. You do what you think is best."

Thompson sees about 20 patients a day at the clinic, a relatively small amount that lets her spend ample time with each new patient to complete a thorough health history and physical examination.

"Sometimes we may see a patient once and they may leave and never come back," says Kristina Yancik, clinical manager at the Samaritan Homeless Clinic. "So Dr. Thompson does as much as she possibly can for her patients at that initial visit. That may not be appropriate at other practices, but in our environment, it's critical."

Thompson takes the education component of her job and the one-on-one time with her patients seriously.

"I'm big on communication. I do a lot of listening and encourage my patients to ask questions about what they don't understand," Thompson says. "This is not an urgent care. This is not a drop-in clinic. This is a family practice clinic, and my patients just happen to be homeless. I am their physician, and my only job is to try to keep them healthy."

It's a job that, beach or not, she loves.

<mark>UK's</mark> Student-Run Free Clinic

The University of Kentucky Student-Run Free Clinic has offered free basic medical care for the poor and homeless in Lexington at the Salvation Army facility on West Main Street since 1986.

Run primarily by second-year UK medical school students, the clinic is open Tuesdays and Thursdays from 5:30 - 8 p.m. and sees roughly 800 patients per year, according to the clinic's medical director, Dr. John M. Bennett.

"My time working at the clinic is my best three hours of medicine each week," Bennett says. "It's a chance to offer assistance to the underserved while teaching students who are the future of medicine."

he UK Art Department opened its doors on Dec. 3 as hundreds of people strolled in to partake in the 13th annual Open Studio Gala.

The event, which was sponsored by the Department of Fine Arts and the Art Graduate Student Association, had gone all out to try and make it one of the most spectacular department events of the year.

"This is a huge celebration of our work," said Bob Shay, dean of the College

of Fine Arts. "It's very exciting."

The works of students from every possible genre decorated the walls of the Reynolds Building. Nude paintings and abstract works dotted the plastered white walls and self-portraits stared hauntingly from their places.

While visitors gazed at sculptures and designs literally sticking out of the floor and ceiling, still others took advantage of the banquet of food and drink. Around every corner and hidden down every dark hall were some sort of performances ranging from live bands, free-stylists and DJs.

We get very few chances to get this kind of mix of people to see our work," said Ben Withers, the newly appointed chairperson of the art department.

'It's a very excellent showcase for student pieces of all kinds.

Open Studio 2004 was a combination showcase of every type of artwork. Both graduate and undergraduate artists showed off work in drawing, painting, sculpture, ceramics, pottery, metalwork and print.

More importantly for the students, most work shown in the event was ac-

companied by a price tag.

"People are really interested in buying pieces — whether it's for a gift or a private collection," said Tamara Ohayon, an artist and ceramist, and president of the Student League of Independent Potters. "The money we make really benefits the students.'

Garry Bibbs, an associate professor and head of the sculpture department, agreed that Open Studio gives students a chance to explore the financial aspect of their work


"We helped start this whole thing as a marketing initiative for students,"

Leslie Michelson Halpern '82 CIS and her husband, Steven, were always debating which movie to see on their date night. He liked action. She needed romance. The solution? "Reel Romance: The Lover's Guide to the 100 Best Date Movies."

Halpern has always enjoyed movies, not just watching, but analyzing them. That, along with some research and polling among her friends, helped her pen a book to solve the movie date-night

dilemma — what movie to watch.

"My husband and I watch a lot of movies," Halpern said. "We go to the video store and the movies all the time. We definitely like different kinds of movies. It seemed like we were always arguing over which movie to watch — action or romance. We always had to try to reach a compromise. The book came about by wanting to find movies that we both could enjoy."

Halpern watched over 150 movies while researching the book. She watched most movies more than once to narrow the list to 100. While romance is at the heart of the list, Halpern contends that this is not just a book about

"chick flicks."

"Not every great movie is a great date-night movie," she said. "The movies in the book must meet three criteria. Romance is the main thing. The story line must have romance as the main or underlying theme. The movie must appeal to both men and women, and it must leave the audience feeling romantic."

If a movie was "too weepy or too violent," it didn't make the cut. In keeping with the desire to appeal to both

men and women, the book includes such movies as "Mask of Zorro,"
"George of the Jungle," and "There's Something About Mary." In a somewhat lighthearted vein, Halpern rates each movie's sexual explicitness and emotional intimacy with an "Intimacy Comfort Level." The book also ranks each movie's sexual heat with a "Make-Out Meter" on a scale of one to five candles.
"The Intimacy Comfort Level lets readers know which movies best fit where

they are in the relationship," she said. "For example, on a first date, a movie like "Bringing up Baby" might be best. It's low on the Make-Out Meter, very light, a one-to-two candle movie. It's perfect for a first date. "The Thomas Crown Affair" is really hot. It's a five candle movie. It is definitely more for the long-term relationship.'

The movies are divided into 10 chapters or themes, such as "Always a Bridesmaid, Never a Bride," and "Once Upon a

"It meets all the criteria," she said. "I have probably watched it 50 times with my husband. We just love it."





Register for the Online UK Alumni Community

Are you a registered user of the online UK Alumni Community? If not, you are missing out on a lot of cool features that we offer such as Lifetime E-mail Forwarding, Class Notes, online UK Alumni Directory, and yellow page listings for alums doing business with alums. In this article I will provide a quick "how-to" on registering for the online community.

Before we begin with the registration process, allow me to iterate a few points. First, registration isn't restricted to members of the UK Alumni Association. Second, before you begin, you will need your alumni identification (ID) number. It is on the label of this magazine. For Alumni Association members, it is also on your membership card.

To register, go to the home page at www.ukalumni.net and enter the keyword "register." Follow these four easy steps:

1: You will be asked to enter your first name and last name. The only piece of information that is required is your last name. Class year is not necessary.

2: A list of matching records will appear on the screen. Choose the record that matches your name and class year. However, if you have a very common name, such as "John Smith," it is possible that multiple records will be returned from the search. This is where step 3 comes in.

3: After you have clicked on your name, some detailed information about your record will appear on the screen as well as a text box for you to enter your alumni ID number. If more than one name appeared on step 2, enter your ID number into each one until you find a match. After you find the record that matches your ID number, proceed to step 4.

4: This is the final step of the registration process. Here you will choose your username, password, security word, provide us with your E-mail address, and accept the terms and conditions of use.

a. Choose your username and password. The username must be between six and 20 characters long. It can only contain the following combination of characters (0-9, A-Z, the underscore "_", and periods "."). The password must be different than your user ID and must be a minimum of six characters long. The same character combination rules of the user ID also apply to the password. Your username also will be used in your Lifetime E-mail Forwarding address, should you choose to activate it. Choose a user name wisely.

b. After you pick your user ID and password, you will be asked to enter a security word. This is used in the event that you have forgotten your user ID or password. When you request either of those, you will be asked what this word is in order to verify that you are in fact legitimately the authorized person to request this information.

c. Enter a valid e-mail address. This is used to send your registration confirmation and any important notices from us. (You can choose later to opt out of certain e-mail publications that we send.)

d. Read over the terms and conditions. Click on "ACCEPT." If you do not agree with these terms, you will not be able to register.

e. Decide how you want your registration confirmation formatted. You can choose to have it send your user ID and password, just your password, or not send the confirmation at all. After you decide this, click on "Complete Registration.

The registration process is now finished. You can log-in to the online community and access all its features, some of which are enhanced for members





Hand-Me-Down Dreams

Attitudes and values held by parents regarding work are often transmitted to their children. If you were fortunate enough to have been reared in a household exposed to adults who found their work to be challenging, engaging, and meaningful, chances are such role models have influenced how you perceive success. On the other hand, if your role

models did not enjoy their work, counted days to the weekend or retirement, then you may be in a vicious cycle of dissatisfaction with your career. Too often clients come to career counseling dissatisfied with their work only to understand more clearly that they are in a career that a frustrated parent chose for them. This is sometimes referred to as "hand-medown dreams." Honestly reflecting upon and uncovering such attitudes may be key to helping you negotiate a future career transition or finding passion in your work.

The following are some suggestions on how adults can emulate positive attitudes toward work to children in their lives.

• Talk about your work — what you do and why you do it.

- Discuss the importance of good work qualities such as being on time, putting in an honest day's work, and giving proper notice upon leaving a job.
- Be careful not to stereotype career choices or career paths.
- Share how your work impacts others and contributes to the larger community.
- Involve your family in work-related projects (assisting with company mailings, events, etc.).
- Participate in "take your child to work" days. Discuss family finances and the relationship between work and meeting family needs.
- Seek community volunteer opportunities with your children. This
 allows you to spend quality time together and exposes them to new
 careers and skill sets.
- Participate in career days at school. Your children will be proud no matter what your chosen field.
- Talk about positive things that happen at work and traits you admire in co-workers, not just the negative.
- Encourage high school and college-age students to explore a variety of classes and interests rather than quickly choosing a major or career path.

When your family clearly understands your work obligations, it might make it easier if there are occasional work commitments that keep you from attending family functions.

If you are dissatisfied with your current job or career choice, be a positive role model by taking ownership of your situation and being proactive in making a change that is a better match with your interests, skills, personality type and values. When children see adults engaging in productive fulfilling work, they begin to understand and absorb satisfying fundamental life principles acquired from work such as contribution, self-worth, dignity, and independence. What greater gift to give a child in your life?



Shagari Alleyne -Tallest Player Is Fan Favorite

Shagari Alleyne has gone from seldom used reserve to an emerging factor in the paint for the Kentucky Wildcats basketball team. The 7-3 sophomore from the Bronx, N.Y., is not only causing a stir on the floor, he has become a fan favorite.

Fan interest has grown so much there is even a Web site devoted to Alleyne. ShagariSafari.com, founded by "Alleyne's Allies" — Dustin Leonard, Wes Harrington, Conley Harrington, and Jenny Bickett — is all about the tallest player in UK history. It features a bio, quotable quotes, and the Big Fella's multi-media page. Visitors to the site can hum along with "Alleyne's Anthem" as they view photo galleries. Fans are also sporting shirts that read "The Shagari Safari" on the front, and "Hop on for the Ride," on the back.

Alleyne is taking the sudden adoration all in stride.

"That's Kentucky fans for you," he said in an interview with Larry Vaught from *The Advocate Messenger*. "I am not the only player on the team. I try to focus on what I have to do, but it's really nice to know they care that much about you to have a Web site like that."

Alleyne's progression from project to contributor began at the end of last season. After scoring a total of 14 points in 18 games as a freshman, he went to work. Over the summer, he gained 10 pounds and practiced his post moves. That hard work is paying off as Alleyne continues to improve, turning potential into production. During Kentucky's 73-58 victory over Indiana in Freedom Hall Dec. 12, Alleyne posted 10 points, five rebounds, four blocks, and two assists in 21 minutes off the bench. That line earned him the game's MVP award, an annual honor presented by the Jefferson County UK Alumni Club.

Phillips had been the wide receivers coach and recruiting coordinator the past two seasons with the Wildcats. Smith comes to Kentucky from Boyle County High School, where he won five consecutive state championships. He is the assistant coach for linebackers. Roper, who coached record-setting quarterbacks Eli Manning and Romaro Miller during the last six seasons at Mississippi, is the assistant coach for quarterbacks. Heggins, who comes to Kentucky after 11 seasons as an assistant at Florida State, will coach the offensive line.

Wildcats Shine in the Classroom

The Wildcat softball team earned the highest cumulative grade point average by any of the 22 varsity athletic teams during the 2004-05 fall semester, posting a team GPA of 3.37. The baseball team posted a team grade point average of 2.97 for the fall 2004 semester. Twenty of the 37 players on the fall roster earned a GPA of 3.0 or better, and nine players scored 3.5 or better. The UK gymnastics team, currently ranked 17th in the country, had four members garner 4.0 GPA averages during the fall 2004 semester. Volleyball players Sarah Spinner and Danielle Wallace have been recognized as CoSIDA Academic All-District IV selections. Spinner earned second-team honors and Wallace was named to the third team.

During his senior season, Burns made 31 tackles, including 4.5 tackles for loss, forced two fumbles, recovered a fumble, and had an interception.

Craig Skinner has been named the University of Kentucky's head volleyball coach. Previously, Skinner was the head assistant coach and recruiting coordinator at the University of Nebraska. Skinner spent five years as an assistant at Nebraska. He also was an assistant at Wisconsin from 1994-96. A 1993 graduate of Ball State, Skinner was an outside attacker for the Cardinals and helped guide the team to a 28-11 record and a third place finish at the 1990 NCAA championships.





John David Smith '73 '77 AS is the editor of "Black Soldiers in Blue: African American Troops in the Civil War Era," recently published in paperback. Inspired and informed by the latest research in African American, military, and social history, the 14 original essays in the book tell the stories of the African-American soldiers who fought for the Union cause.

An introductory essay surveys the history of the U.S. Colored Troops (USCT) from emancipation to the end of the Civil War. Seven essays focus on the role of the USCT in combat, chronicling the contributions of African Americans who fought at Port Hudson, Milliken's Bend, Olustee, Fort Pillow, Petersburg, Saltville, and Nashville. Other essays explore the recruitment of black troops in the Mississippi Valley; the U.S. Colored Cavalry; the military leadership of Colonels Thomas Higginson, James Montgomery, and Robert Shaw; African-American chaplain Henry McNeal Turner; the black troops who occupied postwar Charleston; and the experiences of USCT veterans in postwar North Carolina. Collectively, these essays probe the broad military, political, and social significance of black soldiers' armed service, enriching the understanding of the Civil War and African-American life during and after the conflict.

Smith is the Charles H. Stone Distinguished Professor of American History at the University of North Carolina at Charlotte.


