


M<sup>r</sup> Daniel Defoe

Manchester Feb<sup>r</sup> 15<sup>th</sup> 1759

Referring you to ours of the 30<sup>th</sup> Octo: past, of the Neptune Capt<sup>t</sup> Fullidge from Bristol,  
we are now to acknowledge the receipt of your sundry favours of the 2<sup>d</sup> August, 13<sup>th</sup> Octo.  
& 10<sup>th</sup> November, the first annexing another for some White Thread, the second orders  
us to pay on David Barclay for one hundred pounds - which we did, & the same was duly  
presented about to your credit. The last countenances your order of checks & the Open-  
briggs you ordered w<sup>t</sup> Edmund Jenney accept they would come on the old place, as  
you observe they are so plenty w<sup>t</sup> you, & makes an addition to your thread, we  
therefore now annex you Notice of one case merchandize, being q<sup>t</sup> Order of Thread, &  
some small wares you ordered by M<sup>r</sup> Jenney, which is shipt you by the opportunity  
that hands you this - say the late Capt<sup>t</sup> Job Pollard - a vessel of force  
purposely engaged by us to carry our spring cargo to New York. The amount we bring  
to your debit in a new account, as also the Bill<sup>t</sup> to your ac<sup>c</sup> t as of y<sup>r</sup>. acc<sup>c</sup> court  
Balances, you'll observe we have made no Insurance premium, as you was pleased to  
tell us in a former letter for convenience, we therefore shall not cover any goods you order  
from us till you command us, you'll please to note we send you no checks, tho' we  
had got ~~one~~ every one of yours made on purpose to pay them, & a good commodity they  
were, but twas no disadvantage to us, as ~~they~~ they helped us completing other of our  
friends orders, all of whom we have been obliged to send short of their orders in that article,  
for checks still rise in price, & are so very scarce that we cannot get them on any account  
we therefore expect your markets will be soon drained, as but a few will be Imposs'd into  
your place this year, & there is a greater prospect of their being still dearer than the  
reverse, as to small wares - they are now as scarce an article as anything, for the  
weavers are all turned out ag<sup>t</sup> their Masters in order to raise their wages, & not one  
loom in the worsted branch of that article is this day stirring in Manchester, the  
Masters here have now resolved to sue the weavers, & no less than thirty two are in  
our County goal to take their trial at the next assizes, we now beg leave  
you for all your favours, & believe us to be with the greatest affection
