

2. That the following courses and changes in courses be approved:

✓ Anatomy and Physiology 105a and 105b. Human Osteology. Recitation 1 hour, laboratory four hours a week. Three credits per semester. These courses are intended to take the place of A. & P. 101a and 101b which are two credit courses.

✓ Anatomy and Physiology 107a and 107b. Advanced Anatomy. Recitation 1 hour, laboratory four hours a week. Three credits per semester.

✓ Hygiene 111a and 111b. Independent Work in Hygiene. Three credits per semester.

President McVey called the attention of the Senate to the prevalence of cheating in examinations and quizzes and suggested that a committee should be appointed to study the situation and make some recommendation to the Senate. The Senate approved the appointment of such a committee by President McVey. The following were appointed: Messrs. W. S. Webb (Chairman), J. B. Miner, M. Scherago, L. J. Horlacher, D. V. Terrell, C. C. Ross, Mrs. J. M. Server.

There was some discussion concerning the organization of the Faculty Club of the University. It was decided that this question should be brought up at the next meeting of the University Assembly.

The Senate then adjourned.

MINUTES OF THE UNIVERSITY SENATE MARCH 12, 1928

The University Senate met in the Little Theatre Monday, March 12, President McVey presiding.

The minutes of February 13 were read and approved.

Here
The following recommendations of the Rules Committee were approved:

1. That for seminar courses and independent or individual work courses where more than two semesters' work is assigned, letters c, d, etc., may be used after the course number in the same way that the letters a and b are now used.

2. That the rule on "dropping a subject" (Rules, p. 36) be amended to read as follows:

"A student who drops a subject without permission of his Dean shall be given a semester grade of E in that subject. During the first two weeks of the semester, a student may be dropped from a subject with or without a grade of E at the discretion of his dean. If a student is dropped from a subject later than the third Monday of the semester, he will be marked a grade of E for that course, unless he is excused by the Committee on Scholarship and Attendance. A student who drops out of the University before the end of the semester shall be marked E for the semester in those subjects in which he is reported as failing at the time he leaves. (Underscored represents new material)

A suggestion was made that the rule should be amended so that it would be necessary for the student to have the permission of the instructor as well as that of the Dean before dropping a subject. This suggestion was referred to the Rules Committee.

The following courses, reported by the Committee on Courses of Study were approved:

- ↓ Mathematics 205 - Differential Geometry, 3 credits.
- ↓ Mathematics 118 - Solid Analytics, 3 credits
- ↓ Mathematics 206 - Substitution Groups, 3 credits (To replace Math. 115)
- To replace Math. 117a-b* ↓ Mathematics 207a,b - Theory of Numbers, 3 credits per semester
- ↓ Chemistry 110 - Intermediate Course in Physical Chemistry. three credits
- ↓ Chemistry 111 - Intermediate Laboratory Course in Physical Chemistry - 2 credits.
To replace 105, Advanced Physical Chemistry 5 crs.
- ↓ Home Economics S 116 -- Advanced Costume Design 3 credits.
- ↓ High School Education 167. The Teaching of Related Art. 3 credits
- ↓ Secondary Education 209. Problems in Secondary Education. 3 crs.
- ↓ Industrial Education 76. Special Methods in Trade and Industrial Education. 2 credits.
- ↓ Industrial Education 75. Reorganization of Industrial Arts. 2 credits
- ↓ Agricultural Education 180, and Agricultural Education 181, three credits each, be combined into a single course Agricultural Education 181, and be given additional time, and carry seven credits.

The Senate approved the following recommendations from the faculty of the College of Law:

- ↓ The course in Constitutional Law given the second semester by Professor Chalkley was changed from three hours a week to four hours a week.
- ↓ The courses in Mortgages was changed from the first semester to the second semester and is given two hours credit instead of three hours credit.
- ↓ The course in Civil Procedure was changed from three hours a week in the second semester to two hours a week in the second semester.
- ↓ The course in Evidence was changed from two hours a week throughout the year to four hours per week the first semester.
- ↓ The course in Trusts was changed from three hours a week the first semester to two hours per week throughout the year.
- ↓ Property 11 was changed from two hours to three hours per week the second semester.
- ↓ Municipal Corporations was changed from three hours a week to two hours a week and from the second semester to the first semester.

✓ The courses in Damages had been inserted in the "Schedule of Lectures and Recitations", but did not appear in the last Bulletin. This course was given the first semester, there being two hours credit given therefor.

The meeting then adjourned.

MINUTES OF APRIL 16, 1928

The University Senate met in the Little Theatre Monday, April 16, President McVey presiding.

The minutes of March 12 were read and approved.

The following recommendations from the Rules Committee were approved:

"That the words underscored be added to the rule on dropping a subject so that the rule will read as follows:

A student who drops a subject without the permission of his Dean shall be given a semester grade of E in that subject. After the first week of the semester, no student will be permitted to drop a subject until he has first presented to his Dean a recommendation from his instructor stating whether he should or should not be permitted to drop the subject. During the first two weeks of the semester, a student may be dropped from a subject with or without a grade of E at the discretion of his Dean. If a student is dropped from a subject later than the third Monday of the semester, he will be marked a grade of E for that course, unless he is excused by the Committee on Scholarship and Attendance. A student who drops out of the University before the end of the semester shall be marked E for the semester in those subjects in which he is reported as failing at the time he leaves."

Senate approved the following recommendations concerning courses which have been approved by the Committee on Courses of Study:

- ✓ History 131. European Historiography. One credit.
- ✓ History 132. American Historiography. One credit.
- ✓ History 133a. Historical Criticism. One credit.
- ✓ History 133b. Historical Criticism. One credit.
- ✓ Psychology 117. Psychology of Language. Two hours Laboratory and 2 hours Lecture. Three credits.
- ✓ Psychology 154. Psychology and the Law. Two credits (Passed with Understanding that the final agreement should be made between Dean Boyd and Dean Evans as to allocation of the course).
