- 1. To re-examine the guidelines of the organization (see below).
- 2. To relate the purpose of UKLA to the purpose of the newly formed Library Faculty.
- 3. To determine if UKLA should continue to exist.
- 4. To determine use for UKLA funds.

Following are the present UKLA Guidelines. Please look them over before the meeting on Friday.

GUIDELINES

NAME: University of Kentucky Librarians' Association

PURPOSE: The purpose of the organization shall be to encourage the establishment, maintainence, and support of professional development within the University community.

- MEMBERSHIP: The membership shall be restricted to librarians with faculty appointments within the University of Kentucky library system who have paid dues.
- ORGANIZATIONAL STRUCTURE: The governing body shall be composed of a chair and secretary-treasurer. Standing committees shall be Program and Publicity-Publications. Other committees are to be created and dissolved as necessary.
- ELECTIONS: Shall be regularly held at the beginning of each academic year in October. An Election Committee shall be appointed by the Chair in August of each year to nominate names. In September, ballots for the Chair and Secretary-Treasurer with provisions for write-ins shall be mailed to all potential members, but only those ballots returned with dues payment shall be considered valid. Votes cast shall be counted and results made known by the Election Committee.
- FINANCES: Dues are one (1) dollar per academic year, to be paid in September, until such time as the officers show the necessity for additional funds. The uses of such dues, for other than normal business expenses (i.e., paid speakers, publications, publicity), shall be voted upon by members.
- MEETINGS: Regular open meetings shall be held at least every two (2) months. Special meetings shall be called as necessary.
- VOTING: Only members shall vote. Votes shall be taken by mail on major issues as determined by members. A quorum shall be constituted by a simple majority of the total membership.
