 The faculty met in professor Wilson's class-
 room at 2³⁰ P.M. those present being Presi-
 dent Patterson, professors J. G. White, Neisler,
 W. K. Patterson, Pryor, Anderson, Mathews,
 Neisler, Mackenzie, Norwood, M. White,
 Wilson, Tuttle, Gumbod, Rowe, Frankel,
 and Corbuser.

The minutes of the last meeting were
 read and approved.

Prof. M. White suggested the desirability
 of having a com. appointed from the college
 faculty to aid in the proper entertainment
 of the visitors to the conference upon edu-
 cation to be held in Lexington during the
 holidays, and upon his motion seconded
 by professor J. G. White it was ordered that
 a com. of five members be appointed for
 this purpose. President Patterson appointed
 upon this com. professor Wilson, chairman,
 professors Mathews, Rowe, Nor, and Melcher.

The report of the com. upon entrance re-
 quirements based upon the unit system, was
 then taken up for discussion.

Upon motion of Prof. Rowe, seconded by
 professor Anderson, it was ordered that
 fifteen units instead of fourteen be required
 for admission to the Freshman class of
 the college.

Upon motion of professor Rowe, the
 fixed requirements amounting to eleven and
 one half units (section 2) was adopted,
 it being understood that the two units of
 Ancient or Modern language should refer to
 one language only.

The optional units of which $3\frac{1}{2}$ are to
 be required were then passed upon one by
 one and upon motion adopted.

Upon motion the fourth section was ordered adopted.

Upon motion the fifth and sixth sections were likewise ordered adopted.

Upon motion of Prof. Anderson it was ordered that the committee which presented this report be directed to present the report as now adopted, to the Board of Trustees, and ask for their approval.

Upon motion of professor White, seconded by professor Howwood it was ordered that a committee be appointed to consider the question of arranging a system of units for graduation and that this system shall be uniform for all the courses of study.

President Patterson appointed upon this committee the Deans of courses of study.
The meeting adjourned.

REPORT OF THE COMMITTEE APPOINTED TO PRESENT A SCHEME OF ENTRANCE REQUIREMENTS TO THE VARIOUS COLLEGE COURSES, BASED UPON A UNIT SYSTEM, AS REVISED AND ADOPTED NOVEMBER 6TH., 1907.

1. Fifteen units, each involving the pursuit of a subject for five hours a week during a term of one year, are to be required of all students seeking admission to the Freshman Class in any of the courses of study in the College.

2. Eleven and one half of these units must come from seven subjects, which with their ratings are:--

Higher Arithmetic	1,
Algebra	2,
Plane and Solid Geometry	1 1/2,
English	3,
One Ancient or Modern Language	2,
General or English History	1,
Physics	1,

3. To make up the remaining *three* and one half units, applicants may select from thirteen subjects, which with their ratings are:--

Ancient or Modern Languages	3,
Chemistry	1,
Physical Geography	1/2,
Geology	1/2,
Astronomy	1/2,
Physiology	1/2,
Botany	1/2,
Zoology	1/2,
Civics	1/2,
American History	1/2,
Plane Trigonometry	1/2,
Manual Training	1/2,
Drawing	1/2,

Applicants for admission to the Bachelor of Arts Courses must make their selection so that they can offer three units of Latin in a total of five in foreign languages.

4. No subject offered as an entrance requirement can be counted again in the total credits required for completion of a college course.

5. A student may be allowed to enter the Freshman Class with conditions, provided they do not exceed two units. These conditions must be removed before he enters upon his Sophomore Year.

6. It is recommended that the Board of Examiners provided for by the Board of Trustees consist of three members;-- namely, the Professor of Mathematics, the Professor of English, and the Chairman of the Committee on Accredited Schools; and that this Committee have full power to pass upon the entrance qualifications of all students in accordance with the plan of credits approved by the general faculty.
