60 DAY TIME LIMIT FOR FILING GRIEVANCES
The following paragraph is a revision of the University Grievance
Procedure first paragraph Stage I:

The aggrieved employee shall state his complaint to the immediate supervisor within sixty (60) days of the act aggrieved of or with sixty (60) days of the commencement of the act aggrieved of, if such act is of a continuing nature. In the event the aggrieved employee states his complaint after the sixty (60) day time limit has expired, the immediate supervisor shall notify the Director of Personnel who shall determine whether such extenuating circumstances exist as to warrant receipt of the complaint beyond the normal time limit. The Director of Personnel shall notify the immediate supervisor of the decision which shall be final.
