Minutes of Called Meeting of the Executive Committee of the Board of Trustees of the University of Kentucky, June 28, 1940.

The Executive Committee of the Board of Trustees of the University of Kentucky met in meeting called by the Chairman in President McVey's office at the University of Kentucky Friday, June 28, 1940, at 10:30 a.m. The members of the Committee present were Judge Richard C. Stoll, Chairman; James Park, and H. S. Cleveland. President Frank L. McVey and D. H. Peak, Secretary of the Board, were present.

### 1. Monthly Meeting Date of Executive Committee.

The Chairman stated that it is necessary to fix a date for regular monthly meetings of the Executive Committee. A motion was then made, seconded and carried that the third Friday in each month be fixed as the date for regular monthly meetings of the Executive Committee of the Board of Trustees of the University of Kentucky; the meetings to be held at 10:50 a.m. in the President's Office, University Campus.

### 2. Approval of Minutes.

The minutes of the meeting of the Executive Committee of May 10, 1940, were approved as published.

### 3. Financial Report.

Business Agent's Report.

The Business Agent reported a list of collections and funds not remitted to State Treasurer but ordered to be controlled and expended by direction of the Board of Trustees. He filed with the list copies of the minutes of the Board and Executive Committee continuing such resolutions.

No changes were made in the resolutions, but the Business Agent was directed to compile the resolutions and send copies to members of the Board of Trustees.

9. Coding Funds and Expenditures by Department of Finance.
Letter of Director of Division of Accounts and Control:

Commonwealth of Kentucky DEPARTMENT OF FINANCE Frankfort

June 13, 1940

President Frank L. McVey University of Kentucky Lexington, Kentucky

Dear President McVey:

I am enclosing the suggested re-classification of expenditures of the state institutions of higher education, with the suggestion that you delegate someone connected with your institution, possibly the Business Manager, to go over this suggested classification with the view of accepting or recommending changes.

It is my definite conviction that the classification the State is now using is inadaptable, if not worthless, and I believe it is highly desirable to adopt a classification which can be adapted to all the state institutions of higher education.

At the present time the State is trying to code expenditures of your institution. I am definitely of the opinion that expenditures should be coded at the institution of origin. To get the best results we should have a uniform classification of expenditures that will meet the needs of the institutions of the State, and I request that you notify me if it will be possible for your representative to meet in Frankfort, Monday, June 24, 10:30 a.m. to discuss with representatives of other institutions of higher education and with Dr. Maney, representing my Department, the enclosed proposed re-classification of expenditures.

Your cooperation in this matter will be greatly appreciated and I believe the results will work towards a satisfactory solution of this problem as it relates to your institution.

The Business Agent stated that at President McVey's request, L. H. McCain, of the Business Office, Coleman Smith of the Experiment Station, and D. H. Peak, Business Agent, attended the meeting called by the above copied letter. He reported that representatives of each of the institutions of higher education were present, and the proposed reclassification was discussed at length. It was stated by Mr. Peterson that the object was not to put additional burdens of labor and expense on the institutions, that no additional accounting will be required of the institutions, that all bookkeeping will be done within the Division of Accounts and Control, and that the object is to better systematize the accounting of groups of state institutions of similar nature. A coding system is to be set up and perfected, and the institutions are asked to place the code numbers on each requisition and each voucher, including reports of collections, sent to the Department of Finance.

The Business Agent was authorized by the Executive Committee to comply with the request of the Division of Accounts and Control in so far as that may be done without conflict with the accounting of the University of Kentucky, under resolutions and orders of the Board of Trustees.

- 10. Fees, 1939-40, not Collected.
- a. Report of Business Agent

#### UNCOLLECTED FEES

\$6,180.20

This is about \$1,200.00 in excess of last year's uncollected fees. This amount of uncollected fees for 1939-40 is about 2% of total estimate of fees for the two semesters, \$310,000.00. The per cent last year was 1.8.

This increase is due partly to about \$1,700.00 delinquency of N. Y. A. students. The delinquencies in second semester are due largely to students who work during the summer, consequently the large amount of collections in following year.

Old fees collected during this fiscal year amounted to \$4,117.18, which does not include amount credited to activities. The amount charged off last year was \$4,954.10, and most of the collections were for 1938-39 fees. I estimate the actual loss for that year at less than two-fifths of one per cent.

I suggest that an order be made similar to that made June 29, 1939, which reads as follows:

#### b. Resolution

It was ordered, on motion and second, that the amount of uncollected fees for the year 1938-39 be charged off and not carried as assets on the books of the University, and that the part thereof distributable to General Fund of University that may hereafter be collected, be set aside for P. W. A. Building and Revenue account.

It was suggested that charging off accounts receivable or charging accounts to surplus, in no wise changes obligations of payment of such accounts.

- 11. Fees Out-of-State.
- a. Report on Graduate Students.

l. President McVey, complying with the order of the Board of Trustees, Sec. 8, minutes of June 7, 1940, filed communication copied as follows:

June 18, 1940

President Frank L. McVey University of Kentucky

My dear President McVey:

Pursuant to your request the Committee on Graduate Work and Research met to consider recommendations to the Board of Trustees regarding the increase in fees to out-of-state students in the Graduate School. For the reasons set forth by the committee's chairman, Professor E. N. Fergus, in a letter to you dated June 4, 1940, and because of the University's published announcements regarding the fees to be expected in the Graduate School, the committee unanimously approved the following recommendation:

The Committee on Graduate Work and Research at the University of Kentucky recommends that the ruling of the Board of Trustees of the University regarding the increase of fees for out-of-state students be not applied to scholars, fellows, graduate assistants, or graduate student technicians for the academic year of 1940-41.

On motion, seconded and carried, it was ordered that the compensation of non-resident scholars, fellows, graduate assistants and graduate student technicians employed for the academic year of 1940-41, be increased in each instance in the amount of the increase in non-resident fee of such fellow, scholar, assistant or technician.

b. Registrar's Letter.

President McVey presented a communication from the Registrar regarding the difficulties that arise in the collection of non-resident fees, especially as regards the determining of what is called legal residence. The communication was accompanied by a statement of "Rules and Policies Governing Residence and Non-Residence at the University of Kentucky."

The question of residence was debated at some length by members of the Committee. It was stated that facts and the intention of the party must be considered in each case of establishment of legal residence. It was suggested that the acting president and registrar consult Dean Evans, of the Law College, and try to get the rules of the University Senate and the interpretation thereof in line with what really constitutes legal residence.

- 12. Engineering Equipment -- Report of 1939-40 Purchase.
- a. Letter of Dean Graham

June 3, 1940

President Frank L. McVey University of Kentucky

My dear President McVey:

I attach hereto a condensed statement of expenditures

for engineering equipment under "Account No. 2430" as compiled under date of June 1, 1940. You viewed and inspected personally the results of these expenditures in your inspection of the College of Engineering on May 7. The individual requisitions representing these expenditures have been approved during the fiscal year 1939-40 by the Board of Trustees of the University or by the Executive Committee thereof; but we believe it proper to furnish you with this condensed summary at this time.

You will recall, in this connection, that through the aid of Governor Johnson, a further appropriation of \$25,000 for each of the fiscal years of 1940-41 and 1941-42 was made specifically by the 1940 General Assembly in order to round out and to complete the equipping of the laboratories and shops of the College of Engineering in accord with the program inaugurated in September, 1935. The first sum of \$25,000 will be available for expendi-In anticipation of this, the sevture on July 1, 1940. eral departments of the College have studied their further needs in relation to the program and the equipment already installed, have written specifications and have obtained prices thereon, and I am ready to make the several allocations therefor, all of which is predicated upon and in accord with the aforesaid program. we may expect some administration changes shortly and something in the nature of a "twilight zone" during the next few months and as I find that I am in duty bound to remain with the University until I have concluded finally P. W. A. Docket No. KY-1305 and also execute certain assignments or responsibilities given me by Governor Johnson, I request some expression from the Board of Trustees as to its desire concerning procedure for the allotment and expenditures of the aforementioned appropriation. words, shall I proceed with the plans as formulated, by and with the approval of the Executive Committee of the Board, under the practice in effect for the first two fiscal years? I may state in this connection that to do otherwise will cause probable delays in execution. which will render the equipment in question non-effective during the next College year.

In like case is the appropriation of \$20,000 for scientific equipment. You and I have discussed the allotments of this sum to the several departments and in accord therewith, we have planned and specified certain purchases with Dean Funkhouser and others interested and these are now ready for execution promptly in order that the new equipment may be available for use in the Biological Sciences Building when the University opens next September.

13. Scientific Equipment Appropriation - Budget Approved.

a. Submission

June 24, 1940

President Frank L. McVey University of Kentucky

My dear President McVey:

I attach hereto a tentative budget for the expenditure of the appropriation in the sum of \$20,000 for scientific equipment, and available for the fiscal year beginning July 1. This distribution has been studied and drawn in accord with our several discussions of this problem since last February and the various items listed

comply with the desires of the several departments involved. You will note that the largest item (\$10,200) is for microscopes for the Department of Zoology, which is in accord with the wishes of Dean Funkhouser and the Department.

You will remember that we discussed together and reviewed the needs of the Department of Art, which will occupy one wing of the Biological Sciences Building. Accordingly we have listed the sum of \$2,200 which will be largely expended for materials wherewith the Department of Buildings and Grounds may manufacture the equipment. I am not familiar with just how far you instructed the Department of Buildings and Grounds to proceed in the planning of this particular item, but I suggest that they prepare a bill-of-material for purchase as promptly as possible.

I can state that all other items are in readiness for prompt execution and installation. If it should be your desire, we can place the orders, in due form, for the equipment during the coming week, as we have secured prices, etc., in accord with specifications prepared in consultations with the departments.

To the Members of the Executive Committee of the Board of Trustees of the University of Kentucky:

My dear Sirs:

Since we are moving into a smaller house than Maxwell Place, and since we cannot use the large dining room furniture, I am anxious to sell this suite, consisting of a side-board, china closet, buffet, extension table scating eighteen, and twelve chairs, all mahogany in Empire design.

Because this furniture is adapted to Maxwell Place, I am asking you first of all, if you would like to purchase it as a permanent possession of the President's House. As you know, the furnishing of a large house is sometimes a heavy responsibility to demand of a president.

I should think that the dining room furniture could not be replaced for a large amount of money and although it needs some refinishing, it is well worth six hundred dollars. If you are interested in buying the furniture I shall be glad to have it appraised by anyone you designate.

### 20. Report on College Catering Company - Cafeteria.

Mr. Park, chairman of the Committee to make investigation of conditions and operation of the College Catering Company, reported that business engagements had made it impossible for him to meet with the Committee until the morning of this meeting of the Executive Committee. A memorandum made by other members of the Committee, together with papers, reports, etc., assembled by the Secretary of the Board, were presented at that time. However, no satisfactory report could be made, and the Committee was continued.

# 21. State-wide Recreation Project, W.P.A.

The question of University sponsorship of State-wide Recreation Project of W.P.A., deferred from the meeting of May 10, 1940, was presented for further consideration. The purpose of the project and the obligations of the University are stated as follows:

# Project to Furnish Recreational Leadership

Project will operate throughout the State. Headquarters for purposes of supervision will be located in Louisville, Kentucky. District supervisory headquarters located at Madisonville, Owensboro, Louisville, Lexington, London and Paintsville, Kentucky.

It is expected that the contributions listed on this proposal will be made by local co-sponsoring groups in the communities in which this project will operate. The University of Kentucky does not guarantee these contributions and is under no obligation to contribute in any material way other than through the professional services of its representatives who shall give technical advice and assistance in cooperation with the State Supervisor of the project.

The obligation and liability of the University having been satisfactorily stated in the project, on motion and second, the President was authorized to have it executed by the University.

#### 22. Naming Science Building.

President McVey presented a proposal made by Dr. A. C. McFarlan of the Department of Geology, and Dr. Hobart Ryland, of Department of Romance Languages, to name the Science Building "Miller Hall", in honor of Professor A. M. Miller, deceased. As this is a matter for consideration of the Board of Trustees, action thereon was deferred to the September meeting of that Board.

#### 23. Lease - Smith Hall.

Renewal of lease of Smith Hall to the Chi Omega Sorority, which expires June 30, 1940, was authorized for period of September 1, 1940, to June 30, 1941; rental \$100.00 per month, payable in advance. The following repairs and renewal to the building set out below were authorized. The acting president was authorized to have the contract prepared and executed.

#### 24. Athletic Funds.

A report of the director of the Department of Athletics heretofore made contemplated a balance of funds for this fiscal year in
the Athletic account. The Athletic account is now carried as a
sundry ledger account, and the balance of funds after payment of
game expense is remitted to State Treasurer and carried in the College Revolving Fund. Thus the balance of athletic funds after payment of budget expenditures operates as what is usually termed a
book balance not necessarily reflected in actual cash. President
MeVey and Mr. Shively said that it was contemplated that the unexpended balance of athletic funds be allowed to accumulate and not be
covered into the University General Fund. This question was discussed in the meeting, and it was the consensus of opinion of the
members of the Committee that funds of the Department of Athletics
collected from games and other sources should be kept separate from
the General Fund of the University so that balance may be available

for expenditures for operation of the Department only.

To this end it was ordered on motion, seconded and carried, that the balance of Athletic funds for the year 1939-40, after payment of game expenses and departmental expenses be transferred from the General Fund of the University to the Organizations Fund, and the Business Agent was ordered to make the transfer on the books of the University.

On motion seconded and carried, it was ordered that beginning with next fiscal year all collections made by and through the Department of Athletics for purposes of conducting athletic contests and the operation of the Department of Athletics be paid to the Treasurer of the Organizations Fund and that all orders of the Department of Athletics be made through the secretary of the Organizations Fund. The Athletics funds account shall be carried on the Organizations Funds ledger, so that balances in that fund may be reflected in cash, and athletic funds may be expended only for purpose of operating the Department of Athletics.

25. Grant of General Education Board Continued.

On motion and second, the appropriation was accepted, and Dean Cooper was directed to notify the General Education Board of the acceptance, expressing appreciation for the appropriation.

### 26. Auditorium of Quicksand.

In the WPA project for the erection of an auditorium and service building at the Robinson Substation, approved at the April meeting of the Board of Trustees, certain changes were required which modified the amount of funds requested by the sponsor. Dean Cooper reports that the funds are available and requested approval of the changed agreement on both the changes and the President is authorized to execute the agreement.

### 27. Tobacco Barn - Experiment Station.

Report of Dean Cooper:

On motion, seconded and carried, the Business Agent was directed to make following transfers to Operation and Maintenance Account from college collections, Sundry Ledger account, fees and other collections in amount sufficient to balance the account.

# 29. Payment of Salaries of Agricultural Extenssion Agents.

a. Proposal submitted

June 26, 1940

President Frank L. McVey University of Kentucky

Dear President McVey:

During the winter I discussed with you at various times question of our paying the entire salary of county agricultural and home demonstration agents on funds paid through the University. You will recall that a request was made of the legislature for a special amount to meet these payments. The request was not granted, but \$10,000 additional was appropriated.

After considering the matter, it seems advisable to set up a number of experimental counties in which to try out this method, and thus determine something of its effectiveness and the problems that would arise. Therefore, we have selected a number of counties, list of which is attached, in which the entire salary of the county agricultural and home demonstration agent will be paid through University funds. The county funds will be used as offsets in the payment of travel expense, clerical hire, etc. The payment of the entire salary of the group of agents in these counties will come within the funds allotted.

#### c. Resolution

On motion, seconded and carried, the proposal of Dean Cooper set out above was approved and ratified, and he was directed to proceed with its institution.

#### 29. The University and War Matters.

President McVey brought to the attention of the Executive Committee several communications relative to the activities of the University in connection with national defense. These communications dealt with two matters in particular; one was what part it should have in the matter of training students for the aeronautical service; the other, whether it would be in a position to offer courses for students in vocational fields to prepare them as mechanics. It was pointed out that the University has sent a number of students to Army posts, and that a considerable group, about twenty-two in all, had received training in the Air Service at those posts. The University can do something in the field of engineering training, but so-called trade courses should be offered elsewhere. In case there should be need for young engineers, the University would be in a position to assist, but not in the matter of vocational training. It was recommended that these matters be kept before the committee, that the Engineering College be informed of the action and requested to keep in contact with the situation.

#### 30. Automotive Building.

Judge Stoll stated that the next item on the Call was the consideration of the donation of an aviation research laboratory building for the use of the College of Engineering by the Viking Foundation and asked Dean Graham to explain the situation to the Committee.

Dean Graham stated that, while no definite proposal had been received from the Viking Foundation, he had had a general discussion with Mr. Axel L. Wenner-Gren, an official of the Foundation, with respect to the matter and felt, based upon such discussion, that there was a probability that the Foundation would offer to make the donation. Dean Graham proceeded to outline briefly the type of laboratory under consideration. It was stated that the estimated cost of the building would be approximately \$30,000, the estimated cost of operation and service of the laboratory approximately \$50,000 per year.

Plans of the proposed building were then presented and explained, —the building to be of one story, approximately 160 feet in length by 50 feet in width, of concrete and brick construction, and to be equipped with the most modern methods of soundproofing for both within and without the building.

The site for the proposed building was then discussed with the statement that several sites upon the campus and upon the Experimental Farm had been studied carefully, the space needed being approximately 200 feet by 100 feet, and the space finally selected was the plot immediately opposite the Central Heating Plant on Upper Street and parallel to the spur line railway serving the heating plant, which was the major reason for the selection of this site.

Therefore, the site on Upper Street opposite the Central Heating Plant adjacent to the Southern Railway spur track had been chosen. President McVey objected to placing the length of the building parallel to Upper Street as the south end of such a long building would come very close to the College of Education building. After discussion, it was decided to ascertain if the building could not be erected parallel to the spur railway track, upon the assurance of the engineers that the building would be adequately soundproofed.

It was the consensus of opinion of the Executive Committee that if the Viking Foundation should offer to make a donation to the University of a laboratory along the lines discussed at the meeting, such donation should be accepted.

President McVey presented staff appointments and other changes requested by deans and heads of departments, and, on his recommendation, by motion and second, the following were approved and record ordered made in the minutes:

James F. Hopkins, Instructor, Department of History, for the year 1940-41, at a salary of \$1500 a year. Mr. Hopkins received his A. B. degree "with distinction" from the University of Mississippi and his M. A. degree from the University of Kentucky. He is now a fellow at Duke University.

Nolan Fowler, Graduate Assistant in Department of History, for the year 1940-41, at a salary of \$500.00. He received the A. B. degree from Marshall College and the M. A. degree from the University of Kentucky.
